1. Banking Reforms

1. RURAL BANKING: TRANSLATING VISION TO REALITY

Why banks are hesitating to open branches in rural areas?

- ✓ Rural households have irregular income and expenditure patterns and hence banks will have high non performing loans in the rural areas.
- ✓ The loan waivers driven by political agenda and the economy behaving to the tunes of monsoon aggravate the problem further.
- ✓ The average ticket size of both a deposit transaction and a credit transaction in villages is small, which means banks need more customers per branch or channel to break even.
- ✓ Since many rural folks are not literate and so not comfortable using technology driven channels like ATMs, phone banking or internet banking, hence mostly dependent on bank branches, leading to banks' high cost to serve.
- ✓ The highly irregular and volatile income streams and unscheduled expenditure like medical and social emergency, attribute to higher risk of credit for the banks.

What are the steps to be taken to promote rural banking?

- For optimum usage of Banking Correspondents they need to be adequately compensated by banks so that they are sufficiently incentivised to provide banking services to villagers at their door steps.
- ✓ Banks need to initiate suitable training and skill development programmes to the BCs for their effective functioning.
- ✓ To wean away villagers from borrowing from money lenders, banks should develop simplified credit disbursement procedures and also flexibility in their processes.

- ✓ To reduce the overall transaction ticket costs in rural areas, use of domestic Rupay cards must be promoted in large scale.
- ✓ Since remittance facility for migrant population is of paramount importance, providing easy and cheap remittance facilities to migrants is an absolute imperative.
- ✓ To deal with poor villagers, banks need to initiate training programmes to equip their staff as well as BCs on human side of banking.
- ✓ To achieve meaningful financial inclusion, banks should give priority for small farmers as compared to large farmers while sanctioning credit.
- ✓ There is a need to promote Electronic Benefit Transfer systems effectively for boosting rural banking.
- ✓ Govt. banks should initiate steps to increase the credit absorption capacity in rural areas by promoting employment and other opportunities.
- ✓ The need for vernacularisation of all banking forms is an absolute must, at least in major languages.
- ✓ As a part of financial literacy drive, bans need to take proactive steps in helping the common public to get over their English phobia.

What are the challenges encountered by Banking system due to new initiatives?

- ✓ A large number of PMJDY accounts do not have any money and lie dormant which only increases costs of banks to run these accounts.
- ✓ Poor people live on subsistence level of earning and with no source of regular earning, they don't have surplus to save in bank account or take any other financial instrument.
- ✓ Payment banks will have the benefit of wider reach but they will need to counter the issues of complex user interfaces, lack of internet penetration and lack of grievance redressal mechanism which might deter users.

✓ Direct benefit transfer may see collaboration of erstwhile middle men with bank officials to delay/deny benefits.

- ✓ Payment banks might also deprive regular banks of the fee income they earn from customers like those of making demand drafts, cash transfers, remittances, cash withdrawal through cheques and ATM transaction fees.
- ✓ In quite number of cases, the Business Correspondents have been accused of siphoning the money.
- ✓ Banking technology related frauds are increasing at the alarming rate.
- ✓ In rural and hinterland areas mobile connectivity is still in poor condition.
- ✓ Even some villages need the electrical connection also which is essential for the new age services of banking.
- ✓ Schemes like PMJJBY, PMSBY, APY etc are largely dependent on the success of banking reaching the poor and face a herculean task when a large section of population does not have access to or awareness of pension or insurance products.

2. STRENGTHENING OF CYBER SECURITY

What are the measures to be taken to ensure secure financial transactions?

- ✓ The originator of any transaction shall ensure that his device from which he is originating is completely cyber sanitised. The devise should have been patched up with latest Anti Virus signatures.
- ✓ Care should have been taken to type the banking website addresses and if it is an online transaction it should not be clicked from an email as it can route to phishing attacks.
- ✓ "No lunch is free lunch" Any mobile / online tools which are offered free or given free should be dealt or used with due diligence.
- ✓ The PIN which is used by the originator should be kept confidential and should not be shared with anyone or through any link.

- ✓ The financial institution act as an mediator in transaction between an originator and the beneficiary, so the financial institution IT systems must be protected well enough to carry out the safe and secure transaction.
- ✓ Data must not be changes during the transit, and steps must be taken to ensure that data cannot be altered in an unauthorised manner.
- ✓ The IT infrastructure of the financial institutions which are interacting online must conform to the standards and procedures created by the nodal agencies like CERT In.
- ✓ What are the steps taken by GOI to promote cyber security?
- ✓ In order to address the issues of cyber security in a holistic manner, the Government has released the "National Cyber Security Policy-2013" for public use and implementation by all relevant stakeholders.
- ✓ Government has setup National Critical Information Infrastructure Protection Centre (NCIIPC) to protect the critical information infrastructure in the country.
- ✓ Action has been initiated to set up a centre for tracking all the compromised systems connected on the Internet in the country and clean them on online basis so that the infection does not carry forward.
- ✓ All government websites are to be hosted on infrastructure of National Informatics Centre (NIC), ERNET India or any other secure infrastructure service provider in the country.
- ✓ All the new government websites and applications are to be audited with respect to cyber security prior to their hosting. CERT-In provides necessary expertise to audit IT infrastructure of critical and other ICT sectors.
- ✓ Indian Computer Emergency Response (CERT-In) has empanelled a total no. of 45 security auditors to carry out security audit of the IT infrastructure of Government, Public and Private sector organizations.

- ✓ All the Ministries/ Departments of Central Government and State Governments have been asked to implement the Crisis Management Plan (CMP) to counter cyber attacks and cyber terrorism.
- ✓ The National Watch and Alert System Indian Computer Emergency Response (CERT-In) team is working 24/7 and scanning the cyber space in the country. The team works with Government, Service Providers, private sector and citizens both on pro-active and reactive basis and help in mitigating cyber incidents.
- ✓ Cyber Security mock drills are being regularly conducted to prepare the organizations to detect, mitigate and prevent cyber incidence.
- ✓ Sectoral CERTs have been functioning in the areas of Defence and Finance for catering to critical domains. They are equipped to handle and respond to domain specific threats emerging from the cyber systems.

List out some recent initiatives?

- ✓ USB Pratirodh A desktop security solution, which protects from USB mass storage device threats.
- ✓ **AppSamvid** A desktop solution which protects systems by allowing installation of genuine applications through white listing. This helps in preventing threats from malicious applications.
- ✓ M-Kavach An indigenously developed solution to address the security threats in mobiles.
- ✓ **Browser JSGuard** An browser that detects and defends from malicious HTML & JavaScript based attacks made through the web browser. It blocks access to the harmful, inappropriate and dangerous websites that may contain malicious content through Heuristics.

3. MISSION INDRADHANUSH: REVAMPING OF PUBLIC SECTOR BANKING IN INDIA

What are the reasons behind the need of banking reforms?

✓ The Public Sector Banks (PSBs) play a vital role in India"s economy.

- ✓ In the past few years, because of a variety of legacy issues including the delay caused in various approvals as well as land acquisition etc., and also because of low global and domestic demand, many large projects have stalled.
- ✓ Public Sector Banks which have got predominant share of infrastructure financing have been sorely affected.
- ✓ It has resulted in lower profitability for PSBs, mainly due to provisioning for the restructured projects as well as for gross NPAs.
- ✓ What is mission Indradhanush?
- ✓ The GOI rolled out many reforms which are nicknamed as ABCDEFG reforms to revamp the banking sector and put the PSBs back on track and the reforms are as follows.

Appointments:

- ✓ The Government decided to separate the post of Chairman and Managing Director by prescribing that in the subsequent vacancies to be filled up the CEO will get the designation of MD & CEO and there would be another person who would be appointed as non-Executive Chairman of PSBs.
- ✓ This approach is based on global best practices and as per the guidelines in the Companies Act to ensure appropriate checks and balances.
- ✓ The selection process for both these positions has been transparent and meritocratic and even private persons were allowed to apply for these posts.

Bank Board Bureau:

- ✓ The BBB will be a body of eminent professionals and officials, which will replace the Appointments Board for appointment of Wholetime Directors as well as non-Executive Chairman of PSBs.
- ✓ They will also constantly engage with the Board
 of Directors of all the PSBs to formulate
 appropriate strategies for their growth and
 development.

Capitalization:

- ✓ As of now, the PSBs are adequately capitalized and meeting all the Basel III and RBI norms.
- ✓ However, the Government of India wants to adequately capitalize all the banks to keep a safe buffer over and above the minimum norms of Basel III
- ✓ So the estimated capital requirement of extra capital for the next four years up to FY 2019 is likely to be about Rs.1,80,000 crores and it will be infused to the banks in proper time intervals.

De-stressing PSBs:

- ✓ The infrastructure sector and core sector have been the major recipient of PSBs" funding during the past decades.
- ✓ But due to several factors, projects are increasingly stalled/stressed thus leading to NPA burden on banks.
- ✓ So initiatives like Creation of Project Monitoring groups in respective Ministries, facilitating faster policy decisions, programmes to de stress the DISCOMs are taken to improve the condition of PSBs.

Empowerment:

- ✓ The Government has issued a circular that there
 will be no interference from Government and
 Banks are encouraged to take their decision
 independently keeping the commercial interest of
 the organization in mind.
- ✓ A cleaner distinction between interference and intervention has been made.
- ✓ With autonomy comes accountability, accordingly Banks have been asked to build robust Grievances Redressal Mechanism for customers as well as staff so that concerns of the affected are addressed effectively in time bound manner.

Framework of Accountability:

✓ A new framework of Key Performance Indicators (KPIs) to be measured for performance of PSBs is being announced.

- ✓ Operating performance evaluated through the KPI framework will be linked to the performance bonus to be paid to the MD & CEOs of banks by the Government.
- ✓ The quantum of performance bonus is also proposed to be revised shortly to make it more attractive.

Governance Reforms:

- "Gyan Sangam" a conclave of PSBs and FIs organized at the beginning of 2015 in Pune which was attended by all stake-holders including Prime Minister, Finance Minister, MoS (Finance), Governor, RBI and CMDs of all PSBs and FIs.
- ✓ There was focus group discussion on six different topics which resulted in specific decisions on optimizing capital, digitizing processes, strengthening risk management, improving managerial performance and financial inclusion.
- ✓ The Government has been constantly engaging with the Banks through review meeting and sessions for strategic reviews etc to ease the Governance process.

What are the game changing initiatives taken by GOI in last one year?

- ✓ Insolvency and Bankruptcy Code: The objective of the new code is to promote entrepreneurship, availability of credit, and balance the interests of all stakeholders by consolidating and amending the laws relating to reorganization and insolvency resolution of corporate persons, partnership firms and individuals in a time bound manner and for maximization of value of assets of such persons and matters connected therewith or incidental thereto.
- ✓ The code aims to consolidate the laws relating to insolvency of companies and limited liability entities (including limited liability partnerships and other entities with limited liability), unlimited liability partnerships and individuals, presently contained in a number of legislations, into a single legislation.

✓ Such consolidation will provide for a greater clarity in law and facilitate the application of consistent and coherent provisions to different stakeholders affected by business failure or inability to pay debt.

- ✓ **Recapitalization of Banks**: The Government infused a sum of Rs. 25000 crore in 19 PSBs during financial year 2015-16 and Rs. 24997.182 crore into 16 PSBs during the FY 2016-17.
- ✓ Government has also allowed all PSBs to raise capital from Public markets through Follow-on Public Offer (FPO) or Qualified Institutional Placement (QIP) by diluting Government of India holding upto 52% in phased manner based on their capital requirement, their stock performance, liquidity, market conditions etc.
- ✓ **Consolidation of Banks**: The Union Cabinet has approved the framework for merging state-owned banks. Plans are to consolidate a total of 21 public sector banks.
- ✓ The motive behind the decision is to modify public sector banks according to suit the credit needs of the growing economy that is India.
- ✓ Also, the entities formed after merging PSU banks will be able to absorb shocks and can generate capital without depending on the state exchequer.

4. FACILITATING FINANCIAL INCLUSION

What is financial inclusion?

- Financial inclusion is a process of ensuring access to appropriate financial products and services needed by all sections of the society in general and vulnerable groups in a particular at an affordable cost, in a fair and transparent manner.
- ✓ What are the issues in financial inclusion?
- ✓ There is a need to extend the financial inclusion to the disabled, including those elderly with loco motor activity, vision and hearing is impaired.

- ✓ Even the RBI issued guidelines to make the banks to be disabled friendly, more steps are needed in this direction to make more braches disabled friendly.
- ✓ Technological issues like frequent machine breakdowns and lack of connectivity which negatively impacts confidence of customers towards informal banking.
- ✓ There is an need for facilities lie biometric enabled and multi lingual hand held devices which can provide confidence in rural masses.
- ✓ To monitor developments regarding financial inclusion there is a need to assign responsibility to a dedicated financial institution.
- ✓ Financial literacy is a constant challenge and bankers have to adopt different strategies to reach the larger segments of the society.
- ✓ There is a need to standardise literature / material to extend financial literacy amongst the unbanked.

What are the initiatives of Government to enhance Financial Inclusion?

- ✓ Pradhan Mantri Jan Dhan Yojana (PMJDY):
 Under this, a person not having a savings account
 can open an account without the requirement of
 any minimum balance and, in case they selfcertify that they do not have any of the officially
 valid documents required for opening a savings
 account, they may open a small account.
- ✓ PMJDY offers unbanked persons easy access to banking services and awareness about financial products through financial literacy programmes.
- ✓ In addition, they receive a RuPay debit card, with inbuilt accident insurance cover of Rs. 1 lakh, and access to overdraft facility upon satisfactory operation of account or credit history of six months.
- ✓ Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY): The PMJJBY is available to people in the age group of 18 to 50 years having a bank account who give their consent to join / enable auto-debit. Aadhar is the primary KYC for the bank account.

✓ The life cover of Rs. 2 lakh is for the one year period stretching from 1st June to 31st May and is renewable.

- ✓ Risk coverage under this scheme is for Rs. 2 lakh in case of death of the insured, due to any reason.
- ✓ The premium is Rs. 330 per annum which is to be auto-debited in one installment from the subscriber 's bank account as per the option given by him on or before 31st May of each annual coverage period under the scheme.
- ✓ Pradhan Mantri Suraksha Bima Yojana (PMSBY): The Scheme is available to people in the age group 18 to 70 years with a bank account who give their consent to join / enable auto-debit on or before 31st May for the coverage period 1st June to 31st May on an annual renewal basis.
- ✓ Aadhar would be the primary KYC for the bank account. The risk coverage under the scheme is Rs. 2 lakh for accidental death and full disability and Rs. 1 lakh for partial disability.
- ✓ The premium of Rs.12 per annum is to be deducted from the account holder sbank account through "auto-debit" facility in one installment.
- ✓ Atal Pension Yojana (APY): APY is open to all saving bank/post office saving bank account holders in the age group of 18 to 40 years and the contributions differ, based on pension amount chosen. Subscribers would receive the guaranteed minimum monthly pension of Rs. 1,000 or Rs. 2,000 or Rs. 3,000 or Rs. 4,000 or Rs. 5,000 at the age of 60 years.
- ✓ Under APY, the monthly pension would be available to the subscriber, and after him to his spouse and after their death, the pension corpus, as accumulated at age 60 of the subscriber, would be returned to the nominee of the subscriber.
- ✓ **Stand Up India Scheme**: The Scheme facilitates bank loans between Rs.10 lakh and Rs.1 crore to at least one Scheduled Caste/ Scheduled Tribe borrower and at least one Woman borrower per bank branch for setting up greenfield enterprises.

- ✓ This enterprise may be in manufacturing, services or the trading sector.
- ✓ The scheme which is being implemented through all Scheduled Commercial Banks is to benefit at least 2.5 lakh borrowers.
- Pradhan Mantri Vaya Vandana Yojana: As per the scheme, on payment of an initial lump sum amount ranging from a minimum purchase price of Rs. 1,50,000/- for a minimum pension of Rs 1,000/- per month to a maximum purchase price of Rs. 7, 50,000/- for maximum pension of Rs. 5,000/- per month, subscribers will get an assured pension based on a guaranteed rate of return of 8% per annum, payable monthly.

5. MANAGING NONPERFORMING ASSETS: A PARADIGM SHIFT What are the reasons for the rise in Non

Performing Assets?

- ✓ Exuberance in increasing balance sheet size by lending to borrowers unworthy of such loans on account of their past credit history.
- ✓ Funds were borrowed for creating excess capacities in anticipation of demand without factoring in the global capacities / demand position.
- ✓ Project completion was delayed for various reasons.
- ✓ Recovery of receivables was poor.
- The concerned corporate was not able to raise capital through the issue of equity or other debt instruments from capital markets and used borrowed money as equity leading to double leveraging.
- ✓ Business failure because of overestimated optimistic projections.
- ✓ Diversion of funds meant for expansion / modernization. Borrowed funds are not utilized for the purposes which they have borrowed.
- ✓ Willful defaults, siphoning of finds, frauds, misappropriation etc.,

✓ Lack of skill on the part of the banks to monitor end use of funds and diversion by the borrower through web of shell companies etc.,

✓ Deficiency in credit appraisal and improper due diligence.

What are the changes needed and reforms taken to contain NPA problem?

- ✓ Amendment in banking law to give RBI more powers: The Banking Regulation Act may be amended to give RBI more powers to monitor bank accounts of big defaulters.
- ✓ The amendment in the banking law will enable setting up of a committee to oversee companies that have been the biggest defaulters of loans.
- ✓ RBI wants stricter rules for joint lenders" forum (JLF) and oversight committee (OC) to curb NPAs.
- ✓ **Stringent NPA recovery rules**: The government has over the years enacted and tweaked stringent rules to recover assets of defaulters.

- ✓ The Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act or Sarfaesi Act of 2002 was amended in 2016 as it took banks years to recover the assets.
- ✓ Experts have pointed out that the NPA problem has to be tackled before the time a company starts defaulting.
- ✓ This needs a risk assessment by the lenders and red-flagging the early signs of a possible default.
- ✓ **RBI's loan restructuring schemes**: RBI has over the past few decades come up with a number of schemes such as corporate debt restructuring (CDR), formation of joint lenders' forum (JLF), flexible structuring for long-term project loans to infrastructure (or 5/25 Scheme), strategic debt restructuring (SDR) scheme and sustainable structuring of stressed assets (S4A) to check the menace of NPAs.

2. Supreme Court Verdict on Honour Killing

Why in news?

Supreme Court in its recent verdict has upheld the choice of consenting adults to love and marry as a part of their fundamental rights.

What is the verdict?

- ✓ The judgment came on a petition filed by NGO Shakti Vahini to curb honour crimes.
- ✓ The court held that the consent of the family, community or clan is not necessary for marriage.
- ✓ This is to safeguard young couples under threat for marrying outside their caste or religion.
- ✓ The Court also issued a set of guidelines for the authorities, to stop interference by khap panchayats.
- ✓ The guidelines issued by the Court will be in place till the government comes up with a law.

Why are khap panchayats a concern?

- ✓ Khap panchayats are the self-appointed village courts.
- ✓ Khap panchayats wield enormous influence in villages of several states if India.
- ✓ Honour Killings They are often seen responsible for the growing number of honour killings in the country.
- ✓ They group against young couples to force their presence and dictate punishments.
- ✓ **Sense of honour** These "feudalistic" entities have no reluctance in committing crimes.
- ✓ The "sense of honour" perpetuates the idea of not to marry outside one's caste, clan or religion.
- ✓ Masculine dominance becomes the sole governing factor of perceptive honour.
- ✓ The police turn a blind eye and the administration hardly questions them.
- ✓ **Women** Women are treated by the khaps as servile persons who have no desire for autonomy.
- ✓ Their families are either silent spectators or active participants in their torture.

✓ To highlight the terror inflicted on women, the Supreme Court gave a list of actions which trigger honour-based crimes.

They include

i. loss of virginity outside marriage

ii. unapproved relationships

iii. refusing an arranged marriage

iv. asking for divorce

v. demanding custody of children after divorce

vi. causing scandal or gossip in the community

vii. even "falling victim to rape"

What are the Court's observations on this?

- ✓ The apex court ridiculed the "elevated sense of honour" of elders, the collective and khap panchayats.
- ✓ It observed honour killing that guillotines individual liberty, freedom of choice and one's own perception of choice.
- ✓ The human rights of a person are not mortgaged to the so-called honour of the family or clan or the collective.
- ✓ Khap panchayats were condemned for their belief that their duty is sanctified and their action of punishing the hapless victims is inviolable.
- ✓ It termed the elders, presiding over murder in broad daylight, as "patriarchal monarchs".
- ✓ The verdict thus comes down heavily on crimes committed in the name of honour.

SUPREME COURT GUIDELINES TO PREVENT HONOUR KILLING

Why in news?

Supreme Court in its recent verdict has upheld the choice of consenting adults to love and marry as a part of their fundamental rights.

What are the guidelines?

✓ **States** - The state governments should identify districts, sub-divisions and/or villages concerned.

- ✓ These are areas where instances of honour killing or assembly of Khap Panchayats have been reported in the last 5 years.
- ✓ **Police** Officer In-charge of the police stations of the identified areas needs to be cautious.
- ✓ Any instance of inter-caste or inter-religious marriage within their jurisdiction coming to their notice should be taken care of.
- ✓ They should inform to the immediate superior officer.
- ✓ Also the jurisdictional Deputy Superintendent of Police (DSP) and
- ✓ Superintendent of Police should be intimated.
- ✓ **Prevention** Once done, the DSP or a senior police officer should immediately interact with the members of the Khap Panchayat.
- ✓ It should be made clear that convening of such meeting/gathering is not permissible in law, and should ultimately be prevented.
- ✓ **Meeting** Despite these, if the meeting is conducted, the DSP should personally remain present during the meeting.
- ✓ S/he should ensure that no decision is taken to cause any harm to the couple or the family members of the couple.
- ✓ If this fails, each one participating in the meeting besides the organizers would be personally liable for criminal prosecution.
- ✓ Video Discussion and participation of the members of the assembly meet should be video recorded.
- ✓ The DSP should ensure this, as this is the basis on which the law –enforcing machinery can resort to suitable action, later, if needed.
- ✓ **Proposal** The DSP shall submit a proposal to the District Magistrate/Sub-
- ✓ Divisional Magistrate of the District/ Competent Authority of the concerned area.

- ✓ This is when the gathering cannot be prevented and/or is likely to cause harm to the couple or members of their family.
- ✓ **Orders** The authority can issue orders to take preventive steps under the CrPC.
- ✓ Prohibitory orders under Section 144 CrPC can also be invoked.
- ✓ Arrest of the participants in the assembly under Section 151 CrPC can also be approved.
- ✓ Crime The jurisdictional police official can file an FIR under the appropriate provisions of the Indian Penal Code.
- ✓ This is when, despite all preventive measures, if Khap Panchayat has taken place and passed any diktat against a couple/family.
- ✓ Upon registration of FIR, the Superintendent/Deputy Superintendent of Police should be intimated.
- ✓ S/he, in turn, should ensure that effective investigation of the crime is done.
- ✓ **Security** Immediate steps should be taken to provide security to the couple/family.
- ✓ If necessary, steps to move them to a safe house within the same district or elsewhere should be taken.
- ✓ The District Magistrate/Superintendent of Police must deal with utmost sensitivity, the complaint regarding threat administered.
- ✓ Safe house After the marriage, if the couple so desire, they can be provided accommodation on payment of nominal charges in the safe house.
- ✓ This would be for a period of 1 month to be extended on monthly basis but not exceeding one year in aggregate.
- ✓ The decision would be taken depending on their threat assessment on caseto-case basis.
- ✓ Inquiry The initial inquiry regarding the complaint should be entrusted by the District Magistrate/Superintendent of Police to an officer of the rank of
- ✓ Additional Superintendent of Police.
- ✓ S/he shall conduct a preliminary inquiry and ascertain the authenticity, nature and gravity of threat perception.

✓ On being satisfied as to the authenticity of such threats, a report should be submitted to the Superintendent of Police in one week.

- ✓ The District Superintendent of Police, on such report, should direct the
- ✓ Deputy Superintendent of Police in-charge of the concerned sub-division.
- ✓ This is to cause to register an FIR against the persons threatening the couples and, if necessary, invoke Section 151 of CrPC.
- ✓ Additionally, the DSP should personally supervise the progress of investigation and ensure that the same is completed.
- ✓ **Case** The designated Court/Fast Track Court earmarked for the purpose will try criminal cases pertaining to honour killing or violence to the couple(s).
- ✓ The trial must proceed on day-to-day basis.
- ✓ It must preferably be concluded within 6 months from the date of taking cognizance of the offence.
- ✓ **Negligence** Police or district officer/officials failing to comply with the directions will be considered as an act of deliberate negligence and/or misconduct.
- ✓ This is if such official(s) do not prevent the incident or take appropriate actions thereafter, despite prior knowledge of it.
- ✓ Departmental action would be taken under the service rules.

- ✓ The action shall be initiated and taken to its logical end, preferably not exceeding 6 months.
- ✓ The states are directed to take disciplinary action against the concerned officials.
- ✓ **Special Cells** The State Governments should create special cells in every District.
- ✓ This is to receive petitions/complaints of harassment of and threat to couples of inter-caste marriage.
- ✓ The special cell will comprise of the
 - i. Superintendent of Police
 - ii. District Social Welfare Officer
 - iii. District Adi-Dravidar Welfare Officer
- ✓ These special cells should create a 24-hour helpline to receive and register such complaints.
- ✓ They are also to provide necessary assistance/advice and protection to the couple.
- ✓ Sensitization The different state governments and the centre should work on sensitization of the law enforcement agencies.
- ✓ There should be institutional machinery with the necessary coordination of all the stakeholders.
- ✓ The Home department must take this initiative and work in coordination with the state governments.
- ✓ This is to mandate social initiatives and awareness, to curb such violence, and meet the goal of social justice and rule of law.

3. EUTHANASIA AND LIVING WILL

What is the issue?

- ✓ The Supreme Court, in a landmark verdict in 2011, ruled out active euthanasia, but laid down a legal framework for passive euthanasia.
- ✓ A Constitution Bench is now hearing a petition filed by NGO Common Cause on the issue of living will in relation with passive euthanasia.
- ✓ The centre has told the Supreme Court that it was evaluating a draft law on passive euthanasia, and takes stance against living will.

What is the case?

- ✓ **Passive euthanasia** It refers to the withdrawal of medical treatment with the deliberate intention to hasten a terminally ill-patient's death.
- ✓ The centre has informed that the 'Management of Patients With Terminal Illness — Withdrawal of Medical Life Support Bill' was ready.
- ✓ It has provisions allowing passive euthanasia as recommended by the law commission which specifies certain categories of people.
- ✓ These include those in persistent vegetative state (PVS), in irreversible coma, or of unsound mind, who lack the mental faculties to take decisions.
- ✓ **Living Will** It refers to an advance written directive of the concerned person to physicians for end-of-life medical care i.e. not to provide life support.
- ✓ The court has indicated that it may lay down comprehensive guidelines on operationalising the idea of living wills.
- ✓ However, the government has opposed the concept of an advance directive and opposes permitting people to make a 'living will'.

What are the complications with 'living will'?

- ✓ Deciding on the question of living will comes with all the legal, moral and philosophical implications.
- ✓ **Legal** An earlier verdict from the judiciary has noted that right to life under Article 21 does not include the right to die.

- ✓ Allowing making a living will would contravene this legal stand.
- ✓ **Rights** Allowing it would also acknowledge the patient's autonomy and selfdetermination to the point of legalising a wish to die.
- ✓ **Social** -There are chances of misusing the provision and leading to the abuse and neglect of the elderly.
- ✓ On the other hand, allowing it would relieve the close family members, of a terminally ill patient, of the moral burden of making a life-ending decision.
- ✓ A living will would also rule out the possibility of doubting the life terminating decision as a murder

What could be done?

- ✓ Given the mixed benefits, living will could be provided for with the necessary safeguards.
- ✓ The guidelines should ensure that it was really the will of the concerned person.
- ✓ Also, an independent medical board can examine the health of the person to establish the validity of the decision.

SUPREME COURT'S VERDICT ON PASSIVE EUTHANASIA AND LIVING WILL

Why in news?

A Constitution Bench has made passive euthanasia and living will permissible.

A dignified death should follow a meaningful existence

What is SC's rationale?

- ✓ **Right to Die** The Supreme Court has upheld that the fundamental right to life and dignity includes right to refuse treatment and die with dignity.
- ✓ It observed that the fundamental right to a "meaningful existence" includes a person's choice to die without suffering.
- ✓ But it is held that active euthanasia was unlawful.
- ✓ **Dignified death** Lack of legal backing sometimes lead to suffering and undignified death of the patient.

- As, societal pressure and fear of criminal liability by relatives and medical doctors hamper them from making the needed decision.
- ✓ Religion, morality, philosophy, law and society have differing opinions on whether right to life included right to death or not.
- ✓ However, they all unanimously share the idea that a person should die with dignity.
- ✓ Individual Liberty The issue of death and when to die transcended the boundaries of law.
- ✓ But the court had intervened because the sanctity of life included the dignity and autonomy of the individual.
- ✓ The search for a meaningful existence, the pursuit of happiness included the exercise of free will which includes the right of a person to refuse medical treatment.
- ✓ A person need not give any reasons nor is answerable to any authority on why he/she should write an advanced directive.

What are SC's guidelines on living will?

- ✓ A Living Will is a healthcare directive, in which people can state their wishes in advance for their end-of-life care, in case they are not in a position to make a decision then.
- ✓ **Who** An adult with a sound and healthy mind can make a Living Will.
- ✓ It should be voluntarily executed and based on informed consent.
- ✓ It should be expressed in specific terms in a language "absolutely clear and unambiguous".
- ✓ Content The Living Will should contain the circumstances in which medical treatment should be withheld or withdrawn.
- ✓ It should give the name of the "guardian or close relative" who will give the go-ahead for starting the procedure of passive euthanasia.
- ✓ It should specify that the Will can be revoked any time.
- ✓ An individual has the right to withdraw or alter the Living Will, but only in writing.
- ✓ So, if there are more than one Living Will, the latest one will be valid.
- ✓ Validity The Will shall be attested by two independent witnesses.

- It should preferably be counter-signed by the Judicial Magistrate First Class (JMFC) who is assigned the jurisdiction by the District Court.
- ✓ **JFMC** The JMFC shall preserve one hard copy, along with one in the digital format, in his/her
- ✓ JMFC shall forward a copy of the Will to the Registry of the District Court.
- ✓ JMFC shall inform the immediate family of the executor, if not informed.
- ✓ A copy will be handed over to an official in the local government or Municipal Corporation or Municipality or Panchayat concerned.
- ✓ This authority shall nominate a custodian for the Living Will.
- ✓ Besides the guidelines, it was observed that modern medical science should balance its quest to prolong patient's life.
- ✓ **Exception** The court held that a Living Will shall not be applicable to the 'treatment in question'.
- This is when there are reasonable grounds for believing that circumstances exist which the person did not anticipate at the time of making the advance directive.
- ✓ And necessarily which would have affected his/her decision had he/she anticipated such circumstances.

Aruna Shanbaug case

- ✓ Aruna Shanbaug is an Indian nurse who spent around 40 years in a vegetative state as a result of a sexual assault.
- ✓ In 2011, the Supreme Court, in a landmark judgement, issued a set of broad guidelines legalizing passive euthanasia in India.
- ✓ However, the present judgement observed that the previous judgement had complex procedure to get approval for passive euthanasia.
- This consequently made the dignity of a dying person dependent on the whims and will of third parties.
- The present judgement, allowing individual Living Will and framing the appropriate guidelines, has addressed the earlier shortfalls with taking forward passive euthanasia.

4. International News

1. 17th World Conference on Tobacco held in South Africa

The 17th World Conference on Tobacco or Health (WCTOH) was held in Cape Town, South Africa from 7-9 March 2018.

✓ It united researchers, academics, nongovernmental organizations, civil society, scientists, healthcare professionals and public officials working on all aspects of tobacco control from more than 100 countries.

2. India to host International Competition Network Annual Conference for the first time

India to host 17th Annual Conference of International Competition Network 2018 (ICN2018) from 21st to 23rd March 2018 in New Delhi.

- ✓ While addressing the press conference, Competition Commission of India's Chairperson Shri Devender Singh Sikri said that this is the first time India is hosting the ICN2018 Annual Conference since it joined International Competition Network (ICN) in 2009.
- ✓ CCI Chairperson Shri Sikri said that the ICN is an informal network comprising 138 competition authorities from 125 jurisdictions.

3. Philippines to withdraw from International Criminal Court

The Philippines says it will withdraw from the International Criminal Court (ICC), a month after the judicial body started an inquiry into President Rodrigo Duterte's controversial war on drugs.

- ✓ The country had given notice that it would withdraw from the treaty that established the court.
- ✓ Duterte has been accused of encouraging extrajudicial killings and other rights abuses in his bid to rid the country of drugs since his election in 2016.

4. Mauritius President Ameenah Gurib-Fakim resigns

Mauritius President Ameenah Gurib-Fakim resigned after being embroiled in a scandal over her use of a credit card to buy luxury personal items.

- ✓ Gurib-Fakim, Africa's only female head of state, submitted her resignation in the "national interest," her lawyer Yousouf Mohamed said.
- ✓ Her resignation would take effect on March 23.

5. G20 ministerial meeting opens in Buenos Aires

The first G20 meeting of finance ministers and central bank governors began in Buenos Aires, with the presence of 57 delegations from different countries and institutions.

✓ This is the first of five such meetings to be held before Argentina hosts the G20 Summit on November 30 to December 1.

7. President of India inaugurates world Hindi secretariat in Mauritius

The President of India, Shri Ram Nath Kovind, inaugurated the World Hindi Secretariat building on March 13, 2018 on the third day of his visit to Mauritius.

- ✓ He also launched the World Hindi Secretariat's logo and a large ENT hospital being built with Indian assistance.
- ✓ The President noted that the 11th World Hindi Conference is going to be held in Mauritius in August 2018.
- ✓ Apart from India, Mauritius is the only country where this conference is being hosted for a third time.

Points to Remember

✓ Mauritius, officially the Republic of Mauritius is an island nation in the Indian Ocean.

- ✓ Ameenah Gurib is the President of Mauritius while Pravind Jugnauth is the Prime Minister.
- ✓ Port Louis is the capital of Mauritius while Rupee is its currency.

8. Paper £10 notes go out of circulation in UK

Old paper £10 notes, featuring British naturalist Charles Darwin, went out of circulation across the UK on March 1.

- ✓ They have been replaced by the new polymer version featuring British author Jane Austen introduced last year.
- ✓ Anyone with the old banknote will need to deposit it at a bank as shops will refuse to accept them as they cease to be legal tender.

9. India, Russia, Bangladesh sign pact for Rooppur atomic plant

Indian companies can now participate in construction and installation works in the "non-critical" category for the Rooppur nuclear power plant in Bangladesh.

- ✓ The Rooppur project is the first initiative under an Indo-Russian deal to undertake atomic energy projects in third countries.
- ✓ This will also be the first time Indian companies will be able to participate in a nuclear power project abroad.
- ✓ India is not a member of the Nuclear Suppliers Group (NSG) and hence cannot participate directly in construction of atomic power reactors.

10. India has the third highest number of billionaires in the world

With 31 new Indians on the list, India comes third after China and USA on Hurun's Global Rich List 2018.

- ✓ However, China with 819 names and USA with 571 are way ahead in terms of number of billionaires.
- ✓ The total number of Indians on that list is 131, but if Indian-origins are considered then the tally would move up to 170.
- The Hurun Rich List 2018 ranked 2,694 billionaires from 68 countries and 2,157 companies.

5. NATIONAL NEWS

1. LaQshya Program for Pregnant Women

Ministry of Health and Family Welfare has recently announced the launch of program 'LaQshya', aimed at improving quality of care in labour room and maternity Operation Theatre (OT).

- ✓ The Program will improve quality of care for pregnant women in labour room, maternity Operation Theatre and Obstetrics Intensive Care Units (ICUs) and High Dependency Units (HDUs).
- ✓ The LaQshya program is being implemented at all Medical College Hospitals, District Hospitals and First Referral Unit (FRU), and Community Health Center (CHCs) and will benefit every pregnant woman and new-born delivering in public health institutions.
- ✓ 'LaQshya' will reduce maternal and newborn morbidity and mortality, improve quality of care during delivery and immediate post-partum period and enhance satisfaction of beneficiaries and provide Respectful Maternity Care (RMC) to all pregnant women attending public health facilities.

2. KUSUM Scheme – harnessing solar power for rural India

The Government of India is in the process of formulating a Scheme 'Kisan Urja Suraksha evam Utthaan Mahabhiyan (KUSUM)' which, inter alia, provides for:

- ✓ Installation of grid-connected solar power plants each of capacity up to 2 MW in the rural areas;
- ✓ Installation of standalone off-grid solar water pumps to fulfill irrigation needs of farmers not connected to grid;
- ✓ Solarization of existing grid-connected agriculture pumps to make farmers independent of grid supply and also enable them to sell surplus solar power generated to DISCOM and get extra income; and

✓ Solarization of tube-wells and lift irrigation projects of Government sector.

3. Atal Bhujal Yojana

The Government has proposed Atal Bhujal Yojana (ABHY) aimed at sustainable ground water management with community participation in select over-exploited and ground water stressed areas in seven States (Gujarat, Haryana, Karnataka, Madhya Pradesh, Maharashtra, Rajasthan and Uttar Pradesh).

✓ ABHY is designed as a Central Sector Scheme with a total outlay of Rs. 6,000 Crore and is proposed to be implemented with World Bank assistance.

4. Modi to inaugurate Science Congress

Prime Minister Narendra Modi will inauguratethe 105th edition of the Indian Science Congress in Imphal on March 16.

✓ The Science Congress will see congregation of about 5000 delegations including three Noble laureates, scientists, scholars and researchers from all across the country.

5. PM addresses Rising India Summit organized by Network 18

The Prime Minister, Shri Narendra Modi addressed the Rising India Summit, organized by Network 18.

- ✓ He said that when we speak of a rise, in terms of a nation, it has a very broad context.
- ✓ He said that beyond the rise of the economy, he feels that Rising India implies the rise of selfrespect among the people of India.

6. NITI Aayog to Release SATH-E Roadmaps

SATH-E to introduce System-wide Governance Transformation in School Education

✓ NITI Aayog will release comprehensive roadmaps and detailed timelines for its initiative 'Sustainable Action for Transforming Human Capital in Education (SATH-E)' project at NITI Aayog on March 17.

✓ Shri Amitabh Kant, CEO, NITI Aayog and the Chief Secretaries of the States of Jharkhand, Madhya Pradesh and Odisha will release the forward looking blueprints after a day-long workshop with Principal Secretaries of the States, State Project Directors and other experts and representatives operating in the field.

7. More than 17 lakh beneficiaries enrolled under Pradhan Mantri Matru Vandana Yojana

Number of beneficiaries enrolled under Pradhan Mantri Matru VandanaYojana (PMMVY) has increased to 17,66,423.

- ✓ Every day on an average, around 50, 000 new applications are received for enrolment.
- ✓ So far, Rs. 2048.21 Crores to all 36 States/UTs have been sanctioned under PMMVY out of which Rs. 2042.09 Crores have been released till date.
- ✓ The Government of India has approved Pan-India implementation of PMMVY in all districts of the country from 01.01.2017 under which the eligible beneficiaries get Rs. 5,000/- under PMMVY and the remaining cash incentive as per approved norms towards Maternity Benefit under Janani Suraksha Yojana (JSY) after institutional delivery so that on an average, a woman gets Rs. 6000/-.

8. Nitin Gadkari inaugurates 5th 'Nadi Mahotsava' in Hoshangabad

Union Minister for Water Resources, River Development and Ganga Rejuvenation Nitin Gadkari has inaugurated the 5th 'Nadi Mahotsava' in Hoshangabad District of Madhya Pradesh.

- ✓ Addressing the gathering, the minister said that the pioneering event like 'Nadi Mahotsava' will not only revive rivers, but also improve the condition of people living on their banks.
- ✓ The 'Nadi Mahotsava' event was also addressed by Madhya Pradesh Chief Minister Shivraj Singh Chauhan.

9. Plastic Ban In Maharashtra From March 18

The Maharashtra cabinet decided to impose a ban on certain plastic items from the Marathi New Year, 'Gudhi Padwa', on March 18.

- ✓ An official in the state environment department said the ban will cover plastic carry bags, thermocol and plastic plates, cups, forks, bowls and spoons.
- ✓ An empowered committee under the Environment Minister Ramdas Kadam has been formed to discuss the ban on rest of the plastic goods, the official said.

10. Children's Science Congress concludes

Emphasising the need to provide more opportunities to children, Vice Chancellor of Manipur University, Prof. Adya Prasad Pandey has said that young students are the future of the country.

✓ Delivering the keynote address at the Valedictory session of the Children's Science Congress at the 105th Indian Science Congress in Imphal, Shri Pandey said that with more opportunities, children will contribute more towards a better India.

11. Manduadih to be renamed Banaras railway station

The holy city of Varanasi is soon likely to get a railway station named "Banaras".

- ✓ The Railway Ministry is considering renaming the Manduadih railway station as Banaras railway station.
- ✓ Manduadih is among one of the four railway stations in the city besides Varanasi Junction, popularly known as Varanasi Cantt Railway Station, Varanasi City and Kashi.

Points to Remember

- ✓ Manduadih is a place in Varanasi situated about four kilometers from Varanasi Cant Station.
- ✓ Varanasi, also called Banaras and Kashi, was chosen in 2014 by Narendra Modi to contest the Lok Sabha polls from city of Uttar Pradesh.

✓ The name Varanasi is said to be derived from combination of 'Varuna' and 'Asi' — the names of rivers.

✓ Kashi is the ancient name of Varanasi.

12. Sajibu Nongma Panba Cheiraoba celebrated in Manipur

The traditional festival of Sajibu Nongma Panba Cheiraoba was celebrated in Manipur on 18th March to mark the beginning of a new year.

✓ The festival is mainly observed on the first lunar day of the lunar month Sajibu (March/April) by the Meitei community, a majority ethnic group of Manipur.

13. Punjab to impose permanent ban on hookah bars

The Punjab Government is all set to impose a permanent ban on hookah bars across the State instead of issuing temporary orders against them every two months.

- ✓ Punjab will be the second State in the country, after Gujarat, to take the significant decision.
- ✓ Gujarat has banned Hookah bars in the State by passing the COTPA Amendment Bill, 2017.

14. 'Tribal Diaries' Mobile App to strengthen internal monitoring

The Ministry of Tribal Affairs has developed an android based mobile application called Tribal Diaries for internal monitoring as also connecting with officers/officials concerned with implementation of schemes / programmes for tribal development.

- ✓ The application is for accredited users.
- ✓ This application provides an opportunity for visual feedback in terms of photographs, videos, uploading reports of official tours / inspections and sharing of best practices etc.

15. First National Workshop on POSHAN Abhiyaan

The first National workshop on POSHAN Abhiyaan involving all the states and union territories is being held on 20th March at Pravasi Bharatiya Kendra, New Delhi.

✓ The Ministry of Women and Child Development is organising the day long workshop with participation from all the states/UTs.

16. Government approves Plastic Park to be set up in Deoghar

Union Minister for Chemicals & Fertilizers and Parliamentary Affairs, Shri Ananthkumar announced that the Government of India has approved the setting up of a Plastic Park in Deoghar District, Jharkhand.

- ✓ The project would be set up at a cost of Rs. 120 crores in an area of 150 acres and a range of polymer products including woven sacks, moulded furniture, water tanks, bottles, pipes mosquito nets, etc would be manufactured.
- ✓ It has great potential for attracting investment for setting up an ecosystem for plastic industry and generate employment opportunities for the local populace, the Minister informed.

17. NCAA becomes the World's First Trusted Digital Repository

National Cultural Audiovisual Archives (NCAA) project of the Ministry of Culture, Government of India, implemented by Indira Gandhi National Centre for the Arts (IGNCA) has been certified as the world's first Trusted Digital Repository as per ISO 16363:2012 standard, granted by Primary Trustworthy Digital Repository Authorisation Body Ltd. (PTAB), United Kingdom.

✓ Leveraging this historic achievement, the plan for the next phase is to integrate about three lakh hours of audiovisuals materials, a corpus estimated based on a scoping survey conducted in 25 cities across the country, on this platform over the next five years.

18. Nitin Gadkari inaugurates Inland Ferry Services in Goa

Union Minister of Road Transport and Highways, Shipping and Water Resources, River Development and Ganga Rejuvenation Shri Nitin Gadkari has inaugurated the Inland ferry services in the port city of Vasco in Goa.

✓ The Minister said that while addressing the needs of the poor, environment and ecosystem must be given its due priority.

19. Cabinet approves Opening of Missions in Africa to implement commitments of IAFS

- ✓ The 18 new Indian Missions in Africa will be opened in Burkina Faso, Cameroon, Cape Verde, Chad, Republic of the Congo, Djibouti, Equatorial Guinea, Eritrea, Guinea, Guinea Bissau, Liberia, Mauritania, Rwanda, Sao Tome& Principe, Sierra Leone, Somalia, Swaziland and Togo over a four year period from 2018-2021 thereby increasing the number of Resident Indian Missions in Africa from 29 to 47.
- ✓ The decision will enhance India's diplomatic outreach in the African continent and allow India to engage with Indian diaspora in African countries.
- Opening of new Missions is also a step towards implementing the vision of enhanced cooperation and engagement with Africa.

20. Cabinet approves North-East Industrial Development Scheme (NEIDS) 2017

The Union Cabinet chaired by the Prime Minister Shri Narendra Modi has approved the North East Industrial Development Scheme (NEIDS), 2017 with financial outlay of Rs.3000 crores upto March, 2020.

- ✓ Government will provide necessary allocations for remaining period of scheme after assessment before March 2020.
- ✓ NEIDS is a combination of the incentives covered under the earlier two schemes with a much larger outlay.

21. Cabinet approves Ayushman Bharat – National Health Protection Mission

The Union Cabinet chaired by the Prime Minister Shri Narendra Modi has approved the launch of a new Centrally Sponsored Ayushman Bharat - National Health Protection Mission (AB-NHPM) having central sector component under Ayushman Bharat Mission anchored in the MoHFW.

- ✓ The scheme has the benefit cover of Rs. 5 lakh per family per year.
- ✓ The target beneficiaries of the proposed scheme will be more than 10 crore families belonging to poor and vulnerable population based on SECC database.
- ✓ AB-NHPM will subsume the on-going centrally sponsored schemes —Rashtriya Swasthya BimaYojana (RSBY) and the Senior Citizen Health Insurance Scheme (SCHIS).

22. Cabinet approves closure of India Development Foundation of Overseas Indians

The Union Cabinet chaired by Prime Minister Shri Narendra Modi has given its approval for closure of India Development Foundation of Overseas Indians (IDF-OI)to enhance synergies in channelizing Diaspora's contributions to Government of India's flagship programmes such as National Mission for clean Ganga and Swachh Bharat Mission.

- ✓ IDF-OI was set up by Government of India with the approval of Cabinet in 2008 as an autonomous not-for-profit Trust, to facilitate Overseas Indian philanthropy into social and development projects in India.
- ✓ As the Foundation received only Rs. 36.80 Lakhs between December 2008 and March 2015 as donation from overseas Indian community, a comprehensive review of IDF-OI was undertaken in 2015.

23. Hansraj Gangaram Ahir to inaugurate first National Conference on Drug Law Enforcement

The Minister of State for Home Affairs, Shri Hansraj Gangaram Ahir will inaugurate the two-day first National Conference on Drug Law Enforcement in New Delhi.

- ✓ The conference is being organsied by the Narcotics Control Bureau (NCB), Ministry of Home Affairs.
- ✓ The Union Home Minister Shri Rajnath Singh will be the Chief Guest at the closing session on 24th March.

24. MNRE to set up 65,180 biogas plants in current year

The National Biogas and Manure Management Programme (NBMMP) aims at setting up of family type biogas plants for providing biogas as clean cooking fuel and a source of lighting.

✓ The Ministry of New and Renewable Energy (MNRE) has fixed an annual physical target of setting up 65,180 biogas plants for the current year 2017-18 under the NBMMP.

25. India to be Self-Reliant in Silk Production by 2020

India will be self-reliant in the production of silk by 2020, said the Minister of Textiles Smriti Zubin Irani in a media interaction.

- ✓ The Union Cabinet's decision approving the Integrated Scheme for Development of Silk Industry will help increase the production of Bivoltine silk (high quality) by 62 percent by 2020.
- ✓ The Minister further said the aim of the government is to increase the number of people engaged in the silk sector from 85 lakhs to one crore in the next three years.

The Nirbhaya Fund was set up in the aftermath of the gruesome gangrape and murder of a paramedical student in Delhi in 2012, and aims at improving safety for women.

- ✓ The state government made its announcement via a press release on March 1 — Marathi language
- ✓ It said this will help spread the language across the globe and give Marathi-speaking people a single platform to interact.

✓ "Saposhi is similar in its intensity to Reaper, which was taking over millions of devices at the rate of 10,000 devices per day.

The government has decided to declare 2018 as 'National Year of Millets to boost the cultivation of millets like ragi and jowar on a mission mode to achieve nutritional security.

- ✓ This was stated by Agriculture Minister Radha Mohan Singh while addressing MPs in a consultative committee meeting in New Delhi.
- ✓ The Minister said millet cultivation has declined due to change in dietary habits and unavailability of millets. As a result of this, level of nutrients like proteins, Vitamin-A, iron and iodine fell in women and children.

74. Roundtable of Invest India Held

Minister of Commerce & Industry and Civil Aviation, Suresh Prabhu chaired a roundtable of Invest India in New Delhi.

- ✓ Various regulatory issues faced by Startups in the sectors of e-pharmacy, NBFCs, unmanned aerial vehicle and retail delivery of petroleum from door to door were discussed with the concerned Ministries and departments of the Government of India in the presence of the Minister.
- ✓ Following issues like presence of pharmacist at e-pharmacy platforms, stream lining of the

application process for NBFCs by RBI, reforms in current guidelines for UAV sector, which doesn't allow for manufacturing of drones, and vehicle specifications for door to door retail delivery of petroleum, were discussed at length.

The birth anniversary of India's Dalit social reformer Dr BR Ambedkar will be celebrated as 'Social Justice Day'.

- ✓ Born into a poor Dalit family, on 14 April 1891, Ambedkar became independent India's first law minister, the principal architect of the Constitution of India.
- ✓ Ambedkar was awarded the Bharat Ratna posthumously in 1990.

79. West Bengal tops the list of states with most number of beggars

The government has come out with the total number of beggars in the country. As per the data released by Union ministry of Social Justice, there are around 4 lakh beggars in total.

- ✓ The highest number of beggars, 81,000, are in West Bengal.
- ✓ West Bengal is followed by Uttar Pradesh and Bihar at number two and three respectively.
- ✓ Lakshadweep, a union territory, has only two people begging for their livelihood.

80. UIDAI set to introduce face authentication feature from July 1

The Unique Identification Authority of India (UIDAI) is all set to make face authentication available alongside iris or fingerprint scan as means of verifying Aadhaar users from July 1, 2018.

✓ The UIDAI, which is in-charge of the 12-digit identifier Aadhaar, in January had announced that it will introduce face authentication feature to help those who run into problems in biometric authentication due to old age, hardwork or wornout fingerprints.

87. IM-PDS approved for implementation during 2018-19 and 2019-20

- ✓ With the above proposed houses, cumulative houses under PMAY(U) would become 42,45,792 after final approval from CSMC.

91. MP has the highest number of tribal habitations fully covered by Drinking Water supply

- ✓ The bank has registered a business turnover of Rs 1.06-lakh crore.

2. Fitch forecasts 7.3% growth for India next year

Fitch has projected India's economic growth to rise to 7.3 per cent next fiscal and further to 7.5 per cent in 2019-20.

- ✓ In its Global Economic Outlook report, the USbased agency forecast Indian economy to clock a growth rate of 6.5 per cent this fiscal.
- ✓ The economy grew 7.1 per cent in 2016-17.

3. INDIA and ADB Sign \$120 Million Loan to Improve Rail Infrastructure

Government of India and the Asian Development Bank (ADB) have signed a \$120 million loan agreement for completion of works for doubletracking and electrification of railways tracks along high-density corridors to improve operational efficiency of Indian railways.

- ✓ The tranche 3 loan is part of the \$500 million multi-tranche financing facility for Railway Sector Investment Program approved by the ADB Board in 2011.
- ✓ The loan amount will be used to complete the ongoing works commenced under earlier tranches.

4. SBI launches Quick App

State Bank of India is giving a special facility to its ATM card holders. With this, customers can keep their ATM cards under control.

- ✓ SBI Quick App has special features for controlling special ATM cards.
- ✓ It provides the facility of blocking, turning on or off ATM cards and generating an ATM PIN.

5. SBI, IMGC sign MoU

India's largest lender SBI and India Mortgage Guarantee Corporation (IMGC) today signed a pact to offer mortgage guarantee scheme for prospective non-salaried and self-employed home loan customers.

- ✓ The offering will help increase home loan eligibility up to 15 per cent within the regulatory norms, the State Bank of India (SBI) said in a statement.
- ✓ IMGC is a joint venture between National Housing Bank, Genworth Inc International Finance Corporation and Asian Development Bank.
- ✓ It is providing mortgage default guarantee to the lending Institutions in India.

6. RBI slaps Rs 40 lakh penalty on SBI

The Reserve Bank has slapped a penalty of Rs 40 lakh on SBI for not complying with its directions on detection and impounding of counterfeit notes.

- ✓ RBI said it found deficiencies on SBI's part in regulatory compliance with counterfeit notes regulations.
- ✓ The regulator had carried out inspection of currency chests of two branches of the country's largest lender and noticed violation of its instructions issued on the detection and impounding of counterfeit notes.

7. ISA-ADB, NDB, GCF, AfDB and AIIB joint declarations of Financial partnership

The International Solar Alliance (ISA) and the African Development Bank (AfDb), the Asian Development Bank (ADB), the Asian Infrastructure Investment Bank (AIIB), the Green climate fund (GCF), and the New Development Bank (NDB) signed Joint financial partnership Declarations.

✓ The International Energy Agency (IEA) also signed a Joint partnership Declaration with the ISA.

✓ The objective of the agreements is to deepen their cooperation in support of Renewable Energy.

8. IREDA & EIB sign Loan Agreement for Renewable Energy Financing in India

European Investment Bank (EIB) and Indian Renewable Energy Development Agency (IREDA) Ltd. have signed a loan agreement for a second line of credit (LoC) of Euro 150 million on non-sovereign basis.

- ✓ The line of credit is for tenure of 15 years including a grace period of 3 years, and it will be used for financing Renewable Energy and Energy Efficiency projects in India.
- ✓ More than 1.1 million households are expected to benefit from clean energy produced with these funds.

9. KVGB rolls out loan scheme for women entrepreneurs

Karnataka Vikas Grameena Bank (KVGB) has launched 'Vikas She Plus', a loan scheme for women to take up new ventures or for expanding/modifying the existing enterprises.

- ✓ This scheme provides loan up to a maximum of Rs 2 lakh with a repayment period of 60 months.
- ✓ The bank has disbursed loans amounting to Rs 22 crore to about 2,500 women beneficiaries on the day of launch itself.

10. Passport details must for loans of Rs 50 cr and above

Passport details of borrowers taking loans of Rs 50 crore and more have been made mandatory to ensure a swift action in case of fraud and prevent fraudsters from fleeing the country.

✓ Passport details will help banks to take timely action and inform the relevant authorities to prevent fraudsters from fleeing the country.

11. RBI discontinues Letter of Undertaking, Letter of Comfort

In view of the alleged Rs 12,700-crore Punjab National Bank (PNB) scam, done through fraudulent issuance of Letter of Understanding (LoUs) by connivance of the bank's staff, the Reserve Bank of India (RBI) has discontinued issuance of LoUs by banks for trade credits for imports into India.

✓ The RBI notification further said that Letters of Credit and Bank Guarantees for trade credits for imports into India may continue to be issued subject to compliance with the provisions.

12. World Bank projects India's FY19 GDP growth at 7.3 per cent

The World Bank has projected India's GDP growth at 7.3 per cent for the next financial year and accelerate further to 7.5 per cent in 2019-20.

✓ The World Bank's biannual publication, India Development Update: India's Growth Story, expects the economy to clock a growth rate of 6.7 per cent in the current fiscal ending March 31.

13. India's GDP growth rises to 7.2% in December quarter

India regained the status of the world's fastest-growing major economy in the October-December quarter, driven by a pick-up in growth in manufacturing and services sectors.

- ✓ Gross domestic product or GDP grew 7.2 per cent in the October-December quarter.
- ✓ This is the highest quarterly growth recorded since July-September quarter of 2016-17.
- ✓ China had recorded a growth of 6.8 per cent in the December quarter.

14. Cabinet approves Establishment of National Financial Reporting Authority

The Union Cabinet chaired by the Prime Minister Shri Narendra Modi has approved the proposal for establishment of National Financial Reporting Authority (NFRA) and creation of one post of Chairperson, three posts of full-time Members and one post of Secretary for NFRA.

- ✓ The decision aims at establishment of NFRA as an independent regulator for the auditing profession which is one of the key changes brought in by the Companies Act, 2013.
- ✓ The inclusion of the provision in the Act was on the specific recommendations of the Standing Committee on Finance (in its 21st report).

15. EESL to install energy-efficient LEDs across all airports in India

Energy Efficiency Services Limited (EESL signed a Memorandum of Understanding (MoU) with the Airports Authority of India (AAI) for

installing energy-efficient LED lights at airports, buildings and facilities owned by AAI across India.

- ✓ EESL will make the entire upfront investment of Rs. 24.41 crore on the project.
- ✓ The MoU is signed under the Buildings Energy Efficiency Programme (BEEP).

16. RBI lifts per-borrower loan cap for MSMEs

In view of the increasing importance of the services sector and to encourage banks to lend more to this sector, the Reserve Bank of India has decided to lift per borrower loan limits to Micro/Small and Medium Enterprises (Services).

- ✓ So far, loans to Micro/ Small and Medium Enterprises (Services) up to Rs 5 crore and Rs 10 crore, respectively, were classified as priority sector lending (PSL).
- ✓ Now all bank loans to MSMEs will qualify under priority sector without any credit cap.

17. Paytm emerges largest UPI transaction platform

Paytm has said it is the largest contributor to the overall volume of UPI transactions in February 2018.

- ✓ In a statement, Paytm said it had registered 6.8 crore UPI transactions in February.
- ✓ In December 2017, Paytm contributed 3.3 crore to the overall transaction volume for UPI.

18. RBI slaps Rs 3 cr penalty on Axis Bank, 2 cr on IOB

The Reserve Bank said it has imposed a penalty of Rs 3 crore on Axis Bank for violation of NPA classification norms, and Rs 2 crore on Indian Overseas Bank for not complying with the KYC regulations.

- ✓ The RBI has imposed, a monetary penalty of Rs 3 crore on Axis Bank Limited for noncompliance with the directions issued by RBI on Income Recognition and Asset Classification (IRAC) norms," it said.
- ✓ Regarding the state-owned Indian Overseas Bank, the regulator said in a separate release that a "fraud was detected" in one of the branches of the bank.

19. ISRO-BHEL Tie up for the Production of Space Grade Lithium-Ion Cells

ISRO has entered into a Technology Transfer Agreement (TTA) with Bharat Heavy Electricals Limited (BHEL), which is one of the country's leading PSUs, to transfer the technology for the manufacture of space grade Li-Ion cells.

- ✓ The TTA was signed at ISRO Headquarters, Bengaluru in the presence of Dr. K. Sivan, Chairman, ISRO and Mr. Atul Sobti, Chairman & Managing Director, BHEL.
- ✓ ISRO uses Li-Ion batteries as power sources for satellite and launch vehicle applications due to their high energy density, reliability and long cycle life.

20. Equitas Bank ties up with CSK

Equitas Small Finance Bank has launched a new 'Yellow Army Savings Account' to increase its customer base through its association with the Chennai Super Kings (CSK), a franchise of the Indian Premium League (IPL).

- ✓ The yellow army savings account will offer an interest rate of six per cent per annum for balance below Rs.10 lakh and 6.5 per cent per annum for balance above Rs.10 lakh.
- ✓ The average quarterly balance requirement will be Rs.10,000 per account.

26. RBI imposes Rs 59 cr penalty on ICICI Bank

27. Fino Payments Bank to deploy mPoS devices across 10,000 banking points

Fino Payments Bank has said it plans to deploy multi-utility Android-based mPoS (mobile point-of-sale) devices across 10,000 banking points in the country in a phased manner.

- ✓ The mPoS is a portable device with an in-built fingerprint scanner, card reader, camera, printer and a tablet, the payments bank said.
- ✓ The device will gradually replace the combination of devices currently used to facilitate fingerprint authentication and digital transactions.

- ✓ The two medals took India's medal tally to six a gold, a silver, and four bronze medals.

The Indian combine of Pankaj Advani and Manan Chandra staged a remarkable recovery to beat Pakistan in the final of the inaugural IBSF Snooker Team World Cup.

✓ After being 0-2 down in the best-of-five final, India found themselves in a deeper hole at 0-30 down in the third frame, but won the next three sets to win the game.

8. Shooter Rizvi wins World Cup gold

Indian shooter Shahzar Rizvi created a new world record on his way to the gold medal in the men's 10m air pistol event at the ISSF World Cup.

- ✓ The Indian beat reigning Olympic champion Christian Reitz of Germany, who had to settle for the silver.
- ✓ India's Jitu Rai bagged the bronze with 219.

Star shuttler P V Sindhu has been named the flag-bearer of the Indian contingent for the opening ceremony of the Commonwealth Games in Gold Coast next month.

- ✓ The opening ceremony will be held on April 4.
- ✓ Having won a silver medal at the Rio Olympics two years ago, the Hyderabad-based World No. Sindhu is one of the favourites to win the badminton women's singles title in Gold Coast.
- ✓ In the last Commonwealth Games in Glasgow in 2014, Sindhu bagged a bronze in women's singles.

12. Shooter Manu wins gold at Junior World Cup
