

Oscars awards 2023

On March 12, 2023, the 95th Academy Awards 2023/Oscars 2023 held at Dolby Theatre at Ovation Hollywood in Los Angeles, United States.It has honoured movies released in 2022 in 23 categories. The ceremony for the same was held by the US' Academy of Motion Picture Arts and Sciences (AMPAS).

- ✓ The ceremony was hosted by American Television host Jimmy Kimmel (James Christian Kimmel) for the 3rd time, who previously hosted the Oscars in 2017 and 2018.
- ✓ Indian Actress Deepika Padukone was one of the presenters at Oscars 2023.She is the third Indian ever to present an Oscar after Persis Khambatta in 1980 and Priyanka Chopra in 2016.
- ✓ American Film 'Everything Everywhere All at Once' was the 2023's most-nominated film, with 11 total nominations. It was followed by All Quiet on the Western Front and The Banshees of Inisherin with 9 nominations each.
- ✓ The sci-fi film 'Everything Everywhere All at Once' won 7 awards out of 11 nominations. The film won the Best Picture, Best Actress, Best Supporting Actor, Best Supporting Actress and

Best Director awards apart from other technical nods for Original Screenplay and Editing.

- ✓ It's became the most-awarded best-picture winner since Danny Boyle's "Slumdog Millionaire" at the 2009 Oscars.
- ✓ Michelle Yeoh from Malaysia won the Oscar 2023 for Best Actress in Leading Role category for her role in the movie 'Everything Everywhere All at Once'. She became the first Asian actress to win in the category.
- ✓ Oscars 2023 witnessed the replacement of the red carpet with a champagne-coloured one, breaking a 62 year record.

About Academy Awards/Oscars:

- ✓ This Awarded annually by the US' AMPAS, these awards acknowledges artistic and technical merit for the global film industry. The winners are awarded a copy of a golden statuette as a trophy, officially called the "Academy Award of Merit".
- ✓ The 1st Academy Awards were held in 1929.
- ✓ The person with the most Oscars ever is Walt Disney, who took home 26 in his lifetime.
- ✓ The most awarded woman in Oscar history is American costume designer Edith Head, who won 8 Academy Awards.

India's Wins at Oscars 2023 RRR

✓ The song Naatu Naatu from Telugu film RRR (Rise, Roar, Revolt) directed by S. S. Rajamouli

has maden history by becoming the first Indian film song to win an Oscar. It won Best Original Song at the 95th Academy Awards 2023.



- ✓ The song is composed by the music director M.M. Keeravani. Its lyrics were written by Chandrabose
- ✓ It is sung by Kaala Bhairava and Rahul Sipligunj while the dance scene was choreographed by Prem Rakshith.

The Elephant Whisperers

✓ The Elephant Whisperers became the first Indian



film to win an Oscar in the 'Best Documentary Short film' category. It was produced by Guneet Monga and directed by Kartiki Gonsalves.

✓ The plot of documentary revolves around a family who

adopts two orphan baby elephants in Tamil Nadu's Mudumalai Tiger Reserve.

List of Indians who won the Oscars

1. Bhanu Athaiya - Best Costume Design

✓ At the 55th Academy Awards, Bhanu Athaiya became the first Indian to win an Academy Award for designing the costumes. Ravi Shankar was nominated for Best Original Score for the same



film.She won an Academy Award for "Best Costume Design" for her work in the movie Gandhi (1982).

2. Satyajit Ray - Honorary Award

 \checkmark He is considered one of the finest directors of



Indian and Bengali cinema, and his legacy remains even today. At the 64th Academy Awards, in 1992, the Academy of Motion

Picture Arts and Sciences awarded Ray an Honorary Oscar for Lifetime Achievement. He could not attend the ceremony personally because of his ill health. His video message was shown at the ceremony in the Dolby Theatre.

3. Resul Pookutty - Best Sound Mixing

He is an Indian film sound designer, sound editor, and audio mixer. He received an Oscar for his work in the Oscar-winning film Slumdog Millionaire at the 81st Academy Awards in 2009. He won the award along with Ian Tapp and Richard Pryke.

4. A R Rahman - Best Original Score and Best Original Song

✓ In 2009, Indian composer A.R. Rahman's 'Jai Ho'

won the Oscars for original song as well as for the Original Score in Danny Boyle's U.K. production 'Slumdog Millionaire'.



5. Gulzar- Best Original Song

✓ Gulzar Sahab, a famous personality who also needs no introduction, is an Indian poet, lyricist, author, screenwriter, and film director. At the 81st Academy Awards, he won an Oscar for "Best Original Song" for "Jai Ho."

Egypt joins BRICS bank as new member

✓ After President Abdel-Fattah El-Sisi visited India as a chief guest for the Republic Day celebrations,

Egypt has become a member of the BRICS New Development Bank (NDB).



- ✓ The African-Arab nation intends to enhance its infrastructure, and NDB funding can make a significant contribution toward achieving this goal.
- ✓ Following President El-Sisi's visit to India for the Republic Day celebrations, the Egyptian Parliament approved the agreement that permitted Egypt to join the NDB. The lawmakers welcomed the move, recognizing it as a means of reducing the need for US dollars.
- ✓ The upcoming BRICS Summit, scheduled to be hosted by South Africa in August, is anticipated to promote intra-BRICS trade using national currencies, allowing member nations to safeguard their foreign exchange reserves.

About BRICS New Development Bank (NDB)

- ✓ It is a multilateral development bank jointly founded by the BRICS countries(Brazil, Russia, India, China and South Africa) at the 6th BRICS Summit in Fortaleza, Brazil in 2014.
- ✓ It was formed to support infrastructure and sustainable development efforts in BRICS and other underserved, emerging economies for faster development through innovation and cutting-edge technology.
- ✓ It is headquartered at Shanghai, China.

✓ In 2018, the NDB received observer status in the United Nations General Assembly, establishing a firm basis for active and fruitful cooperation with the UN. ✓ Bangladesh, the United Arab Emirates, and Uruguay joined the NDB in September 2021. Egypt was welcomed as a new member of the NDB in December 2021.

Bangladesh commissions its first submarine base 'BNS Sheikh Hasina'

✓ Prime Minister Sheikh Hasina inaugurated the first submarine base of Bangladesh 'BNS Sheikh

Hasina' at Pekua in Cox's Bazar. Hailing the newly inaugurated naval base as an 'ultra modern submarine



base', Prime Minister called the event a proud chapter in the history of Bangladesh navy.

- ✓ This is the first ever full-fledged submarine base of Bangladesh Navy. Built at a cost of \$1.21 billion.
- ✓ The base can accommodate a total of six submarines and eight warships at a time.
- ✓ It will allow for safe and swift movement of the submarines in case of emergency, as the base is located at the Bay of Bengal.
- ✓ The Government of Bangladesh signed an agreement with China in September 2019 for the construction of the submarine base.
- ✓ The government of Bangladesh is working on 'Forces Goal 2030' to transform its military force into a modern organization appropriate for the times.

India-Bangladesh Friendship Pipeline to be jointly inaugurated by PM Modi and Sheikh Hasina

✓ Prime Minister Narendra Modi, and his Bangladesh counterpart Sheikh Hasina, will inaugurate the India-Bangladesh Friendship Pipeline via video conference. It is first such pipeline through which refined diesel will be supplied to Bangladesh from India. The project is built under grant assistance from the government of India.

The project involves construction of 130-kilometre long pipeline that will connect Siliguri in West Bengal and Parbatipur in Dinajpur district of

82.50 km 35.50 km

 \checkmark Of the total stretch. sixkilometre will be in Indian side and remaining 124

kilometres will in Bangladesh. Indian leg of the pipeline project will be implemented by Assam-Numaligarh Refinery Limited based and Bangladeshi leg will be implemented by Bangladesh Petroleum Corporation.

- The pipeline has capacity of 1 million metric tons per annum. It will supply refined diesel will be supplied to Parbatipur depot from Numaligarh of Assam in India.
- Initially, it will supply Bangladesh 2.5 lakh tonnes of diesel every year and gradually it will be increased to 4 lakh tonnes.
- \checkmark The project will replace existing practice of sending diesel by rail covering distance of 510 kilometers. The estimated this pipeline project is Rs. 346 crore and it will be completed in 30 months' timeframe.

US recognized McMahon Line as international border

- \checkmark A bipartisan resolution was passed by the US, formally recognizing the McMahon Line as the international boundary between China and India's Arunachal Pradesh. The resolution rejected China's claim that the state belongs to its territory and instead acknowledged Arunachal Pradesh as an integral part of India. Furthermore, the resolution expressed support for India's sovereignty and territorial integrity.
- The resolution, titled 'Reaffirmation of Arunachal

Pradesh as Indian territory and condemnation of China's provocative activities in South



Asia', came after a major clash between the Indian and Chinese forces in Arunachal's Tawang in December last year.

Japan PM Fumio Kishida Visit to India

✓ On March 20-21, 2023, Fumio Kishida, Prime



India and held the 'Japan-India Summit 2023' Meeting with PM of India Narendra

Modi, to discuss ways to strengthen bilateral cooperation in a number of fields, including defence and security, trade and investment, and high technology.

- PM Fumio Kishida met with PM Narendra Modi at Hyderabad House in New Delhi, Delhi, to discuss priorities as Japan assumes the G7 (Group of Seven) presidency in 2023 and India holds the G20 (Group of Twenty) presidency in 2023.
- \checkmark This is Kishida's second visit to India as Japan's PM. The year 2022 commemorated the 70th anniversary of the diplomatic relations between India and Japan.
- \checkmark Japan's PM, Fumio Kishida, discussed the "Japan-India Special Strategic and Global Partnership" and efforts to realise a "Free and Open Indo-Pacific" (FOIP), with a focus on India's rising prominence in the Indian Ocean Region (IOR).
- He has held discussions with PM Modi in light of the upcoming G7 Summit in Hiroshima in May 2023 and the G20 Summit in New Delhi in September 2023.
- \checkmark The leaders of Japan and India, PM Fumio Kishida and PM Modi, reaffirmed their commitment to continuing their partnership through the 'Japan-India Act East Forum' in order to advance the development of India's northeastern region.
- \checkmark The two leaders reaffirmed their commitment to advancing bilateral cooperation under the "India-Japan Clean Energy Partnership," which was announced in 2022.
- \checkmark PM Modi further declared that the year 2023 will be celebrated as "Japan-India tourism exchange year" with the theme "Connecting the Himalayas with Mount Fuji".

- ✓ India & Japan Sign 2 MoU On Cooperation On Japanese Language & Bullet Train
- ✓ In conjunction with Japan's PM Fumio Kishida visit to India on March 20, 2023, two agreements were signed between India and Japan. They are as follows:
- ✓ Exchange of Notes concerning the FY2022 Yen Loan for the "Project for Construction of Mumbai-Ahmedabad High Speed Rail (IV)" [loan provision of up to 300 billion yen]
- ✓ India-Japan Memorandum of Cooperation (MoC) in the Field of Japanese Language Education in India.

ICC issues arrest warrant for Vladimir Putin over Ukraine war crimes

✓ The International Criminal Court (ICC) issued an arrest warrant for Russian President Vladimir Putin over the forced transfer of children to Russia after

the Kremlin's invasion of Ukraine. Ukrainians accuse Russia of attempting genocide against them and seeking



to destroy their identity — partly through deporting children to Russia.

- ✓ The ICC issued the warrant for Putin's arrest on suspicion of unlawful deportation of children and unlawful transfer of people from the territory of Ukraine to the Russian Federation.
- ✓ This is the first time the ICC has issued warrants in relation to Russia's full-scale invasion of Ukraine, which began last February.
- ✓ Moscow has previously said it did not recognize the court's authority.

Indonesia's Mount Merapi volcano erupted

✓ Mount Merapi, one of the world's most active volcanoes, erupted, spewing out smoke and ash that covered villages near the crater. There were no immediate reports of casualties, the the National Disaster Mitigation Agency said. The images broadcasted shows ash-covered houses and roads at a village near the volcano, in Yogyakarta.

- ✓ The Merapi Volcano Observatory estimated the ash cloud reached 9,600 feet (3,000 metres) above the summit.
- ✓ Authorities established a restricted zone of seven kilometres from the crater after the eruption, which was recorded at 12:12 pm (0512 GMT).
- ✓ The volcano's last major eruption in 2010 killed more than 300 people and forced the evacuation of some 280,000 residents. It was Merapi's most powerful eruption since 1930, when about 1,300 people were killed. An eruption in 1994 left about 60 people dead. The volcano's alert status has remained at the second-highest level since 2020 after showing renewed activity.

5th ASEAN-India Business Summit 2023

- ✓ The 5th Asean-India Business Summit took place on 6 March 2023 in Kuala Lumpur. Speakers and participants from Asean and India convened to discuss how business linkages, connectivity and supply chain resilience can be enhanced through deeper ASEAN-India cooperation. The Minister of State for Electronics & Information Technology addresses the 5th ASEAN-India Business summit.
- ✓ <u>About the ASEAN-India Business summit</u>: It is being held as part of the ASEAN-India Year of Friendship to commemorate the more than threedecade-long engagement between India and the 10member bloc in Kuala Lumpur.

China spent \$240 billion bailing out 'Belt & Road' countries

- ✓ A recent study conducted by researchers from the World Bank, Harvard Kennedy School, AidData, and the Kiel Institute for the World Economy has revealed that China spent approximately \$240 billion from 2008 to 2021 bailing out 22 developing countries that had difficulty repaying loans taken for Belt and Road infrastructure projects.
- ✓ A recently published study shows that from 2008 to 2021, China provided approximately \$240 billion to bail out 22 developing nations that encountered challenges in paying back loans obtained for the Belt and Road infrastructure projects

NATIONAL

Gol Launches NRCP for Prevention and Control of Rabies

- ✓ The Government of India (GoI) launched the National Rabies Control Programme (NRCP) for rabies prevention and control, and the National Centre for Disease Control (NCDC), Ministry of Health and Family Welfare (MoHFW), released the NRCP strategies, which are as follows:
- ✓ Provision of rabies vaccine & rabies immunoglobulin through national free drug initiatives.
- ✓ Training on appropriate animal bite management, prevention and control of rabies, surveillance and intersectoral coordination.
- ✓ Strengthening surveillance of animal bites and rabies deaths reporting.
- ✓ Creating awareness about rabies prevention.

PM Modi inaugurated new ITU Area Office & Innovation Centre in New Delhi

- ✓ On 22 March 2023, the Prime Minister(PM) Narendra Modi inaugurated India's new International Telecommunication Union (ITU) Area office and Innovation Centre at a programme in Vigyan Bhawan, in New Delhi, Delhi.
- ✓ ITU which is headquartered in Geneva, Switzerland has a network of field offices, regional Offices and area offices. It was founded in 1865 as International Telegraph Union, the ITU is the oldest existing international organisation.
- ✓ Other initiatives: PM also launched the 6G R&D Test Bed and the 'Call before u Dig' App.
 <u>6G R&D Test Bed:</u>The PM unveiled the Bharat 6G Vision Document and launched the 6G R&D Test Bed.
- ✓ Bharat 6G vision document is prepared by the Technology Innovation Group on 6G (TIG-6G) that was constituted in November 2021.
- ✓ <u>CBuD App</u>: The Call Before You Dig (CBuD) app is a tool created to prevent the damage to underlying assets like optical fiber cables.

- ✓ Due to uncoordinated digging and excavation, the optical fiber cables are getting damaged leading to loss of about Rs 3000 crore every year.
- ✓ The app will save potential business loss and minimize discomfort to the citizens due to reduced disruption in essential services like road, telecom, water, gas and electricity.

Finance Secretary T V Somanathan to Head Panel on Pension Schemes

- \checkmark The Government of India has decided to form a
- committee led by Finance Secretary TV Somanathan to recommend ways to reform the National Pension System (NPS) for government employees.



- ✓ The action is being taken against a backdrop of a number of states abandoning the NPS and returning to the Old Pension Scheme (OPS) for their employees.
- ✓ The GoI has been allowing states to enhance their borrowing limits by an amount equal to what they contribute each year to new NPS accounts for their state government employees. This implies that states that return to the OPS will not obtain as much additional borrowing capacity.

Govt allows import of urea through India potash till March 2024

- ✓ According to the Directorate General of Foreign Trade (DGFT), the import of urea (agricultural grade) on the Government account has extended the tenure of Indian Potash Limited (IPL) until 31st March 2024.
- ✓ Earlier, the import of urea was supposed to be allowed till March 2023. As per the notification, which was issued on 22 March 2023, India will not need to import food for the upcoming season because supply would be greater than demand in the Kharif season due to larger stock positions.
- ✓ Government fertilizer companies Rashtriya Chemicals and Fertilizers Limited and National

Fertilizers Limited are 2 other canalising agencies that import urea on government account.

Union Minister Rajeev Chandrasekhar launches Skill Hub Portal

- ✓ On 24th March 2023, Rajeev Chandrasekhar, Union Minister of State (MoS) for Skill Development and Entrepreneurship, launched the Skill Hub portal in Bengaluru, Karnataka, as part of the Government's initiatives to deliver industry-ready employable skills to young Indians in all region of India.
- ✓ Skill Hub portal is an initiative by National Skill Development Corporation (NSDC).
- ✓ The portal ensures that students all throughout India have easy access to skill training by inviting all colleges and universities to join the Skill India Network.

Union Minister Sarbananda Sonowal inaugurates 'Sagar Manthan', Dashboard

- ✓ On March 23, 2023, the Union Minister Sarbananda Sonowal, Ministry of Ports, Shipping and Waterways (MoPSW) virtually launched 'Sagar Manthan', a Real-time Performance Monitoring Dashboard of MoPSW, in New Delhi, Delhi.
- ✓ Sagar Manthan is a digital platform that contains all the integrated data related to the Ministry and other subsidiaries. This dashboard will transform the workings of various departments by improving well-coordinated real-time information.
- ✓ This platform has been developed completely inhouse under the guidance of Sudhanshu Pant, IAS, Secretary, MoPSW in the span of less than 1.5 months efficiently.

Narendra Singh Tomar Launched NCIP's DigiClaim Module for Fast Settlement of Crop Insurance Claims

✓ On March 23, 2023, the Union Minister Narendra Singh Tomar, Ministry of Agriculture & Farmers Welfare (MoA&FW), launched the National Crop Insurance Portal's (NCIP) digitized claim settlement module namely 'DigiClaim' under the ambit of Pradhan Mantri Fasal Bima Yojana (PMFBY) at Krishi Bhawan, New Delhi, Delhi for fast settlement of crop insurance claims.

- ✓ Currently several instances of insured farmers' claims are being delayed, thus the launch of DigiClaim Module will be useful for the farmers of six states as it will speed up the claim disbursal process of valid crop loss claims, and process the claims directly to their respective bank accounts in a transparent and accountable manner.
- ✓ After the launch of the DigiClaim module, on the same day, the insurance claims totaling Rs 1260.35 crore have been disbursed to insured farmers in the states of Rajasthan, Uttar Pradesh, Himachal Pradesh, Chhattisgarh, Uttarakhand and Haryana at once quickly.

Ministry of environment, forest and climate change launched Aravalli Green Wall Project

- ✓ Aravalli Green Wall Project is inspired by Africa's Great Green Wall (GGW) programme, an initiative launched in 2007 in Sahel region bordering Africa's Sahara Desert, to combat desertification and land degradation.
- ✓ GGW project aims to restore 100 million hectares of degraded land by 2030.
- ✓ Green Wall Project is a major initiative to create green corridors in 5 km buffer area around Aravalli Hill Range in four states - Haryana, Rajasthan, Gujarat and Delhi.
- ✓ It'll involve planting native species of trees and shrubs on scrubland, wasteland and degraded forest land, along with rejuvenating and restoring surface water- bodies such as ponds, lakes and streams.

Objectives of Aravalli Green Wall Project

- ✓ Improving ecological health of Aravalli range. Prevent eastward expansion of Thar Desert and reduce land degradation.
- ✓ Enhancing India's image as a global leader in environmental protection and green development.
- ✓ Promote sustainable development and livelihood opportunities by involving local communities.

Centre to reduce 'Disturbed Areas' tag under AFSPA from many northeast districts

- ✓ Starting from Ministry of Home Affairs has decided to further decrease the jurisdiction of "disturbed areas" under Armed Forces (Special Powers) Act (AFSPA), 1958 in Nagaland, Assam and Manipur
- ✓ Earlier, AFSPA was completely withdrawn from Meghalaya in 2018, Tripura in 2015 and Mizoram in 1980s.
- Currently, AFSPA is in effect in Nagaland, Assam, Manipur and parts of Arunachal Pradesh.
- ✓ AFSPA grants special powers to armed forces to maintain public order in "disturbed areas". Disturbed areas are declared under Section 3 of AFSPA Act, 1958 when a part or whole state/UT is in such a condition that the use of armed forces in aid of civil power is necessary.
- ✓ Disturbed areas are declared by Governor of state or administrator of Union Territory or by Central government. Under section 4 of Act, Armed forces can fire upon or arrest anyone who is acting against law & order in disturbed area after giving warning. Section 6 of the Act gives legal immunity to persons acting under Act.

PM Modi addresses One World Tb Summit held in Varanasi, UP

✓ One World TB Summit held in varanasi.It was organised by Ministry of Health and Family Welfare (MoHFW) and Stop TB Partnership.

- While addressing One World TB Summit, PM has launched a range of initiatives to eradicate TB on occasion of World TB Day (24 March).
 Initiatives launched includes
- ✓ TB-Mukt Panchayat initiative (representatives to take a resolution that not a single TB patient will be there in the village).
- ✓ Official pan-India rollout of shorter TB Preventive Treatment (TPT).
- ✓ Release of annual TB report titled "Leading the way India TB report 2023".
- ✓ Key findings of Report
- ✓ 24.2 lakh cases were recorded in 2022; an increase of 13% as compared to 2021.
- ✓ By end of 2022, 94% districts of India expanded TPT.
- ✓ Approximately Rs 2000 crores have been directly transferred to about 71 lakh persons affected under Ni-kshay Poshan Yojana (NPY).
- ✓ TB is caused by Mycobacterium tuberculosis, which most commonly affects lungs.
- ✓ It is transmitted from person to person through air. It is treatable and curable disease.
- ✓ Most common medications used to treat TB include isoniazid, rifampin, ethambutol, pyrazinamide etc.
- ✓ Currently, Bacille Calmette-Guerin (BCG) is the only vaccine against tuberculosis.

India aims at becoming 'Global Hub for Green Ship' building by 2030

- ✓ India is aiming to become a leader in the global shipbuilding industry by launching the Green Tug Transition Programme (GTTP) and setting a goal of becoming a 'Global Hub for Green Ship' building by 2030.
- ✓ The GTTP will start with the production of Green Hybrid Tugs, which will run on Green Hybrid Propulsion systems, and eventually switch to alternative fuel sources like Methanol, Ammonia, and Hydrogen.
- ✓ Union Minister of Ports, Shipping & Waterways (MoPSW) and Ayush, Shri Sarbananda SonowaI has inauguarted the National Centre of Excellence in Green Port & Shipping (NCoEGPS) set-up in Gurugram, Haryana, and the Green Tugs will begin

- ✓ Government, Ministry of Textiles, has issued a notification to set up 7 Pradhan Mantri Mega Integrated Textile Region and Apparel (PM MITRA) Parks with a total outlay of Rs. 4,445 crore.
- ✓ Seven sites were chosen out of 18 proposals for PM MITRA parks which were received from 13 States.
- The Parks will come up in Tamil Nadu, Telangana, Gujarat, Karnataka, Madhya Pradesh, Uttar Pradesh and Maharashtra.
- ✓ These Parks will offer an opportunity to create an integrated textiles value chain right from spinning, weaving, processing/dyeing and printing to garment manufacturing at 1 location.
- ✓ Integrated Textile Value chain at 1 location will reduce logistics cost of Industry.

About PM MITRA Scheme:

✓ It will offer the opportunity to create an Integrated Textiles Value Chain right from spinning, weaving, processing/dyeing and printing to garment manufacturing etc. at one location and will reduce the logistics cost of the Industry.

✓ A Special Purpose Vehicle owned by the Centre and State Government will be set up for each park which will oversee the implementation of the project.

Indian Railways to become Net Zero Carbon Emitter by 2030

- ✓ Indian Railways has set a target of becoming a 'netzero carbon emitter' by 2030, said Union Railways Minister Ashwini Vaishnaw in a written reply to the Lok Sabha. The Railways plans to achieve this ambitious target in two steps: A complete transition to electric trains by December 2023 and powering the trains and stations primarily through nonrenewable sources by 2030
- By 2030, the total energy requirement of the Railways is expected to increase to 8,200 MW, or 8.2 GW. A small portion of the projected energy requirement 700 MW or 8.5 per cent of the total energy demand will still be sourced from non-renewable sources because of the current power purchase agreements with coal plants, says the official. The lion's share 91.5 per cent will be met through renewable sources.
- ✓ The move will help India meet its nationally determined contribution of reducing its carbon emissions by 33 per cent by 2030, as transport is a key sector with substantial mitigation potential.

Atal Innovation Mission launches ATL Sarthi

- The objective of Aahar 2023, which was put \checkmark together with the help of the Union Ministry of Food Processing Industries, the Agriculture and Processed Food Products Export Development Authority (APEDA), and other organizations, is to showcase the hospitality industry's potential and showcase technologies, goods, and services to both domestic and foreign consumers.

India's bullet train to run by August 2026

- \checkmark According to railways and telecom minister Ashwini Vaishnaw, the first bullet train in India will begin service in August 2026. The project will stimulate the economy because several of the suppliers to the project have begun receiving export orders. The government intends to start operating the first bullet train in August 2026. The goal is to run the bullet train on a larger section in 2027.
- \checkmark The Indian Railways is building the country's first bullet train from Ahmedabad, Gujarat to Mumbai, over 508-kilometer route. The high-speed train will run at top speed of 350 kms per hour, covering the distance in three hours.

PM Modi inaugurates world's longest railway platform in Hubballi

✓ Prime Minister Narendra Modi dedicated World`s longest railway platform of 1.5 kilometres at Sri Siddhaarooda railway station in Hubballi in the state of Karnataka. The inauguration of the platform was done during the PM's Karnataka visit in the presence of Union Minister Pralhad Joshi. It is to be noted that Indian Railways, South Western Railway Zones Hubbali is now registered in the Guinness Book of World Records for having the longest platform.

Gorakhpur platform in Uttar Pradesh is the second longest at 1.366.33 meters, and Kollam Junction in Kerala has the third longest platform at 1,180.5 meters.

Bengaluru-Mysuru expressway

- Meanwhile, Prime Minister Narendra Modi also inaugurated the 118-km long Bengaluru-Mysuru expressway. This new project is expected to aid the social and economic growth in the region.

- The first methanol-powered buses in Bengaluru will be unveiled by Union Minister for Road and Transport, Nitin Gadkari. The Bengaluru Metropolitan Transport Corporation (BMTC), NITI Aayog, Indian Oil Company (IOC), and Ashok Leyland are working together to carry out the

The U20 is convened by C40 Cities (C40) and United Cities and Local Governments (UCLG) under the leadership of a rotating Chair city based in the G20 host country.

 \checkmark The Y20 is the official youth engagement group for the G20, which is a forum for the largest and most advanced economies in the world. The Y20 process aims to bring together young leaders from all over the world to discuss and debate global challenges and propose policy recommendations that G20 leaders can implement. These policy recommendations are compiled in a communiqué, which is publicly announced at the Y20 Summit and presented to world leaders as part of the official G20 summit. India recently hosted the Y20 summit for the first time and its key focus was to bring young leaders together from across the globe to discuss ideas and draft an agenda for action.

- ✓ This year's edition of Raisina Dialogue assumes special significance coming against the backdrop of India's G20 Presidency.

World's first' bamboo crash barrier installed on Maharashtra highway

The world's first 200-metre-long bamboo crash barrier has been installed on a highway connecting Chandrapur and Yavatmal districts in Maharashtra. Named 'Bahu Balli', the bamboo crash barrier underwent "rigorous testing" at various government-run institutions like the National Automotive Test Tracks (NATRAX) in Pithampur, Indore. This was rated as Class 1 during the Fire Rating Test conducted at the Central Building Research Institute (CBRI) in Roorkee and it has also been accredited by the Indian Road Congress, According to Nitin Gadkari-led Ministry of Road Transport and Highways.

President Droupadi Murmu inaugurated Unnathi Programme

- ✓ Recently, the President inaugurated the silver jubilee celebration of 'Kudumbashree' - one of the largest women's self-help networks in the world and launched 'Unnathi' – an umbrella programme to create opportunities for employment and selfemployment, among the youth belonging to SC and ST communities.
- Kudumbashree was launched in Kerala in 1998 as a joint programme of the Government of Kerala and NABARD to wipe out absolute poverty through community action. It is the largest women empowering project in the country. It has three components i.e., microcredit, entrepreneurship and empowerment. It has three tier structure neighborhood groups (SHG), area development society (15-20 SHGs) and Community development society (federation of all groups).

STATES

Rajasthan became India's 1st state to guarantee right to health

- ✓ On March 21, 2023 Prasadi Lal Meena, Minister of Medical & Health, announced that the Rajasthan Assembly had cleared a bill named 'Right to Health' (which was passed in September 2022), becoming the first state in India to do so.
- ✓ The 'Right to Health', gives every resident of the state the right to avail free Out Patient Department (OPD) services and In Patient Department (IPD) services at all public health facilities.
- It also provides similar healthcare services (free of cost) at select private facilities.
- ✓ All residents of the state will be entitled to emergency treatment and care for accidental emergency without prepayment of any fee or charges.
- ✓ As per the bill, free healthcare services, including consultation, drugs, diagnostics, emergency transport,procedure and emergency care, will be provided at all public health institutions and select private facilities subject to conditions specified in the rules.

NGT slaps ₹10 crore penalty on Kerala government for failure to protect Ramsar sites

- ✓ The Kerala government has been fined Rs 10 crore by the Principal Bench of the National Green Tribunal (NGT) for their inability to prevent the uncontrolled pollution of the designated Ramsar sites.
- ✓ The order by NGT was made in lines with a petition alleging failure of statutory and administrative authorities in taking remedial action for protection of the Vembanad and Ashtamudi lakes hit by illegal waste dumping.

About Vembanad Lake

- ✓ This is the largest lake in Kerala and the longest Lake in India.
- ✓ The lake has its source in four rivers, Meenachil, Achankovil, Pampa and Manimala

- In 2002, it was included in the list of wetlands of international importance, as defined by the Ramsar Convention.
- ✓ It is the second-largest Ramsar site in India only after the Sundarbans in West Bengal.
- ✓ The Kumarakom Bird Sanctuary is located on the east coast of the lake.
- ✓ In 2019, Willingdon Island, a seaport located in the city of Kochi, was carved out of Vembanad Lake

TamilNadu's18thWildlifeSanctuary Opens in Erode

- The government of Tamil Nadu has decided to declare Thanthai Periyar Wildlife Sanctuary as the 18th wildlife sanctuary in the state. This sanctuary covers an area of 80,567 hectares in the forest regions of Anthiyur and Gobichettipalayam taluks in Erode district, and includes reserve forest areas in Anthiyur, Bargur, Thattakarai, and Chennampatti. It is home to a variety of wild animals such as tigers, elephants, leopards, wild boars, gaurs, and deer.
- ✓ This wildlife sanctuary is located in close proximity to other sanctuaries such as Malai Mahadeshwara wildlife sanctuary, BRT Wildlife Sanctuary, Cauvery wildlife sanctuary in Karnataka, and it serves as a connecting point between Nilgiris Biosphere Reserve and Cauvery South Wildlife Sanctuary. This announcement was made during the state budget.

Asia's largest 4-metre liquid mirror telescope inaugurated in Uttarakhand

✓ Dr. Jitendra Singh, the Union Minister of State (Independent Charge) for Science & Technology,

inaugurated Asia's largest 4-metre International Liquid Mirror Telescope at Devasthal, Uttarakhand,



in the presence of Lt. Gen (Retd.) Gurmeet Singh, the Governor of Uttarakhand.

✓ The Aryabhatta Research Institute of Observational Sciences (ARIES) has declared that the 4-meter International Liquid Mirror Telescope (ILMT) is operational and can now be used to observe the deep celestial sky. The telescope recorded its first light in the second week of May 2022 and is located on the Devasthal Observatory campus of ARIES in the Nainital district of Uttarakhand. ARIES is an independent institute under the Department of Science and Technology (DST) of the Indian Government, situated at an altitude of 2450 meters.

Rajasthan CM announced 19 new districts and three new divisions

- ✓ On 17 March 2023, Chief Minister Ashok Gehlot announced the creation of 19 new districts and 3 new divisions in the state during his course of the discussion on the Finance and Appropriation Bill in the Legislative Assembly. Rajasthan will now have 19 new districts and 3 new divisions, taking the number of districts to 50 and divisions to 10.
- Rajasthan now has the third highest number of districts in the country after Uttar Pradesh (71) and Madhya Pradesh (53).

Amitesh Kumar, the Nagpur City commissioner of police, announced that notification 144 CrPC has been issued in this regard. The social welfare division of the Nagpur Municipal Corporation (NMC) and the Nagpur City Police are partners in this effort. In order to accommodate homeless people in its shelters, the NMC has developed particular provisions.
- ✓ This will be severely enforced by the Nagpur police, and begging is not permitted in public areas. The social welfare division of the Nagpur

Municipal Corporation (NMC) and the Nagpur City Police are partners in this effort.

✓ In order to accommodate homeless people in its shelters, the NMC has developed particular provisions. The civic organisation has a bus and an ambulance on standby to transport beggars apprehended by police to its shelter residence.

'Kashi' declared as 1st Tourism & Cultural Capital of SCO

- ✓ 'Kashi' has been declared the First Tourism & Cultural Capital of the Shanghai Cooperation Organization (SCO) at the Meeting of Heads of SCO Tourism Administrations held in Kashi, Varanasi, Uttar Pradesh.
- ✓ The action plan for "Year of Tourism Development in the SCO Space in 2023" was also adopted at the meeting.
- ✓ The next meeting of the SCO Heads of Tourism Administrations was scheduled to be held in Kazakhstan in 2024.

Andhra Pradesh FM presented Budget of Rs 2,79,279cr for FY24

✓ The Finance minister of Andhra Pradesh (AP)

Buggana Rajendranath presented the annual budget for the financial year 2023-2024(FY24) with a financial outlay of



Rs. 2,79,279 crore in the state Assembly in Amaravati, AP. He presented the annual Budget for the 5th time in a row.

- ✓ The fiscal deficit would be 3.77% of Gross State Domestic Product (GSDP), while the revenue deficit would be 1.54% of GSDP.
- ✓ Rs 54,228 crore has been allocated for Direct Benefit Schemes (DBT), an 11% increase from the previous year's Rs 48,668 crore. A total of 22 schemes are covered under the DBT category and the majority of them saw an increase in the budget allocation.
- ✓ Rs 500 crore is assigned for interest free loans to farmers and YSR Rythu Barosa was given Rs 4,020 crore

Resham Keet Bima: India's 1st silkworm insurance scheme launched in Uttarakhand

- ✓ Ganesh Joshi, Agriculture Minister of Uttarakhand, launched 'Resham Keet Bima' scheme, India's first programme to safeguard sericulturists. With this launch, Uttarakhand became the first Indian state to launch a Silkworm Insurance Scheme under which crop insurance will be provided to all farmers cultivating silkworms to produce silk.
- ✓ This insurance will save the farmers from bearing the loss of natural calamities. It is implemented and managed by Saral Krishi Beema.

HP Govt signs MoU with French Agency to Improve Drinking water, Sanitation

- ✓ MoU b/w: Himachal Pradesh (HP) Government (Govt) with the French Development Agency – Agence Francaise de Développement (AFD) Purpose: For Rs 817.12 crore project to improve drinking water and sanitation services in five towns of the state.
- ✓ Under the project, Rs 612 crore would be provided by AFD, whereas the HP Govt would provide Rs. 204.85 crore. Rs. 612 crore will be provided by AFD via two phases i.e. in the first phase, AFD would finance Rs 340 crore (out of Rs 425.85 crore) and in the second phase, AFD would provide Rs 272 crore (out of a total project cost of Rs 371 crore).

Himachal Pradesh becomes 1st State in India to have Organised Liquorice (Mulethi) Cultivation

- ✓ Himachal Pradesh (HP) has become the 1st state in India to begin the commercial cultivation of Liquorice (Mulethi) (Glycyrrhiza glabra) with the distribution of planting material among the farmers by the Council of Scientific and Industrial Research (CSIR)- Institute of Himalayan Bioresource Technology.
- ✓ It has been traditionally known and used in Ayurvedic medicine (known as "Yashtimadhu" in Ayurveda) for rejuvenation. It has anti-viral, antiinflammatory, antioxidant, and antibacterial.

Arogya Mahila: Telangana Health Minister launched new health

programme for Telangana Women

- ✓ On the occasion of International Women's Day 2023 (8th March 2023), T Harish Rao, Telangana Health Minister, launched 'Arogya Mahila', a new health programme for women, in Karimnagar, Telangana.
- ✓ "Nutrition Kit," another scheme would be started for the benefit of pregnant women after the Sri Rama Navami(30th March 2023), a festival that celebrates the birth of Lord Rama. The festival is usually celebrated on the 9th day of Chaitra month in the Hindu calendar(March or April in the Gregorian calendar.).

Odisha Announces Rs 500 Crore Worth Livelihood Scheme for Tribal Community

- ✓ The Cabinet of Odisha has approved the launch of a new Livelihoods Cluster Development initiative for tribal people under the "Mukhya Mantri Janajati Jeebika Mission" with a total outlay of Rs 500 crore.
- ✓ The scheme will be implemented by the ST & SC Development, Minorities & Backward Classes Welfare department, over a period of 3 years from 2023-24 to 2025-26.

Govt presents Rs.1.18 lakh crores Budget for UT of J&K for 2023-24 in Lok Sabha

- ✓ Nirmala Sitharaman, Union Minister of Finance, Government of India, presented a Rs 1,18,500 crore budget for the Union Territory (UT) of Jammu and Kashmir (J&K) for 2023-2024 in the Lok Sabha.
- ✓ Pankaj Chaudhary, Union Minister of State (MoS) for Finance, tabled the budget for the UT of J&K. The budget of J&K is required to be presented and approved by the Parliament as there is no legislature in J&K currently.
- ✓ The total budget estimates for fiscal 2023- 2024 is Rs 1,18,500 crore including the developmental expenditure of Rs 41,491 crore. The capital

component of the budget of J&K has increased substantially.

✓ The debt/GDP ratio for 2023-24 is estimated to be at 49%, and the GDP growth for the UT for 2023-24 is projected at Rs 2,30,727 crore. This shows a growth of 10% over the previous year.

Uttarakhand to set up India's 1st government mother milk bank

- ✓ The government of Uttarakhand is set to establish India's first government mother milk bank, a facility that can ensure to provide the nutritional elements of mothers' milk to newborns.
- ✓ Among the Himalayan states, Uttarakhand has the 3rd -highest infant mortality rate (IMR) of 27 deaths per 1,000 live births in 2019.
- ✓ The infant mortality rate for India in 2022 was 27.695 deaths per 1000 live births, a 3.74% decline from 2021.

Union Minister Ashwini Vaishnaw releases 'Go Green, Go Organic' cover for Sikkim

- ✓ Union Minister Ashwini Vaishnaw, Ministry of Communications and Electronics & Information Technology released a unique cover of the Department of Posts, 'Go Green, Go Organic' for Sikkim.
- ✓ This cover acknowledges the state's achievements in organic farming, and its contribution to India's agriculture sector, and showcases the importance of sustainable development for India.
- ✓ Notably, Sikkim is the first state in the world to get recognized as a 100% Organic state by the World Book of Records (London).

Paytm Signs MoU with Andhra Pradesh Govt to Promote Financial Inclusion

- ✓ MoU b/w: Digital financial services firm One97 Communications which owns the Paytm brand with the Andhra Pradesh (AP) Government
- ✓ Purpose: To promote mutual cooperation and financial inclusion in the areas of Industrial Development, Financial Inclusion, Public Health, Cyber Security and Prevention of Financial Frauds in AP.

✓ Paytm will empower merchants, street vendors and street hawkers in AP to accept digital payments and provide them access to loans through its lending partners.

Mauganj introduced as the 53rd district of Madhya Pradesh

✓ Mauganj was declared as 53rd district of Madhya Pradesh by Shivraj Singh Chouhan, the chief minister of Madhya Pradesh. Mauganj is a tehsil of the Rewa district. CM Chouhan declared that Mauganj would become the 53rd MP district during a function in Rewa. It will be built by combining four of the Rewa district's tehsils.

Chief Minister of Nagaland and NDPP leader Neiphiu Rio takes the oath of office

✓ Neiphiu Rio, the leader of the Nationalist Democratic Progressive Party (NDPP), took the

Himanta Biswa Sarma launches Mission Lifestyle for Environment(LiFE) in Assam

- ✓ Chief Minister of Assam, Himanta Biswa Sarma, inaugurated the 'Mission Lifestyle for Environment' (LiFE) in the state, which is a global mass movement led by Prime Minister Narendra Modi. Sarma stated that the initiative aims to encourage an environmentally conscious lifestyle, with a focus on utilizing resources rather than engaging in wasteful consumption.
- ✓ As part of the Mission Lifestyle for Environment (LiFE) initiative, various week-long activities will be conducted across all districts in Assam.
- ✓ These activities will target seven identified categories, including energy and water conservation, reducing plastic and e-waste, and promoting healthy lifestyles, according to Sarma.

World Bank Grants \$363 million Loan to Karnataka for Clean Drinking Water Supply

✓ The World Bank has granted a loan of USD 363 million to the state of Karnataka in India, which will help to provide clean drinking water to two million rural households. The initiative aims to establish piped water connections in households throughout the state, including the construction of a drinking water distribution network and the installation of water meters. The project is set to benefit around 10 million people across all 31 districts in the state. The loan is part of the Karnataka Sustainable Rural Water Supply Program, which seeks to introduce policies and initiatives that will improve the operational efficiency of rural water supply services.

World Bank approves \$108 million loan for Assam's flood management project

✓ The World Bank has given the nod to provide a loan of \$108 million (about ₹ 889 crores) to assist Assam in its efforts to improve its disaster preparedness and enhance flood forecasting. The multilateral bank has stated that around six million individuals will benefit from this project, which is part of a larger investment program worth \$500 million for the state. The main aim of the Assam Integrated River Basin Management Project is to build eco-friendly infrastructure in the Beki and Buridehing river basins to lessen the impact of floods and river erosion on the state, ultimately safeguarding around one lakh individuals.

Union Home Minister Amith Sah inaugurated Mata Sharda Devi Temple

- Recently, Home Minister e-inaugurated Mata Sharda Devi Temple dedicated to Goddess Sharda Devi and announced that the government of India will attempt to build a Kartrapur-style corridor to Sharda Peeth as an important step in the direction of discovery of Sharda-civilization and promotion of Sharda-script. Sharda peeth is an abandoned Hindu temple and ancient center of learning.
- ✓ It is located at Neelum Valley in Pakistan-occupied Kashmir across Teetwal village in Jammu and Kashmir's Kupwara district along the Line of Control. It is one of the 18 Maha Shakti Peethas and is considered to be the abode of the Hindu Goddess Saraswati. Sharda peeth is the most revered religious place for Kashmiri Pandits.

ECONOMY AND BANKING

Cabinet approves release of an additional instalment of DA to Gol Employees

- ✓ The Union Cabinet, presided over by PM Narendra Modi, has approved the release of an additional instalment of Dearness Allowance (DA) to Government of India (GoI) employees and Dearness Relief to pensioners effective January 1, 2023.
- ✓ The additional instalment, which would bring the total to 42%, will represent a 4% increase over the current rate of 38% of the basic pay/pension to offset price increase.
- ✓ The DA and Dearness Relief would have a combined impact of Rs. 12,815.60 crore per year on the exchequer.
- ✓ This will benefit around 47.58 lakh GoI employees and 69.76 lakh pensioners.
- ✓ This increase is in line with the accepted formula, which is based on the recommendations of the 7th Central Pay Commission.
- ✓ The government provides DA to both pensioners and employees to help counteract the effects of inflation. The DA is typically revised twice a year, in January and July, and the announcement of the DA increase and payout is usually made in March.
- ✓ The DA for GoI employees is determined using the most recent Consumer Price Index for Industrial Workers (CPI-IW).
- ✓ Every month, the CPI-IW data is released by the Labour Bureau, a division of the Ministry of Labour and Employment (MoL&E). The last DA hike was announced by the GoI on September 28, 2022, and it went into effect on July 1, 2022.

Cabinet approves MSP of Raw Jute for 2023 -24 season

- ✓ The Minimum Support Price (MSP) for Raw Jute for the 2023–2024 season has been approved by the Cabinet Committee on Economic Affairs (CCEA), which was presided over by PM Narendra Modi.
- ✓ During the 2023–24 season, the MSP for Raw Jute (TDN3 equivalent to TD5 grade) has been fixed at

Rs. 5050 per quintal. It was Rs. 4,750 per quintal for 2022-23 season.

- ✓ This would guarantee a return of 63.20% over the all India weighted average cost of production.
- ✓ The approval is made on the recommendations from the Commission for Agricultural Costs and Prices (CACP), Ministry of Agriculture and Farmers Welfare (MoA&FW).
- ✓ The MSP for raw jute set for the 2023-24 season is consistent with the principle of fixing the MSP at a level of at least 1.5 times the all-India weighted average cost of production, which was announced by the GoI in the Budget 2018-19.It ensures at least a 50% profit margin.

CCEA Approves Targeted Subsidy to PMUY Consumers

- ✓ The CCEA, chaired by PM Narendra Modi, has approved a Rs. 200 per 14.2 kg liquefied petroleum gas (LPG) cylinder subsidy for up to 12 refills per year for the beneficiaries of Pradhan Mantri Ujjwala Yojana (PMUY).
- ✓ For the fiscal years 2022–2023 and 2023–2024, the total expenditure will be Rs. 6,100 crore and Rs. 7,680 crore, respectively.
- ✓ All PMUY beneficiaries are eligible for this targeted subsidy, which encourages PMUY consumers to keep using LPG.
- ✓ The subsidy is credited directly to the bank accounts of eligible beneficiaries.
- ✓ This subsidy has been offered since May 22, 2022, by public-sector oil marketing firms such Indian Oil Corporation Ltd. (IOCL), Bharat Petroleum Corporation Ltd. (BPCL), and Hindustan Petroleum Corporation Ltd. (HPCL).

<u>Pradhan Mantri Ujjwala Yojana (PMUY)</u>

✓ The GoI introduced the Pradhan Mantri Ujjwala Yojana (PMUY), which offers deposit-free LPG connections to adult women from poor households, in May 2016 to make LPG, a clean cooking fuel, more accessible to rural and underprivileged poor households. As of March 1, 2023, there are 9.59 crore PMUY beneficiaries. Current Affairs

✓ The average LPG consumption of PMUY consumers has increased by 20%, from 3.01 refills in 2019–20 to 3.68 in 2021–22

IMF confirmed a USD 3 billion bailout plan under EFF for Sri Lanka

- \checkmark The International Monetary Fund (IMF) Board
- approved a 48-month extended arrangement under the Extended Fund Facility (EFF) of SDR 2.286 billion (about US\$3 billion) to support Sri Lanka's economic policies and reforms.



- ✓ It is also negotiating with Pakistan for a USD 1.1 billion bailout plan on account of its severe economic crisis marked by falling currency and price rise.
- ✓ Bailout is a general term for extending financial support to a company/country facing a potential bankruptcy threat.
- ✓ It can take the form of loans, cash, bonds, or stock purchases.A bailout may (not) require reimbursement but is often accompanied by greater oversight and regulations.
- ✓ <u>IMF Bailouts:</u> Countries seek help from the IMF usually when their economies face a major macroeconomic risk, mostly currency crisis (such as the ones Sri Lanka is facing).
- ✓ Countries seek such assistance from the IMF to meet their external debt and other obligations, to purchase essential imports, and to prop up the exchange value of their currencies.

How is an IMF Bailout Provided?

Procedure:

- ✓ The IMF lends money to the troubled economies often in the form of Special Drawing Rights (SDRs).
- ✓ SDRs simply represent a basket of five currencies, namely the U.S. dollar, the euro, the Chinese yuan, the Japanese yen, and the British pound.
- ✓ This lending is carried out by a number of lending programs such as extended credit facility, flexible credit line, stand-by agreements, etc.
- ✓ Countries receiving the bailout can use the SDRs for various purposes depending on their individual circumstances.

Finance Bill 2023 passed in Lok Sabha

- ✓ The Lok Sabha passed the Finance Bill 2023, which implements tax proposals for the upcoming fiscal year, without any discussion. The passage of the Bill occurred amid Opposition uproar over the Adani controversy.
- ✓ Proposals for a total of 64 official amendments were put forward in the Bill, including one that aims to eliminate long-term tax benefits for specific categories of debt mutual funds and another that calls for the establishment of the GST Appellate Tribunal.

Key Amendments in the Finance Bill 2023

- The Finance Bill 2023 includes several amendments, such as the taxation of mutual funds having less than 35% AUM in domestic equity as short-term capital gains and the provision of enhanced tax benefits to offshore banking units operating in GIFT City, which will receive a 100% deduction on income for 10 years.
- ✓ Additionally, the tax on royalty or technical fee earned by foreign companies has been increased from 10% to 20%.
- ✓ Other amendments include the formation of a committee to address the pension system's needs, and a proposal for marginal relief to limit the tax one pays to the income that exceeds Rs. 7 lakh.
- ✓ The Bill also proposes that all Liberalized Remittance Scheme (LRS) payments made through credit cards for foreign tours be considered under LRS and be subject to Tax Collection at Source (TCS).
- ✓ Furthermore, the Securities Transaction Tax on the sale of options has been raised from Rs. 1,700 to Rs. 2,100 on a turnover of Rs. 1 crore.
- ✓ The Finance Bill, as a Money Bill, needs to be passed by the Lok Sabha — the lower house of the Parliament. Post the Lok Sabha's approval, the Finance Bill becomes Finance Act.
- ✓ There are different kinds of Finance Bills the most important of them is the Money Bill. The Money Bill is concretely defined in Article 110.
- ✓ The Speaker of the Lok Sabha is authorised to decide whether the Bill is a Money Bill or not.

Income tax dept launches mobile app 'AIS' for Taxpayers

- ✓ On March 22, the Income Tax Department launched a mobile application called "AIS for Taxpayer" that enables taxpayers to view their taxrelated information in the Annual Information Statement (AIS) or Taxpayer Information Summary (TIS). The app has become essential and beneficial since starting from the new financial year on April 1, Form 26AS will only show information related to tax deducted at source (TDS) and tax collection at source (TCS).
- ✓ Taxpayers can get a detailed summary of their information from Form 26AS by referring to the Annual Information Statement (AIS). The AIS not only provides a comprehensive overview of the taxpayer's information, but it also has a feedback mechanism.

Government imposes surcharge for Google Pay and other payment apps

- ✓ Starting from April 1, the National Payments Corporation of India (NPCI) has implemented interchange fees of up to 1.1 percent for prepaid payment instruments used in merchant UPI transactions. The fee, ranging from 0.5 percent and based on the merchant category code, will be charged for UPI payments exceeding ₹2,000 made to online merchants, large merchants, and small offline merchants.
- ✓ The purpose of imposing an interchange fee is to compensate for the expenses incurred by payment service providers in handling, verifying, and approving transactions.
- ✓ Consequently, this fee increase is anticipated to result in higher transaction costs.
- ✓ Wallet issuers such as banks receive payment from payment service providers in the form of interchange fees.
- ✓ These wallets are primarily utilized for online transactions, such as those facilitated by Paytm, PhonePe, and Google Pay.

NPCI recommends PPI charges for UPI payments

✓ Starting from April 1, merchants carrying out transactions through the Unified Payments Interface (UPI) using Prepaid Payment Instruments (PPI) will be subjected to charges, according to a circular issued by the National Payments Corporation of India (NPCI).

✓ The National Payments Corporation of India (NPCI) has issued a circular stating that merchants conducting transactions on the Unified Payments Interface (UPI) using Prepaid Payment Instruments (PPI) will be charged an interchange fee of 1.1% on the transaction amount for amounts over Rs 2,000.

About NPCI

- ✓ Under the 'Payment and Settlement Systems Act, 2007,' the Reserve Bank of India (RBI) and the Indian Banks' Association (IBA) jointly established the National Payments Corporation of India (NPCI) as an umbrella organization responsible for operating retail payment and settlement systems in India.
- ✓ This non-profit company operates under the regulations of Section 25 of the Companies Act 1956, as amended in 2013.
- ✓ Its primary aim is to provide both physical and electronic payment infrastructure to India's entire banking system.

World Bank's IFC to invest USD 73 Million in Mahindra's Last Mile Electric Mobility Unit

✓ International Finance Corporation (IFC), the World Bank's private investment arm, is set to invest USD 73 million (Rs 6020 crore) in an Indian automaker, Mahindra and Mahindra (M&M) Limited's lastmile electric mobility unit. This investment is the IFC's 1st investment in an electric vehicle maker in India.

Indian economy likely to grow 6% in FY24: Crisil

- ✓ As per the rating agency CRISIL annual growth forecast, India's Gross Domestic Product (GDP) growth will touch 6% in FY24 slower than the 7% estimated by the National Statistics Office (NSO) for FY2023.
- ✓ Indian economy averaging a growth rate of 6.8% over the next five fiscals.
- ✓ India's external vulnerability is expected to decline with a narrower Current Account Deficit (CAD). CAD is expected to narrow to 2.4% of GDP (~\$88 billion) in FY24 from an estimated 3.0% (~\$100 billion) in FY23.

MoF Monthly Economic Review, February 2023: India's GDP to Grow at 7% in FY23: Inflation to Moderate

- ✓ According to the "Monthly Economic Review February 2023" published by the Ministry of Finance (MoF), the Indian economy is projected to grow at 7% in the fiscal year 2022-2023 (FY23) despite global challenges.
- ✓ Retail inflation is anticipated to decline in accordance with wholesale inflation, which dropped to a 25-month low in January 2023.
- ✓ The real GDP (Gross Domestic Product) in Q3 FY23 registered a YoY (Year on Year) growth of 4.4% which is lower than that of 6.3 % in Q2 FY23.

MSME Minister Narayan Tatu Rane launches MSME Competitive (LEAN) Scheme

- ✓ Union Minister Narayan Tatu Rane, Ministry of Micro, Small & Medium Enterprises (MoMSME), launched the MSME Competitive (LEAN) Scheme (MCLS) and National Scheduled Castes (SC)/Scheduled Tribes (ST) Conclave under MSME Champion Scheme in the event organised at the NDMC Convention Centre, New Delhi, Delhi.
- ✓ LEAN is defined as a set of management practices to improve efficiency and effectiveness by eliminating waste through Kaizen.
- ✓ Kaizen is a Japanese word that essentially means "change for the better" or "good change."
- ✓ The MCLS will be implemented through Quality council of India (QCI) and National Productivity Council (NPC).

6 digit HUID on Gold Jewellery made Mandatory from 1st April 2023

- ✓ Department of Consumer Affairs announced that the sale of hallmarked gold jewellery or gold artefacts without a 6 digit alphanumeric HUID (Hallmark Unique Identification) number, consisting of alphabets and numbers, will not be allowed after 31st March 2023 i.e., from 1st April 2023 onwards. Following this, the sale of jewellery with a 4-digit HUID number will also be stopped on April 1.
- ✓ From April 1, 2023, each piece of gold jewellery will have a Bureau of India Standards (BIS) hallmark, purity of gold (for example, 0 22K916), and a 6-digit HUID embossed on it.

Bandhan MF renamed India's 1st International Debt ETF as "Bandhan US Treasury Bond 0-1 Year Fund of Fund"

✓ The Bandhan Mutual Fund(MF) renamed the recently launched India's First US Debt Exchange-Traded Fund (ETF) 'IDFC US Treasury Bond 0-1year Fund of Fund' as 'Bandhan US Treasury Bond 0-1 Year Fund of Fund'. Current Affairs

HDFC Bank & Flipkart Wholesale launches industry-first co-branded credit card

- ✓ HDFC Bank and Flipkart Wholesale, the B2B (Business To Business) platform of Flipkart Group, launched an industry-first co-branded credit card exclusively for Flipkart Wholesale members.
- ✓ The credit card will run on the Diners Club International network which is a part of the Discover Global Network.

J&K Bank Signs Corporate Agency Agreement with LIC

- ✓ Jammu and Kashmir Bank (J&K Bank) signed a Corporate Agency Agreement with the Life Insurance Corporation of India (LIC), India's largest insurer, for servicing and soliciting life insurance products through J&K Bank's Branch Network.
- ✓ The agreement will be operational or effective from 1st April 2023. On 15th March 2023, Life Insurance Company (LIC) reported that it has sold 2% of its equity stake in the state-owned NMDC Limited (formerly National Mineral Development Corporation), taking its total shareholding in the public sector unit to 11.69% as of March 14.

Maharashtra, Gujarat lead in FDI inflows in April-December of FY23

✓ According to the Department for Promotion of Industry and Internal Trade (DPIIT) data, Maharashtra and Gujarat recorded positive growth during the 3 quarters of the current fiscal (FY23) – April 2022 to December 2022. FDI inflows into Maharashtra went up by 19% year-on-year (y-o-y) to Rs 85,186 crore during the April-December of FY23 as compared to Rs 71,858 crore of FDI inflows during April-December of FY22.

- ✓ FDI inflows into Gujarat during April- December of FY23 more than doubled to Rs 32,349 crore compared to Rs 15,321 crore in April-December of FY22.
- ✓ The three States: Maharashtra, Karnataka and Gujarat alone accounted for 68% of the FDI equity inflows (in dollar terms) into the country between October 2019 and December 2022.

Lockheed Martin & Tata Group Sign MoU to Manufacture Fighter Wings in India

- ✓ MoU b/w: Lockheed Martin Corporation (LMT), a global defence aerospace player based in the United States (US), with India's Tata Group
- ✓ Purpose: For the production of fighter plane wings at their joint venture (JV) facility, Tata Lockheed Martin Aerostructures Ltd (TLMAL), in Hyderabad, Telangana.
- ✓ LMT has a proposed F-21 (Advanced Multirole Fighter) partnership with India, which is intended to deliver 114 MFRA specifically configured for India and the Indian Air Force (IAF).
- ✓ Tata Advanced Systems Limited (TASL) and Lockheed Martin Aeronautics established TLMAL as a joint venture in 2010.

WPI inflation slips to 25-month low of 3.85% in February 2023: Govt Data

- ✓ According to the "Index Numbers of Wholesale Price in India for the Month of February 2023 (Base Year: 2011-12)" released by the Office of the Economic Adviser, Department for Promotion of Industry And Internal Trade (DPIIT), Ministry Of Commerce & Industry(MoCI), the Wholesale Price-Index (WPI) based inflation rate eased to a 25month low of 3.85% (Provisional) in February 2023 (over February 2022) against 4.73% recorded I January 2023.
- ✓ The decline in the rate of index is contributed by the drop in prices of Primary Articles, Fuel & Power, and Manufactured Products.

Current Affairs

✓ According to the data released by the National Statistical Office (NSO), The Retail Inflation based on Consumer Price Index (CPI) declined to 6.44% in February 2023 against 6.52% in January 2023 and 6.07% in February 2022. Retail inflation dipped mainly on account of a slight easing in prices of food and fuel items.

GSTN empanels 4 private Companies to provide e-Invoice Registration

- ✓ On the recommendation of the Goods and Services Tax (GST) Council, the Goods and Service Tax Network (GSTN) has launched e-Invoice Registration Services through multiple private Invoice Registration Portals (IRPs) as another step towards further digitization of the business process flow.
- Ernst & Young Global Limited (EY), Clear (formerly ClearTax), Cygnet Infotech Pvt. Ltd., and IRIS Business Services Limited; were enlisted for providing e-invoice (electronic invoicing) registration services to all GST taxpayers of India.

World Bank's Women, Business, and the Law 2023 report: Nearly 2.4 Billion Women Globally Don't Have Same Economic Rights as Men

- ✓ According to the 9th edition of the World Bank's "Women, Business, and the Law 2023" report, women across the world only have 77% of the legal rights that men do, and nearly 2.4 billion women of working age live in countries that do not provide them the same rights as men.
- ✓ Furthermore, the global pace of reforms towards equal treatment of women under the law slowed to a 20-year low in 2022.
- ✓ From 2021 to 2022, the global average score on the Women, Business, and Law index increased just by half a point to 77.1. "Women, Business, and the Law 2023" examines laws and regulations impacting women's economic participation in 190 economies from 1971 to 2023 (calendar years 1970 to 2022).

IREDA, EIB explore Partnership to finance Renewable Energy Projects in India

- ✓ A meeting was held between the European Investment Bank (EIB) and Indian Renewable Energy Development Agency (IREDA) to explore partnership on financing of renewable energy and green hydrogen projects in India.
- ✓ The meeting was held between Maria Shaw-Barragan, Global Director, EIB; and IREDA Chairman & Managing Director (CMD) Pradip Kumar Das in Delhi.
- IREDA: HQ- New Delhi, Delhi; Parent Ministry- Ministry of New and Renewable Energy (MNRE).

WorldBankSigns2LoanProgrammesPHSPP, EHSDP of USD500 million each to Support India'sHealth Sector

- ✓ Government of India (GoI) and World Bank (WB) signed 2 complementary loans of \$500 million Public Health Systems for Pandemic Preparedness Program (PHSPP) and \$500 million Enhanced Health Service Delivery Program (EHSDP) to support and improve India's healthcare infrastructure.
- ✓ Through the combined financing of USD 1 billion (about Rs 8,200 crore), the WB will support India's flagship Pradhan Mantri- Ayushman Bharat Health Infrastructure Mission (PM-ABHIM), which was launched in October 2021, to improve the public healthcare infrastructure across India.
- ✓ Both the PHSPP and EHSDP loans which will be obtained from the International Bank for Reconstruction and Development (IBRD) (The financial institution which is a part of the World Bank Group) have a final maturity of 18.5 years including a grace period of 5 years.
- ✓ One of the loans would prioritise health service delivery in 7 states including Andhra Pradesh, Kerala, Meghalaya, Odisha, Punjab, Tamil Nadu, and Uttar Pradesh.

RBI UPDATES

RBI allows India and Tanzania to use national currencies for trading

- ✓ India and Tanzania have received approval from the Reserve Bank of India (RBI) to utilize their respective national currencies in bilateral trade settlements. This move is anticipated to decrease transaction costs and improve the effectiveness of cross-border trade, resulting in higher trade volumes and increased economic collaboration between the two nations.
- ✓ The benefits of this bilateral trade mechanism that uses local currency, the Indian High Commission in Tanzania is organizing a Stakeholders Consultation Meeting on March 24th, 2023. This initiative aligns with the RBI's goal of promoting the use of domestic currencies in cross-border transactions to decrease reliance on foreign currencies, particularly the US dollar.
- ✓ According to Binaya Pradhan, the Indian High Commissioner to Tanzania, the recent development of allowing the use of the Indian Rupee and the Tanzanian Shilling (Tsh) for settling bilateral trade is a positive development for the business community.
- ✓ The recently approved mechanism allows authorised banks in India to establish Special Rupee Vostro Accounts (SRVAs) for the correspondent banks of Tanzania.

RBI's Data Centre and Cybersecurity Training Institute to come up in Bhubaneswar

- ✓ The Governor of the Reserve Bank of India (RBI), Shaktikanta Das, initiated the establishment of a "Greenfield Data Centre" and an "Enterprise Computing & Cybersecurity Training Institute" in Bhubaneswar, Odisha, during a foundation stone laying ceremony.
- ✓ The new Data Centre and Training Institute, which will cover an area of 18.55 acres, will be able to address the emerging needs of the RBI and the financial sector, according to a statement by the central bank.

RBI, Central Bank of UAE sign MoU to promote innovation in financial products and services

- ✓ The Reserve Bank of India (RBI) on March 15 said that it has signed a Memorandum of Understanding (MoU) with the Central Bank of United Arab Emirates for promoting innovation in financial product and services.
- ✓ Both central banks will collaborate on various emerging areas of FinTech, especially Central Bank Digital Currencies (CBDCs), and explore interoperability between the CBDCs of UAE's central bank and the RBI.
- Central Bank of UAE and RBI will jointly conduct proof-of-concept (PoC) and pilot(s) of bilateral CBDC bridge to facilitate cross-border CBDC transactions of remittances and trade.
- ✓ This bilateral engagement of testing cross-border use case of CBDCs is expected to reduce costs, increase efficiency of cross border transactions and further the economic ties between India and UAE.

RBI accords 'infra finance company' status to IREDA

- ✓ The Reserve Bank of India (RBI) granted an 'Infrastructure Finance Company (IFC)' status to Indian Renewable Energy Development Agency (IREDA), a company statement said. It was earlier classified as an 'Investment and Credit Company (ICC)'.
- ✓ With the IFC status, IREDA will be able to take higher exposure in RE financing. The IFC status will also help the company to access a wider investor base for fund mobilisation, resulting in competitive rates for fundraising.
- ✓ The recognition of IREDA as an IFC will increase the investors' confidence, enhance the brand value and generate a positive outlook in the market.
- ✓ The grant of IFC status is a recognition of IREDA's 36 years of infrastructure financing and development with focused development of renewable energy.

Daily UPI transactions jump 50% to

36 crore: RBI

- ✓ Reserve Bank of India governor Shaktikanta Das said payments through UPI (unified payment interface) have grown exponentially in the past 12 months with daily transactions crossing 36 crore, which is up 50 per cent from 24 crore in February 2022.
- ✓ In value terms, these transactions are worth Rs 6.27 lakh crore, registering a growth of 17 per cent from Rs 5.36 lakh crore in February 2022, the governor told reporters while launching the Digital Payments Awareness Week at the RBI headquarters. He also said the overall monthly digital payment transactions crossed over Rs 1,000-crore-mark each month during the past three months.

RBI launches mission to make every citizen a user of digital payment

- ✓ While digital payments have skyrocketed during the past few years, a significant portion of the population still does not use digital payments for day-to-day transactions. In order to bridge this gap, Reserve Bank of India (RBI) governor Shaktikanta Das launched a mission — "Har Payment Digital" – with the aim of making every citizen in the country a user of digital payments as part of Digital Payments Awareness Week (DPAW) 2023.
- ✓ The central bank will launch "Har Payment Digital" (HPD) mission that would run till the period of Vision 2025, with an intention to convert the nonusers into users of digital payments. Vision 2025 has its theme as "E-Payments for Everyone, Everywhere and Everytime".
- ✓ RBI in collaboration with the banks and other stakeholders of the payment systems will carry out a multimodal campaign covering print, television, radio and social media during the week around the theme — "Adopt digital payments and Teach others also".

RBI imposes restrictions on Musiri Urban Co-operative Bank

- ✓ The Reserve Bank of India imposed a Rs 5,000 cap on withdrawals by individual customers from Tamil Nadu-based Musiri Urban Co-operative Bank as part of several restrictions slapped on the lender due to its deteriorating financial condition.
- ✓ The restrictions on the lender will remain in force for six months from the close of business on March 3 and are subject to review, the RBI said in a statement. With curbs in place, the cooperative bank, without approval of the RBI, cannot grant loans, make any investment, and disburse any payment. The lender cannot also dispose of any of its properties, among others.
- ✓ The RBI, however, said the directions should not per se be construed as cancellation of the banking licence.

RBI's new pilot project on coin vending machines

- ✓ Recently, RBI Governor Shaktikanta Das had stated during the most recent Monetary Policy Committee (MPC) address that the apex banking regulator, in collaboration with banks, would launch a pilot project to evaluate the operation of a QR-code based coin vending machine.
- ✓ The vending machines would dispense coins, with the appropriate amount debited from the customer's account via the United Payments Interface (UPI), instead of physically tendering banknotes.
- ✓ The pilot project is planned to be initially rolled out at 19 locations in 12 cities across the country. These vending machines are intended to be installed at public places such as railway stations, shopping malls, and marketplaces to enhance ease and accessibility.

RBI's March 2023 Monthly Bulletin: India Possess Strong Recovery Post Pandemic; Outward remittances in April-January FY23 Surpass FY22

✓ According to the State of the Economy report released by the Reserve Bank of India (RBI), India's recovery from the pandemic has been more robust than initially expected, with a consistent

build-up of momentum from Q2FY23. The RBI's nowcast model projects real GDP growth for the Q4 FY23 at 5.3%.

- ✓ On the other hand, global growth is set to slow down or even enter a recession in 2023.
- ✓ Outward remittances under the RBI's liberalized remittance scheme (LRS) stood at \$22.08 billion during the April 2022–January 2023 period, surpassing the all-time high of \$19.61 billion in FY22.
- ✓ In January 2023, the amount remitted overseas totalled \$2.72 billion. This is the highest amount remitted under the scheme in a month during FY23. On a year-on-year (YoY) basis, these were up 35.17%.

RBI infuses Rs 82,650 crore into Banking System via VRR Auction

- ✓ The Reserve Bank of India (RBI) infused liquidity amounting to Rs. 82,650 crore into the banking system through a 14-day Variable Rate Repo (VRR) auction.
- ✓ Under the VRR auction, Banks borrowed Rs. 82,650 crore against the announced Rs. 1 lakh crore (USD 12.19 billion) at a weighted average rate of 6.53%.

RBI Released Data on the Performance of the Private Corporate Sector in Q3 FY23

- ✓ The Reserve Bank of India (RBI) released data on the performance of the private corporate sector during the third quarter of 2022-23 (i.e., Q3 FY23).
- ✓ The year-on-year (y-o-y) sales growth of listed private non-financial companies moderated to 12.7% in Q3 FY23 from 22.6 % in Q2 FY23.
- ✓ Considering the deteriorating financial condition of Musiri Urban Co-operative Bank Ltd., Musiri, Tamil Nadu, the Reserve Bank of India (RBI) has imposed a Rs 5,000 cap on withdrawals by individual customers.

RBI launched March 2023 round of its 2 Surveys – IESH & CCS to gather 'Useful Inputs' for its Monetary Policy

- ✓ The Reserve Bank of India (RBI) launched the March 2023 round of its 2 surveys: Inflation Expectations Survey of Households (IESH), and Consumer Confidence Survey (CCS). Data gathered from these surveys, which are regularly done by RBI, will provide useful inputs for RBI's monetary policy.
- ✓ RBI launched the March 2023 round of IESH whose purpose is to determine the inflation expectations of households across the following 19 cities:
- Ahmedabad (Gujarat), Bengaluru (Karnataka), Bhopal (Madhya Pradesh), Bhubaneswar (Odisha), Chandigarh, Chennai (Tamil Nadu), Delhi, Guwahati (Assam), Hyderabad (Telangana), Jaipur (Rajasthan), Jammu (Jammu & Kashmir), Kolkata (West Bengal), Lucknow (Uttar Pradesh), Mumbai (Maharashtra), Nagpur ((Maharashtra), Patna (Bihar), Raipur (Chhattisgarh), Ranchi Jharkhand) and Thiruvananthapuram (Kerala)'.

RBI Foundation Day 2023 observed on 1st April

✓ The Reserve Bank of India (RBI) was established on April 1, 1935, in accordance with the provisions

of the Reserve Bank of India Act, 1934.

✓ The Central Office of the RBI, initially set up in



Kolkata, was permanently moved to Mumbai in 1937.

- ✓ Sir Osborne Smith the first Governor of the Bank. The Bank was constituted as a shareholders' bank. The RBI is the central bank of India and is responsible for regulating the country's monetary and credit system. It is also responsible for issuing currency and managing the country's foreign exchange reserves.
- ✓ The RBI works closely with the government of India to formulate and implement monetary and fiscal policies that promote economic growth and stability. It was set up as a private shareholder's bank with a capital of Rs. 5 crores.

ISRO launches LVM3-M3/Oneweb India-2 Mission in Sriharikota

- ✓ The Indian Space Research Organisation (ISRO)
 - successfully launched its heaviest rocket, LVM3, for the sixth consecutive time from the Sriharikota



spaceport. The rocket successfully placed 36 satellites belonging to the UK-based OneWeb group company into their intended orbits.

- ✓ The launch took place at 9 a.m. from the second launch pad situated approximately 135 kilometres away from Chennai, following a 24.5-hour countdown.
- ✓ This marks the 18th launch for the OneWeb Group, while it is ISRO's second mission of 2023, with the SSLV/D2-EOS07 mission in February being the first.
- ✓ As per the contract signed between ISRO's commercial arm NSIL and OneWeb, a total of 72 satellites are set to be launched in two phases. The first phase, which included 36 satellites, was successfully launched on October 23, 2022, in the LVM3-M2/OneWeb India-1 mission.
- ✓ The OneWeb Constellation operates in a Low Earth Orbit (LEO) Polar Orbit, where the satellites are arranged in 12 rings, also known as orbital planes.
- ✓ Each orbital plane consists of 49 satellites, and they are inclined to be near-polar at an inclination of 87.9 degrees.
- ✓ The satellites are placed at an altitude of 1200 km above the Earth's surface, and each satellite completes a full trip around the Earth every 109 minutes.

NASA to send 4 humans to live on Mars from June 2023

- ✓ This summer, the National Aeronautics and Space Administration (NASA) is preparing four individuals to live on Mars on June 2023.
- ✓ The four "Martians" will be a part of NASA's human exploration trip on Mars, even though the American space agency has long sought to send

humans to the neighbouring planet. Also, NASA has sending satellites, the InSight lander, a rover mission with the Perseverance rover, the Ingenuity small robotic helicopter, and related delivery systems, all of which are intended to provide the Red Planet with its first comprehensive examination.

✓ The four volunteers are a part of a 12-month project to get people ready for visiting Mars. When humans eventually land on Mars, they will do so in a habitat that replicates the circumstances there.

ISRO Receives NISAR Satellite, Jointly Developed by NASA & ISRO

- ✓ NASA-ISRO Synthetic Aperture Radar (SAR) (NISAR), an Earth-observation satellite, was handed over to the Indian Space Research Organization (ISRO) from National Aeronautics and Space Administration (NASA) Jet Propulsion Laboratory (JPL), California, United States of America(USA).
- ✓ NISAR, Earth-observing mission, was jointly developed by NASA and ISRO.
- ✓ NISAR will observe Earth's land and ice- covered surfaces with 12-day regularity on ascending and descending passes, sampling Earth on average every 6 days for a baseline 3-year mission.
- NASA: Administrator– Bill Nelson; HQ– Washington, D.C., USA

SpaceX launches 40 OneWeb internet satellites, lands rocket

✓ SpaceX launched a Falcon 9 rocket from Cape

Canaveral Space Force Station with 40 more internet satellites for rival OneWeb, followed by the landing of the rocket's first stage



booster back at the Florida spaceport.

- ✓ The two-stage Falcon 9 lifted off from Cape Canaveral Space Force Station in Florida

GPT-4, a new generation of AI language model announced by OpenAI

- ✓ GPT4, the most recent release of OpenAI's large language model, which powers popular apps like ChatGPT and the new Bing, has been announced. According to San Francisco-based research company OpenAI, GPT-4 is more advanced than the previous version and has been trained on more data, costing more to operate.
- ✓ GPT-4 may produce analyses, classifications, and captions. Additionally, GPT-4 can handle 25,000 words of text, allowing for prolonged chats, content creation, and document search and analysis.
- ✓ As per the company GPT4 "can tackle challenging issues with better accuracy" and is "more creative and collaborative than ever before."

Exostoma Dhritiae: ZSI Scientists discovered a New Catfish Species in Arunachal Pradesh

- ✓ Zoological Survey of India (ZSI) Scientists have discovered a new species of sisorid catfish named "Exostoma Dhritiae" in Siking stream, a tributary of the Siang river in the Upper Siang district of Arunachal Pradesh.
- ✓ The new species is named after Dhriti Banerjee, the 1st woman director of the ZSI, as a tribute to her contribution to research on the fauna of India.
- ✓ It is a small fish found in streams in hills and locally called "Ngorang" by local tribals.

ISRO successfully carries out Controlled Re-Entry Experiment of MT-1 Satellite

- ✓ The Indian Space Research Organisation (ISRO) successfully carried out an extremely challenging controlled re-entry experiment of the decommissioned orbiting Megha-Tropiques-1 (MT-1) satellite in an uninhabited area in the Pacific Ocean between 5 degrees south(°S) to 14°S latitude and 119° West(W) to 100°W longitude.
- ✓ It was carried out from the Mission Operations Complex in ISTRAC (ISRO Telemetry, Tracking and Command Network), Bengaluru (Karnataka).

- ✓ The United Nations (UN)/Inter-Agency Space Debris Coordination Committee (IADC) space debris mitigation guidelines recommend deorbiting a LEO (Low Earth Orbit) object at its end-of-life, preferably through controlled re-entry to a safe impact zone, or by bringing it to an orbit where the orbital lifetime is less than 25 years.
- ✓ ISRO: Chairman− S. Somanath; HQ− Bengaluru, Karnataka; Establishment− 1969.

DRDO conducted Successful Flight Tests of VSHORADS and PTO Shaft

- ✓ The Defence Research and Development Organisation (DRDO) conducted two consecutive successful flight tests of Very Short Range Air Defence System (VSHORADS) missile at the Integrated Test Range (ITR), Chandipur, Odisha.
- ✓ Based on the SA-18 Grouse MANPADS (Man-Portable Air Defense System) developed by Russia, VSHORADS's purpose is to neutralize low-altitude aerial threats at short ranges. It has been designed and developed indigenously by Research Centre Imarat, Hyderabad (Telangana) in collaboration with other DRDO laboratories and Indian Industry Partners.
- DRDO also successfully conducted a maiden flighttest of the Power Take off (PTO) Shaft on Light Combat Aircraft (LCA Tejas) Limited Series Production (LSP) -3 aircraft in Bengaluru (Karnataka).

Central Government launches High Price DAM and Surplus Power Portal (PUShP)

- ✓ The Central Government has launched a High Price Day Ahead Market-HPDAM and Surplus Power Portal (PUShP) – an initiative to ensure greater availability of power during the peak demand season.
- ✓ The portal was launched by Union Minister Raj Kumar Singh, Ministry of Power at a virtual function in New Delhi, Delhi which was attended by over 200 stakeholders from state governments and the power sector.
- ✓ HP—DAM was part of the overall strategy to ensure that all available power capacity is utilized for supply the power to consumers.

DEFENCE

Defence Ministry inks deal worth over Rs 1,700 crore to boost critical weapon system production

- ✓ The Ministry of Defence (MoD) signed a contract worth over Rs 1,700 crore with BrahMos Aerospace Private Limited (BAPL) for the procurement of Next Generation Maritime Mobile Coastal Batteries (Long range) (NGMMCB-LR) and BrahMos Missiles under the Buy (Indian) Category.
- ✓ Delivery of NGMMCBs equipped with supersonic BrahMos Missiles is expected to start in 2027, and they will significantly improve the Indian Navy's ability to carry out multi-directional maritime strikes.
- ✓ This contract will provide a significant impetus to the domestic production of critical weapons systems and ammunition, with active participation from indigenous industries.

First batch of Agniveers passes out of INS Chilka

✓ On a recent occasion, 2,585 Agniveers, including
 272 women from the Indian Navy, successfully

completed their training at INS Chilka, located in Odisha. The parade was reviewed by the Chief of



the Naval Staff, Adm R Hari Kumar, and also attended by PT Usha, a Member of Parliament, and notable sports personality Mithali Raj, along with eminent naval veterans.

Khushi Pathania, a 19-year-old from Pathankot, was honored with the General Bipin Rawat Trophy for Best Female Agniveer at the first passing out parade of Agniveers held at INS Chilka. Khushi's grandfather was a Subedar Major, and she is the daughter of a farmer. Additionally, Amalakanti Jayaram was awarded the Chief of the Naval Staff Rolling Trophy and Gold Medal for Best Agniveer SSR, while Ajith P received the same award for the MR category. ✓ The Union home ministry has announced a 10 per cent reservation for former Agniveers in vacancies in the Central Industrial Security Force (CISF), just after taking a similar initiative for jobs for them in the BSF.

About the 'Agniveer'

✓ The "Agnipath" scheme is a defence recruitment initiative in India that aims to reduce the increasing salary and pension expenses by hiring short-term soldiers on a contract basis. These soldiers, known as 'Agniveer', will be initially recruited for four years, after which some of them may be retained. The scheme offers Indian youth an opportunity to serve in the Armed Forces and aims to achieve an optimal balance between youth and experience in the Army. Women will also be recruited into the armed forces under this scheme.

India's Defence Exports to Reach Rs 40,000 Crore by 2026: Rajnath Singh

- ✓ India is set to become a major exporter of defense equipment and materials, with exports projected to be worth Rs 35,000 to Rs 40,000 crore by 2026. The announcement was made by Union minister Rajnath Singh during a speech at Symbiosis International University, where he emphasized the importance of self-reliance and creating an ecosystem that fosters self-confidence.
- ✓ Since adopting the Indianization program, India's defense exports have increased from Rs 900 crore in 2014 to Rs 15,000 crore to Rs 16,000 crore today. Singh expressed his pride in the country's defense forces, which are now meeting 80% of their needs through indigenous procurement.

1st joint Conference of army chiefs of India and African countries

✓ The inaugural joint conference between the Indian and African army chiefs is scheduled to take place in Pune, with Defense Minister Rajnath Singh as the guest of honor and Indian Army Chief General Manoj Pandey in attendance. This marks the first-

Multi-Domain Exercise Α Vavu Prahar held at LAC

- Recently, during the on-going tensions between India and China at the Line of Actual Control (LAC), the Indian Army and Air Force carried out a 96-hour joint exercise named 'Vayu Prahar' in the Line of Actual Control (LAC) between India and China, eastern region in the state of Arunachal Pradesh.
- \checkmark The exercise aimed to develop plans to achieve synergy in multi-domain operations by using air and land forces. It was conducted in the second week of March, and its primary objective was to enhance coordination between the Army and Air Force for effective operations in a multi-domain battlefield.

Defence Ministry Inks Rs 3700 Cr Contracts with BEL for Radars and Receivers

- The Indian Defence Ministry has recently signed two contracts with Bharat Electronics Limited (BEL) worth more than Rs 3,700 crore, with the aim to enhance the operational capabilities of the Indian Air Force. Under the Buy Indian - IDMM (Indigenously Designed Developed and Manufactured) category, both projects are part of the ongoing vision of Aatmanirbhar Bharat. The first contract, worth over Rs 2,800 crore, involves the supply of Medium Power Radars (MPR) 'Arudhra'. which have been designed and developed by the Defence Research and Development Organisation (DRDO) and will be manufactured by BEL. The second contract, with a cost of approximately Rs 950 crore, relates to Radar Warning Receivers (RWR).
- The successful trials of the MPR have already been conducted by the Indian Air Force, and the RWR has been designed to enhance the capabilities of Su-30 MKI aircraft. In addition to Radar Warning

Receivers, the projects are aimed at improving the surveillance, detection, tracking, and Electronic Warfare capabilities of the air force.

India and UK'S annual bilateral maritime exercise 'Konkan 2023'

The annual bilateral maritime exercise called Konkan 2023 was conducted between the Indian Navy and the Royal Navy of UK from 20th to 22nd March 2023 off the Konkan



coast in the Arabian Sea. The Royal Navy is the United Kingdom's naval warfare force.

✓ The exercise involved INS Trishul, a guided missile frigate, and HMS Lancaster, a Type 23 guided missile frigate, and aimed to improve cooperation and learn best practices through various maritime drills. These drills covered air, surface, and subsurface operations, such as gunnery shoots on an inflatable surface target called 'Killer Tomato,' helicopter operations, anti-aircraft, and antisubmarine warfare exercises, Visit Board Search and Seizure (VBSS), ship manoeuvres, and personnel exchange.

GRSE launched the 'Most Silent **Ship' INS Androth**

 \checkmark Garden Reach Shipbuilders and Engineers (GRSE), a shipbuilding company in India, has launched INS

> Androth, a vessel claimed to be the "most silent ship in the country" for the Indian Navy.

- The vessel is the first in a series of eight antisubmarine warfare shallow-watercraft to be delivered to the navy. The ships will be used for patrolling, search and rescue operations, and other military missions.
- \checkmark The INS Androth has been designed to accommodate 50 crew members and is equipped with state-of-the-art communication systems, radars, and sonars to detect and track enemy submarines. The ship also features a stealth design that reduces its acoustic signature, making it difficult to detect underwater.
- \checkmark The INS Androth, launched by GRSE, is a 77meter-long, waterjet propelled ASW Shallow water craft that is designed to operate in coastal waters for

anti-submarine operations, mine laying operations, and Low Intensity Maritime Operations (LIMO).

Africa-India field training exercise AFINDEX-23 to be held in Pune

- ✓ The Africa-India Field Training Exercise (AFINDEX-2023) has begun with the participation of 100 participants from 23 African countries, including Botswana, Egypt, Ghana, Nigeria, Tanzania, and Zambia, among others.
- ✓ The exercise aims to improve interoperability and operational readiness for UN peacekeeping missions, and focuses on Humanitarian Mine Action and Peace Keeping Operations.
- The joint exercise is divided into four phases, including training of trainers, a Humanitarian Mine Action and Peace Keeping Operations Phase, and a validation exercise to assess the results of the training. The exercise seeks to enhance peace and security, exchange ideas, and promote а collaborative approach in capacity enhancement of African armies. Tactical drills, procedures, and the jointly with ability to operate seamless interoperability are the primary focus of the joint exercise.

DRDO organises workshop on 'Human Factors Engineering in Military Platforms'

- ✓ A two-day workshop on "Human Factors Engineering in Military Platforms" was inaugurated by the Chief of Defence Staff General Anil Chauhan on March 15 in New Delhi.
- ✓ The workshop is being organized by the Defence Institute of Physiology and Allied Sciences (DIPAS), which is a Delhi-based laboratory of the Defence Research and Development Organisation (DRDO).
- ✓ The objective of the workshop is to establish a policy framework and practices that ensure the scientific implementation of Human Factors Engineering (HFE) in the defence sector, thus contributing to the vision of 'Aatmanirbhar Bharat.'
- ✓ HFE is a science that focuses on designing tools and systems that take into account human capabilities and limitations, enabling their safe and effective use.

INS Dronacharya Receives Prestigious President Droupadi Murmu's Colour Award

✓ The Indian Navy's top gunnery school, INS

Dronacharya, will be presented with the President's Colour in honor of its outstanding services. President Droupadi Murmu will be conferring the award as the highest recognition bestowed upon a unit by the



President, who serves as the Supreme Commander of the armed forces, for its exceptional service to the country.

About the INS Dronacharya

- ✓ INS Dronacharya, situated in Kochi, is responsible for providing comprehensive training on gunnery and missile warfare to officers and sailors from the Navy, Coast Guard, and friendly foreign maritime forces. Its primary objective is to equip them with the skills necessary to deliver ordnance on target with precision.
- ✓ In 2004, INS Dronacharya was named the Center for Excellence in gunnery and missile warfare. The unit has a joint affiliation with the Indian Army School of Artillery, fostering a spirit of collaboration. The institution's alumni have demonstrated exceptional courage, dedication, and professionalism in both wartime and peacetime operations, earning them several awards, including one Mahavir Chakra, Kirti Chakra, and Yudh Seva Medal, five Veer Chakra, and seven Shaurya Chakra accolades.

Multi-lateral ASW Exercise 'Sea Dragon 23' organized by the US Navy

- ✓ The Indian Navy deployed a P8I aircraft to Guam, USA, on March 14, 2023, to participate in the third edition of 'Exercise Sea Dragon 23', a coordinated multi-lateral Anti-Submarine Warfare (ASW) exercise for Long Range MR ASW aircraft organized by the US Navy. The exercise, scheduled from March 15 to March 30, 2023, will focus on coordinated ASW tactics among the participating countries and will involve advanced ASW drills.

Joint India-Singapore exercise 'bold kurukshetra' concludes

- ✓ Operation Bold Kurukshetra, a bilateral armour training exercise, was held from March 6–13, 2023, in Jodhpur Military Station in India. It was the 13th iteration, and the Singapore Army and Indian Army both took part. Both armies participated in the first command post exercise in the series, which included computer wargaming and planning components at the battalion and brigade levels. Participants in the exercise, which was held by the Indian Army, included members of the 42nd Battalion, Singapore Armoured Regiment, as well as an Indian Army Armoured Brigade.
- ✓ Exercise Bold Kurukshetra is carried out in accordance with the bilateral agreement between the Indian Army and the Singaporean Army for joint army training and exercises. This exercise, which was first carried out in 2005, highlights the long-standing bilateral defence connection between the two nations and strengthens coordination between the two forces.

3rd edition of Exercise La Perouse-**2023 begins**

- ✓ On March 13 and 14, 2023, the Indian Ocean Area will host the third edition of the multilateral exercise La Perouse. The Royal Australian Navy, French Navy, Indian Navy, Japanese Maritime Self Defence Force, Royal Navy, and United States Navy will all have people, ships, and essential helicopters participating in this event.
- ✓ Every two years exercise La Perouse, an exercise run by the French Navy, aims to improve maritime domain awareness and maritime cooperation among the participating navies in the Indo-Pacific region.

India, France conduct Maritime Partnership Exercise (MPX)

✓ Indian Navy's indigenously built guided missile frigate, INS Sahyadri participated in a Maritime Partnership Exercise (MPX) with French Navy (FN) ships FS Dixmude, a Mistral Class Amphibious Assault Ship and FS La Fayette, a La Fayette Class Frigate, in the Arabian Sea. The partnership exercise was conducted on March 10-11.

✓ According to the Ministry of Defence, the exercise witnessed a wide spectrum of evolutions at sea which included cross-deck landings, boarding exercises and seamanship evolutions. The seamless conduct of the exercise reaffirmed the interoperability and high level of cooperation between the two navies.

Indian Army installed J&K's steep Doda district's tallest iconic national flag

✓ In the rugged Doda area of Jammu & Kashmir, the Army erected the tallest "Iconic National Banner". The highest



- tricolour in the Doda district, which has been erected on a 100-foot pole, was unfurled by Maj Gen Ajay Kumar, GOC Delta Force, Commander 9 Sector RR Brig. Samir K. Palande, DC Doda Vishesh Paul Mahajan, and SSP Abdul Qayoom.
- ✓ The raising of the nation's flag on a 100-foot pole, the first of its type in the Doda district, is a moment of pride for all of the area's citizens, not just the Army.

Indian Navy gets first-ever privately made indigenized fuze of Anti-Submarine Warfare rocket

- In what is being seen as a major success for the "Make in India" initiative in defence sector, the Indian Navy has received a fully indigenised fuze for an anti-submarine warfare (ASW) underwater rocket, manufactured for the first time by a private Indian industry. This would be the first time the Indian Navy has placed a supply order for underwater ammunition fuzes with an Indian private sector industry.
- ✓ This marks the first time that the Indian Navy has procured an underwater ammunition fuze from an Indian private manufacturer. It is a major boost for the self-reliance of the Indian defence sector. The use of simulated dynamic trial facilities during the development and manufacturing process is also a noteworthy achievement.

AWARDS AND HONOURS

Luis Caffarelli won the 2023 Abel Prize

 \checkmark Luis Caffarelli, 74, has won the 2023 Abel Prize "for his seminal contributions to regularity theory

for nonlinear partial differential equations including free-boundary problems and the Monge-Ampère equation". The prize includes a monetary



award of 7.5 million kroner (roughly \$ 720,000) and a glass plaque designed by Norwegian artist Henrik Haugan. It is awarded by The Norwegian Academy of Science and Letters, on behalf of the Ministry of Education.

About Abel Prize

The Abel Prize is an international mathematics award, often considered to be the equivalent of the Nobel Prize for mathematics. It is named after the Norwegian mathematician Niels Henrik Abel, and was first awarded in 2003 by the Norwegian Academy of Science and Letters. The prize recognizes exceptional contributions to the field of mathematics, including pure and applied mathematics, and is open to mathematicians from any country. The award comes with a monetary prize of 7.5 million Norwegian kroner (roughly \$720,000) and is presented annually in Oslo, Norway

NGO from Assam honoured with **Children's Champion Award**

Tapoban, an NGO based in Pathsala, Assam, which focuses on supporting children with special needs and autism, has been honored with the prestigious Children's Champion Award 2023 in the health and nutrition category. In 2022, the Delhi Commission for Protection of Child Rights launched the Children's Champion Award to honour people and organizations who have made significant contributions to children's education, health, nutrition, justice, sports, and artistic expression.

Kashmir's Aliya Mir honoured with Wildlife Conservation Award 2023

 \checkmark The Union Territory has awarded wildlife conservationist Aliya Mir for her exceptional

efforts in conservation. Aliya is the first woman from Jammu and Kashmir to work for Wildlife SOS and is the first



woman in the region to receive this honour. She received the award from Lt. Manoj Sinha at the World Forestry Day celebrations hosted by the Jammu and Kashmir Collective Forests. Aliya was recognized for her remarkable contributions to wildlife conservation, including rescuing and releasing wild animals, caring for injured animals, and saving bears in Kashmir.

Bombay Jayashri chosen for Sangita Kalanidhi Award 2023 by Music Academy

 \checkmark The Music Academy has announced that the



Sangita Kalanidhi award for 2023 will be presented to Bombay Jayashri, a Padma Shri awardee and renowned

- At the IBA Women's World Boxing Championship 2023, Nikhat Zareen, Lovlina Borgohain, Saweety Boora and Nitu Ghanghas flourished with their gold medals. All these four women from India took the honours in their respective bouts.
- \checkmark India shines at the 13th edition of the IBA Women's World Boxing Championship 2023 held in New Delhi. The competition concluded with 4 female winners who nailed to grab the gold medals in different categories.
- \checkmark India's leading pugilists topped the show in their sessions and with this, India made the greatest victory in the history of boxing competitions. For the second time, this ground-breaking record has been achieved as the 2006 event was also a powerful performance.
- \checkmark Now, this time it was a roaring success for the nation in the 13th edition of the Women's World Boxing Championship 2023 organised by the International Boxing Association (IBA). The tournament was scheduled between March 15 to March 26, 2023.

Nitu Ghanghas - 48 kg Category

IPL India's first unicorn with a \$1.1 billion valuation: D&P report

✓ D&P Advisory has analyzed the Indian Premier League (IPL) and reported that the cricket tournament was India's first unicorn, with a valuation of \$1.1 billion in 2008, the year it was launched. The advisory had previously announced that IPL had become a decacorn (valued at \$10.9 billion) recently. D&P Advisory is now preparing to publish a new analysis called "IPL: The Pioneer of Indian Unicorns."

- ✓ According to the report, the value of the IPL has consistently grown over the years due to the increasing fees for broadcast and sponsorships. In 2009, the league's value rose to \$1.7 billion, and in 2010 it increased even further to \$2.2 billion when it had 60 matches.
- ✓ The league's value continued to rise in 2011 when the number of matches increased to 74, reaching a valuation of \$2.7 billion.

Sergio Pérez wins Saudi Arabia Grand Prix 2023

✓ At the Saudi Arabia Grand Prix of the 2023



Formula One season, Sergio Perez displayed a dominant performance and earned his first win. His teammate at Red Bull, Max Verstappen, secured

- ✓ Prior to this, she had last played for India in the FIH Women's Hockey Pro League 2021-22 against Belgium, where she earned her 250th cap.
- ✓ After struggling with injuries since the Tokyo Olympics, the 28-year-old player was left out of both the 2022 World Cup and Commonwealth Games squads. However, she is now making a return to international hockey and has been included in the 22-member squad.

Pankaj Advani retains Asian Billiards title defeating Damani

- ✓ Pankaj Advani, the Indian cue sports champion, has retained his Asian Billiards title in the 100-up format after defeating his compatriot Brijesh Damani 5-1 in the final held at Qatar Billiards and Snooker Federation (QBSF) Academy. Advani, who has won the International Billiards and Snooker Federation (IBSF) world championship 25 times, won the match with a scoreline of 100(51)-18, 100(88)-9, 86(54)-101(75), 100-26, 100(66)-2, 101(64)-59.
- ✓ In the women's category, Bai Yulu of China defeated Panchaya Channoi from Thailand 3-0 in the final. This is Advani's eighth Asian Billiards title, and he has previously received the Arjuna Award in 2004, Major Dhyan Chand Khel Ratna in 2006, Padma Shri in 2009, and Padma Bhushan in 2018. He had won the same title in Doha last year

Former Australian test cricket captain Tim Paine announced his retirement

✓ Tim Paine, the former captain of the Australian test cricket team, has announced his retirement from cricket after playing his last Sheffield Shield first-class match for Tasmania against Queensland. Paine led the Australian team in 23 tests from 2018 to 2021 and played a total of 35 tests in his career. He took over as captain after Steve Smith was stripped of the role following the ball-tampering scandal during Australia's 2018 tour of South Africa.

Irani Cup 2022-23 final: Rest of India crowned champions

✓ In the final of the Irani Cup 2022/23, Team Rest of India secured their 30th

title win in the Indian domestic tournament. continuing their dominant performance. They



defeated Madhya Pradesh by 238 runs. Yashasvi Jaiswal, who showcased brilliant batting skills across both innings, was adjudged the Player of the Match. He smashed a double century and a century in the two innings, contributing significantly to ROI's victory.

The Irani Cup, named after the late Z. R. Irani, was introduced in 1959-60 and is a traditional five-day match played between the Ranji Trophy winners and a Rest of India team. It is considered one of the most prestigious domestic cricket tournaments in India

FIFA president Gianni Infantino reelected for another term

Gianni Infantino was re-elected as FIFA president until 2027 by acclamation, after highlighting his



strong financial performance as a reason for keeping a CEO in their position for life. The decision was

made by the congress of 211 member federations, who have seen their annual funding from FIFA increase from \$250,000 to \$2 million since Infantino's first win in 2016. Following the 2022 World Cup in Qatar, FIFA now has \$4 billion in reserves, and it conservatively predicts a record revenue of at least \$11 billion from the 2026 men's World Cup, which will be hosted in North America.

- ✓ Indian Team spinner Ravichandran Ashwin became the second fastest bowler to take 450 Test wickets in 89 matches in terms of Tests played. He has followed Sri Lankan legend Muttiah Muralitharan who achieved this landmark in 80 matches.
- ✓ Virat Kohli completed 75 centuries in his 494th international appearance in the fourth and final Test. He became the fastest player to score 75 international centuries, he achieved the feat in 552 innings.

Jaipur to get India's 2nd largest cricket stadium named after Anil Agarwal

Indian-origin Lt. Manmeet Colon becomes Connecticut's first Asian assistant police chief

✓ Lt. Manmeet Colon, who is of Indian origin and a Sikh woman officer, has recently taken up the



position of assistant police chief in the state of Connecticut, becoming the first-ever person of Asian descent to hold the position.

She has been a member of the New Haven Police Department (NHPD) for 15 years and was appointed as the city's third assistant police chief in an official ceremony.

During ceremony, the Board of Police Commissioners Evelise Chair Ribeiro acknowledged that Colon's appointment as assistant police chief marked "another glass ceiling being broken". Ribeiro also mentioned that Colon, who hails from Mumbai, is not only the second-ever female assistant chief of color but also the first Indian to hold the position.

'Ironman' Krishna Prakash becomes first person to swim from Gateway of India to Elephanta Caves

✓ As part of the 'Drowning Prevention Awareness' campaign, Indian Police Service (IPS) officer

Krishna Prakash swam from Gateway of India to Elephanta Caves, Mumbai. He completed the



expedition of 16.20 kms in just 5 hours 26 minutes and became the first person in history to do so. This is far from the first time the IPS officer broker broke records in sporting competitions. In 2017, he completed the Ironman Triathlon, one of the most challenging sports events in the world.

✓ This is a three-day event that requires the participants to complete a 3.8-kilometre swim, a 180.2-kilometer bicycle ride, and a 42.2 km run in 16–17 hours. This achievement earned Prakash the 'Iron Man' title and a mention in the World Book of Records. He was the first Indian Government

Servant, Civil Servant, and Uniformed Services Officer, including Armed Forces and Paramilitary Forces, to earn this title.

Shaliza Dhami- 1st woman to command frontline IAF combat unit

 \checkmark In the first command appointment for a woman



officer in the Indian Air Force (IAF), Group Captain Shaliza Dhami has been selected to take over the command of a frontline

combat unit in the Western sector. For the first time ever in the IAF's history, Shaliza Dhami a woman officer has been given command of a frontline combat unit – in this case, a missile squadron in the Western sector.

✓ The IAF's move comes just two months after Captain Shiva Chauhan of the Indian Army's Fire and Fury Corps became the first woman officer to be operationally deployed at the world's highest battlefield in Siachen.

Arun Subramanian becomes 1st Indian-American judge at New York Court

✓ Arun Subramanian, an attorney, has been appointed

as the first Indian American judge of the Manhattan Federal District Court in New York. The nomination of Mr. Subramanian for the United



States District Court for the Southern District of New York was first made public by US President Joe Biden in September 2022. The Senate confirmed the nomination of Subramanian by a vote of 58-37.

- \checkmark During his recent visit to India. Australian PM Anthony Albanese paid a visit to India's indigenous aircraft carrier, the Indian Naval Ship (INS) Vikrant, and was accorded a Guard of Honour on the carrier, which was commissioned into the Indian Navy in September 2022.

✓ Two-time Maha Vir Chakra (MVC) recipient Wing Commander Jag Mohan Nath (JM Nath), the Indian

Air Force (IAF) veteran who flew numerous reconnaissance sorties over Tibet and Pakistan in his Canberra aircraft in the 1962 and 1965 wars passed away in Mumbai, Maharashtra. He was born in Jaipur, Rajasthan.

unanimous vote from the 2,977-member National People's Congress (NPC). Xi will head a hand-picked party and government team tasked with steering the world's second-largest



economy through challenges at home and abroad over the next five years.

After the voting, Xi took a constitutional oath, as both the country's president and head of its military - a symbolic move to show the significance of the constitution after it was revised five years ago to scrap the presidential term limit, add Xi's political theory and emphasise the party's leadership of China.

Former Brazilian President Dilma **Rousseff named new President of BRICS New Development Bank**

The New Development Bank (NDB), which is also \checkmark known as the BRICS bank and is a multilateral

financial institution created by Brazil, Russia, India, China, and South Africa. has announced that

She was the first woman to hold the office of President in Brazil. Prior to her presidency, Rousseff served as the Chief of Staff to President Luiz Inácio Lula da Silva from 2005 to 2010.

- ✓ the Indian Institute of Technology-Delhi has been ranked among the top 50 engineering institutions in the QS World University Rankings by Subject 2023. Additionally, this year, a total of 44 programmes offered by Indian higher education institutions in various disciplines have been ranked in the top 100 globally. This represents an increase from last year's report, which saw 35 Indian programmes listed in the top 100.
- ✓ Quacquarelli Symonds (QS) has released a statement indicating that Delhi University has the highest number of entries (27) among Indian universities, followed by the Indian Institute of Technology (IIT), Bombay (25), and IIT Kharagpur (23). In the thirteenth edition of the QS World University Rankings by Subject, 66 universities from India have been ranked. Collectively, these universities have achieved 355 entries, which represents an 18.7% increase from the previous year's 299 entries.
- ✓ IIT Bombay has featured among the world's top 100 in mathematics by clinching the 92nd spot, up by 25 places
- ✓ IIT Kanpur ranks among the world's top 100 in engineering-electrical electronics (87th, up by 21 places) and in computer science information systems (96th, up by 13 places)
- ✓ IIT Kharagpur occupies the 94th spot, up by 15 places, for computer science and information systems
- ✓ IIT Madras has moved up by 50 places to come at 98th spot for mathematics.
- ✓ The universities were evaluated in five broad areas, including engineering and technology, arts and humanities, life sciences and medicine, natural science, and social sciences and management.

- ✓ Since 2012, the World Happiness Report has been released annually around March 20th as part of the International Day of Happiness celebration.
- ✓ The report ranks global happiness basis survey data from people in over 150 countries.
- \checkmark This year, the report ranked 136 countries.
- ✓ The ranking uses six key factors to measure happiness — social support, income, health, freedom, generosity, and absence of corruption.
- ✓ Besides ranking the countries, the report also looks at the state of the world in 2023.

<u>Top Performers</u>

- ✓ For the sixth year in a row, Finland has been crowned as the happiest nation, Denmark is at number two, followed by Iceland at number three.
- ✓ Unlike previous years, where the same countries tend to appear in the top 20, there's a new entrant this year Lithuania (at the 20th spot).

Worst Performers:

✓ Afghanistan was ranked as the unhappiest nation, followed by Lebanon, Sierra Leone, Zimbabwe, respectively.

- ✓ India ranks at 126th position out of 136 countries, making it one of the least happy countries in the world.
- ✓ In 2022, India ranked 136th position out of 146 countries.
- ✓ It even lags behind its neighbouring nations like Nepal (119), China (74), Bangladesh (118), Pakistan (108) Myanmar (117) and Sri Lanka (112).

Global Terrorism Index – India ranked 13th, topped by Afghanistan

✓ Afghanistan remains the country most impacted by

terrorism for the fourth consecutive year, despite attacks and deaths falling

by 75 per cent



and 58 per cent, respectively, the tenth Global Terrorism Index (GTI) report showed. India ranked 13th on the index, marking only a marginal decrease from the previous year. In spite of being among the 25 worst-hit nations on the index, Indian respondents desisted from selecting war and terrorism as the biggest threat to their daily safety.

- ✓ ndia was listed among countries with a "high" impact of terrorism and ranked 13th.
- ✓ India was among the 25 worst terror-hit countries and among 56 of the 120 nations surveyed with no respondents selecting war and terror as the biggest threat to their daily safety.
- ✓ The report lists the Communist Party of India (Maoist) as the 12th deadliest terror group in 2022.
- ✓ The Global Terrorism Index is an annual ranking produced by the Institute for Economics and Peace. As even the definition of terrorism is hotly debated, it is essential to highlight that the methodologies used to measure terrorism are also contested.
- ✓ The Global Terrorism Index ranks 163 countries on four indicators weighted over five years. These four factors are: the number of terrorist incidents per year, the number of fatalities caused by terrorists per year, the number of injuries caused by terrorists per year, and total property damage caused by terrorism per year.

✓ The GTI is based on data from the Global Terrorism Database (GTD) which is collected and collated by the National Consortium for the Study of Terrorism and Responses to Terrorism (START) at the University of Maryland.

- ✓ India's Mayurbhanj and Ladakh, which have been chosen for their endangered tigers and historic temples, as well as their adventures and cuisine, respectively, are two of the 50 locations which are featured in the TIME Magazine's list of World's Greatest Places in 2023. - ✓ As TIME Magazine revealed its list of the "World's Best Places of 2023," the Mayurbhanj region of Odisha and the Union Territory of Ladakh both made the cut.
- ✓ Although the travel industry is back in full force in 2023, it was noticed that there have been some significant changes in the way and places we visit.
- ✓ The magazine asked its global network of journalists and contributors for suggestions of locations, keeping an eye out for those offering novel and interesting experiences, in order to construct this list of the World's Best Places.


India 8th most polluted country in the world: Swiss firm IQAir Report

- ✓ According to the 'Global Air Quality' study published by the Swiss company IQAir, India fell from the fifth to the eighth most polluted nation in the world in 2022. The research shows that the PM2.5 level in the most polluted Indian cities is 53.3. The two Indian cities that made the list of the most polluted cities in the world are Bhiwadi, which is a suburb of Delhi, and Delhi, which was not far behind at 92.6. At the same time, 39 out of 50 cities in the list of most polluted cities are from India.

SIPRI report 2023: India world's largest arms importer


✓ India is still the world's largest importer of military

equipment, despite an 11% decline in arms purchases between 2013–17 and 2018–22, according to a study by the Stockholm



International Peace Research Institute (Sipri). The report is released at a time when India has intensified its efforts to become self-reliant in the defence manufacturing sector. This year's defence budget included about Rs 1 lakh crore for domestic purchases, compared to Rs 84,598 crore, Rs 70,221 crore, and Rs 51,000 crore in the three years prior.

✓ According to data published by the think tank that tracks weapons imports over a five-year period,



India had the biggest percentage of the world's arms imports in the past five years at 11%, followed by Saudi Arabia (9.6%), Oatar

(6.4%), Australia (4.7%), and China (4.7%).

- ✓ In the past five years, the US exported 40% of all military goods worldwide, followed by Russia (16%), France (11%), China (5.2%), and Germany (4.2%), according to new Sipri data. From 2013–17 and 2018–22, American armament exports increased 14% while those of Russia decreased 31%. India imported 37% fewer goods from Russia.
- ✓ According to Sipri, Ukraine was the 14th largest importer of major weaponry in 2018–2022 and the third largest in 2022.

- ✓ According to the data shared by the Ministry of Education, Bihar (61.8 %) has the lowest literacy, followed by Arunachal Pradesh (65.3 %) and Rajasthan (66.1 %). Kerala has the highest literacy rate in India at 94%, followed by Lakshadweep at 91.85% and Mizoram at 91.33%.
- ✓ The literacy rate in rural India is 67.77 per cent as compared to 84.11 per cent in urban India

India at 108th Position in Electoral Democracy Index 2023

- ✓ India has now been ranked at the 108th spot globally for electoral democracy, far behind nations like Tanzania, Bolivia, Mexico, Singapore, and even Nigeria, which comes in at a modest 91st spot by V-Dem Institute in its Electoral Democracy Report for 2023. This ranking may come as a shock to many, but it is also far below nations like Tanzania, Bolivia, Mexico, Singapore, and even India.
- ✓ India's standing on the Liberal Democracy Index (LDI) is once more appallingly low, and it even has the sad distinction of falling from 100th place in 2022 to 108th this year.
- ✓ The only other factor that might temporarily cheer democratic and patriotic Indians is the fact that Pakistan, which is next door and is currently experiencing a severe economic crisis, is only ranked two places lower, at 110.
- ✓ According to the report "Defiance in the Face of Autocratization," the current wave of autocratization affects almost every region of the world, but in the Asia-Pacific, democracy has suffered significantly, and nearly 3.5 billion people

- ✓ Mukesh Ambani, the Chairman and Managing Director (CMD) of Reliance Industries Limited (RIL), ranked 9th (globally) is the only Indian to feature in the World's top 10 billionaires list.

- China's Zhong Shanshan (YST) is now Asia's 2nd richest businessman.

City Index 2023: India Has the 5th-Highest Number of Female Billionaires Globally

- ✓ India has the fifth-highest number of female billionaires in the world, according to a new International Women's Day study report from City Index 2023, which was based on the analysis of Forbes' live billionaire tracker (March 2023).
- ✓ India is tied for 5th position with Australia and Hong Kong, with each country having 9 female billionaires.
- ✓ Savitri Jindal, an Indian politician and businesswoman, is the richest woman in India with a family fortune of USD 16.96 billion.
- ✓ The US leads the list with a total of 92 female billionaires, which is double the amount of China, which comes in second with 46. Germany ranks 3rd with 32 female billionaires, led by German

automobile heiress Susanne Klatten (USD 27.58 billion). Italy, which ranks 4th on the list, has 16 female billionaires.

WHO Global Report On Sodium Intake Reduction': Countries Must Make 'Massive Efforts' to Reduce Salt Intake

- ✓ The World Health Organization (WHO) Global Report On Sodium Intake Reduction states that nations must make "massive efforts" to get people to consume less salt, which can lower their risk of developing cancer, heart disease, and stroke.
- ✓ The WHO remarked in its first-of-its-kind global report on sodium intake reduction that the world is falling short of its global target of reducing sodium intake by 30% by 2025.
- ✓ For the first time, a Sodium Country Score is assigned to each Member State based on the level of implementation of sodium reduction policies and other measures, ranging from 1 (the lowest level) to 4 (the highest level).
- ✓ As per the report, India's Sodium intake is about 9.8 g salt/day and its Sodium Country Score was 2.

26 % of world's population does not have safe drinking water: UNESCO report

- ✓ A report presented by UNESCO at the UN 2023 Water Conference in New York reveals that a significant portion of the world's population still does not have access to safe drinking water and adequate sanitation. The report indicates that 26% of the global population lacks safe drinking water, while 46% do not have access to well-managed sanitation facilities.
- ✓ It will be the second UN Conference dedicated to water after the one held in Mar del Plata, Argentina, in 1977. UN has launched a global campaign called 'Be the Change' to mark World Water Day 2023.
- ✓ It is projected that by 2050, nearly half of the world's urban population will face water scarcity, up from one-third in 2016. India is expected to be one of the most severely affected countries in this regard.
