India's tallest Ambedkar statue

Telangana CM KCR unveiled a 125-feettall statue of Dr. B R Ambedkar on the banks of Hussainsagar, marking the latter's 132nd birth anniversary.

About India's tallest Ambedkar statue

Location: On the banks of Hussainsagar near the new Secretariat complex in Hyderabad. It is claimed to be the tallest statue in the country ever built for Dr. B R Ambedkar. Height: It has an overall height of 175 feet, including a 50 feet high circular base resembling the edifice of the Parliament of India. The statue weighs 474 tonnes.

Designers: It was designed by renowned sculptors Ram Vanji Sutar and his son Anil Ram Sutar of Ram Sutar Art Creations in Noida, Uttar Pradesh, who also designed several monumental sculptures, including the world's tallest statue — the Statue of Unity (597 feet) of Sardar Vallabhbhai Patel in Gujarat.

About Dr. B R Ambedkar

He was an Indian jurist, economist, politician, and social reformer.

Name: Bhimrao Ramji Ambedkar is popularly known as Babasaheb, meaning "respected father" in Marathi and Hindi.

Ambedkar was born into a poor low Mahar (dalit) caste, who were treated as untouchables and subjected to socio-economic discrimination. He campaigned against social discrimination toward the untouchables.

In 1930, Ambedkar launched the Kalaram Temple movement to enter Kalaram Temple.

Poona Pact: It was an agreement made in 1932 between Ambedkar and Mahatma Gandhi on the reservation of electoral seats for the depressed classes.

Architect of Constitution

He was the architect of the Constitution of India by serving as the Chairman of the Constitution Drafting Committee.

He was independent India's first law and justice minister.

Logistics Performance Index 2023

According to the World Bank's report titled Connecting to Compete 2023: Trade Logistics in an Uncertain Global Economy – the Logistics Performance Index (LPI) and its indicators" released on April 21,2023, India has climbed six places on the World Bank's Logistic Performance Index (LPI) 2023, now ranking 38th(Score 3.4) in the 139 countries Index.This is a significant improvement from its previous ranking of 44th in 2018 and 54th in 2014. India share the 38th rank with Lithuania, Portugal , Saudi Arabia, Türkiye. Singapore topped the ranking followed by Finland at second, and Denmark at third.

Note: In 2016 India ranked at the 35th position among 160 countries

✓ The LPI was reported by the World Bank every two years from 2010 to 2018 with a break in 2020 due to the COVID-19 pandemic and a restructuring of the index methodology, eventually came out in 2023. This is the 7th edition of Connecting to Compet, a report that summarize the findings from the new dataset for LPI and its component indicators.

- ✓ LPI 2023 allows for comparison across 139 countries and for the first time, LPI 2023 measures the speed of trade with indicators derived from big datasets tracking shipments..
- ✓ India's score and rank under The LPI considers 6 parameters to evaluate logistics performance: Customs (Score-3, Rank-47), Infrastructure (Score-3.2, Rank-47), International shipments (Score-3.5,Rank-22), Logistics competence and equality (Score-3.5, Rank-38), Timeliness (Score-3.6,Rank-35), Tracking and tracing (Score-3.4,Rank-41).

Policy Interventions

- ✓ <u>PM Gati Shakti Initiative</u>: In October 2021, government announced the PM Gati Shakti initiative, a National Master Plan for multimodal connectivity. This initiative aims to reduce logistics costs and boost the economy by 2024-25.
- ✓ <u>National Logistics Policy (NLP):</u> The PM launched the National Logistics Policy (NLP) in 2022 to ensure quick last-mile delivery, end transport-related challenges, save time and money for the manufacturing sector and ensure desired speed in the logistics sector. These policy interventions are fructifying, which can be seen in India's jump in LPI and its other parameters.

INTERNATIONAL AND BILATERAL

US State Officially Declares Diwali as a National Holiday

- ✓ Thousands of people across Pennsylvania, a US state, celebrate the Diwali festival and the state has now announced it as a holiday.
- ✓ Northeastern State's senator Nikil Saval posted this on Twitter and welcomes all residents to celebrate the Indian event.
- ✓ He further asserted that Diwali is a festival of lights and happiness and represents light over darkness.
 People usually spark diyas and visit temples for offerings to deities.

Syria Becomes Biggest Narco-State in the World

- ✓ It came to light that Syria's earnings are largely from Captagon hence it is now the largest narcostate in the world.
- ✓ A narco-state is one whose economy and income depend on the trading of illegitimate drugs.
- ✓ Captagon is a dangerous alternative to amphetamine and is considered an illegal drug at a global level. The cost of this drug is not much however with bribing and corruption, the range increases up to USD 14-20.

IIT Madras to set up its first international campus in Tanzania

- ✓ Chennai(Tamil Nadu) based Indian Institute of Technology (IIT) Madras is set to establish its first
- ✓ International campus in Zanzibar, Tanzania and plans to start the classes in October 2023. This will be the first IIT established in Africa.
- ✓ This will play a major role in towards growth and nation-building of Tanzania and Africa.
- ✓ In February 2023, a team of 5 professors from IIT Madras visited Tanzania and discussed with the officials about starting the campus.
- ✓ This announcement was made by Director V Kamakoti, IIT Madras, during the IIT Madras's 64th Institute Day (20 April 2023).

Ghana becomes 1st Country to Approve Oxford Malaria Vaccine

- ✓ The Republic of Ghana has become the 1st country to approve a highly effective malaria vaccine "R21/MatrixM" developed at Oxford University in the United Kingdom (UK).
- ✓ The vaccine was approved by Ghana's Food and Drug Authority (FDA).
- ✓ The R21/Matrix-M vaccine has been licenced for use in children aged 5-36 months, who are most at risk of dying from malaria.
- ✓ Oxford's R21/Matrix-M vaccine, meanwhile, was found to be 77 percent effective at preventing malaria
- ✓ This vaccine is the first to surpass the World Health Organization's (WHO) target of 75% efficacy.
- ✓ The vaccine R21 contains Matrix-M, a saponinbased adjuvant from Novavax that increases immune system response and increases the vaccination's potency and durability.
- ✓ WHO estimates that 619,000 people died from malaria in 2021, the majority of whom were children in SubSaharan Africa.

India-built Mongolia's First greenfield Oil Refinery to be completed by 2025

- ✓ Mongolia's first greenfield oil refinery, built in the South Gobi on the outskirts of the capital city -Ulaanbaatar, Mongolia, and funded with Indian assistance,will be completed by 2025.
- ✓ Its first stage of Mongol Oil Refinery, built with a USD 1.2 billion Indian soft loan, will be completed at the end 2023 while its Stage-2 (Open Art Units, Utilities & Offsites, Plant Buildings) and Stage-3 (Captive Power Plants) at a cost of USD 790 million will be completed by 2025.
- ✓ The project is part of the Development Partnership Administration initiative of the Ministry of External Affairs (MEA), Government of India.
- ✓ It is being developed by the Hyderabad (Telangana)- based Megha Engineering and

Infrastructures Limited (MEIL) which received the letter of authorization for this project in 2022.

Georgia becomes first American state to condemn Hinduphobia, passes resolution

- ✓ Georgia, United States of America(USA) passed a resolution condemning "Hinduphobia" and "anti-Hindu bigotry"- becoming the first state in the country to do so.
- ✓ The resolution was introduced by Representatives Lauren McDonald and Todd Jones from Forsyth County in the suburbs of Atlanta, home to one of the largest Hindu and Indian-American diaspora communities in Georgia.
- ✓ The resolution observed that the American-Hindu community has been a major contributor to diverse sectors such as medicine, science and engineering, information technology, hospitality, finance, academia, manufacturing, energy, retail trade, among others.

UK Becomes 12th Member of CPTPP

- ✓ On March 31, 2023, the Accession Working Group (AWG) of the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP) agreed on the accession of the United Kingdom (UK) as the 12th member of CPTPP.
- ✓ With this UK became the first European nation and the first non-founding country to join CPTPP. This will now expand the Asia-Pacific bloc's coverage to the edge of Europe.
- ✓ CPTPP is a free trade agreement (FTA) signed by 11 nations – Australia, Brunei Darussalam, Canada, Chile, Japan, Malaysia, Mexico, Peru, New Zealand, Singapore and Vietnam on 8 March 2018 in Santiago, Chile.
- ✓ Together, the 11 members account for about 13% of the world's income.
- ✓ The combined GDP of the 11 CPTPP members and the UK was worth around £ 11 trillion Pound sterling in 2021.
- ✓ UK will be the trade group's second-biggest economy after Japan.

Finland became the 31st member of NATO

- ✓ Finland became the 31st member of the North Atlantic Treaty Organization (NATO) on April 4, 2023, when it presented its instrument of accession to the 'North Atlantic Treaty' (Washington Treaty) with the United States (US) at NATO Headquarters in Brussels, Belgium.
- ✓ The accession of Finland coincides with the 74th anniversary of the signing of NATO's founding treaty i.e. the 'Washington Treaty'(which was signed on April 4, 1949).
- ✓ The accession is commemorated by a flag-raising ceremony at NATO headquarters and it also coincided with a NATO foreign ministers' meeting. On July 5, 2022, NATO Allies signed Finland's Accession Protocol, following which all 30 national parliaments voted to confirm the country's membership.

About NATO

The North Atlantic Treaty Organization (NATO) also called the North Atlantic Alliance, is an intergovernmental military alliance between 31 member states – 29 European and two North American. Established in the aftermath of World War II, the organization implemented the North Atlantic Treaty, signed in Washington, D.C., on 4 April 1949.

✓ NATO Secretary General: Jens Stoltenberg

EU removes Pakistan from list of high-risk third-country jurisdictions

- ✓ The European Commission of the European Union(EU) has removed Pakistan from its list of High-Risk ThirdCountry Jurisdictions, this move is expected to improve the conditions of business activities in Pakistan.
- ✓ Following the deletion, Pakistan will no longer be subjected to enhanced EU scrutiny which includes credit and financial institutions, auditors, external accountants, tax advisers, notaries and independent legal professionals, among others.

NATIONAL

Union Cabinet approves National Quantum Mission to scale-up Scientific & Industrial R&D for QT

✓ The Union Cabinet has approved the National Quantum Mission (NQM) with an outlay of

Rs.6003.65 crore for 8 years (from 2023-24 to 2030-31). With this, India will join the top 6 nations (the United States of



America (USA), Canada, China, France, Austria, and Finland who are involved in the R&D in the QT.

<u>Aim</u>

- ✓ To seed, nurture and scale up scientific and industrial Research and Development (R&D)
- ✓ To create a vibrant & innovative ecosystem in QT
- ✓ To make India one of the leading nations in the development of Quantum Technologies & Applications (QTA)

Target of Mission

- ✓ To develop intermediate scale quantum computers with 50-1000 physical qubits in 8 years in various platforms like superconducting and photonic technology.
- ✓ To develop satellite based secure quantum communications between ground stations over a range of 2000 kilometres within India, long distance secure quantum communications with other countries, inter-city quantum key distribution over 2000 km, and multi-node Quantum network with quantum memories, among others.

Who will run the mission?

- ✓ The mission will be led by the Department of Science & Technology (DST), Ministry of Science and Technology (MoST) under a Mission Director.
- ✓ The Central Government will also constitute a mission secretariat which will have a governing body to steer the work under the leadership of scientists from the quantum field. iii.The Mission

Technology Research Council will work as a scientific advisory body for the governing body.

- ✓ <u>Mission Insights:</u>Under this mission, four Thematic Hubs (T-Hubs) will be set up in top academic and National R&D institutes on the domains − Quantum Computing, Quantum Communication, Quantum Sensing & Metrology and Quantum Materials & Devices.
- ✓ The hubs which will focus on generation of new knowledge through basic and applied research and promote R&D.
- The mission will help in the development of atomic-based magnetometers and atomic clocks, which can improve precision in timing, navigation, and communication.
- ✓ It will also support the design and production of quantum materials, such as superconductors, semiconductor structures, and topological materials, for use in quantum devices.
- ✓ The development of single photon and entangled photon sources/detectors will also be prioritized to advance quantum communication, sensing, and metrology.
- ✓ The mission has the potential to significantly benefit communication, health, financial and energy sectors as well as drug design, and space applications.
- ✓ It will provide a boost to National priorities like digital India, Make in India, Skill India and Standup India, Start-up India, Self-reliant India and Sustainable Development Goals (SDG).

What is Quantum technology (QT)?

✓ It is a field of physics and engineering that utilizes quantum phenomena to create new types of technology and devices. It involves the manipulation and control of the behavior of particles at the atomic and subatomic level. Quantum computers are work on atoms by using quantum bits (qubits) instead of classical bits to perform calculations. It can solve problems much faster with more authenticity, and also offers unique security.

PM Modi inaugurated India's First Water Metro in Kerala

✓ The Prime Minster has recently inaugurated the first

phase of Kochi Water Metro in Kerala – first-ever metro system of its kind. It's a public boat service integrated with the



metro rail network. The project is being implemented by Kochi Metro Rail Corporation with the financial assistance provided by a German funding agency.

- ✓ The main objective is to link ten island communities in Kerala's city with the mainland, resulting in shorter travel times and more costeffective transportation.
- ✓ Moreover, Kochi Water Metro is a modern ferry transport project consisting of numerous boats running along 16 routes across Greater Kochi. Equipped with cutting-edge safety devices and advanced technology, the ferry ensures smoother commutes and more efficient travel experiences. The boats in the Kochi Water Metro are powered by batteries and require only 10 to 20 minutes to traverse each route.

Ministry of Civil Aviation launched the fifth round of the Regional Connectivity Scheme UDAN 5.0

- ✓ Recently, the government has launched the fifth round of the Regional Connectivity Scheme – UDAN (UDAN 5.0).
- ✓ The scheme was launched by the Ministry of Civil Aviation for regional airport development and regional connectivity enhancement. It is a part of the National Civil Aviation Policy 2016. The scheme is applicable for a period of 10 years.
- ✓ Under the scheme, airlines have to cap airfares for 50% of the total seats at Rs. 2,500 per hour of flight.

Objectives:

 Improve the air connectivity to remote and regional areas of India.

- ✓ Development of remote areas and enhancing trade and commerce and tourism expansion.
- ✓ Enable common people to access air travel with affordable rates.
- ✓ Employment creation in the aviation sector.
 Key Features of UDAN 5.0:
- ✓ It focuses on Category-2 (20-80 seats) and Category-3 (>80 seats) aircrafts.
- ✓ There is no restriction on the distance between the origin and the destination of the flight.
- ✓ VGF to be provided will be capped at 600 km stage length for both Priority and Non-Priority areas; earlier capped at 500 km.
- ✓ No predetermined routes would be offered; only Network and Individual Route Proposal proposed by airlines will be considered.
- ✓ The same route would not be awarded to a single airline more than once, whether in different networks or in the same network.
- ✓ Exclusivity of operation provided to an airline will be withdrawn if the average quarterly Passenger Load Factor (PLF) is higher than 75% for four continuous quarters.
- ✓ This has been done to prevent exploitation of the monopoly on a route.
- ✓ Airlines would be required to commence operations within 4 months of the award of the route; earlier this deadline was 6 months.
- Novation process for routes from one operator to another has been simplified and incentivized.
- Previous Phases of the UDAN Scheme:
- ✓ <u>Phase 1</u> was launched in 2017, with the objective of connecting underserved and unserved airports in the country.
- ✓ <u>Phase 2</u> was launched in 2018, with the aim of expanding air connectivity to more remote and inaccessible parts of the country.
- ✓ <u>Phase 3</u> was launched in November 2018, with the focus on enhancing air connectivity to hilly and remote regions of the country.
- ✓ <u>Phase 4</u> of the UDAN scheme was launched in December 2019, with a focus on connecting islands and other remote areas of the country.

Global Buddhist Summit 2023

Recently, the Ministry of Culture in partnership with International Buddhist Confederation (IBC)

has organized the 1st Global **Buddhist** Summit 2023in New Delhi, which aims to enhance cultural and diplomatic relations with other countries.



Buddhist monks from various countries took part in the two-day

Summit, which was held in New Delhi from 20 to 21 April 2023.

- \checkmark Eminent scholars, Sangha leaders and Dharma practitioners from all over the world attended the conference. There are 173 international participants comprising 84 Sangha member and 151 Indian delegates comprising 46 Sangha members, 40 nuns and 65 laity from outside Delhi.
- ✓ **Theme:** Responses to Contemporary Challenges: Philosophy to Praxis.

Sub Themes:

- Buddha Dhamma and Peace
- \checkmark Buddha Dhamma: Environmental Crisis, Health and Sustainability
- Preservation of Nalanda Buddhist Tradition
- \checkmark Buddha Dhamma Pilgrimage, Living heritage and Buddha Relics: a resilient foundation to India's centuries-old cultural links to countries in South, Southeast and East Asia.

About IBC

- \checkmark IBC is the biggest religious Buddhist confederation. The purpose of this body is to create a role for Buddhism on the global stage so as to help to preserve heritage, share knowledge, and promote values and to represent a united front for Buddhism to enjoy meaningful participation in the global discourse.
- In November 2011, New Delhi was host to Global Buddhist Congregation (GBC), where the attendees unanimously adopted a resolution to form an international umbrella body - the International Buddhist Confederation (IBC).

The Ministry of Jal Shakti released first-ever census of water bodies

✓ The Ministry of Jal Shakti recently released the report of its first-ever census of water bodies, revealing crucial insights into the country's water resources.

No encroachment on waterbodies was reported from West Bengal, Sikkim, Arunachal Pradesh and Chandigarh

- The census provides an extensive inventory of water sources in India, highlighting disparities between rural and urban areas and varying levels of encroachment.
- \checkmark The census enumerated a total of 24,24,540 water bodies across the country, with West Bengal accounting for the most (7.47 lakh) and Sikkim the least (134).

The report reveals that:

- \checkmark West Bengal has the highest number of ponds and reservoirs. The top district in terms of waterbodies is South 24 Parganas in West Bengal.
- \checkmark Andhra Pradesh has the highest number of tanks Tamil Nadu has the highest number of lakes

- ✓ Maharashtra leads in water conservation schemes The report highlights that 97.1% of the waterbodies are in rural areas, with only 2.9% in urban areas.
- ✓ Most of the waterbodies are ponds, followed by tanks, reservoirs, water conservation schemes, percolation tanks, check dams, lakes, and others.
- ✓ The census also collected data on the encroachment of waterbodies for the first time, revealing that 1.6% of all enumerated waterbodies are encroached, with 95.4% of encroachments in rural areas and the remaining 4.6% in urban areas.
- ✓ A significant percentage of encroachments cover more than 75% of the waterbody's area.

About Waterbodies

- The census of waterbodies was conducted in conjunction with the 6th Minor Irrigation Census for 2017-18.
- ✓ It defines a waterbody as "all-natural or man-made units bounded on all sides with some or no masonry work used for storing water for irrigation or other purposes."
- ✓ The census aimed to provide an inventory of India's water resources, including natural and man-made water bodies like ponds, tanks, lakes, and more, and to collect data on the encroachment of water bodies.

Union Ministry of Rural Development's DAY-NRLM launched a national campaign called "Sangathan Se Samridhhi

Livelihoods Mission (DAY-NRLM) launched a national campaign called "Sangathan Se Samridhhi– Leaving



no Rural Woman Behind", aiming to mobilize a significant number of women into Self Help Groups (SHGs).

✓ The campaign is a part of the Azadi Ka Amrit Mahotsav Samaveshi Vikaas and aims to mobilize 10 crore women from eligible rural households into SHGs.

- ✓ It aims to mobilize disadvantaged rural communities who are unaware of the benefits of the DAY-NRLM program.
- ✓ The campaign will be organized in all states and form more than 1.1 lakh SHGs through interventions like:
- ✓ Organising general Body Meetings of Village Organizations
- Experience sharing by SHG champions to motivate left-out households to join SHGs
- ✓ Conducting Community Resource Person drives
- ✓ Opening SHG bank accounts, and creation of a common database of SHGs promoted by other stakeholders.

About DAY-NRLM

- ✓ It is a Centrally Sponsored Programme, launched by the Ministry of Rural Development in 2011.
- ✓ It aims to eliminate rural poverty through the promotion of multiple livelihoods and improved access to financial services for the rural poor households across the country.

Functioning

✓ It involves working with community institutions through community professionals in the spirit of self-help which is a unique proposition of DAY-NRLM.

It impacts livelihoods by

- ✓ Mobilizing rural households into SHGs.
- Organizing one-woman member from each rural poor household into SHGs
- ✓ Providing training and capacity building to SHG members
- ✓ Providing access to financial resources from their own institutions and banks.

and improve overall health outcomes. The project will be implemented as a pilot scheme to demonstrate best practices for food businesses. This initiative will not only support the "eat right campaign" and food safety but also enhance the credibility of local food businesses. The project's benefits include creating employment opportunities, improving tourism potential, and boosting the economy.

✓ The initiative will be implemented through the National Health Mission (NHM) in convergence with the MoHUA and with technical support from the Food Safety and Standards Authority of India (FSSAI). States and Union Territories will receive financial assistance of ₹1 crore per food street/district, with assistance under the NHM provided in the ratio of 60:40 or 90:10, subject to standard branding according to FSSAI guidelines.

NHAI plan to develop around 10,000 km of OFC infrastructure across the country by the fiscal year 2025

- ✓ The National Highways Authority of India (NHAI)
 - has announced its plan to develop around 10,000 km of Optic Fibre Cable (OFC) infrastructure



across the country by the fiscal year 2025.

- ✓ NHAI's plan aligns with United Nations' Sustainable Development Goals (SDGs) targets, which aim at providing access to safe, affordable, accessible, and sustainable transport systems for all by 2030.
- ✓ The OFC network will be developed by the National Highways Logistics Management Limited (NHLML), a fully owned special purpose vehicle (SPV) of NHAI.

About OFC

- ✓ Fiber-optic cables are like tubes that hold tiny wires made of glass or plastic. They use light to send information much faster than regular wires that use electricity.
- ✓ Metal wires are preferred for transmission in optical fibre communication as signals travel with less damage.

- The optical fiber works on the principle of Total Internal Reflection (TIR).
- ✓ TIR is the complete reflection of a ray of light within a medium such as water or glass from the surrounding surfaces back into the medium.
- ✓ Light rays can be used to transmit a huge amount of data (In case of long straight wire without any bend).In case of a bend,the optical cables are designed such that they bend all the light rays inwards (using TIR).

The Union Agriculture and Farmers Welfare Minister Narendra Singh Tomar launched the SATHI Portal and Mobile App

✓ The Union Agriculture and Farmers Welfare (MoA & FW) Minister of India has launched the SATHI

(Seed Traceability, Authentication and Holistic Inventory) Portal and Mobile App to address the challenges in seed



production, quality seed identification, and seed certification. The system has been developed by the National Informatics Centre (NIC) in collaboration with MoA & FW with the theme of 'Uttam Beej – Samriddh Kisan'.

- The SATHI portal is a significant step to address the challenges in the agriculture sector and will prove to be a revolutionary step in agriculture when it is used at the grassroots level. This portal will ensure the quality assurance system, identify the source of seed in the seed production chain, and trace the seeds through a QR code.
- ✓ The system will have integrated seven verticals of the seed chain - Research Organization, Seed Certification, Seed Licensing, Seed Catalogue, Dealer to Farmer Sales, Farmer Registration, and Seed DBT. Only seeds with valid certification can be sold by valid licensed dealers to centrally registered farmers, who will receive subsidy through DBT directly into their pre-validated bank accounts.

- ✓ It also highlighted that health-tech is the most significant aspect of the Fourth Industrial Revolution and taking pre-emptive steps remains the key.

✓ The University Grants Commission has announced the implementation of the National Credit

Framework (NCrF) for all regulatory organisatio ns and universities in India.



✓ This framework is designed to integrate the credits earned through school education, higher education,

vocational, and skill education, and provide lifelong learning opportunities.


- ✓ According to the framework, an academic year will be defined by the number of hours a student puts in and credits will be provided to them accordingly at the end of each academic year.
- ✓ NCrF is a meta-framework that consists of three verticals:
- ✓ National School Education Qualification Framework (NSEQF)
- ✓ National Higher Education Qualification Framework (NHEQF), and
- National Skills Qualification Framework (NSQF).
 Credit System
- ✓ The total 'Notional Learning hours in a year' for assignment of Credits will be 1200 hours. A minimum of 40 credits may be earned for 1200 hours of learning every year with 20 credits per semester of six months
- ✓ Notional hours refer to the time that the average student would need to attend all classes, study for tests and do assignments and homework.
- ✓ The total credits earned by a student during the entire schooling period will be 160 credits.
- ✓ By the end of a three-year bachelor's degree course, the student will have earned 120 credits.
- ✓ When a student completes a Ph.D., the earned credits would be 320.
- Students will also get credits for participating in Olympiads, science quizzes, internships, and taking up jobs while they are studying in college.

Credit Levels

- ✓ The NCrF has proposed several levels within this framework ranging from level 1 to level 8.
- ✓ The credit level that can be attained after completion of school education, i.e., grade 5th will be level 1, grade 8th will be level 2, grade 10th will be level 3, and grade 12th will be level 4.
- ✓ Higher education shall be from credit levels of 4.5 to level 8.
- ✓ The NCrF credit levels for school education are upto level 4, while for higher education
- ✓ For vocational education & training level 1 to level 8.

PM Modi released 5th cycle of India's Tiger Census 2022

✓ The Prime Minister of India has released the figures of the 5th cycle of India's Tiger Census 2022, revealing 6.7% in the increase in the past four years.



- ✓ The tiger census covered forested habitats in 20 states of India. Camera traps were set up at 32,588 locations and generated 47,081,881 photographs.
- ✓ The PM has released the Census while inaugurating the International Big Cat Alliance (IBC) in Karnataka's Mysuru, organised to mark 50 years of Project Tiger.

Population

✓ Population has grown by 200 from 2018 to 2022. The current tiger population in India is 3,167, up from 2,967 in 2018.

Growth Rate

✓ The growth rate slowed to 6.7% in the four years from 2018 to 2022, from around 33% during 2014-2018.

<u>Increase</u>

- ✓ There has been a significant increase in the tiger population in the Shivalik Hills and Gangetic Plains, while tiger occupancy in Jharkhand, Odisha, Chhattisgarh, and Telangana showed a decline.
- ✓ The North East Hills and Brahmaputra Plains had 194 tigers captured by camera traps, and the region's Nilgiri cluster is the largest tiger population in the world, contributing significantly to colonisation of tigers in neighbouring areas. <u>Decline</u>

✓ Tiger occupancy in the Western Ghats declined, the latest analysis showed. Significant declines were observed in the Wayanad landscape and in the Biligiriranga Hills.

High Conservation Priority

- ✓ The genetically unique and small population of tigers in Simlipal is also highlighted as being of high conservation priority.
- ✓ The report calls for ecologically viable economic development and trans-boundary tiger conservation strategies to sustain isolated populations.
- ✓ Tiger Census in India
- ✓ The national tiger census is done every four years by the National Tiger Conservation Authority (NTCA) in partnership with state forest departments, conservation NGOs, and the Wildlife Institute of India (WII). The census uses a double sampling method based on ground-based surveys and images from camera-traps.

<u>Traditionally eight subspecies of tigers have been</u> recognized, out of which three are extinct.

- ✓ Bengal Tigers: Indian Subcontinent
- ✓ Caspian tiger: Turkey through central and west Asia (extinct).
- ✓ Amur tiger: Amur Rivers region of Russia and China, and North Korea
- ✓ Javan tiger: Java, Indonesia (extinct).

- ✓ Bali tiger: Bali, Indonesia (extinct).
- ✓ Sumatran tiger: Sumatra, Indonesia.
- ✓ Indo-Chinese tiger: Continental south-east Asia.

- ✓ International Union for Conservation of Nature (IUCN) Red List: Endangered.

- \checkmark It will also disseminate information and create awareness among its members.

Union Minister Sonowal launches 'SAGAR-SETU' app

- ✓ The Union Minister for Ports, Shipping and Waterways Sarbananda Sonowal recently launched the App Version of National Logistics Portal (Marine) - 'Sagar-Setu'.
- \checkmark The mobile app will ensure data mobility such that approvals & monitoring shall be at the fingertips of port & ministry officials and stakeholders as well.
- ✓ National Logistics Portal (Marine) is a national maritime single window platform encompassing complete end-to-end logistics solutions to help importers, and service providers exporters, exchange documents seamlessly and transact business. The overarching NLP Marine Vision is to cater to various stakeholders in Government to

Government (G2G), Government to Business (G2B) and Business-to-business (B2B) model.

India UN **Statistical** elected to **Commission for four-vear period**

India has been elected to the UN Statistical Commission for a fouryear period (beginning on 1 January 2024) in a competitive election. The Commission works under



the United Nations Economic and Social Council (ECOSOC).

- ✓ The UN Statistical Commission, established in 1947, is the highest body of the global statistical system bringing together the Chief Statisticians from member states from around the world. It is the highest decision-making body for international activities, responsible statistical for setting statistical standards and the development of concepts and methods. including their implementation at the national and international levels.
- The Commission consists of 24 member countries (Five members are from African States, four from Asia-Pacific States, four from Eastern European States, four from Latin American and Caribbean States and seven members from Western European and other States) of the United Nations elected by the ECOSOC on the basis of equitable geographical distribution. India has been elected to the Economic and Social Council, one of the six main organs of the United Nations, for the 2022-24 term.

Cabinet gives nod to Indian Space Policy, 2023

- ✓ The Cabinet Committee on Security (CCS) chaired by the Prime Minister (PM) Narendra Modi has approved the Indian Space Policy 2023 that will enable the private sector to participate in various space activities, such as constructing satellites, rockets, and launch vehicles, as well as collecting and sharing data.
- \checkmark It's aim to boost India's space department's role and give a larger participation to research, academia, startups, and industry.

- ✓ This policy delineated the roles and responsibilities of Indian Space Research Organisation (ISRO), space sector PSU (Public Sector Undertaking) NewSpace India Limited (NSIL), and Indian National Space Promotion and Authorization Center (IN-SPACe).
- ✓ NSIL will carry out strategic activities related to the space sector i.e. operational part of ISRO's missions will be moved to NSIL.
- ✓ The INSPACe will be the interface between ISRO and non-governmental entities.
- ✓ ISRO will not do any operational and production work for the space sector and will focus on developing new technologies, new systems and research and development.
- ✓ The policy also create a framework for the private sector to use ISRO facilities for a small charge and encourages them to invest in creating new infrastructure for the sector.
- ✓ Currently, India's share in the global space economy is below 2%, but the space policy is expected to significantly boost it to 10% in the future.
- ✓ The policy will establish a strong foundation for private sector companies and startups to provide a variety of space-based services, including launching satellites and offering convenient services to citizens to enhance their quality of life.

Cabinet clears National Medical Devices Policy 2023

- ✓ On 26th April 2023, The Union Cabinet chaired by Prime Minister (PM) Narendra Modi approved the National Medical Devices Policy, 2023, which is expected to help the Medical Devices sector expand to USD 50 billion(~Rs 4 lakh crore) by 2030.
- ✓ In 2020, the market size of the medical devices sector in India is estimated to be USD 11 billion (~Rs 90,000 crore) and its share in the global medical device market is estimated to be 1.5%.

About the National Medical Devices Policy 2023

✓ <u>Vision</u>: The policy envisions India's accelerated growth path with a patient-centric approach and emerging as the global leader in the manufacturing and innovation of medical devices by achieving 10-

12% share in the expanding global market over the next 25 years.

✓ <u>Mission</u>: The policy provides a roadmap for the growth in the sector to achieve the following missions: Access & Universality, Affordability, Quality, Patient Centred & Quality Care, Preventive & Promotive Health, Security, Research and Innovation and Skilled manpower.

Strategies to Promote the Sector

✓ The policy will facilitate and guide the sector through a set of strategies that will cover six broad areas viz. regulatory streamlining, enabling infrastructure, facilitating R&D (Research and Development) and innovation, attracting investments, human resources development and brand positioning & awareness creation.

Reason behind this Policy

✓ Currently about 75-80% of medical devices are imported in India and with this scheme the government will enhance India's manufacturing capacity. It will also cater to the growing demand for affordable quality medical devices.

Cabinet approved to set up 157 nursing colleges

- ✓ The Cabinet Committee on Economic Affairs (CCEA) approved the establishment of 157 new nursing colleges in co-location with existing medical colleges established since 2014. The outlay for the same will be Rs 1,570 crore.
- ✓ Uttar Pradesh (UP) will have the maximum number of colleges (27), while Rajasthan will have 23 and Madhya Pradesh, 14.
- ✓ The move will add approximately 15,700 nursing graduates every year and will further ensure quality, affordable and equitable nursing education in India.
- ✓ The decision will remove the geographical and rural-urban imbalance in terms of nursing colleges as 40% of the existing colleges are in southern India.
- ✓ This is also being done as a part of the national mandate for Universal Health Care (UHC) and will help in attainment of Sustainable Development Goals (SDG)

PM Modi to release Rs 100 coin to Commemorate 100 episodes of Mann Ki Baat

✓ On 21st April 2023, the Ministry of Finance announced that the Government will release a new

commemorative coin of Rs 100 denomination on 30th April 2023, for the 100th episode of Prime Minister Narendra



Modi's radio show Mann Ki Baat.

- ✓ The coin's obverse side will have the Lion Capital of Ashoka Pillar at the centre with "Satyamev Jayate" inscribed below it. "Bharat" in Devanagari script and "INDIA" in English will be inscribed on the left and right peripherals, respectively. The coin will also feature the Rupee symbol "₹" and "100" denomination.
- ✓ On the reverse side, the logo for the 100th Episode of Mann Ki Baat will be displayed, featuring a microphone with sound waves and the year "2023" inscribed on it. "Mann Ki Baat 100" will be written above and below the microphone image in Devanagari and English.
- ✓ On October 3, 2014, PM Modi made his radio debut with "Maan Ki Baat"

Union Minister Amit Shah Launches World's 1st 'Nano DAP' Developed by IFFCO

- ✓ On April 26, 2023, Union Minister Amit Shah, Ministry of Home Affairs and Ministry of Cooperation, launched "IFFCO Nano DAP(liquid)", the world's first liquid Nano DAP(Diammonium phosphate), developed by Indian Farmers Fertiliser Cooperative Limited (IFFCO) at NewDelhi, Delhi
- ✓ The launch of IFFCO Nano DAP (Liquid), a nano fertiliser product containing nitrogen and phosphorus is intended to make India self-reliant in the field of food production and fertilizers.
- ✓ <u>Background</u>: On March 3, 2023, the Ministry of Agriculture & Farmers Welfare (MoA&FW) approved the launch of IFFCO's nano DAP fertilizer in the market.

What is Liquid DAP?

- ✓ DAP is a concentrated phosphate-based fertilizer. Phosphorus is an essential nutrient along with Nitrogen and plays a vital role in the development of new plant tissues. It fulfills the crops initial requirement of nitrogen and phosphorous. Liquid DAP contains 8% nitrogen and 16% phosphorous.
- ✓ The launch of Nano DAP is a second initiative of IFFCO, i.e. in 2021, IFFCO introduced World's First 'Nano Urea'.

Union Minister Bhupender Yadav Launches New Features in Eshram Portal for Unorganised Workers

- ✓ On 24, April 2023, the Union Minister for Labour & Employment and Environment, Forest and Climate Change, Bhupender Yadav, launched new features in eShram Portal to improve the utility of the portal and facilitate ease of registration for unorganised workers.
- The new version also has a Data Sharing Portal (DSP) and a Data Analytics Portal.

<u>New Features:</u>

- ✓ The portal was added with a feature of capturing family details of migrant worker which will be supportive in providing Child education and women-centric schemes to the migrant workers who have migrated with family.
- ✓ Feature for sharing data of construction workers who are registering on eShram with the concerned Building and Other Construction Workers' (BOCW) Welfare Board, has been added to ensure registration of eShram construction workers with the respective BOCW board and access to the schemes.
- ✓ <u>Purpose</u>: The new feature will enable the eShram registered workers to connect with Employment opportunities, Skilling, Apprenticeship, Pension Scheme, Digital Skilling and States' schemes through eShram portal.

MSME Minister launches Revamped CGTMSE Scheme

- ✓ As part of the government's commitment to enhancing FM connectivity in the country, 91 new 100W FM transmitters were installed and the new expansion focuses on enhancing coverage.

PM Inaugurated 'Commemoration of 50 years of Project Tiger

✓ On April, 9, 2023, the Prime Minister Narendra Modi inaugurated the program 'Commemoration of 50 years of Project Tiger'at Mysuru University in Mysuru, Karnataka, the first of its kind in India, organised to mark 50 years of Project Tiger.

Other Major Initiatives

- ✓ The PM launched the International Big Cats Alliance (IBCA) for the conservation of 7 major big cats.
- ✓ He released the publications 'Amrit Kaal Ka Vision For Tiger Conservation', a summary report of the 5th cycle of Management Effectiveness Evaluation of Tiger Reserves, declared tiger numbers and released the summary report of All India Tiger Estimation (5th cycle).
- ✓ He also released a commemorative coin on the completion of 50 years of Project Tiger.
- ✓ The Government of India (GoI) launched the "Project Tiger" in 1973 for conserving the national animal, the tiger (Panthera tigris). Thus 2023 marks the 50th year of Project Tiger.
- ✓ From 9 tiger reserves since its formative years, the Project Tiger coverage has increased to 51 at present, spread out in 18 of tiger range states. This amounts to around 2.23% of the geographical area of India.
- ✓ The PM launched the International Big Cats Alliance (IBCA) for the conservation of seven major big cats – tiger, lion, leopard, snow leopard, puma, jaguar and cheetah in collaboration with 97 countries which contain the natural habitat of these big cat species.

India's 1st underwater Metro starts trial run under the bed of Hooghly

- ✓ Kolkata Metro Rail Corporation Limited (KMRCL) successfully conducted the trial run of India's 1st underwater metro train under the river bed of Hoogly through a tunnel of 32 meters below water level.
- ✓ The trial runs of the metro from Howrah Maidan to Esplanade will be conducted for the next 7 months and after that regular services on this stretch will begin.
- ✓ The commercial services on this stretch are expected to begin in 2023.Two Metro rakes were involved in the trial run along the 4.8 km underground section from Howrah Maidan to Esplanade. This Metro is expected to cover the 520metre stretch under the river Hooghly in a span of 45 seconds.

Himachal **Pradesh's** Kangra tea gets European GI Tag

✓ On 29th March 2023, Himachal Pradesh's Kangra Tea got a European Union (EU) Geographical

Indication Tag (GI Tag). This will offer an opportunity for the Kangra tea to enter the European Market.



- \checkmark Kangra tea is a type of tea that is grown in the Himachal Pradesh region of India. Since 1999, the cultivation and development of kangra tea have been improved in the Kangra region('Valley of Gods') of Himachal Pradesh.
- ✓ Kangra tea is grown 900-1,400 meters above sea level with the annual rainfall being 270-350 centimeters (cm), on the slopes of the Dhauladhar mountain range in the Western Himalayas.
- \checkmark The demand of Kangra tea has been increasing and it is being exported to Kabul and Central Asia via Peshawar.
- The Kangra tea received the Indian GI tag in 2005.
- \checkmark Geographical indications (GIs) are Intellectual Property (IP) Rights(IPR) is primarily an agricultural, natural or manufactured product (handicraft and industrial goods) originating from a definite geographical territory.
- ✓ European GI tag protects agricultural products and foodstuffs; spirit drinks; wines; and aromatized wines.
- The GI Tag provides assurance of quality and distinctiveness, which is essentially attributable to the place of its origin.
- \checkmark Once a product gets a GI tag, any person or company cannot sell a similar item under that name.
- \checkmark This tag is valid for a period of 10 years following which it can be renewed.

Kiren Rijiju releases 1st Edition of **Dogri version of** Constitution of India

✓ Union Minister Kiren Rijiju, Ministry of Law and Justice (MoL&J), released the 1st edition of the Dogri version of the Constitution of India at the University of Jammu, Jammu and Kashmir (J&K).

- Kiren Rijiju described the translated document as very important in providing justice to the common people.
- \checkmark According to Kiren Rijiju, it is necessary to understand the law and it cannot be done better than organising it in one's mother tongue. Dogri is an Indo-Aryan language spoken in the Jammu region of J&K and is one of the 22 official languages recognized by the Indian Constitution.

NCRTC names India's first semi high-speed Regional Rail Services as 'RAPIDX'

National Capital Region Transport Corporation (NCRTC) has named India's first semi high-speed

Regional Rapid Transit System (RRTS) as RAPIDX as it is easy to read and simple to



pronounce in various languages.

- \checkmark It also signifies speed and progress, the 'X' denotes the next generation technology and the new-age mobility solution.

✓ On 26th April 2023, Union Minister Nirmala Sitharaman, Ministry

of Finance (MoF), approved the upgradation of Rail Vikas Nigam Limited (RVNL) to a



Navratna Central Public Sector Enterprise (CPSE) from a Category-I MiniRatna CPSE.

- ✓ According to the Department of Public Enterprises (DPE), RVNL, a public sector undertaking under the Ministry of Railways (MoR), has become the 13th Navratna amongst CPSEs.
- ✓ On 20th April 2023, RVNL incorporated a subsidiary company named Kinet Railway Solutions Limited.
- ✓ The Government introduced the Navratna scheme, in 1977, to identify CPSEs with comparative advantages and encourage them in their drive to become global giants.

Criteria for Navratna CPSE

- ✓ The eligibility criteria required for a Central Public Sector Enterprises to get the Navratna status are as follows,
- ✓ The company should be listed on Schedule A of CPSEs and have Miniratna Category I status.
- ✓ Out of the last five years, the company should have obtained the rating as Excellent or Very Good under the Memorandum of Understanding system for three years.
- ✓ Moreover, the company must get a score of 60 out of 100 in parameters like net worth, net profit, total
- ✓ production cost, manpower cost, service cost, capital employed, and PBDIT (Profit Before Depreciation, Interest and Taxes).
- ✓ The company should have 4 independent directors on its Board of Directors.

The other 12 Navratna CPSEs of India are

- ✓ Bharat Electronics Limited, Container Corporation of India Limited, Engineers India Limited, Hindustan Aeronautics Limited, Mahanagar Telephone Nigam Limited, National Aluminium Company Limited, National Buildings Construction Corporation Limited, Neyveli Lignite Corporation Limited, NMDC Limited, Oil India Limited, Rashtriya Ispat Nigam Limited, and Shipping Corporation of India Limited.
- ✓ India has 12 Maharatna, 13 Navratna, and 74 Miniratna CPSEs.

Gol Announces Plans to Add 250 GW of RE Capacity over the Next 5 Years

- ✓ The Government of India (GoI) has announced a plan to install 250 gigawatts (GW) of renewable energy (RE) capacity over the next 5 years in order to meet its target of 500 GW of clean energy by 2030.
- ✓ The GoI has chosen to invite bids for 50 GW of RE capacity annually for the next 5 years, from Fiscal Year 2023-24 (FY24) to Fiscal Year 2027-28 (FY28).
- ✓ The installation of wind power capacity of at least 10 GW annually will also be included in these annual bids for RE capacity connected to the ISTS (Inter-State Transmission System).

Gol's target to achieve 20% ethanol blending in petrol advanced from 2030 to 2025-26

- ✓ On April 18, 2023, the Government of India (GoI) advanced its target to achieve 20 percent ethanol blending in petrol from 2030 to 2025-26.
- ✓ While addressing the Global CBG (Compressed BioGas) Conference of the Indian Federation of Green Energy (IFGE) – CBG Producers Forum, Union Minister, Hardeep Singh Puri, Ministry of

✓ The GoI has set a target to increase the share of gas in the energy mix up to 15 per cent in 2030 to make India a Gas based economy.

IGGL completes Asia's largest underwater hydrocarbon pipeline

- ✓ On 22nd April 2023, Mr. Ajit Kumar Thakur, CEO of Indradhanush Gas Grid Limited (IGGL), announced that the company has completed the construction of Asia's largest underwater hydrocarbon pipeline.
- ✓ This pipeline, with a diameter of 24 inches, has been laid below the Brahmaputra river, connecting Jorhat and Majuli in Assam by using the Horizontal Directional Drilling (HDD) method.
- ✓ The total length of this single HDD crossing is 4,080 metres across the main water channel of the Brahmaputra river, making it the longest river crossing by any hydrocarbon pipeline of size 24inch diameter and above in Asia and the second longest in the world.
- ✓ This marks a significant milestone in the construction of the North East Gas Grid (NEGG), which aims to connect North East India to the National Gas Grid.
- ✓ NEGG stretches for 1,656 kilometres and connects major cities and demand centres in North East India to the National Gas Grid.

28 States/UTs adopts National Generic Document Registration System for Land Records

✓ The National Generic Document Registration System (NGDRS) for Land Records has been adopted by a total of 28 States and Union Territories (UT). According to the Department of Land Resources (DoLR), under the Ministry of Rural Development (MoRD), eRegistration is taking place in these States/UTs, or they have started sharing data with the national portal of NGDRS via User Interface /Application Programming Interface (API).

- ✓ According to the latest data from the DoLR's Land Resources Division, the (14- digit alpha-numeric unique ID) Unique Land Parcel Identification Number (ULPIN) or Bhu-Aadhar has been adopted by 26 States/UTs and pilot testing done in 7 more States /UTs.
- ✓ ULPIN is also used by some states in the SVAMITVA (Survey of Villages Abadi and Mapping with Improvised Technology in Village Areas) portal.
- ✓ As of 18 April 2023, computerization of the Record of Rights (RoRs) had been completed in 6,22,030 (94.62%) of the 6,57,403 villages.
- ✓ The DoLR is implementing the Digital India Land Records Modernisation Programme (DILRMP) with effect from 1 April 2016 as a Central Sector Scheme with 100% funding by the Government of India (GoI).

India's First Cable-Stayed Anji Khad Railway Bridge will be ready in May 2023

✓ On 26th April 2023, the Anji Khad cable-stayed

train bridge, the 96 cables on India's 1st cable-stayed bridge connecting Katra and Reasi in Jammu and Kashmir (J&K), have been



installed, which will enable its 'superstructure' to be ready in May 2023 with the cost of over Rs.400 crore. The cable-stayed bridge portion is 473 metres (m) long and has a total length of 725m.

- ✓ The bridge is a vital rail link between Kashmir and the rest of India that runs for 326km from Udhampur to Baramulla via Srinagar. The cablestayed train bridge crosses the Anji River, a tributary of the Chenab.
- ✓ Anji Cable Stay bridge is designed with a total of 96 cables: 48 cables each on lateral and central spans. The cables weigh 848.7 MT (Metric Ton) and the total length of cable strands involved is 653 Kilometre (km).
- ✓ All 96 cables were fully installed on 26 April 2023, in a record time period of 11 months (June 2022 to April 2023).

✓ From April 3–5, 2023, His Majesty Jigme Khesar



Namgyel Wangchuck, the King of Bhutan, visited India on an official trip at the invitation of President

Droupadi Murmu.

- ✓ His Majesty Jigme Khesar Namgyel Wangchuck was accompanied by Lyonpo Dr. Tandi Dorji, Minister of Foreign Affairs and External Trade, and other top Royal Government of Bhutan officials.
- While in India, His Majesty the King of Bhutan met with Droupadi Murmu, President of India, and held talks with Prime Minister Narendra Modi. He was also visited by External Affairs Minister (EAM) Dr.
 S. Jaishankar and National Security Advisor (NSA) Ajit Doval.

- ✓ The conclave was organised by the Department of Telecommunications, Ministry of Communications, and Telecommunication Engineering Center (TEC), in collaboration with Centre For Development Of Telematics (C-DOT), TSDSI (Telecommunications Standards Development Society, India) and IEEE Communications Society – Delhi chapter.

RAMBAAN, Asia's 1st Mobile Biosafety Level-3 Laboratory, Exhibited at G20 Summit, Goa

✓ India's and Asia's first mobile biosafety level-3 (BSL-3) laboratory named 'Rapid Action Mobile BSL-3 Advanced Augmented Network (RAMBAAN)', designed to investigate emerging viral infections was showcased at the second G-20(Group of 20) Health Working Group meeting held in Panaji ,Goa.

- ✓ The made-in-India mobile clinic RAMBAAN (Rapid Action Mobile BSL3+ Advanced Augmented Network) can be used to reach remote regions to carry out testing.
- ✓ RAMBAAN will play a major role in dealing with the COVID-19 pandemic.
- ✓ RAMBAA, equipped with a -20 degree and -80degree refrigerator, bio-safety cabinets, an automatic Ribonucleic acid (RNA) extractor, and a real-time PCR(polymerase chain reaction) machine, can access the remotest part of India.

2nd Tourism Working Group Meeting held in Siliguri, West Bengal

 \checkmark The 2nd Tourism Working Group Meeting, under India's G20 presidency was held in Siliguri, Darjeeling District, West Bengal, from April 1-4, 2023, and was represented by 56 delegates from 17 Member Countries, 8 Invitee Countries, and 4 International Organizations (IOs) including United Programme Nations Environment (UNEP), International Labour Organization (ILO), and United Nations World Tourism Organization (UNWTO). The event was also graced by the participation of Ambassadors from seven G20 countries: Australia, Bangladesh, Japan, Singapore, Mexico, Indonesia, and South Korea.

- ✓ The Ministry of Housing and Urban Affairs (MoHUA) has set up a 14-member committee to examine stalled real estate projects and recommend ways to complete them, and hand them over to homebuyers in a time-bound manner.
- ✓ It will be headed by Amitabh Kant, India's G20 (Group of Twenty) Sherpa for 2023 and the former Chief Executive Officer (CEO) of National Institution for Transforming India (NITI) Aayog.
- ✓ The committee will submit its report within six months from the date of its first meeting.

✓ On the occasion of the 132nd birth anniversary of Dr Bhimrao Ramji (BR) Ambedkar(14th April

2023), Telangana Chief Minister (CM) K Chandrashekhar Rao unveiled the 125-ft tall bronze statue of Babasaheb Bhimrao Ramji (BR) Ambedkar,



the architect of the Indian Constitution, in Hyderabad, Telangana. This is the tallest statue of BR Ambedkar in India.

- ✓ The stands next to the State Secretariat on the banks of Hyderabad's Hussain Sagarlake.
- ✓ The statue has been sculpted by 98-year-old Padma Bhushan awardee (2016) Ram Vanji Sutar from Maharashtra, Mumbai.
- ✓ Ambedkar's grandson Prakash Ambedkar was invited as the chief guest at the event.

Award

- ✓ Telangana government has decided to introduce an award in the name of Bharat Ratna Dr BR Ambedkar which will be presented to the people who excel in public service and render services to the people at the national and state-level every year.
- ✓ The state government plans to deposit Rs 51 crore in the bank and will use the interest of around Rs 3 crore earned on it every year to present the awards.

UP gets World's First Conservation & Breeding Centre for Asian king vultures

✓ Jatayu Conservation and Breeding Centre (JCBC), the world's 1st conservation and breeding centre developed exclusively for the conservation of the Asian king vulture in Maharajganj district in Uttar Pradesh(UP) is set to be inaugurated by UP Chief Minister (CM) Yogi Adityanath on the occasion of International Vulture Awareness Day(first Saturday of September).

- The JCBC is located at the Bhari Baisi village in the Farenda range of the Gorakhpur forest division.
- ✓ Asian king vulture is critically endangered and protected under the Wildlife Protection Act, 1972.
- ✓ Aim: The objective of establishing the centre is to breed king vultures in captivity and release them into the wild to maintain a sustainable population of the species.
- ✓ About Asian King Vulture: The Asian king vulture (Sarcogyps calvus), often known as the red-headed vulture (also known as the Indian black vulture or Pondicherry vulture), is mainly found in the Indian subcontinent, with small disjunct populations in some parts of Southeast Asia.

- ✓ Sharbati Gehu (wheat which is also called The Golden Grain), registered by the GI Registry in the agricultural product category.
- ✓ Morena Gajak, a kind of sweet, has received the GI tag in the food ingredient category.
- ✓ Ujjain Batik print has received the GI tag in the textile category.

Rajasthan Gets 3 New Conservation Reserves: Sorsan in Baran, Khichan in Jodhpur, & Hamirgarh in Bhilwara

- ✓ On the occasion of International Mother Earth Day (Earth Day) 2023 (22nd April 2023), the Forest Department, Government of Rajasthan announced 3 new conservation reserves that will protect the rare and endangered wildlife of Rajasthan.
- ✓ The 3 new wildlife conservation reserves are Sorsan in Baran, Khichan in Jodhpur, and Hamirgarh in Bhilwara.
- ✓ With the declaration of 3 new conservation reserves, the total number of reserves in Rajasthan has now reached 26.
- ✓ Following the declaration of these areas as conservation reserves, It becomes mandatory for any developmental projects in these regions to get clearance as per the Forest Conservation Act, 1990. Any developmental projects within the conservation area need to get the approval of the National Board for Wildlife, and the State Board of Wildlife.

Chennai's WABAG bags Rs 4,400 crore Seawater Desalination Project in Tamil Nadu

- ✓ Chennai (Tamil Nadu)-based VA Tech Wabag Ltd (WABAG) has bagged Rs 4,400 crore Sea Water(salt water) Reverse Osmosis (SWRO) project in Tamil Nadu (TN) which after completion would be the largest sea-water desalination project in the South East Asia region.
- ✓ The project has been bagged in a joint venture (JV) with Metito Overseas Limited (based in United Arab Emirates UAE) and will be implemented on a design, build, operate (DBO) model.
- ✓ WABAG with Metito Overseas wins an SWRO project from Chennai Metropolitan Water Supply and Sewerage Board (CMWSSB).
- ✓ The largest seawater desalination plant in South East Asia, worth Rs 4,400 crore, with a 400 Minimal Liquid Discharge (MLD) capacity, was funded by the Japan International Cooperation Agency (JICA). The DBO will take place over 42 months and will be operated and maintained for 20 years by WABAG.

Telangana Launched India's 1st 'Cool Roof Policy 2023-2028

- ✓ Telangana launched "Telangana Cool Roof Policy 2023-2028" for all types of buildings to reduce temperatures in Hyderabad and other urban areas in Telangana. With this launch, Telangana became the
- ✓ India's first state to introduce Cool Roof Policy. The Telangana Cool Roof Policy 2023-2028 aims to reduce the heat island impact and heat stress in
- ✓ Telangana.
- ✓ This policy encourages and promotes the usage of cool roof.
- ✓ Telangana has set target to cover an area of 7.5 square kilometers, including 5 sq km in Hyderabad, Telangana in the first year (2023).
- The government is set to cool roof an area of 300 sq km of area including 200 sq km in Hyderabad by 2030.
- ✓ The government of Telangana will make it mandatory for all constructions beyond 600 square yards to factor in a cool roof at the design stage.
- ✓ <u>Cool Roofs</u>: Cool roofs are one of the simplest and most cost-effective methods to combat the heat. These will help to keep the indoor air temperature lower by 2.1 to 4.3 degree Celsius compared to traditional roofs.

CM Pushkar Singh Dhami launches "A-HELP" Programme in

Uttarakhand

- ✓ Pushkar Singh Dhami, Chief Minister (CM) of Uttarakhand, launched the "A-HELP" (Accredited Agent for Health and Extension of Livestock Production) programme at Survey of India Auditorium Dehradun in Uttarakhand.
- ✓ Women have been chosen to improve livestockrelated activities in remote rural areas under the A-HELP programme, which was envisioned by the Government of India.
- ✓ Under the A-HELP Programme, trained A-HELPs will give their vital contribution to preventing various infectious diseases of animals, artificial insemination under Rashtriya Gokul Mission (RGM), tagging of animals and animal insurance.

AndhraPradeshrenamedBhavanapaduPort in Srikakulam asMulapetaGreenfield Port

- ✓ On 16th April 2023, the Andhra Pradesh (AP) Government renamed the Bhavanapadu Port as "MulapetaGreenfield Port", respecting the sentiments of local villagers in Srikakulam district, AP.
- ✓ Y S Jagan Mohan Reddy, Chief Minister (CM) of AP, will lay the foundation stone for the greenfield port on April 19.
- ✓ The AP government took this decision as farmers from Mulapeta and Vishnuchakram villages requested the name change since Bhavanapadu village has no scope in the proposed port area, considering all the lands of Mulpeta and some from Vishnuchakram have been earmarked for acquisition.
- ✓ Lathkar Srikesh Balajirao, Indian Administrative Service (IAS) of Srikakulam district, laid the proposals for renaming Greenfield Port, since the total land and the project displaced families belong to Mulapeta and Vishnuchakram villages and not Bhavanapadu.

Kerala adopts Water Budget, the 1st of its kind in India, to tackle water scarcity in Summer

- ✓ Kerala became the first state in India to adopt a water budget to tackle water shortage in summer. Pinarayi Vijayan, Chief Minister (CM) of Kerala, unveiled the details of the 1st phase of the Water Budget in Kerala covering 94 grama panchayats in 15 block panchayats.
- ✓ The Water Budget provides the scientific methods for the conservation of water and it also aims to create awareness about the need for water conservation. This water budget would support Kerala to meet the demand and supply of Water, the precious liquid resource and apportion it accordingly.
- ✓ The water budget will regulate the usage of water in accordance with its availability in the area. This would create awareness among the public against water wastage and will support achieving water conservation.

Himachal Pradesh launches project Sanjeevani to empower dairy farmers

- ✓ On April 9th, The Animal Husbandry Department (AHD) of Himachal Pradesh along with Bharat Financial Inclusion Ltd. (BFIL), (a subsidiary of IndusInd Bank) has launched an initiative called 'Sanjeevani' which aims to provide doorstep veterinary services to farmers.
- ✓ Under the Sanjeevani project, mobile veterinary clinics will be set up to provide doorstep veterinary services to farmers at a single toll-free phone call.
- ✓ The collaboration under National Animal Disease Control Programme-Mobile Veterinary Van (NADCP-AHD-MVU) will enhance the doorstep services.
- ✓ The integrated call centre will function as a single contact point for various matters related to livestock healthcare and vaccination programs.
- ✓ To support farmers and improve their livelihoods, the Chief Minister of Himachal Pradesh, Thakur Sukhvinder Singh Sukhu, has launched the Sanjeevani project which will benefit farmers in 44 blocks of all 12 districts of the state.

Himachal Pradesh becomes India's 1st state to have DNA database of Unidentified Bodies

- ✓ Himachal Pradesh (HP) has become the first Indian state to develop a DNA database for unidentified bodies. The process of creating this database started in April 2022. So far, the records of 150 DNA samples of unidentified bodies had been stored in the database.
- ✓ A database is being prepared and it will have the capacity to store 20,000 DNA profiles, which can be scaled further.
- ✓ More than 100 bodies are recovered in different parts of the state every year and these remain unidentified. Thus the DNA database would be beneficial in bringing transparency, eliminating data inconsistency and catching the criminal in cases where crime led to death.

- ✓ On 19th April 2023, the Government of Kerala launched the "One Panchayat, One Playground" project for reviving the sports culture in Kerala by opening quality playgrounds in every panchayat of Kerala.
- ✓ The project was inaugurated by Pinarayi Vijayan, Chief Minister(CM) of Kerala, at Kallikkad, Thiruvananthapuram, Kerala.
- ✓ The playgrounds would act as a hub for local gatherings and social interactions.
- ✓ The project will address the lack of quality playgrounds in around 450 local bodies in Kerala.
- ✓ The playgrounds will be built in 3 years, and a list of 113 panchayats has been prepared for the project's initial phase.
- ✓ Each playground would cost around Rs 1 crore, of which the Sports Department would cover half and the Member of Legislative Assembly (MLA) and local body money, Corporate Social Responsibility (CSR), public- private partnerships(PPP), etc., would cover the remaining costs.

Odisha CM Naveen Patnaik launches India's first heavy lift logistics drone

- ✓ On April 20, 2023, Chief Minister (CM) of Odisha Naveen Patnaik launched India's first heavy lift logisticseVTOL (electric Vertical Take-off and Landing) BonV drone on the opening day of "Odisha Skill Conclave 2023".
- ✓ The first-of-its-kind heavy-lift logistics drone was made by Odisha-based start-up 'BonV Aero'. It is capable of transporting 50 kg across distances of up to 10 kilometers.
- ✓ The drone will play a vital role in disaster management, emergency evacuation, flood relief,firefighting, and medical supply delivery to remote areas.
- ✓ Benefits of BonV drone: Odisha which is highly disaster-prone see the Cyclone and Flood on regular

basis, these multi-utility Air vehicles are beneficial in the disaster response.

- ✓ Movement of any kind of cargo/ goods where surface logistics are either unfavourable or timeconsuming.
- ✓ Improve accessibility and efficiency of logistics solutions, especially in the remote and Hilly terrains.

Haryana's Forests and Wildlife Minister, Kanwar Pal, shared two images of the tiger, stating that it had been spotted in the Kalesar region for the first time since 1913.

✓ The Kalesar National Park covers an area of 11,570 acres and is situated in the Shivalik foothills. It serves as a habitat to various wildlife creatures such

✓ On April 25, Bengaluru, India's technological hub, is poised to witness a unique celestial event known

as "Zero Shadow Day," according to the Astronomical Society of India (ASI). During this event, any vertical

✓ This decision comes after Prime Minister Narendra Modi supported Chief Minister Pushkar Singh Dhami's assertion that Mana was the first village in the country, and all border villages should be recognized as such. PM Modi, who visited Mana in October last year, stated that areas that were previously viewed as the end of the country's borders should now be viewed as the beginning of the country's prosperity.

✓ Mauganj was declared as 53rd district of Madhya Pradesh by Shivraj Singh Chouhan, the Khongjom Day was commemorated at Khongjom in Thoubal district of Manipur to honour the soldiers who fought in the 1891 Anglo-Manipuri War. Manipur's Chief Minister N. Biren Singh and Governor Ms. Anusuiya Uikey were among those who paid their respects to the heroes at the event, held at Kheba Ching in Khongjom.

✓ Every year, on this day, Manipur pays tribute to the courageous soldiers who sacrificed their lives in the war. The event is typically held at Kheba Ching in Khongjom, where Manipur's Chief Minister and Governor, along with other dignitaries, pay their respects to the fallen heroes.

Tamil Nadu assembly passes Bill allowing 12-hour work days

- ✓ The Act's provisions to extend the mandatory working hours from 8 hours to 12 hours have been the main point of contention for the opposition, with concerns raised about worker's work-life balance.
- ✓ The passage of the Factories (Amendment) Act 2023 in the Tamil Nadu Assembly, which provides for flexible work hours for employees in factories, is reportedly facing opposition from political parties, including DMK allies. The Act's provisions to extend the mandatory working hours from 8 hours to 12 hours have been the main point of contention for the opposition, with concerns raised about worker welfare, safety, and work-life balance.

Uttar Pradesh on track to be first Indian state with 100% EVs in govt depts

- ✓ The government of Uttar Pradesh, led by Chief Minister Yogi Adityanath, has launched an ambitious plan to promote the adoption of electric vehicles (EVs) in the state. As part of this initiative, the government has set a target to convert all vehicles used by government departments into EVs by 2030, in a phased manner.
- ✓ To further encourage the adoption of EVs, the Uttar Pradesh government has also notified the Uttar Pradesh Electric Vehicle Manufacturing and Mobility Policy 2022.

ECONOMY AND BANKING

MoF Increases Interest Rates on Most Small Savings Schemes, Except PPF, for Q1 FY24

✓ The Department of Economic Affairs (DEA), Ministry of Finance (MoF) has announced an



interest rate hike on various Small Savings Schemes for the first quarter of the financial

year 2023-24 (Q1 FY24) (i.e. April 1, 2023 to June 30, 2023), marking the third consecutive quarter of rate hikes.

- ✓ Small Savings Schemes have about 40 crore subscribers, and the basket includes 12 instruments such as the National Savings Certificate (NSC), Public Provident Fund (PPF), Kisan Vikas Patra (KVP), Sukanya Samridihi Account (SSA), Monthly Income Savings Scheme, all post office time deposits, etc.,
- ✓ The interest rate on these savings instruments has been raised by 10-70 basis points (bps) [one percentage point is equivalent to 100 bps].
- ✓ However, the interest rate for PPF scheme has been kept unchanged at 7.1% over Q1 FY24, and its returns have remained constant at 7.1% for the last three years.
- ✓ The GoI reviews the interest rates for small savings plans on a quarterly basis.
- ✓ Although the Reserve Bank of India (RBI) sets small savings interest rates, they are linked to market yields on government securities (G-secs) with a lag and are reviewed and fixed quarterly at a spread of 0-100 basis points (bps) over (100 bps = 1%) and above G-sec yields of comparable maturities.

Key Details Regarding Increased Interest Rates

✓ iThe National Savings Certificates (NCS) witnessed the highest increase in rate, which increased from 7% to 7.7% from January to June.

- The interest rates on small savings schemes hiked by 10-70 basis points across various instruments, and they are currently in the range of 4% to 8.2%
- ✓ With the revision, the interest rate on a one-year term deposit at the post office would increase from 6.6% to 6.8%; for a 2-year term deposit, it would increase from 6.8% to 6.9%; for a 3-year term deposit, it would increase from 6.9% to 7%; and for a 5-year term deposit, it would increase from 7% to 7.5%.
- ✓ The interest rate on 5-year recurring deposits was increased from 5.8% to 6.2%.
- ✓ The interest rate on the Monthly Income Account Scheme has been increased from 7.1% to 7.4%.
- ✓ The interest rate for Senior Citizen Savings Schemes has been increased from 8% to 8.2%.
- ✓ The rate for Kisan Vikas Patras was hiked from 7.2% to 7.5%. The scheme will now mature in 115 months, rather than 120 months previously.
- ✓ The interest rate for the Sukanya Samriddhi Account scheme, which is intended for girl children, will be 8% from April to June 2023 as opposed to 7.6%.

8th Anniversary of the Pradhan Mantri MUDRA Yojana

- Sth April 2023, the Ministry of Finance marked the 8th anniversary of the launch of the Pradhan Mantri MUDRA (Micro Units Development and Refinance Agency) Yojana (PMMY).PMMY was launched on 8th April 2015 by PM Modi in New Delhi, Delhi.
- ✓ <u>Aim of PMMY</u>: To facilitate easy collateral-free micro-credit of up to Rs 10 lakh to non-corporate, non-farm small and micro- entrepreneurs for income-generating activities.
- ✓ **Features of PMMY** The loans have been divided into three categories based on the need for finance and the stage in the maturity of the business.
 - Shishu loans up to Rs 50,000
 - Kishore loans above Rs 50,000 and up to Rs 5 lakh
 - Tarun loans above Rs 5 lakh and up to Rs 10 lakh

- ✓ The rate of interest is decided by lending institutions in terms of Reserve Bank of India(RBI) guidelines.
- ✓ In the case of a working capital facility, interest is charged only on money held overnight by the borrower.
- ✓ Achievements: As of 24th March 2023, around Rs 23.2 lakh crore has been sanctioned in 40.82 crore loan accounts.
- ✓ .Around 68% of the accounts under the scheme belong to women entrepreneurs and 51% of accounts belong to entrepreneurs of Scheduled Caste (SC) / Scheduled Tribes (ST) and other backward classes (OBC) categories.

- ✓ The MoU was signed during the visit of 50-member delegation of the agriculture and food processing sector from India, led by N K Kagliwal, Board Member of FIEO, to Moscow and St. Petersburg, Russia.
- ✓ Business Russia is an All-Russia Public Organization which represents the interests of private non- resource businesses local industry leaders.

ITC Overtakes Infosys as India's 6th Largest Company; RIL tops the list

✓ ITC Limited has overtaken Infosys Limited, an

Indian multinational information technology company, to become



India's 6th largest company, as per market capitalization (m-cap). ITC's market cap stands at Rs 5.11 lakh crore (as of April 24, 2023) while the market cap of Infosys (7th place) stands at ~Rs 5.08 lakh crore.

India's 5 biggest companies

- Reliance Industries Limited (RIL) is India's largest company with a market cap of ~Rs 16.07 lakh crore followed by Tata Consultancy Services (TCS) with ~Rs 11.62 lakh crore and HDFC Bank with ~Rs 9.28 lakh crore. ICICI Bank stands at the 4th position with an m-cap of ~Rs 6.38 lakh crore and Hindustan Unilever Limited (HUL) stands at 5th place with an m-cap of ~Rs 5.85 lakh crore.
- ✓ ITC achieved this feat after its share surged 59% in 2022.
- ✓ In 2023 so far, ITC shares are up 24%, the best performer in the benchmark Nifty50.
- ✓ In 2022, ITC has given 61% returns. It has also given 129% returns in the past 3 years.

BHEL-led consortium bags Rs 9,600 crore order to Supply 80 Sleeper Class Vande Bharat Trains

- ✓ A consortium led by state-owned Bharat Heavy Electricals Ltd (BHEL) has bagged an order worth more than Rs 9,600 crore to supply 80 sleeper class Vande Bharat trains to Indian Railways over a period of 6 years.
- ✓ The consortium, comprising BHEL and Titagarh Wagons Ltd, is called Technology Partner.
- ✓ In the mega-tender of the Indian Railways, the BHEL-led consortium received an order for 80 Vande Bharat trains.
- Sleeper class Vande Bharat or Train18 trainsets are in demand since they can travel on long routes like Delhi-Mumbai and Delhi-Howrah.
- ✓ The order is for the supply of 80 trains each at a cost of Rs 120 crore, excluding taxes and duties. The order for an Annual Maintenance Contract (AMC) has also been placed for 35 years.

India Development Update(Spring 2023 Edition) By WB: India's GDP Growth Probably to Slow Down to 6.3% in FY24

 ✓ The World Bank (WB) lowered its fiscal year 2023-24 (FY24) growth projection for India to 6.3% in its "India Development Update" (Spring 2023 Edition), down from 6.6% in December 2022

(FY23). It further added that slower consumption growth and unfavourable external conditions are anticipated to restrain India's GDP growth.

- ✓ The World Bank projected a 6.9% growth in FY23.
 Key Observations from the IDU 2023
- ✓ According to the latest IDU 2023, increased borrowing costs and weaker income growth are likely to adversely affect private consumption growth.
- ✓ Due to the removal of pandemic-related fiscal assistance measures, government consumption is projected to rise more gradually.
- ✓ Despite some initial indications of a slowdown in the second half of FY23, India's economy remained robust.
- ✓ The report also states that, while headline inflation remains high, it is expected to fall to 5.2% in FY24, down from 6.6% in the current fiscal year (FY23).
- ✓ The Reserve Bank of India (RBI) increased the policy interest rate in order to end accommodative measures to control inflation.
- ✓ Since May 2022, the RBI has increased interest rates by 250 basis points in an effort to control inflation.
- ✓ According to the update, India's financial sector remains strong, driven by improvements in asset quality and robust private-sector credit growth.
- ✓ Furthermore, the Government of India (GoI) is projected to achieve its fiscal deficit target of 5.9% of Gross Domestic Product (GDP) in FY24.
- ✓ When coupled with the consolidation of state government deficits, the Union Government deficit is also predicted to decrease along with the reduction of the Current Account Deficit (CAD).
- ✓ Due to strong service exports and a decreasing goods trade deficit, CAD is anticipated to reduce to 2.1% of GDP in FY24 from an estimated 3% in FY23.

Net Direct Tax Collections Rose by 17.63% to Rs 16.61 Trillion in FY23; Exceeds BE & RE

✓ According to the provisional figures of Direct Tax collections for the Financial Year 2022-23 (FY23), the net Direct Tax collections was at Rs. 16.61 lakh

crore(trillion), an increase of 17.63% compared to Rs. 14.12 lakh crore of FY 2021-2022.

- ✓ The provisional Direct Tax collections (net of the refunds) have exceeded the Budget Estimates (BE) by 16.97% and Revised Estimates (RE) by 0.69%.
- ✓ In Union Budget for FY23, The BE for Direct tax revenue was fixed at Rs 14.20 lakh crore and the RE were fixed at Rs.16.50 lakh crore.
- ✓ The gross collections of direct taxes (before adjusting for refunds) for FY 2022-23 was Rs 19.68 Lakh Crore, registering a 20.33% growth over Rs 16.36 Lakh Crore in FY 2021-22. Gross corporate tax collections grew 16.9% to Rs 10.04 Lakh Crore last fiscal against Rs 8.59 Lakh crore in FY 2021-22.
- ✓ Gross personal income tax receipts (including securities transaction tax) grew 24.2% to Rs 9.6 Lakh Crore in FY 2022-23 versus Rs 7.73 trillion in FY22.
- ✓ The income tax department issued refunds worth Rs 3.07 Lakh Crore in FY 2022-23, which was a 37.42% increase over refunds of Rs 2.24 Lakh Crore issued in FY 2021-22.

US Became India's biggest Trading Partner in FY23 Followed by China

- According to the data of the Ministry of Commerce, the United States (US) has emerged as India's biggest trading partner in the financial year 2022-23 (FY23) at USD 128.55 billion followed by China in the second position at USD 113.83 billion.
- ✓ The bilateral trade between India and the US has increased by 7.65% in FY23 due to increasing economic co-operation as against USD 119.5 billion in FY22. It was USD 80.51 billion in FY21.
- ✓ Followed by US and China, the UAE with US\$76.16 billion, was the third largest trading partner of India. It was followed by Saudi Arabia (US\$52.72 billion), and Singapore (US\$35.55 billion).
- ✓ As per the Ministry of Commerce data, China was India's top trading partner since FY14 till FY18 and also in FY21. Before China, the UAE was the India's largest trading partner.

MoC&I Released FTP 2023: India aims for increase exports to USD 2 trillion by 2030

- ✓ On 31st March 2023, The Ministry of Commerce and Industry(MoC&I), Government of India(GoI), released the Foreign Trade Policy (FTP) 2023 which aims to increase India's exports to USD 2 trillion by 2030 by shifting from incentives to remission and entitlement based regime.
- ✓ Union Minister Piyush Goyal, (MoC&I) released the FTP 2023 during an event held in New Delhi, Delhi. The FTP 2023 is set to become effective from 1st April 2023.
- ✓ India is set to end the FY 2023 with a total export of USD 760-770 billion compared to the USD 676 billion in 2021-2022.

IMF WEO 2023 cuts India's growth forecast for FY24 to 5.9% and for FY25 to 6.3%

- ✓ On April 11, 2023, the International Monetary Fund (IMF) in its bi-annual World Economic Outlook (WEO) 2023 report with a title 'A Rocky Recovery' has downgraded India's Gross Domestic Product (GDP) forecast for the financial year 2023-24 by 20 basis points (-0.2%) to 5.9% from 6.1% in January 2023 WEO Update.
- ✓ For FY25, India's growth projections are cut by 50 basis points (-0.5%) to 6.3% from 6.8% in January 2023 WEO Update. However, India will continue to be the fastest-growing economy in the world. Indian Scenario
- ✓ A key reason for lowering the growth forecast is global uncertainties. There is anticipation of lower consumption demand due to higher interest rates.
- ✓ In purchasing power parity terms, India's growth in per capita output will decelerate to 4.9% in 2023 from 5.8% in 2022. It will be 5.4% in 2024.
- ✓ India's retail inflation to ease at 4.9% in FY24 from 6.7% in FY23. It will be 4.4% in FY25.
- ✓ The current account deficit to come down to 2.2% of GDP in FY24 from an estimated 2.6% in FY23.
- ✓ <u>Global Scenario</u>: The global economy will grow by 2.8% in 2023 and 3% in 2024, down 10 basis points each from its January WEO 2023 forecasts.

✓ Global inflation will fall from 8.7% in 2022 to 7% in 2023 and 4.9% in 2024.

ADB Projected India's GDP Growth Forecast for FY24 at 6.7%, FY23 at 6.4%

- ✓ The Asian Development Bank's (ADB) Asian Development Outlook April 2023, has reduced India's GDP (GrossDomestic Product) growth forecast for the Financial year 2022- 2023 (FY23) to 6.4% from 7% of its earlier projection.
- ✓ India's GDP growth forecast for FY24 was projected at 6.7% due to improvement in private investment and growth in the industry.

Morgan Stanley: India's GDP to grow at 6.2% in FY24; Inflation to be 5.5% in FY24

✓ According to the Morgan Stanley, India's gross domestic product (GDP) was proposed to grow at 6.2% in FY24 (Financial year 2023-24) due to the contribution of a cyclical recovery in consumption, increased private sector capex (Capital Expenditure), and acceleration on government spending.

- ✓ Nifty REITs & InvITs Index comprises three sectors: realty, power, and services.
- ✓ The realty sector has the highest weight, accounting for 57.52% of the index, followed by power with 35.61% and services with 6.87%.
- \checkmark The index will be reviewed and rebalanced quarterly.

CoRover, LIC Collaborate to Launch 1st Phase of AI virtual assistant LIC Mitra

- ✓ Ruchira Kamboj, India's Permanent Representative to the United Nations (UN), presented USD 2 million to the United Nations Trust Fund in support of the African Union Transition Mission in Somalia (ATMIS).
- ✓ With this grant, the Government of India (GoI) reaffirms its dedication to promoting peace and stability in Somalia and the Horn of Africa.
- ✓ India had previously granted the African Union Mission in Somalia (AMISOM) USD 4 million.

India gives USD 500,000 to UN Women for Women Empowerment

- ✓ From April 1, 2023, each piece of gold jewellery will have a Bureau of India Standards (BIS) hallmark, purity of gold (for example, 0 22K916), and a 6-digit HUID embossed on it.
- ✓ India has made a contribution of USD 500,000 (Rs 4.09 crore) to the United Nations Entity for Gender Equality and the Empowerment of Women, also known as UN Women, for women empowerment. The cheque for the same was handed over by Ruchira Kamboj, the Permanent Representative of India to the UN, supporting UN Women's core voluntary budget.
- ✓ The donation was received by Sima Sami Bahous, the Under Secretary General and Executive Director of UN Women.
- ✓ This funding highlights India's commitment towards gender equality and empowerment of women, as well as the government's support towards UN Women's activities.
- ✓ The donation will be utilized towards UN Women's efforts to promote gender equality and empower women globally.
- ✓ India currently serves as a member of the Executive Board of the UN Women and Women-led

Development is one of the priorities of India's G20 presidency.

✓ India's development model is centered around women-led initiatives, entrepreneurship, and STEM (Science, technology, engineering, and mathematics) education.

Norway, Singapore gain as India's FPI destinations in FY23, Mauritius declines

- ✓ According to the data from the Mumbai (Maharashtra)-based National Securities Depository
- ✓ Limited (NSDL), Norway, and Singapore gained as the FPI (Foreign Portfolio Investment) destinations for India in FY23 while Mauritius witnessed the sharpest decline.
- ✓ Now, Singapore is the second biggest jurisdiction for FPI flows in India after the United States of America (USA).
- ✓ Singapore is followed by Luxembourg at 3rd place, and Mauritius' ranking has dropped to 4 in FY23 (from 2nd in FY22), Norway ranked at 8th Place.

ICICI Bank introduces EMI facility for UPI payments by scanning QR code

- ✓ On April 11, 2023, the ICICI Bank introduced an easy first-of-its-kind EMI (Equated Monthly)
 - Instalment) facility for UPI (Unified Payment Interface) payments made by scanning QR code.



- ✓ To improve convenience of the customers and to provide unique solutions to address their evolving credit needs.
- ✓ Eligibility: Customers who are eligible for PayLater, the Bank's 'buy now, pay later' service can avail of the
- ✓ EMI facility in an instant, easy and seamless manner.
- ✓ The facility can be availed across different categories such as electronics, groceries, fashion apparels, travel and hotel bookings.
- ✓ Customers could pay transaction amounts above Rs 10,000 by scanning a QR code for easy instalments in three, six or nine months.

SBI Board Approves to Raise USD 2 Billion via Long-Term Debt

✓ On 18th April 2023, the State Bank of India (SBI), a public sector lender.

in its Executive Committee of the Central Board, approved to examine the status and decide on long-term fund-



raising in single or multiple trenches up to USD 2 billion (about Rs 16,000 crore) under Reg-S/144A, through Public Offer and/or private placement of senior unsecured notes in USD or other convertible currency during FY2023-2024.

- ✓ SBI will raise USD 2 billion through foreign currency bonds in 2023-2024 in single or multiple tranches.
- ✓ SBI will utilise the fund for augmenting additional Tier 1 capital and the overall capital base, and for strengthening capital adequacy according to Reserve Bank of India (RBI) guidelines.
- ✓ In March 2023, SBI raised Rs 3,717 crore through an additional tier 1 bond sale.
- ✓ According to SBI, this is the 3rd Basel III compliant additional tier 1 (AT1) bond sale and the latest issue was closed at a coupon rate of 8.25%.

Reserve Bank of Zimbabwe to Launch Gold-Pegged Digital Currency

- ✓ Reserve Bank of Zimbabwe (RBZ) is set to launch a gold-backed digital currency to serve as legal tender in Zimbabwe. This is an initiative of the government of Zimbabwe to stabilize the local currency from continued depreciation against the United States (US) dollar.
- ✓ This will allow small amounts of Zimbabwean dollars to be exchanged for the digital gold token, enabling more Zimbabweans to hedge against currency volatility.
- ✓ In 2009, Zimbabwe adopted the U.S. dollar as its currency following hyperinflation and in 2019, the Zimbabwean dollar was reintroduced in an effort to revive its struggling economy.

SIB introduces 2 Savings Accounts for NRIs – SIB SEAFARER & SIB PULSE

- ✓ On April 18, 2023, South Indian Bank (SIB) launched two flexible saving products namely, SIB SEAFARER and SIB PULSE for its non-resident Indian (NRI) customers specifically for mariners and healthcare professionals.
- ✓ The two saving products would enable the NRIs to either maintain the term deposits or the prescribed minimum balance in the saving account.

The new P2P payments system has been made available with the introduction of Scan & Pay is based on the Unified Payments Interface (UPI).
- ✓ This service is designed to enable CRED customers to make secure, instant payments to other users via UPI IDs or contact numbers, thus elevating their overall user experience.
- ✓ Cred provides variety of payment methods to its members, including bill payments, scan-and-pay, tap-to-pay, UPI P2P, CRED Pay, and CRED flash for online merchants.

IBA Constituted 4-Member Working Group on ARCs

- ✓ The Indian Banks' Association (IBA) has constituted a four-member working group on Asset Reconstruction Companies (ARCs) which will operate on various issues and report them to the IBA, the RBI (Reserve Bank of India) and the Union government.
- \checkmark The four-member of the working group include
 - Hari Hara Mishra, Secretary, Association of ARCs in India.
 - Purshotam Agarwal, Chief investment officer, National Asset Reconstruction Company Limited (NARCL).
 - Mythili Balasubramanian, Executive Director, Edelweiss.
 - Tarun Kumar, Director, Encore Asset Reconstruction Company.
- ✓ Association of ARCs in India is a Representative Body of 28 Asset Reconstruction Companies registered with the Reserve Bank of India.
- They are registered under RBI and regulated under the Securitisation and Reconstruction of Financial Assets and Enforcement of Securities Interest (SARFAESI) Act, 2002.

SBI Reintroduced Retail term deposit scheme 'AMRIT KALASH'

✓ On April 12, 2023, the State Bank of India (SBI) decided to reintroduce the retail term deposit scheme 'AMRIT KALASH'. It is a special scheme of 400 days tenor with an interest rate of 7.6% for senior citizens and 7.1% for others.

Backdrop

- ✓ In February 2023, the SBI launched 'AMRIT KALASH', the retail term deposit scheme with a specific duration with validity from February 15, 2023, to March 31, 2023.
- ✓ Now the Scheme was reintroduced with validity from April 12, 2023, to June 30, 2023.
- ✓ Domestic retail term deposits, including nonresident Indian (NRI) rupee term deposits (less than Rs.2 crore), new and renewals, term deposits, and special term deposits are eligible for this specific tenure deposit scheme.

SIDBI Announces a Financial Scheme to Enhance the Electric Vehicle Market

✓ Small Industries Development Bank of India (SIDBI) has announced the launch of a pilot

scheme 'Mission 50K-EV4ECO' to unlock the electric vehicle market by providing better financing terms and understanding other solution bouquets needed to address the



better adoption of electric vehicle (EV).

- ✓ The scheme will provide direct finance at competitive rates for the purchase of EVs to Micro, Small and Medium Enterprises (MSMEs).
- ✓ This would cover vehicle aggregators, fleet operators, and leasing companies.
- ✓ SIDBI will also fund non-banking finance companies (NBFCs) that provide loans for EV purchases and push electrification in the threewheeler segment.
- ✓ Direct finance will also be provided to the developing charging infrastructure, including battery-swapping.

CUB launches India's 1st Voice Biometric Authentication for Logging into its Banking App

✓ On 12th April 2023, the Citi Union Bank (CUB) based in Kumbakonam (Tamil Nadu), launched

- ✓ The newly introduced voice biometric will be one more option for customers to log in along with user id, PIN, face id and fingerprint authentication.

UBI becomes 1st Indian Bank to open SRVA Malaysia for Trade Settlement in rupee

- ✓ On April 1, 2023, the Union Bank of India (UBI) became the first Indian Bank to open its 'Special Rupee Vostro Account (SRVA)' in Malaysia to facilitate transactions between India and Malaysia in the Indian rupee. - ✓ The will allow the Indian and Malaysian traders to invoice the trade in Indian Rupee.

Reason

✓ The opening of this account is in the backdrop of ongoing official efforts to Safeguard Indian trade from the impact of Ukraine crisis. Also, India is taking steps towards de-dollarization of its international trade, as the US (United States) dollar has been the dominant reserve currency for international trade.

Aim

✓ To facilitate the growth of global trade and to support the interests of the global trading community in Indian Rupee.

IRDAI Identified LIC, GIC & New India Assurance as D-SIIs for FY23

- ✓ On March 31, 2023, the Life Insurance Corporation of India(LIC), General Insurance Corporation of India Limited (GIC Re), and New India Assurance continued to be identified by the Insurance Regulator and Development Authority of India (IRDAI) as Domestic Systemically Important Insurers (D-SIIs) for the Financial year 2022-23.
- ✓ IRDAI annually identifies D-SIIs and publishes the name of the insurers for public information.

- ✓ Canara Bank, in collaboration with the Reserve Bank Innovation Hub (RBIH), announced the launch of a new customer-friendly service termed 'Digitalised Submission of Form 15G/15H'.
- ✓ Form 15G (Individual and HUF (Hindu Undivided Family)) and Form 15H (Individual-Senior Citizen) are self- declaration forms that an individual submits to the bank requesting not to deduct TDS (Tax Deducted at Source) on interest income as their income is below the basic exemption limit.
- ✓ Submission of PAN (Permanent Account Number) is necessary for the form submission.

- ✓ On April 10, 2023, a Rs 150 crore (USD 18.2m) agreement has been inked between the Tata Power Delhi Distribution Limited (TPDDL), the distribution arm of The Tata Power Company Limited (Tata Power), and Asian Development Bank (ADB) to boost Delhi's power distribution.
- ✓ Under this, ADB will subscribe to non-convertible debentures worth 150 crore. The funds will be utilized for grid enhancements.

RBI 1st Bi-Monthly Monetary Policy for FY24



- ✓ The Reserve Bank of India's (RBI) 6-members Monetary Policy Committee (MPC) met on 3rd, 5th and 6th of April 2023 and released its first bimonthly monetary policy statement for FY24 (Financial year 2023-2024).
- The MPC meeting was headed by RBI Governor Shaktikanta Das the other 5 members of the committee include, Shashanka Bhide, Ashima Goyal, Prof. Jayanth R. Varma, Michael Debabrata Patra, and Dr. Rajiv Ranjan.

✓ The MPC has decided to keep the policy rates unchanged with the stance remain focused on the withdrawal of accommodation.

- ✓ MPC has unanimously decided to keep the repo rate unchanged at 6.50 per cent. MPC has raised the repo rate by 250 bps in the last 11 months, since May 2022.
- ✓ The Unchanged Policy rates are as follows:

Growth

✓ India's real gross domestic product (GDP) growth for FY24 was projected at 6.5 percent with 7.8 percent in Q1, 6.2 percent in Q2, 6.1 percent in Q3, and 5.9 percent in Q4.

Inflation

- ✓ Consumer Price Index (CPI) inflation was projected at 5.2 percent in FY24, with 5.1 percent in Q1, 5.4 percent in Q2, 5.3 percent in Q3, and 5.2 percent in Q4.
- ✓ CPI headline inflation rose from 5.7 percent in December 2022 to 6.4 percent in February 2023 due to higher inflation in cereals, milk and fruits and slower deflation in vegetables prices.
- ✓ Core inflation (i.e., CPI excluding food and fuel) remained above 6% in January-February 2023.

PRAVAAH portal

- ✓ RBI decided to develop a secured web-based centralised portal named 'PRAVAAH' (Platform for Regulatory Application, Validation And AutHorisation).
- ✓ To overcome the existing difficulty process, RBI developed the PRAVAAH portal. The portal will bring greater efficiencies into regulatory processes and facilitate ease of doing business for the regulated entities of RBI.
- ✓ The portal will show time limits for deciding on the applications/approvals sought.

Pre-Sanctioned Credit Lines at Banks through UPI

- Currently, the Unified Payments Interface (UPI) transactions are enabled between deposit accounts at banks, sometimes intermediated by pre-paid instruments including wallets.
- ✓ RBI proposed enabling transfer to/from presanctioned credit lines at banks through UPI, i.e. the UPI network will facilitate payments financed by credit from banks.
- ✓ The ability to access pre-sanctioned credit lines through UPI will reduce the time and effort required to obtain loans.
- ✓ UPI handles 75% of the retail digital payments volume in India.

Loan Growth

- ✓ According to the Reserve Bank of India's (RBI) Monetary Policy Report (April 2023), credit growth continued to outpace deposit growth in financial year 2022-23 (FY23) at an eleven-year high, despite banks fully transmitting lending rates linked to external benchmarks [250 basis points (bps)], which now account for nearly half of floating-rate loans.
- ✓ In FY23, bank loans increased 14.6% while deposits increased just 9.6%.
- ✓ The rate of credit growth in FY23 was the greatest since FY 2011–12, when credit increased 17%.
- ✓ Significantly, lending rates surged the most in FY23.
- ✓ The Monetary Policy Report (MPR) states that demand for credit is more closely related to economic activity than interest rates.

<u>RBI to Issue New 5-Year Govt Bonds to Raise Rs</u> 8000 Cr

- ✓ RBI decided to auction new 5-year government bonds, which are set to mature in 2028, to raise approximately Rs 8,000 crore in the first bond auction of the FY24 which is scheduled on April 06, 2023.
- ✓ The Government of India (GoI) also intends to raise up to Rs 33,000 crore by auctioning 3 securities that will mature in 2028, 2033, and 2052.
- ✓ Additionally, the GoI can retain additional subscriptions up to Rs 2,000 crore for each security.

RBI Data: Bank credit growth Increased by 15% in FY23, Highest since FY12

- ✓ According to the Reserve Bank of India (RBI) data, India's Bank credit increased by 15% year-on-year (YoY) in the Financial year 2022-23 (FY23), against 9.6% YoY in 2021-22 (FY22).
- ✓ FY23 credit growth is the highest since FY12 when it was 19.3%.
- ✓ Bank deposits expanded 9.58% YoY in FY23, against 8.9% YoY growth in FY22.
- ✓ In FY23, the bank deposit mobilisation was lagged behind credit disbursements.
- ✓ Rs 15.78 trillion was raised through deposits in FY23, against Rs 13.51 trillion raised in FY22.

✓ The credit in absolute terms rose Rs 17.83 trillion in FY23, up from Rs 10.43 trillion in FY22. According to the RBI's data on Scheduled Bank's Statement of Position in India, the outstanding credit stood at Rs 136.75 trillion at the end of the last fortnight of FY23 (on March 24, 2023), up from Rs 118.91 trillion in FY22 (on March 25, 2022).

- ✓ Outstanding deposits stood at Rs 180.43 trillion in FY23, against Rs 164.6 trillion in FY22.
- ✓ The interest rate on one-year term deposits was in the range of 5-5.6% around the end of March 2022 and moved up to 6-7.25% by the end of March 2023.
- ✓ The savings deposit rate remained in the range of 2.7-3% in March 2022 and March 2023.

RBI simplifies the application process for registration of CICs

- ✓ On April 10, 2023, RBI has undertaken a comprehensive review of the system of processing of applications for registration of Core Investment Companies (CICs) to make the process smoother and easier.
- ✓ The application form has been revamped to make it structured and aligned with the extant CIC regulations.
- ✓ To make the registration process user friendly, the number of documents to be furnished along with the application form has been reduced to 18 from the existing set of 52 documents.

RBI Granted AD Category-I Licence to AU SFB, Equitas SFB to Deal in Foreign Exchange

- ✓ On 19th April 2023, the Reserve Bank of India (RBI) has granted an Authorised Dealer(AD) category-I licence to AU Small Finance Bank (SFB) under Section 10 of FEMA (Foreign Exchange Management Act), 1999 to deal in foreign exchange. The permission is subject to compliance with applicable regulations.
- ✓ The licence will enable AU Small Finance Bank to open a range of foreign currency-related products to serve the importer-exporter segment and process inward and outward remittances.

RBI accepts Rs 5,500 crore Bids at Switch and Conversion Auction of Government Bonds

- ✓ On 17th April 2023, the Reserve Bank of India (RBI) accepted bids worth Rs 5,500 crore at an auction for the switching and conversion of 5 Government of India (GoI) bonds against the notified amount of Rs 11,000 crore.
- ✓ Against the notified amount of Rs 4,000 crore, bids for the floating rate bond (FRB) expiring in 2024, which will be converted into the paper to be redeemed in 2032, were accepted at Rs 2,000 crore.

InPrime Finserv Received NBFC Licence from RBI

- ✓ InPrime Finserv (a brand owned by STK Credit Private Limited), a financial services start-up catering to the informal economy, has obtained a Certificate of Registration (COR) from the Reserve Bank of India (RBI) to operate as a Non-Banking Financial Company (NBFC).
- ✓ InPrime is on a mission to 'Redefine the way informal customers access formal finance'.
- ✓ It is focused on providing financial services to the 'Prime' segment of India's informal economy, which consists of around 50 million households with an annual credit need of Rs. 5 Lakh Crores.

Capacity Utilisation robust but New Orders dip in Q3FY23: RBI's 60th OBICUS

- ✓ The Reserve Bank of India (RBI) has conducted the 60th round of quarterly Order books, Inventories and Capacity Utilization survey (OBICUS) covering 762 manufacturing companies. It was conducted during Q3:2022-23 to provide a snapshot of demand conditions in India's manufacturing sector during October- December 2022.
 New order book
- ✓ In Q3FY23, New order book of companies recorded a decline to 8.4% indicating a slowdown in demand in the manufacturing sector.

- ✓ The average amount of new order books has dipped from its peak of Rs 307.9 crore in Q2 FY23 to Rs 212.2 crore in Q3FY23.
- ✓ This decline is due to Difficult external environment with the threat of recession in many advanced economies and slowing domestic demand due to RBI's aggressive rate hikes.
- ✓ While the growth of New Order Books was negative between Q2FY20 and Q1 FY21, the order book grew consecutively in the next three quarters till Q1FY22, registering a staggering 105% growth. Capacity Utilization
- ✓ Capacity Utilization (CU) at manufacturing facilities was at a robust 74.3% in Q3 FY23, up from 74% in Q2.
- ✓ Utilization has held above the 72% mark since Q3 FY22, indicating that the manufacturing activity is taking place at a rapid pace.
- ✓ Utilisation had hit a low of 47.3% in Q1 FY21 when most manufacturing units cut down production. The pre- pandemic level (Q1 FY20) was 73.6%.

SCBs end FY23 with 15.4% Credit Growth: RBI Data

- ✓ According to the Reserve Bank of India (RBI) data on 'Sectoral Deployment of bank Credit- March 2023', Scheduled commercial banks (SCBs) reported a robust credit growth of 15.4% in FY23 as compared to the 9.7% in FY22.
- ✓ The development is driven by growth in personal loans, and loans to services sector, and agriculture and allied activities.
- ✓ The data for the same was collected by RBI from 40 select SCBs accounting for about 93% of the total non-food credit deployed by all SCBs.
- ✓ Personal loans registered a growth of 20.6% in FY23 as compared with 12.6% in FY22, driven by housing loans.
- ✓ Credit growth to services sector accelerated to 19.8% in FY23 from 8.7% in FY22 due to the improved credit to NBFCs and trade.
- ✓ Credit to agriculture and allied activities rose by 15.4% in FY23 as compared with 9.9% in FY22. Credit to industry registered a growth of 5.7% as against 7.5% in FY22.

SCIENCE AND TECHNOLOGY

James Webb Telescope Discovered 4 Oldest Galaxies

 \checkmark According to the papers published in the journal

"Nature", a team of 80 international astronomers from 10 countries have detected 4 oldest



galaxies in the known universe using the James Webb Space Telescope (JWST).

- ✓ The observations were part of the JWST Advanced Deep Extragalactic Survey (JADES), which gets just over one month of the telescope's time spread over two years, and is designed to provide a view of the early universe unprecedented in both depth and detail.
- ✓ The light from the 4 galaxies took more than 13.4 billion years to reach Webb located nearly 15 lakh kilometres away from Earth.
- ✓ These galaxies date back to less than 400 million years after the big bang when our universe came to life.
- ✓ These four galaxies exist in the epoch of reionization, a time when astronomers think the first stars were being created.

MIT Engineers developed Injectable Synthetic nanoparticles and a polymer to Stop Internal Bleeding

- ✓ Engineers at the Massachusetts Institute of Technology (MIT), Massachusetts, United States of America (USA), has designed a two-component system – a combination of Synthetic nanoparticles and a polymer that can be injected into the body and help form blood clots at the sites of internal injury.
- ✓ These materials mimic the actions of both platelets and fibrinogen, a protein that helps form clots. The nanoparticle recruits platelets and a polymer mimics fibrinogen.
- ✓ The paper on the study was published in the "Advanced Healthcare Materials". It can be injected into the body and help form blood clots at the sites

of internal injury can save people from severe internal injuries.

✓ The two components performed significantly better than hemostatic nanoparticles that were developed earlier.

Japanese startup iSpace failed to land its Hakuto-R lander on Moon

- ✓ On 25th April 2023, Tokyo (Japan)-based iSpace Inc, a private lunar robotic exploration company, failed its moon landing mission after its Hakuto-R Mission 1 (M1) lander unexpectedly accelerated and probably crashed on the lunar surface.
- ✓ The robotic Hakuto-R aimed to become the first private spacecraft, and the first Japanese-built vehicle, ever to land softly on the moon.
- ✓ The HAKUTO-R Mission 1 was launched from Cape Canaveral, Florida, the United States of America (USA) on a SpaceX rocket in December 2022 and had completed several mission objectives leading up to its landing attempt.
- ✓ Hakuto-R was over two metres (6.5 feet) tall and weighed 340 kilogrammes (kg). Hakuto means "White Rabbit" in Japanese.
- ✓ So far, only the USA, Russia and China have managed to put a spacecraft on the Lunar surface.

ISRO completes PMD operation of GSAT-12 satellite

✓ The Indian Space Research Organisation (ISRO)

completed the postmission disposal (PMD) operation of the communication satellite GSAT-12.



- ✓ GSAT-12 is the 23rd GEO (Geosynchronous Earth Orbital) satellite to undergo PMD before decommissioning and it carried 12 extended C band transponders was launched on July 15, 2011 and served for more than a decade.
- ✓ After the launch of its replacement satellite CMS-01 (Communication satellite) in 2020, it was later relocated to 47.96° E longitude from 83° E longitude where it was located till March 2021.

MF Hydra': World's First Liquid Hydrogen-Powered Ferry gets Operational

- ✓ Norwegian company Norled has launched the world's first liquid hydrogen-powered ferry vessel called 'MF Hydra'. The vessel has been going through sea trials and system tests at Hjelmeland since the beginning of 2023. MF Hydra will now operate on the triangular route of Hjelmeland-Skipavik-Nesvik.
- ✓ MF Hydra, powered by Ballard Power Systems FCwave fuel cell modules that use hydrogen to generate power, received clearance from the Norwegian Maritime Administration to start sailing.

Europe Successfully Launches JUICE Mission to Study Jupiter's Icy Moons

- ✓ On April 14, 2023, The European Space Agency (ESA) successfully launched the Jupiter Icy Moons Explorer (JUICE), via the Ariane-5 rocket from Europe's Spaceport from Kourou, French Guiana.
- ✓ Juice, a robotic explorer's, mission was to make detailed observations of the solar system's biggest planet, Jupiter and three ice-encrusted moons which scientists believed to have underground oceans where sea life could exist.
- ✓ Juice is expected to reach Jupiter in 2031 and has a mission lifespan of about three years which could be extended by 200 or more days.
- ✓ It will make multiple flybys of Jupiter's satellites Ganymede, Callisto and Europa before orbiting around Ganymede.

Taifa-1:KenyalaunchesFirstOperational Satellite into Space

- ✓ On April 15, 2023, Kenya successfully launched its inaugural operational 3U Earth Observation Satellite (EOS) 'Taifa-1' (Nation-1, in the Swahili language), using a SpaceX Falcon 9 rocket from Vandenberg Base in California, United States of America (USA).
- ✓ Taifa-1 is designed and developed by SayariLabs and EnduroSat. Created by a team of nine Kenyan engineers, it is designed to gather environmental and agricultural data, such as flood, drought,

wildfire, forest and urbanization changes data, which will be employed by authorities to manage disasters and tackle food insecurity.

- ✓ The satellite was developed over a two-year period at a cost of 50 million Kenyan shillings (USD 372,000), with assistance from the Bulgarian aerospace firm Endurosat.
- ✓ It is anticipated to operate for five years before disintegrating over a 20-year period as it enters the atmosphere and burns up.

India become 1st Country in the World to Develop Own Model to Estimated TB Cases

- ✓ India becomes the first country in the world to estimate tuberculosis (TB) burden in-country and launch its country-level mathematical model to estimate the prevalence of TB cases in India.
- ✓ The mathematical model to estimate TB cases was launched in the 36th Stop TB Partnership Board meeting (participated by delegates from 40 countries) at the One World TB summit 2023 which was held in Varanasi, Uttar Pradesh from 23- 26 March 2023.
- Existing Mechanism: Each year, the World Health Organization (WHO) Global TB Report provides a comprehensive and up-to-date assessment of the TB epidemic, and of progress in prevention, diagnosis and treatment of the disease, at global, regional and country levels.
- ✓ As per the Indian mathematical model's data, the global TB reduction number was about 11% while the reduction in TB cases in India is 18%.

ISRO launched 2 Singaporean Satellites under PSLV-C55/TeLEOS-2 Mission

✓ On 22nd April 2023, the Indian Space Research

Organisation (ISRO) launched PSLV-C55 with two Singaporean satellites – TeLEOS-2 as the primary satellite



and Lumelite-4 as a co-passenger satellite, as a part of the PSLV-C55/TeLEOS-2 mission, from Satish

- ✓ The 2 satellites, TeLEOS-2 and Lumelite-4 were intended to be launched into an Eastward lowinclination orbit.
- ✓ This marks the 57th flight of the Polar Satellite Launch Vehicle(PSLV) and the 16th mission using the PSLV Core Alone configuration (PSLV-CA).
- ✓ The PSLV-C55 also carried the PSLV Orbital Experimental Module-2 (POEM-2).
- ✓ The two satellites are being launched under a contract with the New Space India Limited (NSIL), the commercial arm of ISRO.
- ✓ The TeLEOS-2 satellite was developed under a partnership between the Defence Science and Technology
- ✓ Agency (DSTA), representing the Government of Singapore, and ST Engineering(Singapore Technologies Engineering Ltd)
- ✓ The LUMELITE-4 satellite was co-developed by the Institute for Infocomm Research (I2R) of the Agency for Science, Technology and Research (A*STAR) and the Satellite Technology and Research Centre (STAR) of the National University of Singapore(NUS).

China's Space Pioneer Launched Liquid-Fueled Rocket – Tianlong-2 into Orbit

- ✓ On 2nd April 2023, Space Pioneer (also known as Beijing Tianbing Technology Company Limited), a Chinese aerospace company developing reusable orbital rocket technology, launched its Tianlong-2(TL-2) Yaoyi carrier rocket, a liquid-fueled rocket, from the Jiuquan launch centre in northwest China.
- ✓ With this launch, Space Pioneer becomes the 1st Chinese aerospace company(private) to launch a liquid-fueled rocket into orbit and this also marks the first time a startup company has successfully reached orbit on its 1st attempt.

Fengyun-3G: China launches 1st satellite dedicated to monitoring heavy rainfalls

 ✓ On April 16, 2023, China launched Fengyun-3G(FY-3G), its first satellite allowing scientists to monitor the Earth's precipitation from space. It was launched by China's Long March 4B rocket from the Jiuquan Satellite Launch Center in Northwest China's Gansu Province.

- ✓ With a lifespan of 6 years (2023 2029), FY 3G is dedicated to monitoring heavy rainfalls during catastrophic weather conditions in global regions of low- and mid-latitude i.e. it will forecast global meteorological disasters through its powerful tool.
- \checkmark This is one of only three such satellites in the world.
- ✓ This satellite is a continuation of the Global Precipitation Measurement mission (GPM) which is led by Japan and the United States of America(USA).

BDL Successfully Tested the Indigenous Anti Tank Guided Missile, Amogha-III

✓ Bharat Dynamics Limited (BDL) successfully conducted a field firing test of its indigenous third

generation manportable Anti Tank Guided Missile (ATGM), Amogha-III.

✓ Amogha-III has been developed under Integrated Creided



Integrated Guided Missile Development Programme (IGMDP) by the Research and Development (R&D) Division of BDL.

- ✓ About Amogha-III ATGM:
- ✓ The model of the new 3rd Generation ATGM, Amogha III was unveiled during the DefExpo 2020, a flagship biennial event of the Ministry of Defence(MoD) held in Lucknow, Uttar Pradesh in February 2020 in a hybrid format.
- ✓ The whole missile system comes with a command launch unit (CLU), remote operation capability and a tripod.
- ✓ Amogha-III ATGM which requires no external intervention following the lauch boasts the fire and forget capability.
- ✓ The missile also features a dual-mode Imaging Infrared (IIR) Seeker with a range of 200 to 2500 meters.

DEFENCE

Solar Industries bagged the contract to supply 400 Nagastra-1 drones to the Indian Army

- On April 21, 2023, the Nagpur (Maharashtra)-based Solar Industries India Limited has bagged an order to supply 400 Unmanned Aerial Vehicle (UAV) 'Nagastra – I' to the Indian Army. Solar Industries won the contract defeating competitors from Israel and Poland.
- ✓ The 1st indigenous man-portable loitering munition (LM), Nagastra-1(a fixed-wing electric UAV), has been designed and developed by Economics Explosives Ltd (EEL), a wholly owned subsidiary of Solar Industries, in association with Zmotion Autonomous Systems Private Limited(Z-Motion) based in Bengaluru, Karnataka.

India Acquires Weapons Worth USD 300 Million from US for Indian Navy

- ✓ India is set to clear the proposal to acquire armaments worth over USD 300 million from the United States of America(USA) to arm the Indian Navy's MH 60 "Romeo" chopper, the multi-role helicopters which will enhance its capabilities to counter enemy warships and submarines.
- ✓ Under this, the fleet of 24 choppers will get additional Hellfire missiles and Mk 54 lightweight torpedoes.

Ajeya Warrior 2023: India UK joint military exercise begins at Salisbury Plains of UK

- Ajeya Warrior 2023, The 7th edition of India and the United Kingdom (UK) bilateral training exercise 'Ajeya Warrior' commenced at the Salisbury Plains, UK on 27th April 2023.The exercise will culminate on 11th May, 2023.
 Participants
- ✓ The UK Soldiers of the 2 Royal Gorkha Rifles, a rifle regiment of the British Army, and Indian Army soldiers from the BIHAR Regiment, an Indian Army infantry regiment, are participating in the exercise.

Exercise Orion: IAF Participated in Multilateral Military Exercise at Mont-de-Marsan Airbase in France

- ✓ On April 17, 2023, Exercise Orion, a Multilateral Military Exercise, was initiated at Mont-de-Marsan, an Air Force base of the French Air and Space Force (FASF) in France. Indian Air Force (IAF) contingent will take part in the exercise which will be conducted from 17th April 2023 to 5th May 2023.
- ✓ Along with IAF and FASF, Air Forces from Germany, Greece, Italy, Netherlands, United Kingdom, Spain and the United States of America (USA) also participates in the exercise.

Indian Navy conducts offshore security exercise 'Prasthan' in Mumbai

- ✓ On April 6th 2023, Indian Navy conducted the offshore security exercise Prasthan, a bi-annual co-ordinated exercise along with other defence, state and civilian agencies on the Greatdrill Chaaya platform about 30 nautical miles(nm) South West of Mumbai harbour, Maharashtra.
- ✓ The previous 'Prasthan' exercise was conducted on 11th and 12th October 2022 in the Krishna Godavari Basin Offshore Development Area (ODA) under the aegis of Headquarters, Eastern Naval Command, Visakhapatnam in Andhra Pradesh.

Exercise Cope India 23 begins between Indian Air Force and US Air Force in West Bengal

- ✓ The first phase of Exercise Cope India 23(CI23), a bilateral Air Exercise between the Indian Air Force (IAF) and the United States Air Force began on 10th April 2023 at Air Force Station Arjan Singh(Panagarh Air Force base) in Panagarh, West Bengal(WB).
- ✓ The 11-day exercise is scheduled to be held in Panagarh, Kalaikunda(West Bengal) and Agra (Uttar Pradesh)air force stations.

- ✓ The 1959 Ramon Magsaysay award was given by the Ramon Magsaysay Award Foundation in the Philippines in August 1959.
- ✓ It was the first international recognition given to the 14th Dalai Lama for his leadership in the preservation of Tibet's society, religion and culture and way of life during a critical time
- ✓ GyaloThonden, elder brother of Dalai Lama, had received the Magsaysay Award on his behalf in Manila, the Philippines in August 1959.

Winners of Goldman Environmental Prize 2023 Announced

- ✓ On April 24, 2023, winners of the Goldman Environmental Prize 2023 were announced at the War Memorial Opera House in San Francisco, California, the United States of America(USA). 6 winners of the 2023 prize are Alessandra Korap Munduruku from Brazil, Chilekwa Mumba from Zambia, Delima Silalahi from Indonesia, Diane Wilson from the USA, Tero Mustonen from Finland, and Zafer Kızılkaya from Türkiye.
- ✓ 2023 marks the 34th anniversary of the Goldman Environmental Prize which honors one grassroots activist from each of the six inhabited continents.
- ✓ The award is also known as the "Green Nobel Prize".
- ✓ The ceremony for the same was hosted by Rue Mapp, founder of Outdoor Afro, an organization dedicated to celebrating Black connections and leadership in nature

Karnataka Bags National Award For Pradhan Mantri Fasal Bima Yojana

- ✓ In a first, Karnataka has bagged the national award for the best implementation of Pradhan Mantri Fasal Bima Yojana (PMFBY), a crop subsidy insurance scheme, for the year 2022-23.
- ✓ The award was received by the Secretary to the government, Department of Agriculture, Karnataka, Shivayogi C Kalasad, at the national conference at Chhattisgarh on April 14 2023.
- ✓ Under the scheme (between the kharif season 2021 and 2022), the state recorded a 47.74% increase in the enrolment of farmers and the area covered under the scheme increased by 41.80%.

Union Bank of India Secures 1st Rank in EASE Reforms Index for Q3 FY23

- ✓ On April 20, 2023, As per the report on Enhanced Access & Service Excellence (EASE) Reforms Index for Q3 FY23 published by Indian Banks' Association (IBA), the Union Bank of India, for the first time, secures 1st rank among all PSB (Public Sector Banks) for adopting various reforms prescribed for PSBs.
- ✓ EASE is an initiative by the Department of Financial Services (DFS), Ministry of Finance, as part of the PSB Reforms Agenda and is currently under its 5th iteration which focuses on Enhanced Digital experience, Data – driven, Integrated and Inclusive Banking.

Economist Utsa Patnaik selected for Malcolm Adiseshiah Award 2023

- ✓ Utsa Patnaik, a renowned economist of national and international repute, has been selected for the Malcolm Adiseshiah Award 2023 by the Malcolm & Elizabeth Adiseshiah Trust (MEAT) based in Chennai, Tamil Nadu (TN).
- ✓ MalcolmAdiseshiah Award is annually presented by the MEAT to honour the contributions of outstanding social scientists in the field of development studies.
- ✓ The recipients are selected by a national-level jury specially constituted for this purpose, from the nominations received.

Noted Indian-American statistician CR Rao wins the 2023 International Prize in Statistics

✓ Calyampudi Radhakrishna Rao (CR Rao), a



prominent Indian-American Statistician, has been awarded the 2023 International Prize in Statistics, the

statistics' equivalent of the Nobel Prize, for his monumental work 75 years ago that revolutionised statistical thinking.

- ✓ CR Rao will receive the prize, which comes with a USD 80,000 award, in July 2023 the biennial International Statistical Institute(ISI) World Statistics Congress, which will be held in Ottawa, Ontario, Canada.
- ✓ The International Prize in Statistics, established in 2016, is awarded biennially at the ISI World Statistics Congress.

SIPRI Report: World Military Expenditure in 2022 rose by 3.7% to US\$2240 billion; US Topped the List, India Ranked 4th

- ✓ According to the SIPRI (Stockholm International Peace Research Institute) Fact Sheet April 2023 'Trends In World Military Expenditure, 2022', World military expenditure grew for the 8th consecutive year in 2022 by 3.7% in real terms (i.e. when adjusted for inflation) to an all-time high of US\$2240 billion.
- ✓ With a military expenditure of US\$81.4 billion, India was the fourth largest spender in the world in 2022. Its spending increased by 6.0% from 2021 and 47% from 2013. The United States, China, Russia, India and Saudi Arabia, were the five biggest spenders in 2022, which together accounted for 63% of world military spending.
- ✓ Total world military spending accounted for 2.2% of global gross domestic product (GDP) in 2022.

Al Index Report 2023: India Ranked 5th with most Al Investment; US Tops

- ✓ According to 'Artificial Intelligence Index Report 2023', the 6th edition of the annual Artificial Intelligence(AI) index report published by Stanford University's Human-Centered Artificial Intelligence (HAI), India is ranked 5th in terms of private investments received in 2022 by startups offering AI-based products and services with a total investment of US\$3.24 billion.
- ✓ In 2022, the United States (US) led the world in terms of total AI private investment with US\$47.4 billion investment followed by China (US\$13.4 billion), United Kingdom (US\$4.4 billion), Israel (US\$3.24 billion).
- ✓ India which stood in 5th place was ahead of South Korea, Germany, Canada and Australia, among others.
- ✓ Global AI private investment was \$91.9 billion in 2022, which represented a 26.7% decrease since 2021.

India – Ranked 77 in World's 'most criminal countries' List, Ranked 71 at Crime Rate by Country 2023

- ✓ According to the ranking of the world's 'most criminal countries' released by the World of Statistics, Venezuela ranked first in the list followed by Papua New Guinea and Afghanistan. India was at the position 77th on the list of criminal countries.
- ✓ The US (United States) and the UK(United Kingdom), have ranked 55th and 65th, being ahead of India in the criminal ranking country.
- ✓ Turkey, Germany, and Japan were among the least criminal countries, ranking at 92nd, 100th, and 135th ranks.
- The top 10 most criminal countries list include Venezuela (1), Papua New Guinea (2), Afghanistan (3), South Africa (4), Honduras (5), Trinidad (6), Guyana (7), Syria (8), Somalia (9) and Jamaica (10).
- ✓ As per the World Population Review's (WPR) 'Crime Rate by Country 2023', Venezuela ranked as the country with the highest crime rates globally with a crime Index of 83.76.
- ✓ India was ranked 71 with a crime index of 44.43.

Mumbai ranked 19th in 'Best public transport in the world 2023'

- According to a survey published by London (United Kingdom) based global magazine 'Time Out', India's Financial Capital Mumbai (Maharashtra) was ranked 19th in the list of 'Best public transport in the world 2023'.
- \checkmark Mumbai is the only Indian city to feature in the list.
- ✓ The list is topped by Germany's Berlin with the best public transport system globally. It has the most reliable, safe, and comfortable public transport network. 97% of its residents praised the public transit network, particularly for its metro system, U-Bahn.
- ✓ The survey was conducted among 20,000 respondents in 50 cities worldwide to gauge public sentiment about their local transport systems.

World's Wealthiest Cities Report 2023 released by Henley & Partners; New York tops

- ✓ The investment migration firm Henley & Partners released its annual 'World's Wealthiest Cities Report 2023' which is again topped by New York, United States of America (USA) with 340,000 millionaires, 724 centi- millionaires, and 58 billionaires in 2022.
- ✓ New York followed by Tokyo (Japan), California's Bay Area (USA), London (United Kingdom) and Singapore.
- ✓ The annual survey looked at 97 cities in 9 regions around the world viz. Africa, Australasia, CIS (Commonwealth of Independent States), East Asia, Europe, the Middle East, North America, South Asia, and Southeast Asia. The data is supplied by wealth intelligence firm, New World Wealth.
- ✓ Established in 2013, New World Wealth tracks the movements and spending habits of the world's wealthiest people.
- ✓ The US has emerged as the leader in the number of wealthy cities, with 10 out of the top 50 cities in the world. It is followed by China with five and Australia with four.

Top 10 Busiest Airports Worldwide for 2022

- ✓ According to ACI, the top 10 airports for total passenger traffic, which account for 10% of global traffic, saw a 51.7% increase from 2021, amounting to an 85.9% improvement over their 2019 figures.
- \checkmark Five of the top ten airports in the world are located in the United States (US), and they all have sizable domestic passenger shares (ranging from 75% & 95% of domestic traffic). Dallas/Fort Worth International Airport (DFW, 73.4 million passengers) is in the 2nd spot, followed by Denver International Airport (DEN, 69.3 million passengers) in the 3rd spot, Chicago O'Hare Airport (ORD, 68.3 million passengers) in the 4th spot.
- Dubai Airport (DXB, 66.1 million passengers, +127%) at 5th rank and Istanbul Airport (IST, 64.3 million passengers, +73.8%) at 7th rank, were also

reinstated in the top ten. It is followed by London Heathrow Airport, Delhi Airport, and Paris CDG Airport in the 8th, 9th, and 10th places, respectively.

3rd India Justice Report 2022: Karnataka tops among Large States in Delivery of Justice

- ✓ According to the 3rd edition of India Justice Report (IJR 3) 2022 released on 4th April 2023, Karnataka has topped the overall ranking among the large and mid-sized States (states with a population over 1 crore).
- ✓ Karnataka is followed by Tamil Nadu (TN) in 2nd position and Telangana in 3rd position.
- ✓ In this category, Uttar Pradesh (UP) is at rank 18th which is the lowest.
- ✓ Sikkim topped the overall ranking among Small States (states with a population up to 1 crore).
- ✓ Sikkim has been followed by Arunachal Pradesh at 2nd and Tripura at 3rd place. Goa is at rank 7th which is the lowest.

WB's World Development Report 2023: Globally 185 million People are Migrant

- According to the World Bank's (WB) annual report 'World Development Report 2023: Migrants, Refugees, and Societies', there are 184 million people (i.e. 2.3 % of the world's population) are migrants (i.e. they lack citizenship in the country in which they live) in which the largest share of 43% of them was living in low- and middle-income countries.
- ✓ The report provides a comprehensive analysis of international migration and its potential to serve as a force for growth and shared prosperity in all countries and it proposes policies to better manage migration in destination, transit, and origin countries.
- ✓ As per the report, the faster ageing of economies will increase dependence on migration.
- ✓ Out of the 184 million migrant people, 37 million are refugees, a number that has tripled over the last decade.
