#### person of the month

Bal Gangadhar Tilak (23 July 1856 - 1 August 1920)

Recently, the Prime Minister of India paid tributes to Bal Gangadhar Tilak on his Jayanti on 23rd July 2023.

#### About

- Bal Gangadhar Tilak, born on 23rd July 1856, was a freedom fighter, lawyer, and educationist known as Lokmanya Tilak.
- Tilak emphasized the need for self-rule or swarajya and popularized the slogan "Swaraj is my birthright and I shall have it!"
- \*Tilak passed away on 1st August 1920, leaving behind a significant contribution to India's freedom movement.


#### Major Contributions

- \* Tilak founded the Deccan Education Society in 1884, he also established the Fergusson College in 1885.
- \* Tilak joined the Indian National Congress in 1890 and played a significant role in the Surat Split in 1907, advocating complete independence or swarajya.
- \*Tilak founded the All-India Home Rule League in April 1916, aiming for Hindu-Muslim unity through the Lucknow Pact in 1916.
- \* Known for his newspapers Kesari (Marathi) and Mahratta (English) and authored books like Gita Rhasya and Arctic Home of the Vedas.
- \* He propagated the Swadeshi and Boycott Movement to promote Indian self-reliance.
- \* Indian Home Rule Movement: It was a movement in British India along the lines of the Irish Home Rule movement.

  Starting in 1916, it is believed to have set the stage for the independence movement under the leadership of Annie Besant and Bal Gangadhar Tilak for the educated English-speaking upper-class Indians.

Between 1908 and 1914, Tilak spent 6 years in Mandalay Prison for defending the actions of revolutionaries Khudiram Bose and Prafulla Chaki.

IACE



India's third moon mission, Chandrayaan-3, was successfully launched onboard a Launch Vehicle Mark-3 (LVM-3) rocket from the second launch pad at the Satish Dhawan Space Centre in Sriharikota at 2.35 pm on July 14. This is India's second attempt at soft-landing robotic instruments on the lunar surface after the previous attempt, Chandrayaan-2, failed in 2019.

#### • Highlights of Chandrayaan-3

- ✓ Chandrayaan-3 consists of an indigenous Lander module (LM), Propulsion module (PM) and a Rover with an objective of developing and demonstrating new technologies required for Inter planetary missions.
- ✓ The lander (Vikram) and rover payloads (Pragyan) of Chandrayaan-3 remain the same as the Chandrayaan-2 mission.
- ✓ The scientific payloads on the lander aim to study various aspects of the lunar environment. These payloads include studying lunar quakes, thermal properties of the lunar surface, changes in plasma near the surface, and accurately measuring the distance between Earth and the moon.
- ✓ The propulsion module of Chandrayaan-3 features a new experiment called Spectro-polarimetry of Habitable Planet Earth (SHAPE).

✓ SHAPE aims to search for smaller planets with potential habitability by analyzing reflected light.

#### ✓ Objectives of Chandrayaan-3

- To demonstrate Safe and Soft Landing on Lunar Surface
- To demonstrate Rover roving on the moon and
- To conduct in-situ scientific experiments.
- ✓ Chandrayaan 3's landing process involves three stages: Earth orbit manoeuvres, Trans-lunar injection, and Lunar orbit manoeuvres. Once completed, the lander separates from the main spacecraft and performs a soft landing on the moon
- ✓ The spacecraft will take nearly 42 days to reach moon. The Lander and rover are expected to land near the lunar south pole region on August 23 or 24, 2023.
- ✓ The lander and the rover will have a mission life of one lunar day (about 14 Earth days) as they work on solar energy.

#### **Reason behind south pole**

- ✓ Historically, spacecraft missions to the Moon have primarily targeted the equatorial region due to its favorable terrain and operating conditions.
- ✓ However, the lunar south pole presents a vastly different and more challenging terrain compared to the equatorial region.

- ✓ Sunlight is scarce in certain polar regions, resulting in perpetually dark areas where temperatures can reach to -230 degrees Celsius.
- ✓ This lack of sunlight and extreme cold pose difficulties for instrument operation and sustainability.
- ✓ The lunar south pole offers extreme and contrasting conditions that pose challenges for humans but it make them potential repositories of valuable information about the early Solar System.
- ✓ It is crucial to explore this region which could impact future deep space exploration.
- With successful landing, <u>India will be the first</u> country to land spacecraft near Moon's South <u>Pole at 70 degrees latitude</u>, and the 4th country to soft land on the moon after the United States (US) with its Surveyor 1 in 1966; Soviet Union/Russia's Luna 9 in 1966, and China with Chang's 3 in 2013.
- ✓ According to ISRO, the Chandrayaan-3 is built on a budget of around Rs 615 crore. It is one of the most cost-effective space missions as compared to its predecessors.

#### <u>Mass</u>

- ✓ The total for Chandrayaan-3 is 3897.89 Kg consist of the following: Propulsion Module: 2148 kg.
  - Lander Module: 1752 kg including Rover of 26 kg.

#### **Chandrayaan 3 Components**

- ✓ Lander (Vikram): It is box-shaped, with four landing legs and four landing thrusters of 800 newtons each unlike Vikram on Chandrayaan-2 which had five 800 Newtons engines with a fifth one being centrally mounted with a fixed thrust. Additionally, the Chandrayaan-3 lander will be equipped with a Laser Doppler Velocimeter (LDV).
- ✓ **Rover (Pragyaan)**: The rover is a tiny, trolley kind of device with wheels. Once the lander lands on the moon, the rover will slide
- ✓ out of the lander's belly and crawl over the moon's surface like a cockroach. It will pick up soil and do experiments, punch a probe a foot down the surface to check thermal conductivity.
- ✓ **Propulsion Module(PM):** It is a replacement for orbiter (Chandrayaan 2). The main function of PM is to carry the Lander and the Rover from launch

vehicle injection till final lunar 100 km circular polar orbit and make their separation from itself.

### Scientific experiments to be conducted by Chandrayaan 3

- ✓ Gather data on the polarization of light reflected by Earth
- ✓ Measure the density of ions and electrons near the surface of the Moon and its changes over time
- ✓ Measure the temperature of the moon's surface near polar region
- ✓ Scan for moonquakes around landing site, delineating the structure of the lunar crust and mantle
- ✓ Understand the dynamics of the Moon system

#### **About Chandrayaan-1**

- ✓ India's lunar exploration missions began with Chandrayaan-1 in 2008, which aimed to create a three-dimensional atlas of the moon and conduct mineralogical mapping.
- ✓ Launch Vehicle: PSLV C11.
- ✓ Chandrayaan-1 made significant discoveries, including the detection of water and hydroxyl on the lunar surface.

#### **About Chandravaan-2**

- ✓ Chandrayaan-2 consisted of an Orbiter, Lander, and Rover, with the goal of exploring the lunar south pole.
- ✓ Launch Vehicle: GSLV MkIII-M1
- ✓ Although the lander and rover crashed on the moon's surface, the Orbiter successfully collected data and found signatures of water at all latitudes.

#### **Other Types of Moon Missions**

**Human Missions:** These missions involve the landing of astronauts on the moon's surface.

- ✓ Only NASA has achieved this feat, with six successful landings between 1969 and 1972.
- ✓ NASA's Artemis III, planned for 2025, will mark humanity's return to the moon.

**Flybys:** These missions involve spacecraft passing near the moon without entering its orbit, allowing for observations from a distance.

#### Sri Lankan President Ranil Wickremesinghe's Visit to India

✓ Sri Lankan President Ranil Wickremesinghe made an official two-day visit to India from 20- 21st July

2023. He was welcomed by Union Minister of State (MoS) for External Affairs V Muraleedharan. This



marks Wickremesinghe's first trip to India since he was elected president of Sri Lanka in July 2022.

- ✓ The visit takes place as both countries celebrate the 75th anniversary of the establishment of diplomatic relations in 2023.
- ✓ During the visit, Wickremesinghe met Indian External Affairs Minister S. Jaishankar, National Security Advisor Ajit Doval, Adani Group chairman Gautam Adani and President of India Draupadi Murmu.
- ✓ Sri Lanka is an important partner in India's "Neighbourhood First" policy and SAGAR (Security and Growth for All in the Region)vision.
- ✓ India and Sri Lanka adopted a vision document titled, "Promoting Connectivity, Catalysing Prosperity" that would strengthen maritime, air, energy and people-to-people connectivity to boost the economic partnership between India and Sri Lanka.
- ✓ The vision is to accelerate mutual cooperation in tourism, electricity, business, higher education, and skill development.

#### <u>Important MoU's exchanged between India and</u> Sri Lanka

- Joint Declaration of Intent (JDI) in the field of Animal Husbandry and Dairying
- MoU on cooperation in the field of renewable energy.
- Memorandum of Cooperation for economic development projects in Trincomalee district of Sri Lanka.

- Network to Network Agreement between NPCI International Payments Limited (NIPL)and Lanka Pay for UPI application acceptance in Sri Lanka
- Energy Permit for Sampur Solar Power Project.

#### UAE becomes 1st Arab Country to Get Observer Status at Asia/Pacific Group on Money Laundering

✓ The United Arab Emirates (UAE) has become the first Arab country to be granted observer status of

the Asia- Pacific Group on Money Laundering (APG), the largest Financial Action Task Force-style regional body (FSRB) in the world. The decision was made at the APG's 2023 Annual



Meeting and Technical Assistance and Training Forum held in Vancouver, British Columbia, Canada from 9-14 July 2023.

- The meeting was attended by a UAE delegation led by Hamid Al Zaabi, Director-General of the Executive Office of Anti-Money Laundering and Counter-Terrorism Financing (EO AML/CTF).
- ✓ The UAE was named to the Financial Action Task Force list in 2022. The list denotes countries that are working to address "strategic deficiencies" with regard to money laundering and illicit financing, which the UAE has displayed via its participation in Middle East and North Africa Financial Action Task Force (MENAFATF).

# Italy unveils memorial to honour Indian Army Soldiers who fought in World War-II

✓ On 22nd July 2023, the Commune of Monotone, Italy and the Italain Military historians unveiled the

V.C Yeshwant Ghadge Sundial Memorial at Montone, Perugia, Italy, as a tribute to the Indian soldiers from the 4th, 8th and 10th Divisions,



- who fought in the Italian Campaign, during the Second World War (WW-II) (1939-1945).
- The memorial also honoured the supreme sacrifices of Indian Soldier, Naik Yeshwant Ghadge, Victoria Cross (VC) recipient (posthumous), who was killed during the fighting in the of Upper Tiber Valley, Italy on 10th July 1944.
- The memorial is in the form of a live sundial. The motto of the memorial is "Omines Sub Eodem Sole", which translates in English as "We all live under the same sun".

#### World Humanitarian **Drive** special status from the UN

✓ The World Humanitarian Drive (WHD), an Non-governmental international organization

(NGO). which promotes international education and trade, has been granted special consultative status by United Nations (UN)'s **Economic** and Social Council (ECOSOC). With



this ECOSOC status, WHD will be authorised to interact actively with its subsidiary bodies, the Human Rights Council, certain UN General (UNGA) Assembly sessions, intergovernmental bodies, and the UN Secretariat.

- The special consultative status will provide WHD with the privilege to access UN's meetings, provide written and oral statements to ECOSOC.
- ✓ WHD can use UN facilities including submitting a quadrennial (occurring every 4 years) report on the activities of the organisation, in support of the work of ECOSOC and the UN at a recently concluded meeting held in UN in June 2023.

#### Saudi Arabia becomes 51st Nation to sign TAC

✓ On 12th July 2023, Saudi Arabia signed the Treaty of Amity and Cooperation in Southeast Asia(TAC) with the



Association of Southeast Asian Nations (ASEAN) at the 56th ASEAN Foreign Ministers' Meeting (AMM) in Jakarta, Indonesia.

Saudi Arabia became the 51st nation to agree to the TAC and It was signed by Saudi Arabian Foreign Minister(FM) Prince Faisal bin Farhan Al Saud.

#### **About Treaty of Amity and Cooperation (TAC)**

- The TAC is a peace treaty signed by ASEAN nations in 1976 to establish a set of norms to manage regional inter-state interactions based on mutual respect for sovereignty, territorial integrity, and national identity.
- It is a legally enforceable code for regional and global inter-state relations. The Treaty has been revised three times, in 1987, 1998, and 2010, to allow states outside Southeast Asia, as well as regional bodies whose members are sovereign states, to join.

#### Russia bans change and sex transgender marriages

✓ Russian President Vladimir Putin has signed a new legislation that deals a significant blow to the

LGBTQ+ community in the country. The act, passed unanimously by both parliament, houses of prohibits strictly



individuals from officially or medically changing their gender, further marginalizing Russia's embattled LGBTQ+ population.

- The ban on gender changes and the wider crackdown on LGBTQ+ rights in Russia are rooted in the Kremlin's pursuit of preserving what it deems as the nation's "traditional values."
- ✓ Lawmakers argue that the legislation is essential to protect Russia against what they view as "western anti-family ideology."

#### India Extends UPI **Payments France**

✓ On July 13, 2023, during Prime Minister Narendra Modi's state visit to France, India and France signed groundbreaking agreement that allows Indian tourists to use Unified Payments India's



Interface (UPI) for transactions in rupees.

- ✓ This partnership marks a significant milestone as it brings UPI, a popular mobile-based payment system, to Europe for the first time after its successful implementation in Singapore. The move is set to revolutionize the payment experience for Indian tourists in France, eliminating the need to carry foreign currency and offering convenience and flexibility.
- ✓ Since its inception, UPI has steadily expanded its reach globally through strategic partnerships. France is the latest addition to the list of countries that have embraced the UPI system for cross-border transactions. Prior to this agreement, UPI had already established itself in countries like Singapore, Bhutan, Nepal, and the UAE.

# India-Japan Sign MoC for Semiconductor Supply-Chain Partnership

- ✓ On 20th July 2023, India and Japan signed a memorandum of cooperation (MoC) for a semiconductor supply- chain partnership for government-to-government and industry-to-industry collaboration.
- ✓ The agreement was signed between Ashwini Vaishnaw, Union Minister for Electronics and Information Technology and Yasutoshi Nishimura, Japan's Minister of Economy, Trade and Industry in New Delhi, Delhi.
- ✓ The MoC helps India to become a global hub for the semiconductor industry and provides access to Japanese technology, which helps India to develop its own semiconductor industry.
- ✓ The MoC signed between India and Japan will cover the semiconductor industry, including design, manufacturing, equipment research, talent development, and enhancing supply chain resilience.

### Third World Hindu Conference to be organized in Bangkok

The World Hindu Foundation has announced that the third World Hindu Congress (WHC) will be held in Bangkok in November 2023. The three-day event, known as Vishwa Hindu Sammelan, will take place at the Convention Center in Bangkok.

With the theme "Jayasya Aayatnam Dharmah" meaning "Dharma, the Abode of Victory," the

conference will focus
on exploring
opportunities and
addressing challenges
faced by the global
Hindu community.



✓ The World Hindu Congress is organized by the World Hindu Foundation, with Swami Vigyananand serving as its trustee. Swami Vigyanananda is also the Managing Trustee of the Vishwa Hindu Foundation and the Joint General Secretary of the Vishwa Hindu Parishad (VHP). The foundation aims to bring together Hindus from around the world and provide a platform for discussing various issues.

### India, Panama sign MoU on electoral cooperation

✓ India's Election Commission (ECI) and Panama's Electoral Tribunal (ET) have taken a significant step towards enhancing their collaboration in the field of election management and administration. A Memorandum of Understanding (MoU) was signed between the two institutions in Panama City, establishing an institutional framework for ongoing cooperation. The ECI delegation, led by Chief Election Commissioner Rajiv Kumar, engaged in discussions with Alfredo Juncá Wendehake, the Presiding Magistrate of Panama's Electoral Tribunal, on various aspects of strengthening collaboration and knowledge exchange between the two Election Management Bodies.

### India and Singapore extend MoU on cooperation for 5 years

The Department of Administrative Reforms and Public Grievances of India and the Public Service Division of the Republic of Singapore recently signed a protocol document to extend their memorandum of understanding for five more years until 2028. The MoU encompasses various areas of cooperation aimed at promoting administrative reforms, public sector transformation, and capacity building.

#### PM Narendra Modi's Visit to UAE

- ✓ On July 15, 2023, PM Narendra Modi officially visited Abu Dhabi, United Arab Emirates (UAE).
  - This mark's his 5th visit to UAE since 2015.
- ✓ He was welcomed by Crown Prince of Abu Dhabi, HH Sheikh



Khaled bin Mohamed bin Zayed Al Nahyan at the airport and a ceremonial welcome and Guard of Honour were accorded to Modi.

#### **Highlights**

- ✓ During his visit, PM Modi met with His Highness Sheikh Mohamed bin Zayed Al Nahyan President of the UAE, in Abu Dhabi, UAE.
- ✓ During the visit, the Indian PM met Dr. Sultan Al Jaber, President-designate of CoP28 (Conference of the Parties to the UN Framework Convention on Climate Change) and Group CEO of Abu Dhabi National Oil Company.
- ✓ During the visit, two agreements were inked between the Reserve Bank of India (RBI) and Central Bank of UAE (CBUAE) to facilitating seamless cross border transactions and payments, and foster greater economic cooperation between the two countries.
- ✓ During the visit,IIT (Indian Institute of Technology)
  Delhi inked a Memorandum of Understanding
  (MoU) with Abu Dhabi Department of Education
  and Knowledge (ADEK) and the Ministry of
  Education, Government of India, to set up its
  international campus in Abu Dhabi.

#### **PM Narendra Modi's Visit to France**

✓ Prime Minister Narendra Modi paid a 2-day official

visit to France from 13th to 14th July 2023 at the invitation of H.E. Mr Emmanuel Macron, President of France.



#### **Highlights**

- ✓ On 13th July 2023, PM Modi was conferred with the Grand Cross of the Legion of Honour, the highest French order of Merit(both Civilian and Military).
- ✓ PM Narendra Modi has become the first Indian PM to have been conferred with the Grand Cross of the Legion of Honour, France's highest civilian and military honour, by French President Emmanuel Macron at the Elysee Palace in Paris, France.
- ✓ During his visit, PM Modi held formal talks with President Macron and also meet with Élisabeth
- ✓ Borne, Prime Minister(PM) of France, Gerard Larcher, President of the French Senate, and the National Assembly of France.

- ✓ In order to set out their shared vision for this next phase of the India-France Strategic Partnership, both leaders adopted the 'Horizon 2047: 25th Anniversary of the India-France Strategic Partnership, Towards A Century of India-France Relations'.
- ✓ India, France committed to eliminate single use plastic products pollution, intensify maritime cooperation in Indo-Pacific, enhance cooperation in strategic areas, space, science, sustainable development, deepening cooperation in digital public infrastructure, cybersecurity, startup, AI, increase cooperation to end cross-border terrorism.
- ✓ PM Narendra Modi gifted a 'sandalwood sitar' to French President Emmanuel Macron. This unique replica of a musical instrument is an art of sandalwood carving that has been practised in Southern India for centuries.
- ✓ French President Emmanuel Macron gifted Prime Minister Narendra Modi a framed facsimile of a 1916 photograph of a Parisian presenting flowers

to a Sikh officer and a replica of the Charlemagne chessmen, dating back to the 11th Century.

### Union Cabinet Approves Mumbai based NITIE as 21st IIM of India

- ✓ On 12th July 2023, the Union Cabinet chaired by the Prime Minister Narendra Modi approved a bill amending IIM Act to include the National Institute of Industrial Engineering (NITIE) in Mumbai as the 21st Indian Institute of Management (IIM). The amendment will rename NITIE Mumbai as IIM Mumbai.
- ✓ Maharashtra is set to become the first state to have two IIMs, which includes IIM Nagpur, established by the Government of India in 2015, and newly designated IIM Mumbai.
- ✓ The approved bill to be passed in the monsoon session of Parliament, which is set to take place from July 20 to August 11, 2023.

# Union Cabinet has Approved Commercial Mining of 6 Critical Minerals through MMDR Act

- ✓ On 12th July 2023, Union Cabinet approved amendments to the Mines and Minerals (Development & Regulation) MMDR Act of 1957, for the commercial mining of 6 critical minerals: lithium, titanium, beryllium, zirconium, niobium and tantalum.
- ✓ This is the 5th amendment to the act since 2014. Earlier amendments authorised e-auction for minerals and enabled the extension of expiring mine leases.

# Rajya Sabha Chairman reconstituted panel of vice-chairpersons with 50% women Parliamentarians

- ✓ The Vice President of India, ex-officio Chairman of Rajya Sabha Jagdeep Dhankhar has appointed 4 women Parliamentarians namely Pilavullakandi Thekkeparambil Usha (PT Usha), Phangnon Konyak, Fauzia Khan and Sulata Deo to the panel of vice-chairpersons.
- ✓ The panel of vice chairpersons has been reconstituted with effect from 17th July 2023. The

- panel reconstituted before the Monsoon Session contains a total of 8 members, out of which half(4) are women.
- ✓ For the first time in the history of Rajya Sabha (the Upper House of the Indian Parliament) has given equal representation to women members in the panel.
- ✓ Apart from these 4 women members, V Vijaysai Reddy(AP), Ghanaashyam Tiwari(Rajasthan), Dr L Hanumanthaiah(Karnataka), Sukhendu Sekhar Ray (West Bengal) have also been nominated to the panel.
- ✓ The Vice Chairpersons conduct the proceedings of the House when the Chairman and Deputy Chairman are not available.

#### About Rajya Sabha

- ✓ Rajya Sabha is the Upper House of the Indian Parliament.
- ✓ According to article 80 of the Indian Constitution, The total allowed capacity is 250 which includes, 238 elected and 12 appointed members.
- ✓ 30 years is the minimum age required to become a member of the Rajya Sabha.

#### PM Modi Inaugrates IECC complex "Bharat Mandapam" at Pragati Maidan; IECC to host G20 Meet

- ✓ On 26th July 2023, Prime Minister (PM) Narendra Modi inaugurated a futuristic International Exhibition-cum- Convention Centre (IECC), the revamped India Trade Promotion Organisation (ITPO) complex also known as Pragati Maidan Complex, and also unveiled the G20(Group of 20) coin and stamp at Pragati Maidan in New Delhi, Delhi.
- ✓ The IECC Complex has been named "Bharat Mandapam" and the naming ceremony of the Centre was carried out using a drone.

### 7th edition of India Mobile Congress held at Pragati Maidan, New Delhi.

✓ On 12th July 2023, the Minister of Communications Ashwini Vaishnaw inaugurated the Curtain Raiser of 7th edition of India Mobile Congress (IMC 2023) at Pragati Maidan, New Delhi, Delhi.

- ✓ The Department of Telecommunications (DoT) under Ministry of Communications and the Cellular Operators Association of India (COAI) will jointly host the seventh edition of Asia's premier digital technology exhibition with the theme 'Global Digital Innovation' which is scheduled to take place from 27th to 29th October at Pragati Maidan, New Delhi.Delhi.
- ✓ IMC 2023 plans to introduce **Aspire**, a startup event aimed at fostering entrepreneurship growth among young innovators and industry delegates. It will include sections like an Investor zone, pitching zone, workshop zone, and networking zone.

- ✓ The President also launched the 2023 theme of PBKIVV, "The Year of Positive Change" for conducting nationwide seminar and conferences
- ✓ She highlighted the significance of both material and spiritual development for humanity, with technology being a crucial driver of change.
- ✓ She also acknowledged the role of PBKIVV, a social and spiritual campaign in promoting spirituality through meditation and a disciplined lifestyle, leading to mental peace.
- ✓ Brahma Kumaris, officially known as 'Prajapita Brahma Kumaris Ishwariya Vishwa Vidyalaya' is a worldwide spiritual movement founded by Pitashri Prajapita Brahma (well known as Dada Lekhraj) in 1936 in Hyderabad, Sindh (Present Pakistan) and formally established in October 1937.

#### Govt extends Atal Beemit Vyakti Kalyan Yojana for 2 Years upto June 2024

✓ The Ministry of Labour and Employment, Government of India, has extended the Atal Beemit Vyakti Kalyan Yojana(ABVKY), an unemployment

- relief scheme, under the Employees' State Insurance Corporation (ESIC) for two years upto 30th June 2024.
- ✓ According to the gazette notification, the scheme has been extended for a period 1st July 2022 to 30th June 2024 with relaxed eligibility conditions and enhanced rate of relief.
- ✓ This is the third extension since its inception. Previously, the scheme was extended twice from 1<sup>st</sup> July 2020 to 30th June 2021 and from 1st July 2021 to 30th June 2022 to provide relief to those Insured Persons (IPs) who became unemployed during the COVID-19 pandemic.

#### About Atal Beemit Vyakti Kalyan Yojana

- ✓ On 1st July 2018, the Employees' State Insurance Corporation (ESIC) launched Atal Beemit Vyakti Kalyan Yojana (ABVKY) scheme (on pilot basis) under the Section 2(9) of Employees' State Insurance (ESI) Act, 1948.
- ✓ The Scheme aims to provide relief to the Insured Persons (IPs) who have become unemployed (Tenure: 2 years).

#### Jyotiraditya M Scindia Inaugurates Heli Summit 2023 by Launching UDAN 5.2 & HeliSewa app

- ✓ On 25th July 2023, Union Minister of Civil Aviation and Steel, Jyotiraditya Scindia inaugurated the 5<sup>th</sup> Helicopter & Small Aircraft Summit (Heli Summit 2023) in Khajuraho, Madhya Pradesh.
- ✓ During the event Scindia launched Regional Connectivity Scheme UDAN(Ude Desh Ka Aam Nagrik,) 5.2 (RCS UDAN 5.2) and HeliSewa app.
- ✓ The theme of the summit was "<u>Reaching the Last</u> <u>Mile: Regional Connectivity through Helicopters</u> & <u>Small Aircraft</u>".
- ✓ The summit was jointly organized by the Ministry of Civil Aviation, in association with the Government of Madhya Pradesh, Pawan Hans Ltd., and the Federation of Indian Chambers of Commerce and Industry (FICCI).

### 23rd SCO-CHS Summit 2023 under India's First SCO Chairmanship

✓ On July 4, 2023, the Prime Minister (PM) of India Narendra Modi chaired the 23rd Shanghai

- Cooperation Organization (SCO) Council of Heads of State (SCO-CHS) Summit which was held in a virtual format.
- ✓ India, as the Chair of the SCO, hosted the SCO-CHS Summit for the first time. India assumed the chairmanship of the SCO in September 2022.
- ✓ Theme of the Summit: 'Towards a SECURE SCO'
  - **SECURE** stands for Security; Economy (and Trade); Connectivity; Unity; Respect (for Sovereignty and Territorial Integrity); and Environment.

#### **Highlights**

- ✓ During the summit, the member nations signed the New Delhi Declaration coined by the Indian Government to fight against terrorism. It envisages developing common principles and approaches to form a unified list of terrorist, separatist and extremist organizations whose activities are prohibited on the territories of the SCO Member States.
- ✓ Under this declaration, India refused to sign the paragraph supporting China's Belt and Road Initiative (BRI). With this, India is only nation who does not endorsed this agreement.
- ✓ However, other SCO member nations viz. Kazakhstan, Kyrgyzstan, Pakistan, Russia, Tajikistan and Uzbekistan will jointly implement this project, including efforts to link the construction of the Eurasian Economic Union and BRI.
- ✓ <u>Joint Statements</u>: The leaders also adopted the following two thematic joint statements
  - i. Countering Radicalization leading to Terrorism, Separatism and Extremism
  - ii.Cooperation in the field of Digital Transformation

    Rhashini
- ✓ The PM Narendra Modi presented the AI (artificial intelligence) and Natural Language Processing (NLP)- based language platform 'Bhashini' at SCO summit which can transcend language barriers by translating in-real time and allowing people from different languages to interact with one another over digital platforms.

✓ In 2022, PM Modi launched Bhashini under the National Language Technology Mission (NLTM). Developed by Ministry of Electronics and Information Technology (MeitY), its aim is to bring the non-English speaking population of the nation to the global internet and help them access it in their language itself.

#### Iran joins SCO as its 9th Permanent Member

- ✓ During the summit, Iran became the new permanent member (9th) of SCO. Now, the member nations of SCO increased to 9 viz. China, Russia, India, Iran, Pakistan, Kazakhstan, Kyrgyzstan, Tajikistan, and Uzbekistan.
- ✓ <u>Belarus</u> is set to become a full member by 2024 as the nation signed a Memorandum of Obligations which will lead to its membership.

#### Kazakhstan takes over SCO Presidency from India

- ✓ The presidency of the SCO for the forthcoming period is handed over to the Republic of Kazakhstan. The next meeting of the SCO Council of Heads of State will be held in 2024 in the Kazakhstan.
- ✓ The President of Kazakhstan, Kassym-Jomart Tokayev also proposed closer energy cooperation within the SCO.
- **✓** About SCO
- ✓ It is a 9-member intergovernmental organization that was founded in Shanghai on June 15, 2001. The main goals of the SCO are to strengthen mutual trust and good-neighborliness among member states, promote their effective cooperation in political, trade, economic, and other areas.
- ✓ <u>4 Observer States:</u> Mongolia, Iran, Belarus, Afghanistan
- ✓ <u>6 Dialogue Partners</u>: Azerbaijan, Armenia, Sri Lanka, Cambodia, Turkey, Nepal

### Global Food Regulators Summit 2023 held in New Delhi

✓ For the first time, India hosted the Global Food Regulators Summit 2023, held as part of the Group 20 (G20) event, in Manekshaw Centre, New Delhi, Delhi from 20th to 21st July 2023. The summit was organised by the Food Safety and Standards Authority of India (FSSAI).

✓ Dr. Mansukh Mandaviya, Union Minister of Health and Family Welfare inaugurated the Global Food Regulators Summit 2023 to create a global platform of food regulators to exchange perspectives on strengthening food safety systems and regulatory framework across the food value chain.

#### U20 chair city Ahmedabad hosted U20 Mayoral Summit 2023 in Gandhinagar, Gujarat

✓ On 27th June 2023, the Ministry of Housing and Urban Affairs (MoHUA) launched the Field Assessment for the 8th edition Swachh Survekshan (SS) 2023 – Mera Shehar, Meri Pehchan. SS 2023 survey is expected to engage with approximately 10 crore citizens and making it the world's largest annual urban cleanliness survey.

#### **About the U20 Mayoral Summit 2023**

- ✓ i. The Summit was hosted with the support of the Ministry of Housing and Urban Affairs(MoHUA) National Institute of Urban Affairs (NIUA), and the U20 Technical Secretariat.
- ✓ The summit offered a platform for city leaders from G20 countries to deliberate on actions towards sustainability.
- ✓ The current U20 cycle has also created a record with over 50 articles, 6 extensive background research papers, six white papers on the six priority areas and six U20 bulletins being prepared and released during the cycle.
- ✓ The Summit also saw the launch of several technical papers and documents including the Policy brief on Mainstreaming Gender in U20 and the Ahmedabad Resilient City Climate Action Plan, which gives a roadmap for achieving net-zero emissions by 2070.
- ✓ Urban 20 is a city diplomacy initiative that brings together cities from G20 member states under a common framework to discuss global economic, climate and development issues.

# Startup20 Shikhar Summit held in Gurugram; India passes torch to Brazil

✓ Startup20 Shikhar Summit, organised by the Startup20 Engagement Group under the India G20

- Presidency, was held from 3rd to 4th July 2023 in Gurugram, Haryana. The 2-day summit served as a platform for fostering innovations, collaborations, knowledge sharing, and strategic alliances within the global startup ecosystem.
- ✓ During the closing ceremony of the summit, Dr. Chintan Vaishnav, Chair of Startup20 and the Mission Director for Atal Innovation Mission (AIM), handed over the torch to Brazil, which holds the G20 presidency for 2024.

# Centre launches ULLAS mobile application to promote basic literacy

- ✓ The Akhil Bharatiya Shiksha Samagam 2023, graced by Prime Minister Narendra Modi, witnessed the inauguration of the ULLAS: Nav Bharat Saksharta Karyakram at Bharat Mandapam, Pragati Maidan, New Delhi. The initiative, introduced by Union Minister Dharmendra Pradhan, aims to revolutionize education and literacy in India by creating a comprehensive learning ecosystem that bridges gaps in basic literacy and critical life skills. It coincided with the third anniversary of NEP 2020.
- The ULLAS initiative aims to provide a comprehensive learning ecosystem that caters to the needs of every individual. It focuses on promoting functional literacy, vocational skills, and essential life skills, such as financial literacy, legal literacy, and digital literacy. Moreover, it empowers citizens to actively participate in nation-building.

#### 'Meri Mati Mera Desh' campaign to be launched in run-up to Independence Day

- ✓ On 30th July, Prime Minister Narendra Modi announced the launch of "Meri Mati Mera Desh" campaign in run-up to Independence Day to honor the martyred bravehearts of the country.
- ✓ During the campaign of "Meri Mati Mera Desh", an Amrit Kalash Yatra will also be taken out. This 'Amrit Kalash Yatra' will reach Delhi, carrying the soil in 7,500 Kalash from villages and various corners of the country. This yatra will also carry plants from various parts of the country. An 'Amrit

Vatika' will be built close to the National War Memorial from these 7,500 Kalash of soil and plants.

#### **India launched international Big Cat** Alliance for conserving 7 big cats

- India has recently launched the International Big Cat Alliance (IBCA) with the aim of conserving seven major big cat species on Earth. Inspired by
  - the success of Project Tiger, which has contributed to India being home to 70% of the world's



tigers, the IBCA will focus on protecting and conserving key big cat species, including Tiger, Lion, Leopard, Snow Leopard, Puma, Jaguar, and Cheetah.

- The idea for the alliance originated in July 2019. when Prime Minister Modi called for a coalition of global leaders to join forces against poaching and illegal wildlife trade in Asia on Global Tiger Day. The establishment of the International Big Cat Alliance is a testament to the commitment to this initiative's principles. According to Modi, the alliance will play a vital role in mobilizing financial and technical resources to support the entire ecosystem associated with big cats, thereby ensuring their conservation and protection.
- The alliance aims to reach out to 97 range countries covering the natural habitats. IBCA would further strengthen global cooperation and efforts to conserve the wild denizens, especially the big cats.

#### **First** "Credit Guarantee Scheme" Livestock Sector launched for rebooting rural economy by leveraging MSMEs

The Indian government has introduced a pioneering "Credit Guarantee Scheme" for the Livestock Sector aimed at revitalizing the rural economy and empowering

- Enterprises (MSMEs).
- The Department of Animal Husbandry & Dairving (DAHD) has established a Credit Guarantee Fund Trust of Rs 750 crore to provide credit guarantee coverage to eligible lending institutions, enabling improved access to finance for the underserved livestock sector.
- The scheme focuses on supporting first-generation entrepreneurs and underprivileged sections of society who lack collateral security for their ventures in the livestock sector.
- It provides them with financial assistance and access to credit facilities.

#### host World Coffee India Conference in Bengaluru from Sept 25

- ✓ India is set to host the 5th World Coffee Conference (WCC) in Bengaluru from September 25 to 28, where it will present its diverse coffees to buyers from over 80 countries. This is the first time that the event will be held in Asia. The conference aims to create pathways for innovative opportunities and markets, with a special emphasis on benefiting coffee farmers who play a crucial role in the coffee production chain.
- The central theme of the event will "Sustainability through Circular Economy and Regenerative Agriculture" The event will various encompass activities, including conferences, exhibitions, skill-building workshops, a CEOs & global leaders forum, and a growers conclave. Participants from over 80 countries are anticipated to take part in WCC 2023.

#### 3rd Sherpas G20 meeting held in Hampi

- The 4-day 3rd G20 Sherpa meeting was held in the city of Hampi, Karnataka, under the Ministry of Cultural and External Affairs, during India's G20 Presidency.
- Hampi, located in Karnataka, India, a UNESCO World Heritage Site, was hosted the third Sherpas meeting as part of India's G20 Presidency, with Amitabh Kant leading the meeting as the chairperson. The summit, organized by the Ministry

of Cultural and External Affairs, anticipates the participation of more than 200 individuals representing 43 countries.

### **Project Tiger merges with Project Elephant**

- ✓ India has integrated two notable conservation endeavors, Project Tiger and Project Elephant, into a fresh division named Project Tiger and Elephant Division.
- ✓ Project Tiger and Project Elephant, two significant conservation initiatives in India, have been merged under a new division called 'Project Tiger and Elephant Division' by the Union Ministry of Environment, Forest and Climate Change (MoEFCC). Recently, the Prime Minister also commended the success of Project Tiger on its 50th anniversary.
- ✓ A similar proposal was made in 2011 to merge Project Tiger, Project Elephant, and Integrated Development under Wildlife Habitat. However, the plan was dropped after objections from experts on the National Board for Wildlife standing committee.

# Cabinet approves draft Digital Personal Data Protection (DPDP) Bill, 2022

- ✓ The Union Cabinet, chaired by Prime Minister(PM) Narendra Modi, approved the Draft of Digital Personal Data Protection (DPDP) Bill, 2022.
- ✓ The Bill frames out the rights and duties of the citizen (Digital Nagrik) and the obligations to use collected data lawfully of the data fiduciary (entities that collect personal data). It is based on the following six principles of the data economy:
  - i. Collection and usage of the personal data of citizens of India.
  - ii. Data collection exercise: It must be for a legal purpose and the data should be safely stored till the purpose is served.
  - iii. Data minimization: Only relevant data should be collected of individuals and serving the pre-defined purpose should be the only aim.
  - iv. Data Protection and Accountability
  - v. Accuracy of data

- vi. Rules regarding reporting a data breach
- ✓ The Bill will enhance India's trade negotiations with other nations like the European Union (EU), whose General Data Protection Rules (GDPR) are among the world's most exhaustive privacy laws.
- ✓ It will also empower individuals to question private companies as well as governments about their data collection, processing, and storage.

# Cabinet approves changes to Jan Vishwas (Amendment of Provisions) Bill 2023

- ✓ On 12th July 2023, the union cabinet approved amendments to the Jan Vishwas (Amendment of Provisions) Bill, 2023. The amendments were made to decriminalise minor offences by amending 183 provisions in 42 Acts which administered by 19 ministers with the aim to promote ease of business and living.
- ✓ It amends 42 laws, across multiple sectors, in agriculture, environment and media and publication.
- ✓ This includes the Indian Post Office Act, 1898, the Environment (Protection) Act, 1986, the Public Liability Insurance Act, 1991, and the Information Technology Act, 2000.
- ✓ The Jan Vishwas Bill was introduced in the Lok Sabha by Commerce and Industry Minister Piyush Goyal in December 2022.It was referred to a Joint Parliamentary Committee (Chair: Mr. P.P. Chaudhary), which submitted its report on March 17, 2023.

# ITC released a Special Stamp on Mission Millets in collaboration with Department of Post

✓ On 25th July 2023, ITC Limited, a leading Indian multi-business enterprise based in Kolkata, West Bengal, has released a special postal stamp, a "Customised My Stamp" on Mission Millet in collaboration with the Department of Post(India Post) under the Ministry of Communication. The stamp was released by Kailash Choudhary, Minister of State (MoS) for the Ministry of Agriculture & Farmers' Welfare(MoA&FW).

#### Karnataka Launches Gruha Lakshmi Scheme for Women Supporting Households

- ✓ On 19th July 2023, Karnataka Chief Minister Siddaramaiah launched the registration for Gruha Lakshmi scheme, which provides Rs 2,000 monthly assistance to the woman head of the households.
- ✓ The Scheme will benefit around 1.28 crore families in Karnataka and the cash benefit of Rs 2,000 will be transferred through Direct Benefit Transfer (DBT).
- ✓ The Gruha Lakshmi scheme will be implemented from August 15, 2023.
- This was one of the poll promises by the newly elected Siddaramaiah led Congress government in the election manifesto of the 2023 Karnataka general Assembly Election. On 7th July 2023, the Karnataka Government allocated an amount of Rs 24,166 crore for the Gruha Lakshmi scheme for 2023-24 fiscal year.

### Chhattisgarh CM Bhupesh Baghel launches Gramin Awas Nyay Yojana

- ✓ On 19 July 2023, During the announcement of Rs.1,764 crore worth benefits for various segments of government employees, Chief Minister (CM) Bhupesh Baghel introduced the 'Nyay Yojana,' a housing scheme aimed at providing homes to rural homeless individuals in Chhattisgarh.
- ✓ The scheme will be fully sponsored by State Government of Chhattisgarh by allocating Rs.100 crore in budget.

#### Rajasthan Cabinet Introduced 'Minimum Guaranteed Income Bill 2023'

- ✓ On 18th July 2023, Rajasthan cabinet chaired by Chief Minister(CM) Ashok Gehlot introduced the Rajasthan Minimum Guaranteed Income Bill, 2023 aimed to provide social security to individuals and households of Rajasthan.
- ✓ The Bill focuses on 3 main areas such as Right to Minimum Guaranteed Income, Right to Guaranteed

- Employment and Right to Guaranteed Social Security Pension.
- ✓ These social security schemes were implemented by the Government of India's United Progressive Alliance (UPA) through Rights-based Laws such as Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA), Right to Education (RTE) and Food Security Act.

#### J&K launched India's first Tele-MANAS chatbot for people in mental distress

- ✓ On 5th July 2023, Manoj Sinha, Lieutenant Governor of Jammu and Kashmir (J&K) launched India's first TeleMental Health Assistance and Networking Across States (MANAS) chatbot in the Union Territory (UT) to enhance mental health support for distressed people by initiating an instant conversation with those who are in need.
- ✓ The 2-tier system comprises State Tele-MANAS cells, which includes trained counsellors and mental health specialists in Tier 1 and specialists at District Mental Health Programme (DMHP)/Medical College resources for physical consultation and/or eSanjeevani for audio visual consultation in Tier 2.
- ✓ J&K Lieutenant Governor Manoj Sinha, who inaugurated the 'J&K Health Conclave' on Mental Health and Non-Communicable Diseases at Srinagar,J&K.
- ✓ The initiative will ensure round the clock services of health counsellors, clinical psychologists and consultants.

### Kerala to set up India's first fisheries Atal Incubation Centre

- ✓ Kerala University of Fisheries and Ocean Studies (KUFOS) received a grant of Rs.10 crore from NITI Aayog in order to set up India's first Atal Incubation Centre in fisheries.
- ✓ NITI Aayog provided grant of Rs.10 crore to Kerala University of Fisheries and Ocean Studies (FUFOS) to set up India's first Atal Incubation Centre (AIC) in fisheries which will be dedicated to promoting research, technological advancement and entrepreneurship in fisheries and allied sectors.

### Bengaluru Becomes 1st Indian City to Join World Cities Culture Forum

✓ Bengaluru, the capital of Karnataka became the first Indian city to be part of the World Cities Culture Forum (WCCF), a global network of cities that share research and intelligence to explore the role of culture in future prosperity. Bengaluru became the 41st city to join the forum and the network currently includes 40 cities across six continents. The forum includes cities like New York, London, Paris, Tokyo, and Dubai.

### Odisha cabinet approves Mission Shakti Scooter Yojana

- ✓ Odisha's Chief Minister Naveen Patnaik approved the Mission Shakti Scooter Yojana, a scheme aimed at providing interest subvention on bank loans up to INR 1,00,000 to beneficiaries, enabling them to purchase a scooter.
- ✓ This initiative grants affordable access to twowheelers for Mission Shakti Federation Leaders and CSS (Community Support Staff). It will empower them to fulfill their responsibilities more efficiently, thus increasing their effectiveness and extending their outreach within the community.
- ✓ This scheme is expected to benefit roughly 75,000 community support staff members of SHGs (Self Help Groups) and approximately 1,25,000 federation leaders associated with SHGs.

### Authoor betel leaves from Tamil Nadu receives GI certificate

- The Tamil Nadu State Agriculture Marketing Board and NABARD Madurai Agribusiness Incubation Forum have awarded a Geographical Indication (GI) certificate to the Authoor betel leaves from Thoothukudi district in Tamil Nadu. The certificate is granted in the name of Authoor Vattara Vetrilai Vivasayigal Sangam. This GI recognition opens up new avenues for marketing the Authoor betel leaves, enabling their reach in both domestic and international markets, tapping into their marketing potential.
- ✓ The Authoor betel leaf, predominantly utilized during special occasions such as temple festivals, housewarmings, and weddings, possesses a distinctively spicy and pungent flavor.

✓ This exceptional leaf is exclusively found in the village of Authoor, situated in the Thoothukudi district of Tamil Nadu, owing to the utilization of Thamirabarani River water for irrigation purposes in the local fields.

# Indore Municipal Corporation to be the first urban body to get EPR credit

✓ Indore Municipal Corporation (IMC) in Madhya Pradesh, India, has made history by becoming the first urban body in the country to receive Extended Producers Responsibility (EPR) credit for recycling banned single-use plastic items. Indore has implemented a complete ban on single-use plastic items within the city. In recent times, the IMC seized approximately eight tonnes of such plastic, preventing its circulation. Moreover, Indore has also been recognized as India's cleanest city for the sixth consecutive year in the central government's annual cleanliness survey.

#### PM MITRA Park launched in Amravati, Maharashtra

- The Maharashtra Industrial Development Corporation (MIDC), the Maharashtra government, and the Indian Ministry of Textiles joined hands by signing a memorandum of understanding to establish the PM Mega Integrated Textile Regions and Apparel Park (PM MITRA Park) in Amravati,Maharashtra. The inauguration of the PM MITRA mega textile park took place with the aim of attracting an investment of ₹10,000 crore and creating 300,000 job opportunities.
- ✓ Earlier this year, the Government of India unveiled plans to establish 7 PM MITRA Parks across the country as designated sites for the textile industry.
- ✓ The establishment of these parks in Tamil Nadu, Telangana, Gujarat, Karnataka, Madhya Pradesh, Uttar Pradesh, and Maharashtra.
- These parks aim to create top-notch industrial infrastructure that can attract substantial investments, including foreign direct investment (FDI), while fostering innovation and job creation within the sector.

#### ECONOMY AND BANKING

#### **Ministry of Finance amends Small** Saving Rules. 25 **Nominees**

- The Ministry of Finance has amended the Government Savings Promotion General Rules, 2018 with Government Savings Promotion General (Second Amendment) Rules, 2023, under which the Non-resident Indians (NRIs) are made eligible to be nominated as nominee for government saving schemes.
  - This is on the condition that payment to such nominee/s shall be on non-repatriation basis.
  - This amendment has been added as sub-rule (9) in the principal rules, in rule 14, after sub-rule (8).
  - The new rule indicates that the money needs to utilised in India.
- The rule covers various schemes under the Government Savings Promotion Act, 1873, such as Public Provident Fund (PPF), National Savings Certificate (NSC), Sukanya Samriddhi Yojana (SSY), Senior Citizens Savings Scheme (SCSS), Mahila Samman Savings Certificate Scheme (MSSC), Post Office Time Deposits, Kisan Vikas Patra (KVP), and Post Office Monthly Income Scheme.

#### Union **Finance Minister Nirmala** Sitharaman launches **AMC** Repo **Clearing Limited and CDMDF**

- On July 28, 2023, Union Minister Nirmala Sitharaman, Ministry of Finance, initiated the trading on Limited Purpose Clearing Corporation (LPCC) mechanism called AMC Repo Clearing Limited (ARCL), during an event organized by Securities and Exchange Board of India (SEBI) in Mumbai, Maharashtra,
- She also inaugurated Corporate Debt Market Development Fund (CDMDF). Both the initiatives intend to deepen the functioning of the corporate debt markets.
- **About ARCL**: The Union Minister launched the triparty repo in corporate debt securities offered

- through ARCL, a LPCC aimed at developing the underlying Corporate Bond market in India.
- ARCL, setup by MFs)managing debt Assets under management (AUM) acts as a Central Counter Party (CCP) that facilitates clearing and settlement services of corporate bond repo transactions.
- During its launch, ARCL successfully conducted its first transaction, with a total traded value of Rs 480 crore.

#### Central approves 8.15% Govt interest **Employees**' Provident Fund for FY23

- ✓ On 24th July 2023, The Ministry of Finance, Government of India(GoI) has approved Employees' Provident Fund Organisation (EPFO)'s Central Board of Trustees' recommendation to set the annual interest rate of 8.15% on Employees' Provident Fund (EPF) accounts for the financial year 2022-2023(FY23).
- This move will cover over 6 crore subscribers of EPFO. The current rate is 0.05% higher than the FY22 when it was 8.10%.
- Ministry of Labour and Employment (MoL&E) has conveyed this approval of the Central Government under para 60(1) of EPF Scheme, 1952 by crediting the interest to the account of each member of the EPF Scheme as per the provisions under Para 60 of EPF Scheme, 1952.
- Employees Provident Fund Organisation (EPFO) is a statutory body under the Ministry of Labour and Employment, Government of India. It manages the Employees' Provident Fund (EPF), a social security scheme for salaried employees in India.
- Each month, an employee contributes 12 per cent of their earnings to their EPF account, with the entire contribution directed towards the EPF account. On the employer's part, only 3.67 per cent is deposited into the EPF account, while the remaining 8.33 per cent is allocated to the Employees Pension Scheme (EPS).
- According to EPFO's latest provisional payroll data released on July 20, 2023, the top 5 states in terms

of net member addition are Maharashtra, Tamil Nadu, Karnataka, Haryana, and Gujarat.

# Government raises interest rates on select small saving schemes by up to 0.3% for Q2 of FY24

- ✓ The Department of Economic Affairs (DEA), Ministry of Finance (MoF) has announced an interest rate hike on selected small savings schemes by up to 0.3% for the 2nd quarter of the financial year 2023-24 (Q2 FY24) (i.e July 1, 2023-September 30, 2023).
- ✓ The rates are in line with the high-interest rates in the banking system.

#### **Changed Interest Rates**

- ✓ The interest rate for the five-year recurring deposit (RD) has been raised by 30 basis points (bps), resulting in a highest increase of 0.3%. Earlier it was 6.2%, now it is 6.5%.
- ✓ Interest rate has increased by 10bps for The Oneyear term deposits with post offices will now earn 0.1% reaching 6.9% (earlier 6.8%) and, The two years tenor is 7% (earlier 6.9%).

#### **Unchanged Interest Rates**

- ✓ Interest rates on term deposits for three and five years have been retained at 7% and 7.5%.
- ✓ The interest rates for popular Public Provident Fund(PPF) and savings deposits are kept at 7.1% and 4%,
- ✓ The interest rate on the National Savings Certificate (NSC) remained unchanged at 7.7% for July 1 to September 30, 2023.
- ✓ The girl child savings scheme Sukanya Samriddhi rate remained unchanged at 8%.
- ✓ The interest rate on the senior citizen savings scheme and Kisan Vikas Patra (KVP) is 8.2% and 7.5%.
- ✓ There is no interest rate hike for the Monthly Income Scheme, and it gives investors a 7.4 percent gain.

#### **About Small Savings Schemes**

✓ Small Savings Schemes are savings instruments managed by the government to encourage citizens to save regularly. The small savings schemes have three categories- savings deposits, social security schemes, and monthly income plan.

- ✓ On July 12, 2023, the National Bank for Agriculture and Rural Development (NABARD) celebrated its 42<sup>nd</sup> Foundation Day. Amit Shah, the Union Home Minister and Minister of Cooperation was the chief guest of the event held at Pragati Maidan in New Delhi, Delhi.
- ✓ The day was marked by a series of events throughout the country, including a webinar on the theme of "NABARD: 42 Years of Rural Transformation."
- ✓ The webinar was addressed by the Union Minister of Agriculture and Farmers' Welfare, Narendra Singh Tomar, who highlighted the important role that NABARD has played in the development of rural India by enhancing agricultural production, developing infrastructure, and fostering financial inclusion.
- ✓ About NABARD: NABARD is a development bank focusing primarily on the rural sector of the country by providing finance for Agriculture and rural development.
- ✓ It is a statutory body established under Parliamentary act-NABARD Act, 1981.

### 50th meeting of GST Council held in New Delhi

- ✓ On July 11, 2023, the 50th meeting of the Goods and Services Tax (GST) Council was held in New Delhi, Delhi under the chairpersonship of Union Minister Nirmala Sitharaman, Ministry of Finance.
- ✓ To mark the milestone of 50th meeting of the GST Council, Union Minister Nirmala Sitharaman (Chairperson) released a short video film titled 'GST Council- 50 steps towards a journey' in the presence of the Members of the Council.
- ✓ The GST on snack pellets, the semi-finished ingredient that is used to manufacture snacking products is decreased to 5% from 18%. This includes uncooked, unfried and extruded snack palettes.

- ✓ Integrated Goods and Services Tax (IGST) exemption on imported Dinutuximab (Quarziba), a rare cancer drug, for personal use.
- ✓ GST exemption on satellite launch services supplied by Indian Space Research Organisation (ISRO), Antrix Corporation Limited and New Space India Limited (NSIL) may be extended to similar services supplied by organizations in the private sector.

# HDFC Bank Crossed USD 100 Billion Valuation; Becomes World's 7th largest Lender

✓ On 14th July 2023, following its reverse merger with its parent company, Housing Development

Finance Corporation (HDFC) limited, HDFC Bank crossed the USD 100 billion market capitalisation(m-cap) and



traded at a market value of around USD 152 billion. With this, HDFC Bank has emerged as the World's 7th largest lender, moving ahead of Bank of China and Morgan Stanley, and Goldman Sachs.

✓ HDFC bank has entering the list of the world's top 10 banks by market capitalisation. JPMorgan Chase (USD 438 billion) tops the list followed by Bank of America at 2nd (USD 232 billion) and ICBC at 3rd (USD 224 billion).

### ADB Retained India's GDP Growth Forecast at 6.4% in FY2023

✓ Asian Development Outlook (ADO) July 2023: Robust Growth with Moderating Inflation



with Moderating Inflation published by the Asian Development Bank (ADB) has retained India's Gross Domestic Product (GDP) growth forecast at 6.4% in

FY2023 and 6.7% in FY2024, as projected in ADO April 2023.

- ✓ The inflation projection for India in FY2023 is reduced slightly from 5.0% in ADO April 2023 to 4.9% and maintained at 4.5% in FY2024.
- This is driven by continued domestic demand that supports India's recovery.

✓ The growth in South Asia is projected at 5.5% in 2023 and 6.1% in 2024.

# IMF WEO July 2023 Update projects Indian Economy Growth at 6.1% in 2023

✓ On July 25, 2023, the International Monetary Fund (IMF) in its 'July 2023 World Economic Outlook

(WEO) Update- Near-Term Resilience, Persistent Challenges' projected a growth rate of 6.1% for India in 2023, which is a 0.2 percentage point upward revision compared



with the April 2023 projection of 5.9%.

- ✓ This shows a stronger-than-expected growth in the Q4 of 2022 driven by robust domestic investment.
- ✓ For 2024, it remained at 6.3%, as projected in April 2023 WEO Update. India grew at 7.2% in 2022.
- ✓ As per Calendar Year, India's growth projections are 6.6% in 2023 and 5.8% in 2024.

#### The Global Scenario

- ✓ i.The global growth is projected to fall at 3% in both 2023 and 2024 from an estimated 3.5% in 2022.
- ✓ ii.Global headline inflation is projected to fall to 6.8% in 2023 and 5.2% in 2024 from 8.7% in 2022.
- ✓ iii.The global recovery is slowing amid increased dissimilarity among economic sectors and regions.
- ✓ iv.The forecast for 2023 is modestly higher than predicted in the April 2023 WEO, however, it remains weak by historical standards.
- ✓ v.The outlook projected the moderation of adverse risk globally as the United States (US) debt ceiling standoff, and strong action by authorities to contain turbulence in US and Swiss banking which reduced the immediate risks of financial sector turmoil.
- **✓** Regional Highlights
- ✓ i.On the regional front, Emerging market and Developing Economies will grow at 4% in 2023, and 4.1% in 2024.
- ✓ Emerging and Developing Asia will grow at 5.3% in 2023, and 5% in 2024. China and India are part of this region.

- ✓ The exporters receive international payments locally via the Razorpay platform such as FedWire, Automated Clearing House (ACH) and more in order to save from high transfer costs, chargebacks and payment failures.
- ✓ With the MoneySaver Export Account, Indian exporters can experience consistent wire transfer from their international customers over 200 countries and have their funds settled directly in their Indian bank accounts.
- ✓ By using the Razorpay dashboard, users can access the features and all the payments will come with an electronic Foreign Inward Remittance Statement (FIRS).

#### PhonePe Launches India's First Health Insurance Platform with Monthly Subscriptions

- ✓ On 18th July 2023, PhonePe Insurance Broking Services Private Limited (PIBS), a wholly owned subsidiary of PhonePe Private Limited, launched the health insurance plans offering comprehensive insurance in partnership with leading insurers.
- ✓ With this launch, PhonePe Insurance became the first and only Platform in India to enable customers to pay for insurance in easy monthly installments through Unified Payments Interface (UPI) on the PhonePe app.
- ✓ These health insurance plans come with coverage up to Rs 1 crore.
- ✓ PhonePe Insurance Is Registered With IRDAI (Insurance Regulatory And Development Authority) As A Direct Broker (Life And General).

### Google Pay Introduced UPI LITE to Boost Small Value Transactions

- ✓ On 13th July 2023, Google Pay introduced its Unified Payments Interface (UPI) LITE payment (on-device wallet) feature to allow users to make small payments without entering the UPI personal identification number (PIN).
- ✓ Using Google Pay's UPI Lite, users can make payments of up to Rs(INR) 200 without the use of a UPI PIN. Users maintain a balance of Rs 2000 (Maximum balance) in their UPI Lite wallet, which can be loaded up to twice in a day and can spend up to a total of Rs 4000 within 24 hours.
- ✓ This is possible because the LITE account is linked to the user's bank account but does not rely on the issuing bank's core banking system in real time.
- ✓ The UPI LITE support feature was launched by the Reserve Bank of India (RBI) along with the National Payments Corporation of India (NPCI) in September 2022, and currently it is supported by 15 banks. Paytm, PhonePe and BHIM(Bharat Interface for Money), have the UPI LITE feature already.

#### LIC launches Jeevan Kiran to offer Life Cover with Premium Return

# Canara Bank Leads PSBs in Lending with Rs 187,813cr to State PSUs & Corp.; TN holds Highest Debt

- According to the Parliamentary Questions and Answers data (Lok Sabha) on Outstanding Debt of States and Union Territories (UTs), Canara Bank topped the list of Public Sector Banks (PSBs) with the highest lending of Rs 187,813 crore in FY23 to Corporations and Public Sector Undertakings (PSUs) of States and Union Territories (UTs) for the 5th consecutive time.
- ✓ This information was revealed in a written statement by the Union Minister Nirmala Sitharaman, Ministry of Finance, on July 24, 2023, in response to questions raised by Member of Parliament (MP), Velusamy P.
- ✓ Out of the 12 PSBs, 10 reduced their lending to PSBs in FY23. Only two banks viz. Canara Bank and Central Bank of India, increased their exposure in FY23.
- ✓ Canara Bank lending amount of ₹187,813 crore to government-backed entities, alone accounting for over 45% of the total lending of all PSBs in the financial year 2022-2023(FY23).
- ✓ This lending amount was 11% higher compared to the ₹1,69,532 crore the bank had lent to government entities in the previous financial year (FY22).
- ✓ Punjab National Bank (PNB) has notified as second highest lender in FY23 with a total loan disbursal of Rs 70,142.5 crore.
- ✓ State Bank of India (SBI) as 3rd highest lender, lent Rs 66,523.2 crore to State enterprises in FY23, down from Rs 81,735 crore in FY22.
- ✓ PNB and SBI are followed by Bank of India (Rs 25,147 crore), Bank of Baroda (Rs 15,706.8 crore), Union Bank of India (Rs 12,584.8 crore), Bank of

- Maharashtra (Rs 10,822.7 crore), Indian Bank (Rs 9,021 crore), Indian Overseas Bank (Rs 7,490 crore), Central Bank of India (Rs 3,949 crore from Rs 1,475 crore in FY22), UCO Bank (Rs 2,939.4 crore), Punjab and Sind Bank (Rs 87.7 crore).
- ✓ Punjab & Sind Bank had the lowest exposure to State PSUs and corporations in FY23 as compared to Rs 3,570 crore in FY22.
- ✓ As per the RBI's 'State finances: A study of budgets of 2022-23' report published in 2023, Union Minister of Finance Nirmala Sitharaman shared data on outstanding liabilities, highlighting that Tamil Nadu(TN) has the highest amount of outstanding debt among all States and Union Territories in India, at Rs 7.54-lakh crore (as per budget estimates for FY23).
- ✓ TN is followed by Uttar Pradesh (UP) at 7.10-lakh crore outstanding debt.
- ✓ Odisha is the only state in the country to reduce its debt consistently over the past three years: 1.8% in 2019-20, 8.4% in 2020-21, and 12% in FY 2022-23.

#### EIB commits € 1 billion loan to support India's National Green Hydrogen Mission

- ✓ European Investment Bank(EIB) is set to support India's National Green Hydrogen Mission with a substantial loan of up to EURO 1 billion to boost green hydrogen and renewable energy projects in India.
- ✓ The EIB aims to boost India's renewable energy ambitions by supporting renewable energy generation, energy storage technologies, power transmission and distribution infrastructure.
- ✓ EIB Vice-President Kris Peeters is set to confirm EIB's interest to support NGHM during his visit to India to attend G20(Group of Twenty) Infrastructure Investors Dialogue (IID), which takes place during the 3rd meeting of finance ministers and central bank governors in Gandhinagar, Gujarat, India.
- The investments align with the European Green Deal, the EU Global Gateway strategy, and India's own agenda on climate change, renewable energy, connectivity, and sustainable finance.

# HDFC Bank becomes first to offer interoperability between CBDC and UPI

- ✓ On 13 July 2023, HDFC(Housing Development Finance Corporation) Bank, the largest private sector lender in India launched UPI QR code(Unified Payments Interface Quick Response code)interoperable with India's sovereign digital currency, Central Bank Digital Currency (CBDC).
- ✓ With this, HDFC Bank became the first bank in the country to complete the integration process between UPI payment system and Digital currency.
- ✓ HDFC Bank will enable Digital Rupee payments in several cities, including Mumbai, Delhi, Chandigarh, Bhubaneswar, Bengaluru, Ahmedabad, Guwahati, and Gangtok.
- ✓ This feature will benefit customers as it enables them to transact using the funds available in their CBDC wallet through UPI QR codes.
- ✓ Previously, HDFC Bank customers had to scan two separate QR codes for their CBDC wallet and UPI payment respectively, causing inconvenience.
- ✓ The new single UPI QR code allows customers to make CBDC wallet payments with a single scan. Merchants also benefited by displaying only one OR code.

#### 3 Multilateral Development Banks Have Pledged upto USD 27 bn for India's Green Growth

✓ During the International Conference on Green Hydrogen (ICGH-2023), three Multilateral Development Banks, the European Investment Bank (EIB), the Asian Development Bank (ADB) and the World Bank have contributed USD 27 billion for India's Green Growth.

#### The funding allotment

- ✓ The EIB has pledged Euro(€) 1 billion to develop a large-scale hydrogen industry hub
- ✓ The ADB intends to provide USD 20-25 billion over 5 years to support India's green growth
- ✓ The World Bank approved USD 1.5 billion to aid India's low-carbon transition journey.

# Razorpay launches first international payment gateway in Malaysia

- ✓ India's renowned fintech giant and leading Full-Stack Payments and Business Banking Platform, Razorpay, has made a significant announcement regarding its first-ever international Payment Gateway for the Malaysian market as it acquires Malaysian fintech start-up 'Curlec' for \$20 million, which has been rebranded as 'Curlec by Razorpay'.
- ✓ The introduction of the Curlec Payment Gateway aims to bridge the gap between local and international payment gateways, while also addressing the unique digital payment challenges prevalent in emerging markets.

#### ONGC Becomes India's First PSU to Achieve Anti-Bribery Management System Certification

✓ Oil and Natural Gas Corporation (ONGC) has recently made history by becoming the first Central Public Sector Enterprise (CPSE) in India to receive certification for its Anti-Bribery Management System (ABMS). The certification was awarded by the internationally accredited certification body InterCert USA. ONGC's commitment to combat bribery was previously demonstrated in 2005 when it became the first organization in India to adopt the Integrity Pact (IP) initiated by Transparency International.

### India set to be third-largest economy by FY28: SBI Research

India will become the third largest economy by FY28, two years earlier than projected, said SBI Research economists in a note. SBI economists said India will likely grow 8.1% in the first quarter of FY24, pushing the overall growth rate to 6.5%. India recorded a 13.5% growth in the first quarter of FY23. The forecast aligns with RBI projections of 6.5% growth in FY24 but is more optimistic than the International Monetary Fund's revised forecast of 6.1%. Earlier this week, the IMF revised its growth forecast upwards by 0.2 percentage points on the back of strong domestic investment.

### Digital payments grew significantly at 13.24% in FY23, shows RBI index

- ✓ The remarkable 13.24% growth in digital payments during FY23, as reflected in the RBI-DPI, underlines the significant progress of India's digital payment ecosystem.
- ✓ In the fiscal year 2022-2023 (FY23), digital payments in India experienced remarkable growth, as indicated by the Reserve Bank of India (RBI) Digital Payments Index (RBI-DPI). The RBI-DPI, a comprehensive measure of payment digitization, displayed a substantial increase across all parameters during this period, driven by significant advancements in payment infrastructure and performance across the country. The index for March 2023 recorded a value of 395.58, marking a 13.24% growth compared to September 2022 (377.46), as announced on January 31, 2023.
- ✓ The RBI-DPI began with a base index value of 100 in March 2018 and has been consistently rising ever since. It provides a reliable gauge of the extent of digital payment adoption in India and is updated semi-annually, with a four-month lag.

# Banknotes with a Star (\*) symbol identical to any other legal banknotes: RBI

- Banknotes with a Star (\*) symbol have recently become a subject of discussion on social media
  - platforms. RBI issued a press release to clarify that these banknotes, known as the "Star Series" banknotes, are



- legitimate and have a specific purpose. The Star symbol is added to identify banknotes used as replacements for defectively printed ones in a packet of 100 serially numbered banknotes.
- The Star Series banknote is a special category of banknotes issued by the RBI to replace defectively printed banknotes in a packet of 100 serially numbered banknotes. These replacement banknotes are identical to regular legal banknotes, except for the addition of a Star (\*) symbol in the number panel.

#### RBI Treasury Bill And Bond Auction Update: T-Bill Yield 6.86%; Punjab Offers Highest SDL Rates at 7.41%

- The Reserve Bank of India (RBI) has announced the next auction of Treasury bills and state development loans (SDLs) with attractive yields for various maturities. The T-bill yields for three-month, six-month, and 364-day maturities are set at 6.71 per cent, 6.83 per cent, and 6.86 per cent, respectively. The auction will see the participation of 11 states, including Punjab, Rajasthan, West Bengal, and others.
- Punjab is offering the highest interest rate of 7.41 per cent for SDLs maturing on July 5, 2034.
- ✓ Following closely are Rajasthan and West Bengal, each offering SDLs at 7.40 per cent.
- ✓ MTNL (Mahanagar Telephone Nigam Ltd.) has tapped the corporate bond market with a government of India guarantee this week.
- ✓ The total issue size is Rs 2500 crore, including the green shoe option.GGThe issue garnered substantial interest from long-term investors and proprietary traders, with bids worth Rs 9,178 crore, of which the issuer accepted Rs 2,480 crore at 7.59 per cent yield, payable semi-annually.

### RBI to detail SOP for banks to help expedite rupee trade

- RBI is set to introduce a standard operating procedure (SOP) to enable banks to expedite the issuance of Foreign Inward Remittance Certificates (FIRC) and Electronic Bank Realization Certificates (e-BRCs). This proactive step comes in response to the challenges faced by exporters using the rupee-based trading mechanism for foreign trade.
- ✓ FIRC serves as a crucial document, acting as a testimonial for all incoming remittances to India.
- ✓ Statutory authorities widely accept this document as proof that individuals or businesses, including limited companies, partnership firms, sole proprietorship firms, among others, have received foreign currency payments from abroad.

# RBI Includes S.Korea's 'NongHyup Bank' in the list of Scheduled Banks under Schedule II of RBI Act, 1934

- ✓ Reserve Bank of India (RBI) released a notification addressing all the banks regarding the inclusion of 'NongHyup Bank' in the Second Schedule to the Reserve Bank of India Act, 1934.
- ✓ As per the RBI notification, NongHyup Bank has been officially include in the Second Schedule of the RBI Act 1934 and published in the Gazette of India (Part III Section 4).
- ✓ The notification informs all the banks about the addition of NongHyup Bank to the regulated list.
- ✓ NongHyup Bank (NH Bank), established in 2012, is a commercial bank headquartered in Seoul, South Korea.

#### **About Scheduled Banks**

Scheduled banks are those banks that are listed under Schedule II of the Reserve Bank of India Act, 1934. To qualify as a scheduled bank, the bank's paid-up capital and collected funds must be at least Rs. 5 lakh. These banks are eligible for low interest loans from the RBI and also have membership in clearing-houses.

### RBI Sets Restrictions on Bengaluru based National Co-operative Bank

- ✓ On 24th July 2023, Reserve Bank of India(RBI) imposed business limitations on Bengaluru's one of the oldest banks, National Co-operative Bank Limited because of its poor declining financial condition.
- Starting from July 24, 2023, the business restrictions will be in place for a duration of six months and are subject to review.
- ✓ The restrictions are imposed under the provision of the Banking Regulation Act, 1949.
- ✓ Depositors will be entitled to receive deposit insurance claim amount up to Rs 5 lakh from the Deposit Insurance and Credit Guarantee Corporation(DICGC)

### RBI cancels Licence of United India Co-operative Bank Limited, UP

- ✓ On 19th July 2023, Reserve Bank of India(RBI) cancelled the licence of United India Co-operative Bank Limited, Nagina(Bijnor, Uttar Pradesh) as the bank does not have adequate capital and earning prospects to pay its present depositors in full.
- ✓ The bank also does not comply with the provisions of Section 11(1) and bank has failed to comply with the requirements of Sections 22(3) (a), 22 (3) (b), 22(3)(c), 22(3) (d) and 22(3)(e) read with Section 56 of the Banking Regulation Act, 1949.
- ✓ The bank is prohibited from engaging in any 'banking' activities, including the acceptance and repayment of deposits, as defined in Section 5(b) in conjunction with Section 56 of the Banking Regulation Act, 1949.

# India needs Average Annual growth rate of 7.6% for 25 years to Become Developed Nation: RBI Paper

- ✓ According to the article titled "India @ 100" published in Reserve Bank of India (RBI) Bulletin July 2023 published by RBI's Economic Research Department, India needs to achieve an average annual real Gross Domestic Product (GDP) growth rate of 7.6% over the next 25 years to become a developed nation by 2047-48.
- ✓ This would require raising the current per capita GDP from USD2,500 to USD22,000, an increase of 8.8 times.

#### RBI cancelled Licence of 2 cooperative banks, Harihareshwar Sahakari Bank and Sri Sharada Mahila Cooperative Bank

- ✓ On 11th July 2023, the Reserve bank of India (RBI) cancelled the banking licence of two cooperative
- ✓ banks, Sri Sharada Mahila Co-operative Bank, Tumkur, Karnataka and Harihareshwar Sahakari Bank, Satara in Maharashtra.
- ✓ The licence were cancelled by RBI under Section 22 of the Banking Regulation Act, 1949 as these

- cooperative banks do not have adequate capital and earning prospects and have failed to comply with the requirements of the banking regulation act.
- ✓ RBI has asked these two lenders to cease banking business from 11 July 2023 in two separate statements.

### RBI allows Card Network Portability from Oct 1, 2023

- ✓ The Reserve Bank of India (RBI) has issued a 'Draft Circular – Arrangements with Card Networks for issue of Debit, Credit and Prepaid Cards' empowering the debit, credit, and prepaid card users in India with Card network portability w.e.f. October 1st, 2023.
- ✓ This means users can port their card network just like one can port switch/port mobile service providers while retaining the same phone number.
- ✓ The Card network portability will keep their existing card accounts, balances, and credit history intact.
- The RBI has invited opinions from various stakeholders for the same up to August 4, 2023. This decision by RBI has been taken in exercise of its powers conferred under Section 18 read with Section 10(2) of the Payment and Settlement Systems Act, 2007 (Act 51 of 2007), by ensuring the interest of payment system and public interest.

# IBA sets up 5-member group to implement RBI committee's recommendations on ARCs

- ✓ Indian Banks' Association (IBA) has formed a fivemember working group for the Implementation of recommendations from the Reserve Bank of India's committee on the working of Asset Reconstruction Companies (ARCs).
- The primary focus of the working group is to conduct a thorough review of assignment agreements and trust deed templates related to the acquisition of distressed assets by ARCs from lenders.
- ✓ The aim of this review is to update these templates to align with the evolving changes and expectations

within the ARC sector, enabling them to meet the growing demands of the financial industry.

- Previously, Propelld provided lending solutions by partnering with NBFCs but now the new license will help the company to lend directly along with functioning as a loan service provider (LSP).
- With the NBFC Licence, Propelld will provide tailored loan products, flexible repayment options and competitive interest rates to its customers, particularly in tier two and tier three cities.

### India May 2023 services exports rise 7.7% to USD 27.06 billion: RBI

- ✓ According to the Reserve Bank of India (RBI) provisional data on July 4, 2023, India's services exports in May 2023 increased by 7.7% compared to May 2022, reaching USD (\$)27.06 billion while imports rose 2% to USD 15.5 billion.
- ✓ The government's initial estimates, released in mid-June, had indicated that services exports amounted to USD 25.3 billion, with services imports at USD13.53 billion.
- ✓ The RBI's figures are provisional and subject to further updates which are published quarterly as part of India's overall balance-of-payments data.

#### SCIENCE AND TECHNOLOGY

### NASA, DARPA enlist Lockheed to build Nuclear-Powered Spacecraft

✓ On 26th July 2023, United States Defense Advanced Research Projects Agency (DARPA) and

National Aeronautics and Space Administration (NASA) penned an agreement with Littleton, Colorado



based aerospace and defence firm Lockheed Martin to construct Nuclear Thermal Rocket (NTR) vehicle to use in NASA's Demonstration Rocket for Agile Cislunar Operations(DRACO) program for crewed missions to Mars.

- ✓ GThis will help NASA & DARPA jointly to launch a nuclear-powered satellite as soon as 2027
- ✓ The engine uses a nuclear fission reactor to generate high temperatures which is efficient than chemical propulsion systems.
- ✓ NASA is attempting to develop a nuclear rocket that will take humanity to Mars and beyond. Under the DRACO program, NASA aims to have an inspace test of Nuclear Thermal Propulsion (NPT) within 2027 with an estimate of USD 499 million.
- ✓ In 1979, NASA contemplated a manned Mars Mission utilising a nuclear-powered spacecraft known as Nuclear Engine for Rocket Vehicle Application (NERVA). Unfortunately, the NERVA project was abandoned.
- ✓ Under the agreement with DARPA, Lockheed Martin is responsible for spacecraft design, integration, and testing.

### 14th CEM adopted CEM-Hubs initiative

✓ On July 21, 2023, The Clean Energy Ministerial (CEM) adopted first-of-its-kind 'Clean Energy Marine Hubs Initiative (CEM-Hubs)' for scaling up low carbon fuel production during the 14th Clean Energy Ministerial (CEM14) and 8th Mission Innovation meeting (CEM14/MI-8) held on July 19-22, 2023 in Goa, India.

- ✓ The CEM14/MI-8 meeting was simultaneously organized by the Bureau of Energy Efficiency (BEE), under the Ministry of Power, and the Department of Science and Technology, Ministry of Science and Technology, in Goa from 19th to 22nd July 2023.
- ✓ CEM was held on the sidelines of 4th G20 (Group of Twenty) Energy Transitions Ministerial Meeting (ETMM) under India's G20 Presidency in Goa during July 19-20, 2023.
- ✓ Theme of CEM14/MI-8: Advancing Clean Energy Together
- ✓ Aim of CEM14/MI-8: To Bring Together The Global Clean Energy Community.

#### **About CEM-Hubs Initiative**

✓ It is a high-level global forum jointly led by private sector and governments across the energy-maritime areas to promote policies and programs to transform maritime transportation and production hubs for future low- carbon fuels.

# China Successfully Launches World's First Methane-Powered Rocket to Space

- ✓ On July 12 2023, LandSpace, a Chinese private aerospace company became the world's first aerospace company to launch a two-stage rocket 'ZhuQue-2 Y-2' using liquid methane as fuel and liquid oxygen (LOx) as oxidizer.
- ✓ The rocket was launched from Jiuquan Satellite Launch Centre in the Gobi desert, China.
- ✓ A test payload was deposited into the Sun-Synchronous Orbit (SSO).
- ✓ The launch was the second attempt for the Zhuque-2 Y-2 rocket, following a failed initial launch of Zhuque-2 Y-1 in December, 2022.

#### **About Methane engines**

✓ The exceptional performance and cost-effectiveness
of methane engines have potential to produce
methane by combining water and carbon dioxide in
space. The technology holds great promise for
reusable rockets, positioning it at the forefront of
the new era of rocketry.

#### India Launches First 100% DME-Fueled Tractor for Sustainable On and Off-Road Usage

- ✓ The research was supported by the Science and Engineering Research Board (SERB) and was aligned with NITI Aayog's 'Methanol Economy' program.
- ✓ Dimethyl Ether (DME) is an indigenous and renewable fuel that has been widely adopted in countries like the United States, Japan, China, Sweden, Denmark, and Korea for powering vehicles.

# North Korea Conducted Second Successful Test of Solid-Fueled ICBM

✓ On 12th July 2023, North Korea's Hwasong-18( Mars Artillery Type 18), a intercontinental ballistic

missile (ICBM) was successfully launched for the second time from Pyongyang, North Korea

(Democratic



People's Republic of Korea). The first test-firing of Hwasong-18 was on 13th April 2023.

- ✓ It uses solid-fuel technology, giving it the capability to launch with minimal preparation and allows faster deployment of missiles during a war which makes it harder for the opponent to detect signs of their launch in advance.
- ✓ The road mobile, three stage missile flew for 74 minutes the longest time for a North Korean missile test.
- ✓ Hwasong-18 is the North Koreas's first solid-fuel intercontinental ballistic missile (ICBM).

#### L&T and Spain's Navantia sign an 'Teaming Agreement to build submarines for Indian Navy

✓ On 10th July 2023, Spain's shipbuilder Navantia and engineering major Larsen & Toubro Ltd (L&T), India signed an 'Teaming Agreement'(TA) in Delhi to jointly bid for a Rs. 43,000-crore (4.8

- billion euros) project to build 6 advanced dieselelectric submarines for the Indian Navy.
- ✓ The TA was signed for the purpose of submission of a techno-commercial bid for the Indian Navy's Project 75 (India) or P75 (I), a military acquisition initiative and submarine programme affiliated to India's Ministry of Defence (MoD).
- ✓ This agreement follows a Memorandum of Understanding (MoU) signed between L&T and Navantia on 11th April 2023 in Madrid, Spain to bid for the Indian Navy's P75 (I).
- ✓ Under the agreement, Navantia will design the P75(I) submarines based on its S80 class. The first S80 submarine, launched in 2021, is undergoing sea trials and will be delivered to the Spanish Navy by end 2023.

# World's largest private communications satellite 'Jupiter 3' launched

✓ SpaceX, Elon Musk's space exploration company, launched the world's largest commercial communications satellite from LC-39A, Kennedy

Space Center,
Florida, USA. The
Falcon Heavy
rocket was used
for the launch,
carrying Maxar



Technologies' biggest satellite to date, named Jupiter 3.

- ✓ JUPITER 3, also referred to as 'EcoStar XXIV', is a satellite of Hughes, an EchoStar company. As the next-generation Ultra High Density Satellite (UHDS), it is designed to provide gigabytes of connectivity to customers across North and South America.
- ✓ EchoStar Corporation, an American company, serves as a global provider of satellite communication and Internet services through its business segments, namely Hughes Network Systems and EchoStar Satellite Services.
- Maxar Technologies has developed JUPITER-3, a satellite that stands out not only for its remarkable size but also for its state-of-the-art technology and capabilities.

✓ India AI and Meta have forged a collaborative partnership with the shared objective of propelling

# Gaganyaan Human spaceflight mission: ISRO successfully tested service module propulsion system

✓ ISRO successfully tested Gaganyaan Human Spaceflight Mission on 19th July at ISRO

Propulsion
Complex (IPRC)
at Mahendragiri in
Tamil Nadu.



- ✓ It involves sending a crew of
  - three members to a 400 km orbit for a three-day mission and bringing them back safely to Earth, with a planned landing in Indian Sea Waters.
- ✓ Gaganyaan Human Spacecraft Mission involved five liquid apogee motor (LAM) engines with a thrust of 440 Newton and 16 reaction control system (RCS) thrusters with a thrust of 100 N. The Gaganyaan project aims to demonstrate India's capability for human spaceflight.
- ✓ The Service Module of Gaganyaan incorporates a regulated bi-propellant based propulsion system, fulfilling various critical functions such as orbit injection, circularisation, on-orbit control, de-boost manoeuvring and SM-based abort procedures during the ascent phase.

✓ The recent hot tests of the System Demonstration Model simulated the fluid circuit of the Service Module Propulsion System, including the propellant tank feed system, helium pressurisation system, flight-qualified thrusters and control components.

### **Dell joins Intel to launch AI skills lab in India**

✓ Dell Technologies and Intel have joined forces to establish an artificial intelligence (AI) lab in Telangana institute. The partnership aims to bridge the digital skills gap and empower students at Lords Institute of Engineering & Technology in Telangana by integrating Intel's 'AI for Youth' program into their curriculum. This initiative seeks to prepare students for the industry with the necessary expertise for the future job market and foster an AI-ready ecosystem on campus.

### ISRO to transfer SSLV to private sector

✓ The Indian Space Research Organization (ISRO) is going to transfer its Small Satellite Launch Vehicle (SSLV) to the private sector after conducting two

development flights of the rocket that seeks to provide on-demand services to put satellites weighing up to 500kg in a lowearth orbit.



✓ The commercial satellite launch services sector in India is projected to contribute \$13 billion to the economy by 2025, with the SSLV transfer expected to accelerate its growth.

#### **About ISRO's SSLV**

- ✓ Small Satellite Launch Vehicle (SSLV) is a three stage launch vehicle configured with three Solid Propulsion Stages and a liquid-propulsion based Velocity Trimming Module (VTM) as a terminal stage.
- ✓ The diameter of SSLV is 2m and the length is 34m with a lift-off weigh of around 120 tonnes.
- ✓ SSLV is capable of launching 500kg satellites in 500km planar orbit.

#### Meta and Microsoft Introduce the Next Generation of Llama

✓ Meta and Microsoft have jointly announced the expansion of their artificial intelligence partnership

by introducing their new large language model (LLM) called "Llama 2". This cutting-edge language model is now available for both



research and commercial use, making it a potential competitor to ChatGPT (OpenAI) and Bard (Google). The offering of Llama 2 for free enhances its accessibility and usability in various domains.

- ✓ Pre-trained on publicly available online data sources, the Llama-2-chat, which is a fine-tuned model, makes use of publicly available instruction datasets and benefits from over 1 million human annotations.

#### **Elena Introduces India's First NavIC**

- ✓ In a significant stride towards achieving selfreliance in navigation applications and services,
  Elena Geo Systems, a Bengaluru-based firm, has
  unveiled the country's first hand-held navigation
  device based on the Indian Regional Navigation
  Satellite System (NavIC). The device aims to
  provide precise directions for various infrastructure
  projects such as railway, land survey, telecoms, and
  hydrocarbon exploration. With a cost of Rs 6,000, it
  can be easily attached to smartphones using an onthe-go (OTG) connector, enabling users to leverage
  data from any mapping application or satellite
  source.
- ✓ Elena Geo Systems plans to collaborate with smartphone manufacturers to integrate the NavIC chip directly into mobile phones.

### Meta launches "Threads" Twitter killer app

✓ Meta, the owner of Instagram, has introduced a new social media platform called Threads. With Twitter

facing instability under its billionaire owner Elon Musk, Meta aims to capitalize on the situation. Threads is now accessible in more than 100 countries through the Apple App Store and Google Play



Store. Like Twitter, users can share brief text messages that can be liked, reposted, and responded to. However, Threads does not include direct messaging features. Users can create posts on Threads with up to 500 characters, as well as share links, photos, and videos up to five minutes in length.

✓ Threads has been integrated with Instagram, with a strong focus on privacy features. Users have the choice to show or conceal a badge on their Instagram profile, and they can customize privacy settings separately for each app. Several popular brands such as Billboard, HBO, NPR, and Netflix, as well as notable celebrities like Shakira and former Meta Chief Operating Officer Sheryl Sandberg, quickly created accounts on Threads. Interestingly, no advertisements were observed during a Reuters review of the app.

### WHO identifies first case of MERS-CoV in UAE this year

According to WHO, a first case of Middle East Respiratory Syndrome Coronavirus (MERS-COV) has been identified in a 28-year old male from United Arab Emirates (UAE). WHO has identified the first case of MERS-CoV in 28-year old male from United Arab Emirates (UAE). WHO stated that the patient is a resident of AI Ain city in Abu Dhabi. He had no travel history and had not come in direct or indirect contact with dromedaries (camels), goats or sheep. The first case of MERS-CoV was reported in UAE in 2013. Till date, UAE has reported 94 confirmed cases and 12 deaths. Globally, the total number of cases of MERS-CoV since 2012 is 2,605 including 936 associated deaths.

- ✓ The Barge proudly exemplifies the "Make in India" initiative of the Government of India, as it stands as a symbol of self-reliance with all its major and auxiliary equipment procured from indigenous manufacturers.
- ✓ The induction of these Missile Cum Ammunition (MCA) Barges is expected to bolster the operational capabilities of the Indian Navy by streamlining the transportation, embarkation, and disembarkation processes for articles and ammunition to Indian Naval Ships.

# DAC approves proposals for procurement of 26 Rafale Marine aircraft from France

- ✓ On 13th July 2023, The Defence Acquisition Council (DAC), chaired by Union Minister Rajnath Singh, Ministry of Defence (MoD), granted Acceptance of Necessity (AoN) for the procurement of 26 Rafale Marine aircraft along with associated ancillary equipment, weapons, simulator, spares, documentation, crew training and logistic support for the Indian Navy from the French government.
- ✓ This procurement is based on an Inter-Governmental Agreement (IGA) between Indian and France and aims to bolster the operational capabilities of the Indian Navy.

- ✓ The previous edition (14th edition) of exercise was held at Special Forces Training School, Bakloh in Himachal Pradesh from 5 to 18 October 2019.

Additionally, fleet tanker INS Shakti, a submarine, maritime patrol aircraft P8I and Dornier, ship-borne helicopters, and fighter aircraft were also a part of the exercise.
- ✓ Japan Maritime Self Defence Force (JMSDF):

  JMSDF will be represented by the guided missile destroyer JS Samidare and its integral helicopters.

#### India-US Joint Operation 'Broader Sword' Halts Illegal Drug Shipments via International Mail System

- ✓ India and the United States recently joined forces in Operation Broader Sword, a multi-agency operation aimed at preventing the illegal shipment of pharmaceuticals, devices, and precursor chemicals through the International Mail System (IMS). The operation, conducted in June 2023, resulted in the interception of over 500 shipments of illicit and unapproved prescription drugs bound for US consumers.
- ✓ Under Operation Broader Sword, law enforcement agencies from both countries, including India's Directorate of Revenue Intelligence (DRI) and the US Food and Drug Administration (FDA), Customs and Border Protection (CBP), Homeland Security Investigations (HSI), Drug Enforcement Administration (DEA), and US Postal Inspection Service (USPIS), worked together to target and halt the smuggling of dangerous and unauthorized pharmaceuticals, combination medical devices, and synthetic drug precursors through International Mail Facilities (IMF).g

- ✓ Jammu-Kashmir continues Operation Trinetra-II in Sindarah and Maidana of Surankote tehsil on 17th July to neutralize hiding terrorists. - ✓ According to the Export Preparedness Index(EPI) 2022 for States and Union Territories(UTs), the 3rd
  - edition of the National Institution for Transforming India (NITI Aayog) report, Tamil Nadu has topped the Index



with an overall score of 80.89.

- ✓ Maharashtra with 78.20 at 2nd place, Karnataka with 76.36 at 3rd place and Gujarat with 73.22 at 4th place are the top performers in EPI 2022 in all categories of states.
- ✓ The report, which presents a comprehensive analysis of India's export performance in FY22, was released by Suman Bery, Vice Chairman of NITI Aayog, on 17th July 2023.
- ✓ The EPI 2022 was prepared by NITI Aayog in association with the Institute for Competitiveness(IFC).
- ✓ The report highlights that Karnataka and Tamil Nadu have the highest number of Geographical Indications (GI) products being exported.

#### **Highlights of EPI 2022**

- ✓ According to EPI 2022, most of the coastal states of India have performed well.
- ✓ Haryana(63.65), Telangana(61.36) and Uttar Pradesh(61.23) are the top performers in landlocked states category.
- ✓ Uttarakhand (59.13) has topped among Himalayan States followed by Himachal Pradesh, Manipur, Tripura, Sikkim, Nagaland, Meghalaya, Arunachal Pradesh and Mizoram.
- ✓ Goa(51.58) has topped among Union Territories followed by Jammu & Kashmir(J&K), Delhi, Andaman and Nicobar and Ladakh.
- ✓ The report stated that among 680 districts, the top 100 districts contributes to around 87% of total exports of India.

- ✓ Gujarat's Jamnagar has toped the list of Districts followed by Surat, Mumbai Suburban, Mumbai, Pune, Bharuch, Kanchipuram, Ahmedabad, Gautam Buddha Nagar and Bengaluru Urban.
- ✓ With 8 districts, Gujarat has the highest number of districts in the top 25 export districts in India.

#### **About EPI**

- ✓ The Export Preparedness Index(EPI) 2022 Report evaluates the performance of the states across four pillars:
  - Policy pillar.
  - Business Ecosystem pillar.
  - Export Ecosystem pillar.
  - Export Performance pillar.
- ✓ These 4 pillars are further based on ten sub-pillars: Export Promotion Policy; Institutional Framework; Business Environment; Infrastructure; Transport Connectivity; Export Infrastructure; Trade Support; R&D Infrastructure; Export Diversification; and Growth Orientation.
- ✓ The index utilise 56 indicators that captures export preparedness of States and UTs in terms of exports at both the state and district-level.

# NITI Aayog launches 2nd National MPI: India's Multidimensionally Poor declines to 14.96% in 2019-2021

✓ On July 17, 2023, the Vice-Chairman of NITI

Aayog, Suman Bery released the 2nd edition of NITI Aayog's Report 'National Multidimensional Poverty Index (MPI): A Progress Review 2023'.



The report represents India's progress in reducing multidimensional poverty between the two surveys, National Family Health Survey [NFHS-4 (2015-16)] and NFHS-5 (2019-21).

✓ India has registered a significant decline of 9.89 percentage points in number of India's multidimensionally poor from 24.85% in 2015-16 to 14.96% in 2019-2021.

#### **Highlights**

- ✓ There is Marked improvement across all the 12 indicators
- ✓ Uttar Pradesh (UP) registered the largest decline in number of poor i.e. 3.43 crore people.
- ✓ The fastest reduction in the proportion of multidimensional poor was observed in the States of UP, Bihar, Madhya Pradesh (MP), Odisha, and Rajasthan.
- ✓ However, Bihar, Jharkhand, Meghalaya, UP and MP (even after decrease) top the chart where the percentage of total population who are multidimensionally poor is high.
- ✓ Delhi, Kerala, Goa and Tamil Nadu have the least number of people facing multidimensional poverty along with the Union Territories.
- ✓ The rural areas witnessed the fastest decline in poverty from 32.59% in 2015-16 to 19.28% in 2019-21.
- ✓ During the same period, the urban areas saw a reduction in poverty from 8.65% to 5.27%.
- ✓ Between 2015-16 and 2019-21, the MPI value has nearly halved from 0.117 to 0.066 and the intensity of poverty has reduced from 47% to 44%.
- This decline showcases Central Government's strategic focus on ensuring sustainable and equitable development and eradicating poverty by 2030. This include Flagship programs like Poshan Abhiyan and Anaemia Mukt Bharat, Swachh Bharat Mission (SBM), Jal Jeevan Mission (JJM), Pradhan Mantri Ujjwala Yojana (PMUY), Saubhagya, Pradhan Mantri Awas Yojana (PMAY), Pradhan Mantri Jan Dhan Yojana (PMJDY), Samagra Shiksha, among others.

# Henley Passport Index 2023: Indian passport ranks 80th; Gives Visa-Free Entry to 57 Countries

✓ According to the Henley Passport Index 2023 (3rd quarter) released by Henley & Partners, a London-based global citizenship and residence advisory

- firm, India ranked 80th by providing visa-free or visas on arrival access to 57 countries.
- ✓ India ranked 87th in Henley Passport Index 2022.

India's current rank ties it with countries like Togo and Senegal.



Singapore is the world's

most powerful passport with visa-free access to 192 travel destinations out of 227 worldwide.

#### The top 5

- ✓ i.Singapore increased its score by 25, pushing it five places up the ranking over the past 10 years
- ✓ to 1st position.
- ✓ ii.The 2nd place is shared by 3 European countries Germany, Italy, and Spain with 190 visa-free destinations
- ✓ iii.Japan, which held the top position for five consecutive years, dropped to 3rd place as the number of visa-free destinations for its passport holders decreased to 189. It shares its position with Austria, Finland, France, Luxembourg, South Korea and Sweden.
- ✓ iv.The United Kingdom, claimed 4th place(a position it last held in 2017) by rising 2 spots. It shares its position with Denmark, Ireland and Netherland.
- v.The 5th position is held by Belgium, Czech Republic, Malta, New Zealand, Norway, Portugal and Switzerland with visa-free access to 187 countries.
- **✓** The least in the index
- ✓ Afghanistan with a score of 27, Iraq 29 and Syria 30 stands at the bottom of the ranking, rounding out the three weakest passports in the world.

# India stands at 126 rank out of 163 countries in the Global Peace Index 2023

✓ According to the 17th edition of the Global Peace Index 2023 released by international think-tank, the Institute for Economics & Peace (IEP), India has ranked at 126th



- position by climbing nine positions from 2022. The list is topped by Iceland.
- ✓ India held the 135th position in 2022 with a score of 2.578, whereas in the current year it has improved to the 126th rank with a score of 2.314.

  India's position with respect to neighbours
- ✓ India is listed as the 126th country on the list which is far behind few of her neighbours such as Bhutan (17), Maldives (23), Nepal (79), China (80), Bangladesh (88), Sri Lanka (107). Countries like Myanmar (145) & Pakistan (146) are listed behind India.
- ✓ The ranking, which is based on 23 indicators grouped into three criteria (societal safety and security; extent of ongoing domestic and international conflict; and degree of militarization), shows 84 countries recording improvement and 79 showing deterioration.
- ✓ The 2023 Global Peace Index, which measures peace in 163 countries, found that violence costs the world USD17.5 trillion in purchasing-power parity (PPP) terms, or 12.9% of total global GDP. This means that each person on the planet is losing out on USD 2,200 in economic output because of violence.
- ✓ The index also found that the level of global peacefulness has decreased for the 13th time in the past 15 years. This is due to a number of factors, including political instability, unresolved internal conflicts, and an increase in violent crime.

### THE Young University Rankings 2023: Mahatma Gandhi University Secures Top among Indian Universities

- ✓ According to the Times Higher Education (THE) 'Young University Rankings (YUR)-2023', Mahatma Gandhi University (MGU), Kerala has emerged as top among Indian universities and secured 77 globally.Nanyang Technological University, Singapore tops the list in 2023.
- ✓ The only three universities from India in the Top 100 World List are Mahatma Gandhi University, JSS Academy of Higher Education and Research, Shoolini University of Biotechnology and Management Sciences.

#### **Indian Universities' Performance**

- ✓ MGU followed by JSS Academy of Higher Education and Research, Mysore, Karnataka and Shoolini University of Biotechnology and Management Sciences, Solan, Himachal Pradesh in top three positions among Indian Universities.
- ✓ JSS Academy of Higher Education and Research, Mysore, Karnataka ranked 79 and Shoolini University of Biotechnology and Management Sciences ranked 91st in the ranking list.
- ✓ A total of 45 Indian institutes were assessed in the THE Young University Ranking 2023 out of 605 universities globally.
- ✓ This category includes universities established in the past 50 years. For the first time, 13-year-old Shoolini University has participated in these rankings.
- ✓ In the year 2022, out of 539 universities ranked globally, only 40 Indian institutions were on the list and JSS Academy of Higher Education and Research topped the list.
- ✓ Lovely Professional University (LPU),Punjab placed in World's Rank Band 251-300 in the ranking THE YUR 2023 list among the other universities created since 1973.LPU has surpassed three IITs, namely IIT Guwahati and Bhubaneswar (ranked within the 301-350 band), as well as IIT Mandi (ranked within the 351-400 band).
- ✓ Australia is top-performing nation for first time in five years, while the United Arab Emirates(UAE) has shown a greater rate of improvement.
- ✓ The THE World University Rankings 2023 include 1,799 universities across 104 countries and regions.

### Tamil Nadu becomes India's Top Electronics Exporter of FY23 with the export worth USD5.37 billion

- ✓ According to the Export data released by the government of India for FY23 (financial year ended in March 2023), Tamil Nadu (TN) becomes India's leading exporter of Electronic goods in FY23, with exports reaching USD5.37 billion (bn), nearly triple the export of FY22 (USD 1.86 bn).
- ✓ Tamil Nadu is followed by Uttar Pradesh (UP) in the 2nd place with export worth USD 4.90 bn and Karnataka in 3rd place with USD 4.52 bn.

- ✓ For the 1st time, TN has overtaken UP, Karnataka and Maharashtra to top the list as India's leading exporter of electronic goods.
- Production from the companies like Tata Electronics and Pegatron helped TN to climb the top spot from the 4th spot in FY22 in the electronics sector.
- In FY 2022-23 India's export of electronic goods were recorded at USD 23.57 bn, the share of TN in the total export is 22.83%.
- ✓ Previously in FY22, India's export of electronic goods were at USD 15.59 bn while TN's share was 11.98%.

### 2023 UNAIDS Global AIDS Update: World can end AIDS by 2030

- UNAIDS, the Joint United Nations Programme on Human immunodeficiency viruses (HIV)/Acquired immune deficiency syndrome (AIDS), report titled "2023 UNAIDS Global AIDS Update – The Path That Ends AIDS" highlights that there is a path to end AIDS by 2030 and it requires strong political leadership, following the science, tackling inequalities and ensuring sustainable funding.
- The report contains data and case studies which highlight that ending AIDS is a political and financial choice, and that the countries and leaders who are already following the path are achieving extraordinary results.
- .Progress in AIDS response has been strongest in the countries and regions such as in eastern and southern Africa (that have the most financial investments), where new HIV infections have been reduced by 57% since 2010.

#### **India Achieved the Best-Performing Nation Digital** on **Trade Facilitation** Sustainable Survey

✓ According to the 5th edition of Survey on Digital and Sustainable Trade Facilitation by the United Nations Economic and Social Commission for Asia Pacific's (UNESCAP), India has emerged as the best-performing country in the South Asian region in terms of trade facilitation.

- India has been positioned at the forefront of global trade facilitation efforts, with an impressive score of 93.55% in 2023 vis a vis 90.32% in 2021 after evaluation of 160 economies(countries) and 60 trade facilitation measures.
- ✓ India has progressed by achieving a perfect score of 100% in four key areas; Transparency, Formalities, Institutional Arrangement and Cooperation, and Paperless Trade.
- ✓ India has shown improvement in the "Women in Trade Facilitation" component, increasing the score from 66.7% in 2021 to 77.8% in 2023.
- ✓ This indicates India's commitment to gender inclusive and empowering women in the trade sector.
- The 2023 survey reveals that India has not made any notable implementation in terms of "Wildlife Trade Facilitation."

#### **Ministry** of **Education** releases **Performance** report on Grading Index 2.0 for States/UTs for 2021-22

- ✓ On July 7, 2023, the Department of School Education & Literacy, Ministry of Education (MoE), released the 'Performance Grading Index (PGI): 2.0: 2021-22: States & Union Territories' which assesses the performance of school education system at the State/UT level by creating an index for comprehensive analysis.
- the PGI: 2.0 is the revised version of earlier 'PGI State structure for 2021 22'.

#### Highlights

- ✓ None of the States/UTs has attained the highest Grade i.e., Daksh.
- The top-most grade attained in PGI 2.0 is Prachesta - 2. It was attained by only 2 States and UTs, namely Punjab with score of 647.4 and Chandigarh (659.0).
- ✓ 6 States/UTs joined Grade Prachesta 3 (score 581-640), 13 States/UTs joined grade Akanshi -1 (score 521-580), 12 States/UTs in grade Akanshi -2 (score 461-520) and 3 States in grade Akanshi – 3 in PGI 2.0.
- Punjab and Chandigarh which are in Prachesta -2, are ranked 21st and 35th respectively in terms of their geographical size amongst States/UTs.

## The Global Multidimensional Poverty Index 2023

- ✓ The latest update of the Global Multidimensional Poverty Index (MPI) was released by the United Nations Development Programme (UNDP) and the Oxford Poverty and Human Development Initiative (OPHI) at the University of Oxford, United Kingdom(UK).
- ✓ As per it, a total of 415 million people moved out of poverty in India within just 15 years from 2005/2006 to 2019/2021 showing 55.1% decrease in 2005-06 to 16.4% in 2019-2021.
- ✓ The analysis of trends from 2000 to 2022, focused on 81 countries with comparable data over time.

#### **Indian Scenario**

- ✓ i.In India, multidimensional poverty declined from 645 million people in 2005-2006 to 370 million in 2015- 2016, and further to 230 million in 2019-2021. Deprivation decreased across all indicators.
- ✓ The proportion of people multidimensionally poor and deprived of nutrition decreased from 44.3% in 2005- 2006 to 11.8% in 2019-2021, and child mortality fell from 4.5% to 1.5%.
- ✓ Those deprived of cooking fuel decreased from 52.9% to 13%, and sanitation deprivation decreased from 50.4% in 2005-2006 to 11.3% in 2019-2021.
- ✓ Multidimensional poverty and deprivation decreased in drinking water (from 16.4% to 2.7%), electricity (from 29% to 2.1%), and housing (from 44.9% to 13.6%).


#### **Global Scenario**

- ✓ Over 18% of the global population (1.1 billion people) live in acute multidimensional poverty across 110 countries, with Sub-Saharan Africa and South Asia housing the majority of the poor.
- ✓ Two-thirds of all poor individuals (730 million people) reside in middle-income countries, highlighting the need for action in these nations. Low-income countries, comprising just 10% of the MPI population, are home to 35% of the poor.
- ✓ Half of the MPI-poor population (566 million) consists of children under 18, with a poverty rate of 27.7%. Poverty predominantly affects rural areas, where 84% of all poor people live.

✓ 25 countries, including India, have successfully halved their global MPI values within 15 years, demonstrating the potential for rapid progress. These countries include Cambodia, China, Congo, Honduras, India, Indonesia, Morocco, Serbia, and Vietnam.

#### **About The Global Multidimensional Poverty Index**

- ✓ The index is a key international resource that measures acute multidimensional poverty across more than 100 developing countries.
- ✓ It was first launched in 2010 by the OPHI and the Human Development Report Office of the UNDP.
- ✓ The MPI monitors deprivations in 10 indicators spanning health, education and standard of living and includes both incidence as well as intensity of poverty.
- ✓ The Global MPI uses three standard dimensions: Health; Education; Standard of Living and ten indicators.
