NOBEL PRIZE WINNERS 2023

The Nobel Prizes for 2023 in Physics, Chemistry, Physiology or Medicine, Literature, and Peace, as well as the Sveriges Riksbank Prize in Economic Sciences in Memory of Alfred Nobel 2023 have been announced. The Nobel Prize is a prestigious international award administered by the Nobel Foundation in Stockholm, Sweden. In 2023, 11 laureates were awarded the Nobel Prize for their contributions to mankind.

- ✓ Between 1901 and 2023, the Nobel Prizes and the Sveriges Riksbank Prize in Economic Sciences in Memory of Alfred Nobel were awarded **621 times to 1,000 people** and organisations. With some receiving the Nobel Prize more than once, this makes a total of **965 individuals and 27 organisations**.
- ✓ Since the start, in 1901, there are some years when the Nobel Prizes have not been awarded. The total number of times are 49. Most of them during World War I (1914-1918) and II (1939-1945).

Winners of Nobel Prize for the Year 2023

Peace: Narges Mohammadi

- ✓ Iranian activist Narges Mohammadi has been chosen by the Royal Swedish Academy for the coveted Nobel Peace Prize, 2023 “for her fight against the oppression of women in Iran and her fight to promote human rights and freedom for all.” The Prize recognizes their contribution for many years, promoting the right to criticize arbitrary policies and protecting the fundamental rights of citizens.



About Narges Mohammadi

- ✓ Narges Mohammadi is a human rights advocate, and a freedom fighter. As per the Academy, this year's Nobel Peace Prize also recognises the hundreds of thousands of people who have demonstrated against the theocratic regime's policies of discrimination and oppression targeting women. The motto adopted by the Iranian demonstrators – “Woman – Life – Freedom” – suitably expresses the dedication and work of Narges Mohammadi.
- ✓ She was arrested for the first time in 2011 for her efforts to assist incarcerated activists and their families. While in prison, she began opposing the regime's systematic use of torture and sexualised violence against political prisoners, especially women, that is practised in Iranian prisons.
- ✓ During Mahsa Amini Protests (Iranian Hijab Movement), she expressed support from the prison for the demonstrators and organized solidarity actions among her fellow inmates.

Other Award Received by Mohammadi are:

- ✓ Alexander Langer Award 2009
- ✓ UNESCO/Guillermo Cano World Press Freedom Prize and the Olof Palme Prize earlier in 2023.
- ✓ Her book 'White Torture: Interviews with Iranian Women Prisoners' also won an award for reportage at the International Film Festival and Human Rights' Forum.
- ✓

Literature: Jon Fosse

- ✓ The Nobel Prize in Literature for 2023 was awarded to Jon Fosse “for his innovative plays and prose which give voice to the unsayable.”



About Jon Fosse

- ✓ Jon Fosse, a Norwegian author and dramatist, writes in Norwegian Nynorsk, the less common of the two official versions of Norwegian language.
- ✓ Jon Fosse is celebrated for his writing style, often referred to as "Fosse minimalism."
- ✓ His style is characterized by simple, minimal, and searing dialogue, drawing comparisons to literary giants like Samuel Beckett and Harold Pinter, both of whom have previously been awarded the Nobel Prize in Literature.
- ✓ His themes explore the absurdity, the futility and yet the power of the human condition; everyday confusions and irresolutions; and the difficulty of forming actual connections.
- ✓ Notable works by Fosse include "A New Name: Septology VI-VII," "I Am the Wind," "Melancholy," "Boathouse," and "The Dead Dogs."

Economic Sciences: Claudia Goldin

- ✓ The Nobel Prize in Economics for 2023 has been awarded to Claudia Goldin, a Harvard University (USA) professor, “for research that has advanced the understanding of the Gender Gap in the Labor Market.”
- ✓ Goldin is only the third woman to win this honor. In 2009, Elinor Ostrom got the award along with Oliver E Williamson, while in 2019, Esther Duflo shared it with Abhijit Banerjee and Michael Kremer.
- ✓ Goldin has been a pioneer in studying the role of women in the economy and has written several books on the topic, such as Understanding the Gender Gap: An Economic History of American Women (Oxford, 1990), and Career & Family:



Women’s Century-Long Journey toward Equity (Princeton University Press, 2021).

- ✓ Goldin had provided “the first comprehensive account of women’s earnings and labour market participation through the centuries. Her research reveals the causes of change, as well as the main sources of the remaining gender gap.
- ✓ Goldin’s path breaking work has shed light on the participation of women in the labour market over the past 200 years, and why the pay gap between men and women refuses to close even as many women are likely to be better educated than men in high-income countries.

Medicine: Katalin Karikó and Drew Weissman

- ✓ The Nobel Prize in Medicine or Physiology for 2023 has been awarded to Katalin Karikó and Drew Weissman “for their discoveries concerning nucleoside base modifications that enabled the development of effective messenger Ribonucleic Acid (mRNA). vaccines against COVID-19”.
- ✓ Through their groundbreaking findings, which have fundamentally changed our understanding of how mRNA interacts with our immune system, the laureates contributed to the unprecedented rate of vaccine development during one of the greatest threats to human health in modern times," the jury said.



How mRNA research contributed to faster vaccine development

- ✓ In human cells, genetic information encoded in DNA is transferred to messenger RNA (mRNA), which is used as a template for protein production. mRNA vaccines work by triggering the production of proteins that stimulate the formation of virus-blocking antibodies in our cells.
- ✓ In the 1980s researchers were able to produce mRNA “in vitro”, that is, without having to first create large-scale cell cultures in a resource-intensive process. The resulting in vitro mRNA, however, was highly unstable and triggered the

immune system, leading to inflammatory responses in the body.

- ✓ Kariko and Weissman found out that mRNA with chemically modified bases did not lead to inflammatory reactions. Subsequent to publishing their discovery in 2005, they also found that using mRNA with altered bases significantly increased protein production.

About Katalin Karikó and Drew Weissman

- ✓ **Katalin Kariko** was born in 1955 in Szolnok in Hungary. She received her bachelor's degree in biology in 1978 and her doctorate in biochemistry in 1982 from the University of Szeged.
- ✓ Since 2021, Ms Kariko has been a Professor at Szeged University and an Adjunct Professor at the Perelman School of Medicine at the University of Pennsylvania.
- ✓ **Drew Weissman** was born in 1959 in Lexington, Massachusetts in the US. He did his BA in biochemistry and MA in Enzymology from Brandeis University in 1981.
- ✓ He established his research group at the Perelman School of Medicine at the University of Pennsylvania in 1997.

Chemistry: Mounqi G Bawendi, Louis E Brus, and Alexei I Ekimov



- ✓ The Royal Swedish Academy of Sciences awarded the Nobel Prize in Chemistry 2023 to Mounqi G Bawendi, Louis E Brus, and Alexei I Ekimov “for their groundbreaking discovery and synthesis of quantum dots”.

The Nobel Laureates' Contributions

- ✓ **Alexei Ekimov**: In around 1980, Soviet-born American physicist, Alexei Ekimov was the first to observe the anomalous behavior in Copper Chloride nanoparticles. He successfully

manufactured these nanoparticles, showcasing their distinctive properties.

- ✓ **Louis Brus:** American scientist Louis Brus made a similar discovery involving Cadmium Sulphide nanoparticles. Like Ekimov, he could create these nanoparticles with altered properties.
- ✓ **Moungi Bawendi:** French-born American chemist, Moungi Bawendi, who initially collaborated with Louis Brus, later played a pivotal role in simplifying the production methods for nanoparticles with unique characteristics.
- ✓ His work paved the way for efficient and controlled manufacturing of nanoparticles displaying desired deviant behaviors.

Physics: Pierre Agostini, Ferenc Krausz, and Anne L’Huillier.



- ✓ The 2023 Nobel Prize for Physics has been awarded to three distinguished scientists: Pierre Agostini, Ferenc Krausz, and Anne L’Huillier “for experimental methods that generate attosecond pulses of light for the study of electron dynamics in matter.”

What is Electron Dynamics?

- ✓ Electron dynamics refers to the study and understanding of the behavior and motion of electrons within atoms, molecules, and solid materials.
- ✓ It encompasses various aspects of electron behavior, including their movement, interactions with electromagnetic fields, and responses to external forces.
- ✓ Electrons are fundamental particles with a negative charge and they orbit the dense nucleus. For a long time, scientists had to rely on indirect methods to understand electron behavior, akin to taking a photograph of a fast-moving race car

with a long exposure time resulting in a blurry image.

- ✓ The rapid motion of electrons rendered them nearly invisible to conventional measurement techniques.
- ✓ Atoms in molecules exhibit movements on the order of femtoseconds, which are incredibly short time intervals, constituting a millionth of a billionth of a second.
- ✓ Electrons, being lighter and interacting even faster, operate within the attosecond realm, a billionth of a billionth of a second (1×10^{-18} of second).

About Pierre Agostini, Ferenc Krausz, and Anne L’Huillier.

- ✓ **Pierre Agostini.** PhD 1968 from Aix-Marseille University, France. Professor at The Ohio State University, Columbus, USA.
- ✓ **Ferenc Krausz,** born 1962 in Mór, Hungary. PhD 1991 from Vienna University of Technology, Austria. Director at Max Planck Institute of Quantum Optics, Garching and Professor at Ludwig-Maximilians-Universität München, Germany.
- ✓ **Anne L’Huillier,** born 1958 in Paris, France. PhD 1986 from University Pierre and Marie Curie, Paris, France. Professor at Lund University, Sweden.

About Nobel Prize

- ✓ The Nobel Prize honours Alfred Nobel, a Swedish chemist, engineer, inventor, and entrepreneur best known for inventing dynamite.
- ✓ Nobel was born on October 21, 1833, in Stockholm, Sweden, and passed away on December 10, 1896, in San Remo, Italy.
- ✓ Alfred Nobel made his last will and testament on November 27, 1895, leaving the majority of his wealth to a series of prizes in five fields: Physics, Chemistry, Physiology or Medicine, Literature, and Peace – the Nobel Prizes.
- ✓ The first Nobel Prizes were awarded in 1901.
- ✓ In 1968, Sveriges Riksbank (Sweden’s central bank) established the Prize in Economic Sciences in Memory of Alfred Nobel, founder of the

Nobel Prize. The first prize in economic sciences was awarded to Ragnar Frisch and Jan Tinbergen in 1969.

- ✓ The prize is officially not a Nobel Prize, but it is known as “The Sveriges Riksbank Prize in Economic Sciences in Memory of Alfred Nobel.”
- ✓ Since 1901, the Nobel Prizes have been awarded to Nobel laureates during ceremonies on December 10, the anniversary of Alfred Nobel’s death.
- ✓ The Royal Swedish Academy of Sciences in Stockholm, Sweden, bestows the Nobel Prize in Physics, the Nobel Prize in Chemistry, and the Sveriges Riksbank Prize in Economic Sciences in Memory of Alfred Nobel.
- ✓ The Nobel Prize in Literature is presented by the Swedish Academy.
- ✓ The Nobel Prize in Physiology or Medicine is presented by the Nobel Assembly at Karolinska Institutet in Sweden.
- ✓ The Nobel Peace Prize is presented by the Norwegian Nobel Committee, a group of five members appointed by the Norwegian parliament.
- ✓ Each prize can have up to three recipients, who share the prize money between them.
- ✓ The Nobel Prizes in Physics, Chemistry, Physiology or Medicine, Literature, and the Sveriges Riksbank Prize in Economic Sciences in Memory of Alfred Nobel are presented in Stockholm, Sweden, whereas the Nobel Peace Prize is presented in Oslo, Norway.
- ✓ The youngest Nobel Prize laureate: Malala Yousafzai (DOB 12 July 1997) The Nobel Prizes in Peace 2014.
- ✓ The oldest Nobel Prize laureate: John B. Goodenough (DOB 25 July 1992) The Nobel Prizes in Chemistry 2019.
- ✓ Between 1901 and 2023 the Nobel Prize and prize in economic sciences have been awarded 61 times to women. Mother Teresa was the first Indian woman to win Noble Peace Prize in 1979.

10 Indians/People of Indian Origin have won the Nobel Prize till now. First Indian to receive Nobel Prize was Rabindra Nath Tagore.

Thailand Announces Visa-Free Entry For Indians to Boost Tourism

- ✓ Thailand is taking steps to revitalize its tourism industry by allowing visa free entries for the citizens of India and Taiwan. This move comes as the high season approaches and is part of a broader strategy to attract more visitors to the country. Thailand had previously visa requirements for Chinese tourists, a significant source of visitors before the pandemic.
- ✓ Starting from 10th November 2023 and continuing until 10th May 2024, tourists from India and Taiwan can enter Thailand without the need for a visa. This decision aims to make it easier for travelers from these countries to explore the beauty of Thailand and contribute to the country's tourism sector.
- ✓ In September, Thailand took a similar step by scrapping visa requirements for Chinese tourists. China was Thailand's top pre-pandemic tourism market, contributing 11 million of the record 39 million arrivals in 2019. This move was aimed at rekindling the flow of Chinese tourists to Thailand and rejuvenating the country's tourism sector.



Sri Lanka announces free visas for Indians

- ✓ Sri Lanka, in a bid to revitalize its tourism sector, has taken a significant step by waiving visa fees for tourists from seven countries, including India. This move aims to attract more visitors and help the country recover from recent economic challenges.
- ✓ To boost tourist arrivals, Sri Lanka's Cabinet has initiated a pilot project to issue free tourist visas to travelers from China, India, Russia, Thailand, Indonesia, Malaysia, and Japan.
- ✓ This policy will be in effect until March 31, 2024.
- ✓ India has historically been Sri Lanka's top source market. This year alone, more than 2 lakh Indian tourists, constituting 20% of total arrivals, visited Sri Lanka until September.

FATF Removes Cayman Islands From Its 'Grey List'

- ✓ The Financial Action Task Force (FATF), an inter-governmental body responsible for setting international standards to combat money laundering, terrorist financing, and proliferation financing, has recently made headlines by removing several countries from its 'grey list' while adding another.
- ✓ In a review published on October 27, 2023, FATF announced the removal of several countries from its 'grey list.' These countries include the Cayman Islands, Panama, Jordan, and Albania. This development is a testament to the significant progress these nations have made in enhancing their AML/CFT systems, ultimately addressing the strategic deficiencies identified by FATF.
- ✓ While several countries celebrated their removal from the 'grey list,' FATF added Bulgaria to the list. This decision reflects the need for Bulgaria to strengthen its AML, CFT, and proliferation financing systems, aligning them with international standards.
- ✓ The FATF maintains a 'grey list,' which consists of jurisdictions that do not meet the organization's anti-money laundering (AML), counter-terrorism financing (CFT), and proliferation financing standards. Countries placed on this list are subject to increased monitoring until identified deficiencies in their regulatory frameworks are resolved.

- ✓ The United Nations, under the leadership of Secretary-General Antonio Guterres, has taken a significant step toward managing the opportunities and challenges posed by artificial intelligence (AI). Guterres emphasized the vast potential of AI for positive transformation, yet acknowledged the pressing need to address associated risks. To facilitate international cooperation and consensus on AI governance, a 39-member advisory body has been established, comprising tech industry leaders, government officials, and academics from diverse backgrounds.
- ✓ The advisory body includes prominent figures like Sharad Sharma, co-founder of India's iSPIRT Foundation, and Amandeep Singh Gill, UN Secretary-General's Envoy on Technology.



S Jaishankar Unveils Mahatma Gandhi's Bust in Vietnam

- ✓ Recently, External Affairs Minister S Jaishankar embarked on a significant official visit to Vietnam. This visit marked not only the strengthening of bilateral relations but also a celebration of the enduring principles and values adopted by Mahatma Gandhi and Rabindranath Tagore. The visit underscored the deep-rooted connections between India and Vietnam and the shared commitment to addressing global issues.
- ✓ One of the prominent events during Jaishankar's visit to Vietnam was the unveiling ceremony of a bust of Mahatma Gandhi in Ho Chi Minh City.



India-Sri Lanka Ferry Service Reopens After Four Decades

- ✓ An age-old sea route between India and Sri Lanka has been rejuvenated with the inauguration of a passenger ferry service from Nagapattinam in Tamil Nadu to Kankesanthurai in Jaffna, Northern Sri Lanka. This initiative aims to bolster bilateral

ties, boost tourism, and increase people-to-people relations while benefiting local traders on both shores.



- ✓ The passenger ferry service, named 'Cheriyapani,' was officially launched. While the recent ferry service inauguration is a new development, maritime linkage between India and Sri Lanka has a long history. The Indo-Ceylon Express or Boat Mail operated between Chennai and Colombo via the Thoothukudi port from the early 1900s until 1982. However, the civil war in Sri Lanka led to the suspension of these services.

Tallest BR Ambedkar Statue Outside India Unveiled In Washington

- ✓ In a historic event, a 19-foot tall statue of Dr. B.R. Ambedkar, the principal architect of India's Constitution, was formally inaugurated in a suburb of Maryland, Washington. This statue is being considered as the tallest of its kind outside of India and holds significant importance for both Indian-Americans and the Indian diaspora around the world.
- ✓ During the inauguration ceremony, the air was filled with enthusiastic chants of 'Jai Bhim.' More than 500 Indian-Americans, including attendees from various parts of the United States, India and other countries, came together to witness this historic moment. The event was an evident to the global reverence for Dr. Ambedkar's contributions.
- ✓ The statue was crafted by the renowned artist and sculptor Ram Sutar, who is known for creating the 'Statue of Unity' of Sardar Patel, located on an island in Gujarat's Narmada River.



India & Switzerland Celebrated 75 Yrs Of Friendship

- ✓ India and Switzerland recently celebrated 75 years of their enduring friendship and fruitful collaboration in a beautiful Kumaon village nestled in the Uttarakhand region of India. The three-day

event, aptly named ‘Swiss Himalayan Bounty,’ unfolded last week at a charming homestay in Satoli village, positioned at an altitude of 6,000 feet near Mukteshwar in the Nainital district. This celebration saw the convergence of participants representing various NGOs, stakeholders, and beneficiaries of the longstanding partnership between these two nations.

Swaminarayan Akshardham, Largest Hindu Temple Set Up In New Jersey

- ✓ BAPS Swaminarayan Akshardham, the largest Hindu temple in the United States, celebrated its grand opening on Sunday, October 8, in Robbinsville, New Jersey. This architectural marvel is not only a testament to the vibrant Hindu community in the US but also a symbol of the enduring spirit of artistry, spirituality, and human dedication.
- ✓ The temple, set up in the picturesque city of Robbinsville, New Jersey, is a remarkable achievement. It stands as the largest Hindu temple outside India in the modern era. The grand opening was marked by a letter from Prime Minister Narendra Modi, recognizing the profound spiritual significance of this momentous occasion.



Akhaura- Agartala rail link to be inaugurated virtually by PM Modi, Sheikh Hasina

- ✓ Prime Minister Narendra Modi and Bangladesh counterpart Sheikh Hasina inaugurated the Agartala-Akhaura rail link project virtually. This cross-border initiative aims to strengthen business ties and provide direct access between India’s landlocked northeastern region and the Chittagong port in Bangladesh. The project is executed by IRCON, a CPSE of Railways, on the Indian side, and it serves as the Project Management Consultant (PMC) for Bangladesh Railways.
- ✓ Originally scheduled for completion in 2020, the project faced delays due to various reasons.

World Health Summit 2023

- ✓ The 2023 World Health Summit took place from October 15 to October 17 under the theme “A Defining Year for Global Health Action” in Berlin, Germany, and online.
- ✓ Non-communicable diseases (NCDs) have emerged as a significant global health challenge, demanding immediate attention and a multi-faceted approach. Dr. Bharati Pravin Pawar, Union Minister of State for Health and Family Welfare, underscored the importance of addressing NCDs during her virtual address at the high-level panel discussion on “Scaling up Integration of NCDs in Primary Care” at the World Health Summit 2023.
- ✓ **The 75/25 Initiative:** India launched the 75/25 initiative, aiming to screen and provide standard care for 75 million individuals with hypertension and diabetes by 2025. This initiative is recognized as the most extensive expansion of NCDs in primary healthcare on a global scale.

Sri Lanka to take over as Chair of Indian Ocean Rim Association

- ✓ Sri Lanka to take over as Chair of IORA for the next two years. The Indian Ocean Rim Association (IORA) is an intergovernmental organisation of 23 member states and 11 dialogue partners from Africa, West Asia, South Asia, South-East Asia, and Oceania. It was established in 1997 to promote regional cooperation and development.
- ✓ The IORA Council of Ministers meeting is the highest decision-making body of the Association. It is held annually to discuss and decide on IORA priorities.

India And UK Hold First 2+2 Foreign And Defence Dialogue In New Delhi

- ✓ The inaugural India-UK ‘2+2’ foreign and defence dialogue, held on Monday, marked a significant milestone in the bilateral relations between India and the United Kingdom. The dialogue saw both sides focusing on ways to enhance cooperation in various critical areas such as trade and investment, defense, critical technologies, civil aviation, health, and energy.

Kozhikode Named India's First 'City of Literature' by UNESCO

- ✓ Kozhikode, a city located in the southern Indian state of Kerala, has made its mark on the global stage by being named one of the latest entrants into the UNESCO Creative Cities Network. This prestigious recognition was bestowed upon Kozhikode on World Cities Day, alongside Gwalior in Madhya Pradesh, which was recognized as a 'City of Music'. Kozhikode's new title as the 'City of Literature' marks a significant milestone, as it's the first city in India to hold this coveted distinction.
- ✓ Kozhikode's journey to becoming the City of Literature began in 2022 when the Kerala Institute of Local Administration proposed the idea. The Kozhikode Corporation swiftly sprang into action, reaching out to the University of Prague in the Czech Republic for assistance in the preparation process. Prague was the first city to receive the City of Literature title in 2014.

PM Modi Inaugurated The 7th Edition Of Indian Mobile Congress (IMC) In New Delhi

- ✓ Prime Minister Narendra Modi inaugurated the 7th Edition of the India Mobile Congress at Bharat Mandapam, Pragati Maidan, New Delhi. This prestigious event brought together leading figures from the telecommunications industry to showcase cutting-edge technologies, discuss vital issues, and promote innovation.
- ✓ During the event, Akash Ambani introduced Reliance Jio's groundbreaking initiative – Space Fibre, India's first satellite-based giga fibre service capable of delivering internet speeds of up to 1 Gbps. This innovation is set to transform high-speed broadband services in previously inaccessible areas of India. Furthermore, the Jio Bharat device, offering 4G services, was on display at the Jio pavilion.

Delhi, Delhi. The event will be organised by a Consortium of Textile Export Promotion Councils (EPCs) with the support of the Ministry of Textiles.

- ✓ This expo is the embodiment of India's 5F vision – Farm to Fibre to Factory to Fashion to Foreign.
- ✓ Union Textiles Minister Piyush Goyal launched the Kasturi Cotton Bharat website (<https://kasturicotton.texprocil.org/>), a digital platform for necessary information and updates on this initiative.

Home Minister Amit Shah inaugurates India's 1st Nano DAP plant in Gujarat

- ✓ India's first Nano Di-Ammonia Phosphate (DAP–Liquid) plant was inaugurated by the Union Minister Amit Shah, Ministry of Home Affairs (MHA) at Kalol in Gandhinagar, Gujarat. It was set up by Indian Farmers Fertilizer Cooperative Limited (IFFCO) at a cost of Rs 300 crore.
- ✓ The development of plant is on the lines of Aatmnirbhar Bharat vision of Prime Minister (PM) Narendra Modi.
- ✓ This is the second IFFCO plant in Gujarat. In May 2022, PM inaugurated IFFCO's world's first Nano Urea Liquid in Kalol.

Prime Minister Narendra Modi visits Telangana to launch multiple development projects

- ✓ In Telangana, PM Modi laid the foundation stone of various development projects worth around ₹ 8000 crore, in important sectors like power, rail, and Health.
- ✓ The first 800 MW Unit of phase 1 of the Telangana Super Thermal Power Project of NTPC will be dedicated to the nation.
- ✓ The Prime Minister dedicated rail projects including the new Railway Line connecting Manoharabad and Siddipet; and the electrification project between Dharmabad – Manoharabad and Mahabubnagar - Kurnool.

- ✓ An exhibition namely Mother of Democracy will also be organized at the venue of the summit to highlight India's ancient and participative democratic traditions.

Indian Oil launches country's first reference fuel

- ✓ The Union Minister of Petroleum & Natural Gas, Hardeep S Puri launched the 'Reference Gasoline and Diesel Fuels' produced by IndianOil for the first time in India.
- ✓ Reference fuels (Gasoline and Diesel) are premium, high-value products used for calibration and testing of vehicles by auto OEMs and organisations involved in testing and certification in the automotive field.
- ✓ IndianOil has successfully commenced the production of Reference Gasoline and Diesel Fuels for the first time in India. These fuels are used for calibration and testing of vehicles by automobile manufacturers and testing agencies like ICAT (International Centre for Automotive Technology) and ARAI (Automotive Research Association of India).

- ✓ With this launch, India joined the elite group of nations with domestic production of 'Reference' Petrol and Diesel and IOCL becomes the 4th refiner in the world to produce 'reference' grade petrol and diesel.

Union Government approves inclusion of Jamrani Dam under PMKSY-AIBP

- ✓ The government of India approved the inclusion of the Jamrani Dam Multipurpose Project under the Pradhan Mantri Krishi Sinchayee Yojana-Accelerated Irrigation Benefit Programme (PMKSYAIBP).
- ✓ The project envisages the construction of a dam near Jamrani village across river Gola, a tributary of river RamGanga, in the Nainital district of Uttarakhand.
- ✓ This project is the seventh project to be included in the PMKSY-AIBP list.
- ✓ Pradhan Mantri Krishi Sinchayee Yojana was launched in 2015-16 to enhance physical access to water on farms, expand cultivable areas under assured irrigation, improve on-farm water use efficiency, and introduce sustainable water conservation practices

PM Modi inaugurates the 37th National Games at Jawaharlal Nehru Stadium in Goa

- ✓ Prime Minister Narendra Modi inaugurated the 37th National Games at the Jawaharlal Nehru Stadium in Goa. Modi informed that from Khelo India to TOPS (Target Olympic Podium Scheme), the government has created a new ecosystem to support players in the country.

Nirmala Sitharaman inaugurates the first GCCEM in New Delhi

- ✓ Union Minister for Finance and Corporate Affairs Smt. Nirmala Sitharaman presided over as Chief Guest at the inaugural session of the first-ever three-day-long Global Conference on Cooperation in Enforcement Matters (GCCEM) in New Delhi.
- ✓ Union Minister of State for Finance Shri Pankaj Chaudhary was the Guest of Honour and Secretary

General, World Customs Organisation, Dr. Kunio Mikuriya, was the Special Guest at the Inaugural Session.

- ✓ Against this backdrop, the Directorate of Revenue Intelligence (DRI) under the Central Board of Indirect Taxes and Customs (CBIC), in consultation with the World Customs Organisation (WCO), Brussels, is hosting the global conference from 30th October to 1st November 2023 with the theme 'It takes a Network to fight a Network'.

Star rating programme for solar PV modules to help consumers make informed decision

- ✓ The Indian government has introduced a star rating programme for solar photovoltaic (PV) modules.
- ✓ The SLP aims to guide citizens in making informed decisions when purchasing and deploying PV modules.
- ✓ The star labelling scheme prepared by the Bureau of Energy Efficiency (BEE) for PV modules is from January 1, 2024 till December 31, 2025.
- ✓ It will be managed by the Bureau of Energy Efficiency (BEE).
- ✓ The programme aligns with the government's broader objective of increasing the share of renewable energy and reducing the emission intensity of GDP by 45% by 2030.

PM Modi flags off Delhi-Meerut Regional Rapid Rail Transit System

- ✓ PM Modi inaugurated the first leg of the Regional Rapid Transit System (RRTS), India's first mass rapid system dedicated to regional connectivity.
- ✓ Trains on the first section will eventually cut the journey time between Delhi and Meerut to less than an hour.
- ✓ India's first regional rapid train, between Delhi and Meerut, has been named "Namo Bharat".
- ✓ The PM inaugurated the priority section of the Delhi-Ghaziabad-Meerut Regional Rapid Transit System (RRTS) corridor and flagged off the "RapidX train" connecting Sahibabad and Duhai Depot.
- ✓ The overall length of this RRTS train system spans 82.15 kilometers, with the initial 17-kilometre

priority section between Sahibabad and the Duhai Depot now operational.

- ✓ The entire corridor is on track for full functionality by June 2025.

About NCRTC

- ✓ NCRTC, under the Ministry of Housing and Urban Affairs, is mandated with implementing the RRTS project across the National Capital Region.
- ✓ It is being developed at a cost of more than Rs 30,000 crore.
- ✓ The Government of India has borrowed about \$1 billion from Asian Development Bank (ADB), \$500 million from New Development Bank (NDB) and \$500 million from Asian Infrastructure Investment Bank (AIIB).
- ✓ Apart from that, the Government of India will fund 20%, Government of Delhi 3.22%, and Government of Uttar Pradesh 16.78%.

Centre approves Minimum Support Prices for Rabi Crops for Marketing Season 2024-25

- ✓ The minimum support price of Rabi crops for the marketing year 2024-25 approved by the Center.
- ✓ The government has increased the MSP of Rabi crops for the marketing season 2024-25, to ensure remunerative prices to producers for their produce.
- ✓ The highest increase of Rs 425 per quintal has been approved for lentils, followed by Rs 200 per quintal for mustard.
- ✓ Additionally, to extend the benefits of the Kisan Credit Card scheme to every farmer across the country, the Government has launched the Kisan Loan Portal (KRP), KCC door-to-door campaign, and Weather Information Network Data System (WINDS).

Centre Now Plans 'One Nation, One ID' For All School Students

- ✓ The Union Ministry of Education is planning to create a unique identification number, Automated Permanent Academic Account Registry (APAAR), for every student from pre-primary to higher education.

- ✓ As part of the National Education Policy (NEP) 2020, the government is planning to create a 'One Nation, One Student ID' for every student.

The Automated Permanent Academic Account Registry - APAAR, dubbed as the 'One Nation, one student ID' is an Education Ecosystem Registry or an 'EduLocker'.

Government amends aircraft rules commercial pilot licenses to be valid for 10 years

- ✓ Commercial pilot licenses will now be valid for ten years, with the government amending rules as part of efforts to further improve ease of doing business in the aviation sector.
- ✓ Till now, the validity of the Commercial Pilot License (CPL) was for five years and after completion of that period, it had to be renewed.
- ✓ The Civil Aviation Ministry amended the Aircraft Rules, 1937.

PM hails Gujarat's Dhordo for being awarded as Best Tourism Village by UNWTO

- ✓ The Prime Minister, Shri Narendra Modi hailed the Dhordo village in Kutch district of Gujarat for being awarded as the Best Tourism Village by the United Nations World Tourism Organization (UNWTO).

Indian Railways' PSUs, RITES Ltd and IRCON granted Navratna status

- ✓ Ircon International Limited (IRCON) and RITES Ltd(RITES) both Central Public Sector Enterprise (CPSE) under the Ministry of Railways, have been announced as 15th and 16th Navratna respectively among CPSEs.

- ✓ The Bureau of Indian Standards (BIS), the National Standard Body of India, has approved IS17017 (Part 2 / Sec 7): 2023, India's first-ever indigenously developed Alternating Current (AC) and Direct Current (DC) Combined Charging connector standard for Light Electric Vehicles (LEVs).
- ✓ It is also the world's 1st charging standard that combines AC and DC charging for small EVs, such as electric scooters, motorcycles, three-wheelers, and quadricycles, and is designed and engineered in India.
- ✓ The new standard is based on Ather Energy's charging connector.

Education Minister Launched NCERT's Web Portal 'Apna Chandrayaan' for Students

- ✓ Union Minister Dharmendra Pradhan, the Ministry of Education(MoE), launched a web portal 'Apna Chandrayaan' for school students in New Delhi, Delhi. The web portal was developed by the National Council of Educational Research and Training (NCERT).
- ✓ The portal features activity-based support material such as interactive quizzes, puzzles for school students in Foundational, Preparatory, Middle, and Secondary level on Mission Chandrayaan3.

- ✓ The ISO certificate is issued for 3 years. With this certification, Mahila Thana has become the 2nd ISO-certified police station in Bhopal.
- ✓ In May 2023, Misrod police station became the first ISO 9001:2015 certified police station of Bhopal.

- ✓ The hallmarking system is administered by the BIS, which is the National Standard Body of India established under 'Bureau of Indian Standards (BIS) Act 2016'.
- ✓ Hallmark Unique Identification (HUID) number is a six digit Alphanumeric code, Introduced in 2021.

Baiga Tribe Becomes the 2nd Tribe to Get Habitat Rights in Chhattisgarh

- ✓ Baiga, classified as the Particularly Vulnerable Tribal Group (PVTG), in Chhattisgarh has received the Habitat rights under the Forest Rights Act(FRA) 2006. With this Baiga has become the 2nd tribal group after Kamar to get habitat rights in Chhattisgarh.
- ✓ The Baiga community, primarily inhabits various districts in Chhattisgarh, such as Rajnandgaon, Kawardha, Mungeli, GPM, Manendra-Bharatpur-Chirmiri, and Bilaspur.

Sarakka Central Tribal University approved for Telangana

- ✓ On October 4th, the Union Cabinet approved the establishment of a tribal university in Telangana, named The Sarakka Central Tribal University. This university, with a budget of Rs 889 crore, will be located in Mulugu district.
- ✓ The initiative was a commitment made by the Central government as a part of the Andhra Pradesh Reorganisation Act, 2014, which aimed to support both Andhra Pradesh and Telangana in establishing tribal universities.

- ✓ Mulugu hosts a biennial festival called the Sammakka Saralamma Jatara, one of the largest gatherings of tribal people globally.

- ✓ Manipur Chief Minister N Biren Singh sent a powerful message of unity and harmony as he participated in this year's Mera Houchongba celebrations in Imphal on 28th October 2023. The event, which brought together the diverse communities of the state, emphasized the strong bond between the people of the hills and the valley. - ✓ Mera Houchongba has deep roots in the history of Manipur. The festival is observed and celebrated during the month of 'Mera,' which typically falls in September or October.

Arunachal Cabinet approves formation of Special Tiger Protection Force For 3 Tiger Reserves

- ✓ The Arunachal Pradesh State Cabinet gave the green light to a host of transformative measures aimed at safeguarding the state's biodiversity and promoting the preservation of indigenous languages. Jharkhand's groundbreaking move to consider minimum wages for gig workers and review minimum wage standards for other laborers is a significant step toward ensuring fair compensation for workers in various sectors. India's Fiscal Deficit Reaches 39.3% of FY24 Target in First Half of the Year

- ✓ In the first half of the 2023-24 financial year, India's central government faced a fiscal challenge, with the fiscal deficit rising to 39.3% of the annual target, a slight increase from the previous year's 37.3%. This widening gap between expenditure and revenue amounted to Rs 7.02 lakh crore by the end of September 2023, as reported by the Controller General of Accounts (CGA). Despite efforts to contain the deficit, the figures reflected the financial landscape.
- ✓ The fiscal deficit stood at 39.3% of the full-year target. In actual terms, the gap between expenditure and revenue amounted to Rs 7.02 lakh crore.
- ✓ The Union Budget aimed to limit the fiscal deficit to 5.9% of the GDP in the fiscal year 2023-24. This

target followed a fiscal deficit of 6.4% of the GDP in the previous fiscal year (2022-23), which was slightly lower than the initial estimate of 6.71%.

8.1% Growth Rate in 8 Key Infrastructure Sectors in September 2023

- ✓ In September 2023, the growth rate of eight key infrastructure sectors in India witnessed a slowdown, reaching a four-month low of 8.1%. This decline is notable compared to the 8.3% growth recorded in the same month the previous year. Several of these sectors experienced deceleration, with crude oil output registering negative growth.

Positive Performers in September:

- ✓ **Coal:** Coal production surged by 16.1% in September.
- ✓ **Natural Gas:** Natural gas production increased by 6.5%.
- ✓ **Steel:** Steel production witnessed growth of 9.6%.

IMF Forecasts Global Growth Slowdown To 2.9% In 2024

- ✓ The International Monetary Fund (IMF) has recently unveiled its latest economic projections, revealing that global growth is expected to remain at 3 percent in 2023 and further decline to 2.9 percent in 2024, marking one of the lowest growth rates in decades. In its “Navigating Global Divergences” report for October 2023, the IMF outlines the key factors contributing to this subdued outlook and highlights the significant challenges the global economy faces.
- ✓ Advanced economies are also expected to experience a decline, with growth dropping from 2.6 percent in 2022 to 1.5 percent in 2023 and 1.4 percent in 2024. This decline is attributed to policy tightening aimed at curbing inflation.

Centre approves 22,303 Crore ₹subsidy on Key fertilizers

- ✓ The Indian government recently announced changes in the subsidy rates for key fertilisers, affecting nitrogen (N), phosphorus (P), potassium (K), and sulphur (S). Despite global price increases, the

government aims to maintain affordable fertiliser prices for Indian farmers.

- ✓ During October-March, subsidies for N, P, K, and S have been reduced compared to April-September. Nitrogen subsidy decreased by 38%, phosphorus by 49%, potassium by 84%, and sulphur by 32.5%.
- ✓ Urea will remain highly subsidized at Rs 266 per bag. Complex fertilisers like DAP will cost Rs 1,350 per bag, NPK varieties at an average of Rs 1,470 per bag, and MOP at Rs 1,655 per bag.

India to surpass Japan in 2030 to become 2nd largest economy of Asia, says S&P Global

- ✓ India’s economy is on the rise! By 2030, its Gross Domestic Product (GDP) is predicted to reach a whopping \$7.3 trillion, making it the second-largest economy in the Asia-Pacific region, just after China.
- ✓ In 2030, India’s GDP is expected to surpass even Germany’s. To put this in perspective, as of the end of 2022, India’s GDP had already outgrown that of the United Kingdom and France.
- ✓ This impressive economic growth has propelled India to become the third-largest economy in Asia-Pacific and the fifth-largest in the world.
- ✓ India’s GDP, when measured in United States dollars (USD), is predicted to jump from \$3.5 trillion in 2022 to \$7.3 trillion by 2030.
- ✓ This rapid expansion will make India’s economy second only to China in the Asia-Pacific region. It’s also expected to continue as one of the fastest-growing economies globally over the next decade.
- ✓ This growth opens up exciting opportunities for companies worldwide. India is becoming an essential long-term market for various industries, including manufacturing (such as automobiles, electronics, and chemicals) and services (like banking, insurance, asset management, healthcare, and information technology).
- ✓ In 2021 and 2022, India experienced rapid economic growth. In 2023, the strong growth trend continued, with the GDP expanding by 7.8% year-on-year from April to June.

- ✓ This growth remains impressive despite the high comparison base established by the GDP growth of 13.1% in the same quarter in 2022.

Centre approves 4% hike in DA for central govt employees

- ✓ The Union Government recently took a significant step to benefit Central government employees and pensioners by increasing the Dearness Allowance (DA) and Dearness Relief (DR) by 4%. This increase will be effective from July 1, 2023.
- ✓ Union Minister Anurag Thakur announced a 4% increase in Dearness Allowance and Dearness Relief. The DA will go up from 42% to 46%.
- ✓ This decision benefits a large number of people, including 48.67 lakh central government employees and 67.95 lakh pensioners.
- ✓ The dearness allowance for employees and pensioners is calculated based on the Consumer Price Index for Industrial Workers (CPI-IW), published monthly by the Labour Bureau. The release of the additional installment of DA and DR will be applicable from July 1, 2023.

IMF Raises India's FY24 GDP Growth Forecast to 6.3%

- ✓ In its October 2023 World Economic Outlook (WEO) report, the International Monetary Fund (IMF) raised India's economic growth forecast for the fiscal year 2023-24. The growth projection was increased from 6.1% to 6.3% due to stronger-than-expected consumption during April-June. The report also highlighted India's resilient domestic economic activity and the positive impact of robust domestic demand, contrasting global economic trends.
- ✓ GDP Growth Projection: The IMF revised India's GDP growth forecast to 6.3% for both 2023 and 2024, indicating a 0.2 percentage points upward revision for 2023. This adjustment was attributed to the nation's strong consumption patterns during the specified period.
- ✓ The IMF anticipated retail inflation in India to rise to 5.5% in fiscal 2023-24 before easing to 4.6% in 2024-25. This projection aligns with the Reserve Bank of India's (RBI) inflation target over the medium term.

- ✓ The IMF anticipated India's current account deficit to remain at 1.8% of GDP in FY24 and FY25, indicating a stable external economic position for the nation

The World Bank expected economic growth of India in 2023-24

- ✓ India's economy showed resilience, growing at 7.2% in FY22/23, despite global challenges. The World Bank expects a growth moderation to 6.3% in FY23/24 due to external factors.
- ✓ Bank credit grew by 15.8% in the first quarter of FY23/24, indicating a healthy financial environment.
- ✓ Despite challenges, the service sector is anticipated to grow by 7.4%, and investment is projected to remain robust at 8.9%

India's Net Direct Tax Collections Surge by 21.8%, Surpassing Half of Budget Projections

- ✓ India has witnessed a remarkable increase in its net direct tax collections, with a substantial growth rate of 21.8% amounting to ₹9.57 lakh crore by October 9. This surge has exceeded over half of the annual Budget estimates. The boost is primarily attributed to a 32.5% rise in personal income tax revenues and a 12.4% increase in corporate taxes.

Urban unemployment rate drops to 6.6% in Q1

- ✓ The Ministry of Statistics and Programme Implementation (MoSPI) released its quarterly bulletin of the Periodic Labour Force Survey (PLFS), shedding light on the urban unemployment situation in India during the first quarter of the fiscal year.
- ✓ In the April-June quarter of this fiscal year, the urban unemployment rate in India dropped to 6.6%.
- ✓ This was the lowest level recorded since the PLFS bulletin was launched in 2018.
- ✓ For males above the age of 15, the urban unemployment rate decreased from 6.0% in the previous quarter to 5.9%.
- ✓ For females in the same age group, the unemployment rate decreased from 9.2% to 9.1% during the same period.

- ✓ Among urban females aged 15-29, the unemployment rate slightly increased to 23.4% in April-June from 22.9% in the previous quarter but was lower than the 23.9% recorded in the same period the previous year.
- ✓ Urban males in the 15-29 age group also saw a slight increase in unemployment, rising to 15.9% from 15.6% in the previous quarter but lower than the 17.4% recorded in April-June 2022.
- ✓ Several states and union territories (UTs) reported higher urban unemployment rates than the national average. Notable ones include Himachal Pradesh (13.8%), Rajasthan (11.7%), Chhattisgarh (11.2%), Jammu and Kashmir (10.9%), and Kerala (10%).
- ✓ States/UTs with lower-than-national average unemployment rates included Delhi (2.7%), Gujarat (2.8%), West Bengal (4.4%), Bihar (6.1%), Maharashtra, and Haryana (6.5%).
- ✓ Key labor market indicators, such as Labour Force Participation Rate (LFPR) and Worker Population Ratio (WPR), improved in urban areas for individuals aged 15 years and above compared to the pre-pandemic period.
- ✓ LFPR in April-June 2023 was 48.8%, higher than the pre-pandemic levels.
- ✓ WPR in the same period was 45.5%, also surpassing pre-pandemic figures.
- ✓ The current unemployment rate of 6.6% is lower than pre-pandemic unemployment rates.
- ✓ Unemployment Rate is the percentage of people unemployed among those in the labor force. People are considered unemployed if they didn't work for even one hour during the week but sought or were available for work for at least one hour during the same period.

52nd GST Council Meeting: Ministry of Finance Notifies 18% GST on Corporate Guarantee

- ✓ The Central Board of Indirect Taxes and Customs (CBIC) under the Ministry of Finance issued a notification stating that GST (Goods and Services Tax) will be levied on guarantees provided by corporations to their subsidiaries prospectively. The corporate guarantee would be taxable from the date of the notification.

- ✓ As per the notification, GST at 18% will be levied on 1% of the total amount guaranteed by the parent company or the actual consideration, whichever is higher.

Key Recommendations

- ✓ GST rates on “Food preparation of millet flour in powder form, containing at least 70% millets by weight” 0% when sold in non-pre-packaged and unlabelled form. And 5% when sold in prepackaged and labelled form.
- ✓ Reduction of GST on molasses from 28% to 5%.
- ✓ The GST on Job work services for processing of barley into malt has been reduced to from 18% to 5%.

ADB Approves USD 175 Million Loan to Upgrade Roads in MP

- ✓ The Asian Development Bank (ADB) has approved a USD 175 million loan for ‘India : Enhancing Connectivity and Resilience of the Madhya Pradesh Road Network Project’. The project aims to upgrade about 500 kilometers of state highways and major district roads to a standard two-lane feature in Madhya Pradesh(MP). ADB is partnering with Madhya Pradesh Road Development Corporation Limited (MPRDC), to build the capacity of MPRDC in climate change adaptation and mitigation, disaster resilience, and road safety.

ADB Approves USD 400 Million Loan to Enhance Urban Services in India

- ✓ The Asian Development Bank (ADB) has approved USD 400 million policy-based loan to India to enhance the infrastructure quality and provide assured public services and efficient governance systems. The loan will be under Sub-programme 2 of ADB's Sustainable Urban Development and Service Delivery Programme.
- ✓ Subprogram 2 will support investment planning and reform actions at the state and urban local body (ULB) levels. It will be implemented by the

Ministry of Housing and Urban Affairs (MoH&UA) with guidance from ADB.

Bank of Baroda Launches Bob LITE Savings Account

- ✓ Bank of Baroda (BoB) launched a lifetime zerobalance savings account called the Bob LITE Savings Account as a part of “BOB Ke Sang Tyohaar Ki Umang” festive campaign.
- ✓ The Bob LITE Savings Account comes with a lifetime-free RuPay Platinum debit card (subject to maintaining a quarterly average balance (QAB)).

NSDC & Coca-Cola India Partners to Launch Super Power Retailer Program

- ✓ National Skill Development Corporation (NSDC), based in New Delhi, Delhi, and operating under the Ministry of Skill Development & Entrepreneurship (MSDE), partnered with Coca-Cola India to launch the Super Power Retailer Program under the Skill India Mission.
- ✓ This will empower the retailer community in the states of Odisha and Uttar Pradesh (UP). The program is being piloted in Odisha.



Sberbank Becomes First Russian Bank to Register with SEBI as FPI

- ✓ Russian State-owned Sberbank has become the first Russian bank to register with the Securities and Exchange Board of India (SEBI) as a foreign portfolio investor (FPI) for a Category I FPI license. Foreign portfolio investment (FPI) involves an investor purchasing foreign financial assets to access equities, bonds, derivatives, mutual funds, and guaranteed investment certificates among others

IOCL to Invest Rs.1,660.15Crore in Indian Oil NTPC Green Energy Pvt Ltd

- ✓ Indian Oil Corporation Limited (IOCL), a stateowned Maharatna company, is set to invest Rs 1,660.15 crore as equity in Indian Oil NTPC Green Energy Pvt Ltd for setting up renewable power

plants.IndianOil NTPC Green Energy Pvt Ltd is a joint venture (JV) company with a 50:50 share between IOCL and NTPC Green Energy Ltd, (a wholly-owned subsidiary of NTPC Limited) formed in June 2023.

FICCI Economic Outlook Survey Predicts Median GDP Growth Rate of 6.3% for FY23- 24

- ✓ According to Economic Outlook Survey released by Federation of Indian Chambers of Commerce & Industry (FICCI), India’s annual median Gross domestic product (GDP) growth rate for the financial year 2023-24 (FY2023-24) is projected at 6.3% with a minimum and maximum growth estimate of 6% and 6.6%, respectively.
- ✓ The median forecast for Consumer Price Index (CPI)-based inflation in 2023-24 is 5.5%, with a minimum and maximum range of 5.3% and 5.7%, respectively.
- ✓ CPI inflation rate will remain above the Reserve Bank of India(RBI)'s target level of 4±2 for Q3 & Q4 of FY 23-24.

Kotak Mahindra Bank Gets RBI Nod for Acquisition of Sonata Finance

- ✓ Kotak Mahindra Bank (KMB) got approval from the Reserve Bank of India (RBI) to acquire 100% of the issued and paid up capital in Lucknow (Uttar Pradesh) based Sonata Finance Private Limited (SFPL) for Rs 537 crore.
- ✓ Sonata Finance, established in 2006, is a Microfinance company registered as Non-Banking Finance Company (NBFC)-Microfinance institutions (MFI) (NonDeposit taking).

Axis Bank and Fibe Partner to Launch India’s First Numberless Credit Card

- ✓ Axis Bank Limited and Social Worth Technologies Private Limited (Fibe) (formerly known as EarlySalary) have partnered to launch India’s firstever numberless credit card called Fibe Axis Bank Credit Card.The card, powered by Rupay, also allows the customer to link this credit card to Unified Payments Interface (UPI).

RBI UPDATES

RBI To Directly Regulate Entities Facilitating Cross Border Payment Transactions

- ✓ In a recent circular, Reserve Bank of India (RBI) has announced its decision to directly regulate all entities that facilitate cross-border payment transactions related to the import and export of goods and services. This directive is aimed at ensuring transparency, security, and adherence to financial regulations in these cross-border transactions.
- ✓ The RBI, in its circular, introduced a novel category known as Payment Aggregator-Cross Border (PA-CB) to encompass all entities involved in facilitating cross-border payments.
- ✓ To strengthen the regulatory framework, the RBI clarified the minimum net worth criteria for non-bank entities providing PA-CB services. According to the circular, entities applying for authorization to operate as PA-CBs must have a minimum net worth of ₹15 crore at the time of application. Additionally, they are required to maintain a minimum net worth of ₹25 crore by March 31, 2026, demonstrating their financial stability and commitment to the industry.
- ✓ The circular also imposes obligations on banks that engage in Payment Aggregator-Cross Border activities. Banks undertaking these activities must fulfill the regulatory requirements applicable to PA-CBs by April 30, 2024, ensuring that all entities involved in cross-border transactions adhere to the same standards, regardless of their nature.

Reserve Bank of India Launches Surveys for Monetary Policy Insights

- ✓ The Reserve Bank of India announced the introduction of two significant surveys, the 'Inflation Expectations Survey of Households' and the 'Consumer Confidence Survey,' aimed at providing valuable inputs for its bi-monthly monetary policy decisions. The next bi-monthly

monetary policy review is scheduled to take place from December 6 to 8.

Inflation Expectations Survey of Households

- ✓ The 'Inflation Expectations Survey of Households' is designed to gather subjective assessments of price movements and inflation. It is based on the individual consumption patterns of households across 19 major cities in India, including Bhopal, Bhubaneswar, Chandigarh, Chennai, Delhi, and Thiruvananthapuram. The survey on inflation solicits both qualitative and quantitative responses from households:
 - ✓ **Qualitative responses** inquire about households' expectations regarding price changes in the three months ahead and the one-year ahead period.
 - ✓ **Quantitative responses** are collected for current inflation rates, expectations for inflation in the next three months, and expectations for inflation in the next one year.

Consumer Confidence Survey

- ✓ The 'Consumer Confidence Survey' is intended to gauge the sentiments of households on various economic aspects. This survey seeks responses from households regarding their views on:
 - General economic conditions
 - Employment scenario
 - Price levels
 - Household income
 - Household spending

RBI Eases Closure Rules for District Central Co-operative Banks

- ✓ The Reserve Bank of India (RBI) has announced a significant change in its regulations, allowing District Central Co-operative Banks (DCCBs) to close un-remunerative branches without seeking prior permission from the central bank. However, DCCBs will need approval from the Registrar of Cooperative Societies in their respective states. The RBI issued a circular outlining the new guidelines on Monday.
- ✓ Under the updated regulations, DCCBs can make decisions to close branches, but such determinations must be made by their Boards. These decisions

should take into account all relevant factors and must be documented in the minutes of the Board meeting, as stated by the RBI.

- ✓ Additionally, the circular stipulates that DCCBs must provide a two-month notice in advance of branch closures to all existing depositors and clients. This notice should be published in local leading newspapers through a press release and communicated individually to each constituent of the branch.
- ✓ Furthermore, the RBI mandates that DCCBs return the original licenses issued for any closed branches to the concerned Regional Office of the Reserve Bank.
- ✓ It's important to note that DCCBs will not be permitted to close branches if the RBI has imposed restrictions on the bank. In such cases, the closure request will not be entertained.

RBI Mandates Minimum Two Whole-Time Directors for Indian Banks

- ✓ The Reserve Bank of India (RBI) has introduced a crucial requirement for Indian banks, stating that they must now have a minimum of two whole-time directors (WTDs) on their boards. This mandate extends to the Managing Director and Chief Executive Officer (MD&CEO) position.
- ✓ This move aims to help banks navigate the growing complexity within the banking sector and effectively tackle emerging challenges. Notably, this directive applies to both private banks and wholly-owned subsidiaries of foreign banks.
- ✓ Banks that currently do not meet the RBI's new requirement must promptly submit proposals for the appointment of WTDs within four months of receiving this directive. Additionally, banks lacking provisions for the appointment of WTDs in their Articles of Association are urged to seek the necessary approvals to meet these requirements.

RBI Issues New Guidelines NBFC – SBR Master Directions 2023

- ✓ Reserve Bank of India (RBI) has recently published a new set of guidelines called the “Master Direction – Reserve Bank of India [Non-Banking Financial Company (NBFC) – Scale Based Regulation (SBR)] Directions, 2023”.

- ✓ It replaces the Non-Banking Financial Company–Non-Systemically Important Non-Deposit taking (Reserve Bank) Directions, 2016, and the Non-Banking Financial Company–Systemically Important Non-Deposit taking Company and Deposit taking Company (Reserve Bank) Directions, 2016. The Reserve Bank of India (RBI) exercises its authority under the RBI Act, 1934 (Act 2 of 1934) and the Factoring Regulation Act, 2011 (Act 12 of 2012).

- ✓ Under this regulatory framework, NBFCs are categorized into 4 layers based on their size, activities, and perceived risk:

i.NBFCs-Base Layer (NBFCs-BL) includes:

- ✓ Non-deposit taking NBFCs with assets below Rs 1,000 crore. NBFCs engaged in specific activities such as NBFC-Peer to Peer Lending Platform (NBFCP2P), NBFC-Account Aggregator (NBFC-AA), Non-Operative Financial Holding Company (NOFHC), and NBFCs not utilizing public funds and lacking customer interactions.

ii.NBFCs-Middle Layer (NBFCs-ML) includes:

- ✓ All deposit-taking NBFCs (NBFCs-D), regardless of their asset size
- ✓ Non-deposit taking NBFCs with assets equal to or exceeding Rs 1,000 crore NBFCs involved in activities like Standalone Primary Dealer (SPD), Infrastructure Debt Fund-Non-Banking Financial Company (IDF-NBFC), Core Investment Company (CIC), Housing Finance Company (HFC), and Non-Banking Financial Company-Infrastructure Finance Company (NBFC-IFC).

iii.NBFCs-Upper Layer (NBFCs-UL)

- ✓ NBFCs that the Reserve Bank identifies as needing stricter regulatory oversight based on specific parameters and scoring methods.
- ✓ The quantitative and qualitative parameters shall have weightage of 70% and 30% respectively
- ✓ Scoring methodology for identification of an NBFC as NBFC-UL shall be based on the set of NBFCs fulfilling the following criteria:
- ✓ Top 50 NBFCs (excluding top ten NBFCs based on asset size, which automatically fall in the Upper Layer) based on their total exposure including credit equivalent of off-balance sheet exposure.

- ✓ NBFCs designated as NBFC-UL in the previous year. NBFCs added to the set by supervisors using supervisory judgment
- ✓ **iv.NBFCs-Top Layer (NBFC-TL)**
- ✓ The Top Layer should remain vacant. If the Reserve Bank determines that certain NBFCs in the Upper Layer pose a substantial systemic risk, they may be moved to the Top Layer from the Upper Layer.

RBI Allows Retail Investors to Subscribe to FRSBs 2020 (T) via Retail Direct Portal

- ✓ On October 23, 2023, the Reserve Bank of India (RBI) in consultation with the Government of India (GoI), has expanded the range of products offered through RBI Retail Direct portal by allowing retail investors to subscribe to Floating Rate Savings Bonds , 2020 (Taxable)- FRSB 2020 (T).
- ✓ Previously, the retail investors were allowed to invest in central government securities, treasury bills, state government securities and sovereign gold bonds through this portal.
- ✓ The subscription of bonds will be in the form of cash (up to Rs 20,000 only)/drafts/cheques or any electronic mode.
- ✓ Prior to this, the FRSB 2020 (T) was only available at designated branches of State Bank of India (SBI), Nationalised Banks, private banks specified by RBI and other entities authorised by RBI as per the guidelines of Floating rate bonds released by GoI in June 2020. Now, FRSBs can be brought through retail Direct Portal.

RBI announced results of 2nd edition of its Global Hackathon – HARBINGER 2023

- ✓ The Reserve Bank of India (RBI) introduced second edition of its global hackathon, “HARBINGER 2023 – Innovation for Transformation”
- ✓ Theme: Inclusive Digital Services.
- ✓ This event was announced on February 14, 2023. The hackathon received 154 proposals submitted by teams from both India and 28 participating teams/entities from countries such as Australia, Canada, Germany, Singapore, Sweden, the United

Kingdom (UK), and the United States of America (USA). The Hackathon ran in three phases.

- ✓ The hackathon is hosted on Application Programming Interface Exchange (APIX) platform.

The winners

- ✓ For its problem statement 'Innovative, easy-to-use, digital banking services for differently abled (Divyaang)', **Ezetap Mobile Solutions Pvt Ltd (Now acquired by Razorpay), India, was the winner**, with a solution DrishtiPay that facilitates effortless Card/UPI payments for the visually challenged.
- ✓ For the problem statement 'RegTech solutions to facilitate more efficient compliance for Regulated Entities (REs)', **the winner WeavAir, Singapore's solution** provides efficient data collection and analytics to facilitate compliance by regulated entities, facilitating financial institutions to improve their regulatory reporting and risk management.
- ✓ For the problem statement 'Exploring use cases/solutions for CBDC-R transactions, including transactions in offline mode', **the winner is Dvgnify Ventures Private Limited, India**, whose mobile application runs on encrypted SMS rails for CBDC-Retail transactions without needing internet.
- ✓ For the problem statement 'Increasing Transactions Per Second (TPS)/ throughput and scalability of blockchains', **the winner Fortis Net Ltd, UK's solution** is a token-based architecture based on two-phase commit protocol.

RBI Starts Wholesale Digital Rupee Pilot in Call Money Market

- ✓ On October 17, 2023, the Reserve Bank of India (RBI) initiated a pilot program for the wholesale segment namely ‘Digital Rupee-Wholesale (e₹-W)’ of its Central Bank Digital Currency (CBDC) in the interbank call money market.
- ✓ e-rupee call money pilot is the second test of wholesale CBDC, after the government securities market in November 2022.
- ✓ State Bank of India (SBI), Bank of Baroda(BoB), Union Bank of India(UBI), HDFC Bank, ICICI Bank, Kotak Mahindra Bank, Yes Bank, IDFC First Bank and HSBC were part of the wholesale CBDC in government securities pilot program.

- ✓ Most participating banks remain the same from the wholesale e-rupee pilot for the government securities market with Federal Bank replacing HSBC in the call money pilot.
- ✓ Under the pilot, the entire wholesale segment, including asset tokenization and repo transactions will be covered.

RBI imposes Rs 5.39 crore penalty on Paytm Payments Bank

- ✓ On October 12, 2023, the Reserve Bank of India (RBI) imposed a monetary penalty of Rs 5.39 Crore on Paytm Payments Bank Limited (PPBL) in exercise of its powers conferred under the provisions of Section 47A(1)(c) read with Section 46(4)(i) of the Banking Regulation (BR) Act, 1949.
- ✓ This penalty will not affect any transaction or agreement entered into by the bank with its customers.

RBI Cancels CoR of Ind Bank Housing Ltd; Imposes Rs 5.39cr penalty on Paytm Payments Bank

- ✓ The Reserve Bank of India (RBI) has cancelled the Certificate of Registration (CoR) Chennai, Tamil Nadu (TN) based Ind Bank Housing Ltd, a Housing Finance Company (HFC) w.e.f. September 21, 2023.
- ✓ In this regard, it cannot transact the business of Housing Finance Institution and a Non-Banking Financial Institution (NBFC) as defined in National Housing Bank (NHB) Act, 1987 and RBI Act, 1934, respectively.
- ✓ This decision has been taken by RBI in exercise of its powers conferred on it under Section 29A (6) of the NHB Act, 1987.

RBI maintains CPI inflation forecast for FY24 at 5.4%

- ✓ RBI projects that Inflation is expected to average 5.4% in the fiscal year 2023–2024, which remained unchanged. Additionally, the target for economic growth remains at 6.5% for the same period.
- ✓ CPI stands for Consumer Price Index, is a way to measure how prices of everyday items change over time. It shows the average cost increase for things people buy regularly, like groceries and services.

RBI Doubles Gold Loan Limit Urban Cooperative Banks

- ✓ RBI announced to double the gold loan limit under Bullet Repayment scheme for Urban Cooperative Banks (UCBs). Monetary ceiling for gold loans under this scheme increased from ₹2.00 lakh to ₹4.00 lakh for UCBs that meet Priority Sector Lending (PSL) target and sub targets as on March 31, 2023.
- ✓ A bullet repayment scheme is when a borrower pays both the interest and the principal amount at the end of the loan tenure, without making any repayments during the loan duration period.

RBI extends PIDF scheme by 2 years till Dec 2025

- ✓ Reserve Bank Governor Shaktikanta Das announced the extension of the Payments Infrastructure Development Fund (PIDF) Scheme by 2 years, until December 31, 2025. This extended scheme will now include beneficiaries of the PM Vishwakarma Scheme, aiming to promote digital transactions at the grassroots level.
- ✓ The PIDF Scheme was operationalized by the Reserve Bank in January 2021 for a 3-year period.
- ✓ Objective: Incentivize the deployment of payment acceptance infrastructure, including physical Point of Sale (PoS) and Quick Response (QR) codes.
- ✓ Target Areas: Tier-3 to tier-6 centers, northeastern states, and Union Territories of Jammu & Kashmir and Ladakh.
- ✓ Beneficiaries: Initially, focused on Tier-3 to Tier-6 centers and northeastern states.
- ✓ In August 2021, beneficiaries of PM SVANidhi Scheme in Tier-1 and 2 centers were included in the PIDF scheme.
- ✓ By end-August 2023, over 2.66 crore new touchpoints have been deployed under the Scheme.

RBI to introduce card-on-file tokenization at bank level

- ✓ RBI proposes to introduce Card-on-File Tokenisation (CoFT) creation facilities directly at the issuer bank level. Currently, Card-on-File (CoF) tokens can only be created through a merchant's application or webpage.

SCIENCE AND TECHNOLOGY

PM Modi directs ISRO to land on the moon by 2040

- ✓ India's Prime Minister, Narendra Modi, has announced ambitious plans to expand the country's space activities, including sending its first astronaut to the moon by 2040 and establishing a native space station by 2035.
- ✓ Originally, India aimed to have its own space station by 2022, but technical issues and the COVID-19 pandemic caused delays.
- ✓ India signed NASA's Artemis Accords for space exploration, and NASA will provide advanced training to Indian astronauts and send them to the International Space Station in 2024.

Ericsson Sets up 6G R&D Centre in Chennai

- ✓ Telefonaktiebolaget LM Ericsson, commonly known as Ericsson, Swedish telecommunication company, has announced setting up a 6G Research and Development(R&D) centre in Chennai, Tamil Nadu(TN) Ericsson is also looking to partner with premier engineering institutes in India for 6G-related research.
- ✓ This 6G R&D centre in India will be the 3rd such centre of Ericsson. The other 2 are in Sweden and the United States of America (USA).
- ✓ At Present, Ericsson has R&D centres at Chennai, Bengaluru(Karnataka) and Gurugram(Haryana). Ericsson was started by Lars Magnus Ericsson in 1876 and it has been present in India since 1903.
- ✓ On 5th October 2023, Nokia established a 6G Lab at its Global R&D center in Bengaluru.

Skyroot Aerospace Unveils Vikram-I Orbital Space Launch Vehicle

- ✓ Skyroot Aerospace Private Limited unveiled 'Vikram-I' orbital space launch vehicle at the newly inaugurated its headquarters 'The MAX-Q Campus' located at the GMR Aerospace and Industrial Park in South Hyderabad, Telangana.
- ✓ The event was attend by Union Minister of State(MoS) Jitendra Singh, Ministry of Science &

Technology (MoST) who also unveiled simulation of Vikram 1.

- ✓ The Vikram-I rocket is capable of carrying a load of up to 480 Kilograms (kg) into 500 Kilometre (km) the Low Earth orbit (LEO) and a load of 290 kg into a 500 km Sun Synchronous Polar Orbit (SSPO).
- ✓ Vikram 1 is the all-carbon-fibre bodied rocket that can place multiple satellites in orbit and features 3D printed liquid engines.
- ✓ Vikram-I is set to launch in 2024 by Skyroot Aerospace Private Limited which was established in 2018 by Pawan Kumar Chandana and Naga Bharath Daka(Co-Founders).

China Launches Shenzhou-17 Manned Spacecraft to Its Space Station

- ✓ China's Chinese Manned Space Agency (CMSA) has launched its 30th flight mission Shenzhou 17 (also known as "Divine Vessel") along with three astronauts to the Tiangong Space Station.
- ✓ The spacecraft lifted off atop a Long March-2F Y17 carrier rocket from the Jiuquan Satellite Launch Center in northwest China.
- ✓ This is the sixth manned mission of China to its space station since 2021.

About the Astronauts

- ✓ The crew is led by former air force pilot Tang Hongbo (48). He is making his second spaceflight. He belongs to China's second batch of astronauts in 2010.
- ✓ The other two members of the crew: Tang Shengjie (33) and Jiang Xinlin (35), are both travelling to space for the first time. They joined the China's 3rd batch of astronauts.
- ✓ The crew is the youngest-ever crew of Chinese astronauts to visit the Tiangong Space Station.

About Shenzhou 17 mission

- ✓ Shenzhou 16 crew will hand over control to the incoming Shenzhou 17 astronauts. The mission will last for six months, during which time the

astronauts will conduct experiments and technology tests. The astronauts will also conduct Tiangong's first extravehicular experimental maintenance work.

Tiangong Space Station

- ✓ The Tiangong space station is a Chinese space station being built in low Earth orbit between 340 and 450 kilometers above the earth.

Pakistan Successfully Conducts Training Launch of Ghauri Weapon System

- ✓ Pakistan Army successfully conducted a training launch of the Ghauri Weapon System, a medium-range, road-mobile, ballistic missile system indigenously developed by Pakistan, to test the operational and technical readiness of Army Strategic Forces Command (ASFC).
- ✓ The launch was witnessed by Lieutenant General Muhammad Shahbaz Khan Commander ASFC, senior officers from the strategic forces, scientists, and engineers of the strategic organisation.
- ✓ Previously on 18th October 2023, Pakistan successfully conducted the flight test of Ababeel Weapon System, the ballistic missile system, in Islamabad, Pakistan.

About Ghauri Weapon System

- ✓ It is capable of carrying both conventional and nuclear warheads and has a reported range of approximately 1,300 to 1,500 kilometers

ISRO Launches the Gaganyaan Mission Test

- ✓ On 21st October 2023, Indian Space Research Organisation (ISRO) successfully launched Gaganyaan's first flight Test Vehicle Abort Mission-1 (TV-D1) from the Satish Dhawan Space Centre in Sriharikota, Andhra Pradesh(AP).

Mission Definition

- ✓ "In-flight Abort Demonstration of Crew Escape System (CES)" at Mach number 1.2 with the newly developed Test Vehicle followed by Crew Module(CM) separation & safe recovery.

Mission Objective

- ✓ Test all the systems of the Test Vehicle to make sure they are working properly.

- ✓ Test the CES to make sure it can safely separate the Crew Module from the Test Vehicle in the event of an emergency.

- ✓ Test the CM's ability to fly and land safely at higher altitudes.

Working

- ✓ The flight simulated the abort condition during the ascent trajectory corresponding to a Mach number of 1.2 encountered in the Gaganyaan mission.

- ✓ At an height of about 17 km, the CES and CM got separated from the test vehicle.

- ✓ The CES then autonomously deployed the parachutes and slow the CM down to a safe landing in the sea, about 10 km from the coast of Sriharikota.

About TV-D1

- ✓ Test Vehicle Demonstration 1(TV-D1) is a low cost liquid propelled single stage rocket which is developed specifically for test missions.

- ✓ TV-D1 uses a modified VIKAS(VIKram Ambalal Sarabhai) engine with CM and CES mounted at its fore end.

- ✓ Navigation of the rocket is taken care by Mini Advanced inertial navigation system (INS) augmented by Indian Regional Navigation Satellite System (NavIC)/ Global Positioning System (GPS)

About Crew Escape System (CES)

- ✓ The Crew Escape System (CES) is a system that can be used to safely evacuate the crew of a spacecraft in the event of an emergency.

Japan Becomes 1st Country Ever To Fire Electromagnetic Railgun

- ✓ The Japanese Maritime Self-Defense Force (JMSDF), along with the Acquisition Technology & Logistics Agency (ATLA), which comes under the Ministry of Defense of Japan, has successfully test-fired a medium-caliber maritime electromagnetic railgun from an offshore platform.

- ✓ With this, Japan became the first country in the world to successfully test-fire a maritime railgun from an offshore platform.

- ✓ Railgun is a type of weapon that uses electromagnetic force to launch high-speed projectiles (at about Mach 7).

- ✓ The projectiles do not contain explosives, but instead rely on their mass, speed, and kinetic energy to inflict damage.
- ✓ Railguns could be used to target a wide range of aerial threats at sea, including hypersonic cruise missiles and hypersonic ballistic missiles.
- ✓ Railguns are stealthy to some extent (due to their small bullets).

About Japan Railgun

- ✓ It is a medium-sized electromagnetic railgun.
- ✓ It can shoot a 320g (or 0.71lb) 40mm steel rounds bullet at a speed of around 2,230 m/s (Mach 6.5).
- ✓ These railguns will be inducted into Japan's defense system in the second half of 2020s(after 2025) after conducting several rounds of testing.
- ✓ These railguns can fire interceptors as well at the desired speeds.

NASA's Psyche Spacecraft was Launched to Study Metal Asteroid 'Psyche'

- ✓ NASA's Psyche Spacecraft was Launched to Study Metal Asteroid 'Psyche' National Aeronautics and Space Administration (NASA) has launched a Psyche Spacecraft to an interplanetary transfer orbit by using SpaceX Falcon Heavy rocket from Launch Complex 39a (LC-39a) at NASA's Kennedy Space Center in Florida, United States of America (USA) on 13th October 2023.
- ✓ After escaping Earth's gravity, Psyche Spacecraft will use solar electric propulsion to accomplish its six-year journey to the asteroid called 'Psyche' which is orbiting the Sun between Mars and Jupiter.

About Psyche Mission

- ✓ This is NASA's first mission to study an asteroid that has more metal than rock or ice
- ✓ NASA selected the Psyche mission on January 2017, as one of two missions for its Discovery Program.
- ✓ The Discovery Program is a series of relatively lowcost missions to explore the solar system.
- ✓ The mission is led by Arizona State University of USA.The Psyche mission will also test a new communication technology called Deep Space Optical Communication (DSOC).

European's First Private Rocket MIURA 1 SN1 was Launched by PLD Space

- ✓ The first private suborbital European rocket MIURA 1 SN1 was launched by Spanish space company PLD Space.
- ✓ The reusable rocket was launched from El Arenosillo Experimentation Centre (CEDEA) of Spanish National Institute for Aerospace Technology (INTA) in Huelva, Spain.
- ✓ The first flight of the MIURA 1 SN1 technology demonstrator aims to collect data about the flight performance of the rocket and its systems, These data will be used to validate the design and technology of the MIURA 5 orbital launch vehicle which is planned to be launched in 2025.

MIURA1 SN1

- ✓ The rocket is of 12.5meters in length with a propellant system of Kerosene and Cryogenic liquid oxygen(KeroLOX).The rocket has TEPREL-B Liquid Bi-propellant engine developed by PLD Space.

Amazon Launched First Test Satellites for Project Kuiper Satellite System

- ✓ Amazon.com, Inc.(AMZN.O) has launched the first two prototype satellites KuiperSat-1 and KuiperSat-2 to low Earth orbit (LEO) at the height of 500 kilometers (311 miles) as part of "Protoflight" mission of Project Kuiper.
- ✓ The satellite was launched by United Launch Alliance's (ULA) Atlas V rocket from Space Launch Complex-41 at Cape Canaveral Space Force Station, Florida, United States of America (USA).

About Project Kuiper

- ✓ Project Kuiper satellite system is a network of satellites in LEO. The Kuiper System will operate at altitudes between 590 and 630 kilometers (roughly 367 to 391 miles). The project aims to provide fast and affordable internet to more than 10 million of underserved communities around the world.

DEFENCE

IAF Test Fired Long Ranged BrahMos Missile

- ✓ Indian Air Force (IAF) successfully tested the air launch version of BrahMos supersonic cruise missile. The missile was launched from a Sukhoi Su30 Modernizirovannyi Kommercheskiy Indiski (MKI) fighter jet in an airbase in Bay of Bengal.
- ✓ This is a long range version of supersonic weapon system with a range of about 1500km. The BrahMos missile can be launched from a range of platforms, including fighter jets, submarines, ships, and land-based systems.
- ✓ It is developed by BrahMos Aerospace which is a joint venture between Russia's NPO Mashinostroyeniya (NPO Mash) and India's Defence Research and Development Organisation (DRDO).



India-Bangladesh holds Joint Military Exercise SAMPRITI-XI 2023

- ✓ Exercise SAMPRITI-XI 2023, an annual joint military exercise between India and Bangladesh is held in **Umroi, Meghalaya**, for 14 days from 3rd October to 16th October 2023
- ✓ This is the 11th edition of the Exercise, which strengthens India-Bangladesh defence cooperation by promoting stronger bilateral connections, cultural understanding, and reciprocal benefits from shared experiences.
- ✓ It emphasizes the necessity of improving interoperability between the armies, as well as sharing tactical drills and encouraging best practises.
- ✓ Indian contingent mainly comprises troops from a battalion of the **RAJPUT Regiment**.
- ✓ The 10th edition of Exercise was conducted at Jashore Military Station in Bangladesh in 2022.

Indian Navy Conducts Annual Joint HADR Exercise CHAKRAVAT 2023

- ✓ The 2023 edition of the Annual Joint Humanitarian Assistance and Disaster Relief (HADR) Exercise (AJHE) – “CHAKRAVAT 2023” was conducted by the Indian Navy (IN) at Goa from 09th to 11th October 2023.
- ✓ AJHE is the result of Prime Minister Narendra Modi's preference conveyed during the Combined Commanders' Conference in 2015.
- ✓ To address the challenges posed by climate change in the Indian Ocean Region (IOR), the Indian armed forces conduct HADR operations as part of India's Security And Growth for All in the Region (SAGAR) initiative.
- ✓ This exercise evolved the Indian armed force's assistance in disaster times as a collaborative government approach that enhanced India's preparedness and response to natural disasters.
- ✓ The first edition of the exercise was held in 2015 and it has been conducted by the Indian Army, Indian Navy (IN), and Indian Air Force (IAF) in rotation since 2016.
- ✓ The last edition of the exercise 'Samanvay 2022' conducted by the Indian Air Force (IAF) was held in Agra, Uttar Pradesh.

East Coast Sagar Kavach 02-23: Coastal Security Exercise held in AP, TN & Puducherry

- ✓ East Coast Sagar Kavach 02-23, a two-day comprehensive Coastal Security Exercise was conducted in Andhra Pradesh(AP), Tamil Nadu(TN) and Puducherry(PY) from 11-12 October 2023 to assess the efficacy and robustness of the coastal security system in responds to unconventional threats from the sea.
- ✓ About 2500 personnel including from Indian Navy, Indian Coast Guard, State and Union Territory Administration, Marine Police, Fisheries, Customs, International Agencies, Light Houses, Ports Forest etc were engaged in the exercise.

- ✓ The Joint Operations Centre (East) in Visakhapatnam(AP) is the nodal hub to monitor all coastal security operations and exercises in area of operations.
- ✓ The exercise was executed under Vice Admiral Rajesh Pendharkar, Flag Officer Commanding-in-Chief (FOC-in-C), Eastern Naval Command(ENC), He is also the Commander-in-Chief, Coastal Defence (East).
- ✓ Indian Navy ships, Coast Guard assets, and other coastal security agencies were deployed to increase surveillance in the area. Enhanced security measures were put in place, and Dornier aircraft and helicopters from Visakhapatnam, Chennai(Tamil Nadu), and Ramnathapuram(Tamil Nadu) conducted extensive aerial surveillance.

Indian Navy conducts Security Exercise 'Prasthan' in AP's Kakinada

- ✓ The Security Exercise Prasthan 2023 was carried out by Commodore Rajneesh Sharma Naval Officer-in-Charge (NOIC), under the aegis of Eastern Naval Command, Indian Navy (IN) in Kakinada, Andhra Pradesh (AP).
- ✓ The exercise was conducted on the Rig ship Platinum Explorer of ONGC (Oil and Natural Gas Corporation) and RG Fixed Oil Platform of Vedanta Ltd.
- ✓ **Aim of Exercise:** Rehearsing responses in handling contingencies and checking the efficacy of security mechanisms at Offshore Development Area (ODA)
- ✓ **Participation:** It involved around 2,500 personnel and IN comprised of INS (Indian Naval Ship) Kora, INS Tihayu, four Immediate Support Vessels, Marine Commandoes, Explosive Ordinance Disposal Team and Helicopters. ICG Ship Kanaklata Barua also participated in the exercise.

Exercise Harimau Shakti 2023: India-Malaysia Joint Army Exercise begins in Meghalaya

- ✓ On October 23, 2023, Exercise Harimau Shakti 2023, the two-week Indo-Malaysia joint military exercise between the Indian Army (IA) and the Malaysian Army, commenced at the Umroi

cantonment, located in Ri Bhoi district of the northeastern state of Meghalaya. The exercise is scheduled till November 5, 2023.

About Harimau Shakti

- ✓ i.Harimau Shakti, the Indo-Malaysia joint exercise, has been conducted annually since 2012 to foster the bilateral relations between the two nations.
- ✓ The last edition of the exercise, Harimau Shakti 2022, was conducted in Pulai, Kluang, Malaysia in November 2022.
- ✓ India is represented by a Battalion of the **Rajput Regiment**

India-EU's First Joint Naval Exercise Held in Gulf of Guinea

- ✓ India and the European Union(EU) conducted their first joint naval exercise in the Gulf of Guinea on 24th October 2023. The exercise was designed to uphold the United Nations Convention on the Law of the Sea (UNCLOS).
- ✓ The exercise took place after the third meeting of the EU-India Maritime Security Dialogue, which was held in Brussels on October 5, 2023.
- ✓ **Participated Ships**
- ✓ The exercise involved the Indian Navy's Offshore Patrol Vessel Indian Naval Ship (INS) Sumedha
- ✓ Ships of 3 EU member states(Italy, France and Spain) also participated the exercise. They are:
 - Italian Ship Foscari – Italian Navy
 - French Ship(FS) Ventôse – French Navy
 - Spanish Ship Tornado – Spanish Navy.

Indian Army Establishes first-ever BSNL BTS on World's Highest Battlefield Siachen Glacier

- ✓ The Indian Army (Siachen Warriors) in collaboration with Bharat Sanchar Nigam Limited (BSNL) has installed the first-ever BSNL Base Transceiver Station (BTS) on the world's highest battlefield, 'Siachen Glacier' in Ladakh.
- ✓ The tower was inaugurated on 6th October 2023 and will provide mobile communication services to soldiers at an altitude of over 15,500 feet. A radio transceiver that links mobile devices to a cellular network is known as a base transceiver station(BTS).

3/5 Gorkha Rifles of Indian Army wins Gold in Cambrian Patrol 2023 Military Exercise in UK

- ✓ The 3/5 Gorkha Rifles (Frontier Force) team clinched a gold medal for the Indian Army (IA) at the Cambrian Patrol Competition 2023, an International Military Exercise organized in Wales, United Kingdom (UK) from October 6, 2023 to October 15, 2023.
- ✓ 67 Punjab Regiment of Pakistan Army received silver medal
- ✓ Soldiers from 1st Battalion Irish Guards (British Army) and the 13th Demi-Brigade of the French Foreign Legion (France) have become the first joint effort between a British Army and international team to complete and win Bronze in the exercise.

Cambrian Patrol 2023 Military Exercise

- ✓ Cambrian Patrol 2023 Military Exercise was hosted by Headquarters 160th (Welsh) Brigade on behalf of Commander Field Army of UK Army.
- ✓ The Cambrian Patrol Exercise is often dubbed the 'Olympics of Military Patrolling' as it is considered the ultimate test of human endurance and team spirit. It is a mission focused and scenario-based exercise.
- ✓ **Participants:** The 2023 exercise saw a participation of 111 teams, encompassing 38 international contingents.

Yard 12706 (Imphal): Third Stealth Destroyer of Project 15B delivered to the Indian Navy

- ✓ Yard 12706 (Imphal), the third Stealth Destroyer of Project 15B Class Guided Missile Destroyer build at the Mazagon Dock Shipbuilders Limited (MDL) was delivered to the Indian Navy (IN).
- ✓ The ship was designed by the Indian Navy's Warship Design Bureau (WDB).
- ✓ The INS Imphal's keel was laid on 19 May, 2017 and it was launched into water on 20 April, 2019. The time taken for Imphal's construction and testing is the shortest for any indigenous destroyer.
- ✓ Imphal, constructed using Indigenous Steel DMR 249A, is one of the largest Destroyers constructed in India, with an overall length of 164 meters and

displacement of over 7500 Tons. Imphal has approximately 75% indigenous content.

Special Forces Training School at HP Gets Indian Army's 1st Vertical Wind Tunnel

- ✓ General Manoj Pande, Chief of the Army Staff (COAS), virtually inaugurated the Indian Army's 1st Vertical Wind Tunnel (VWT) at the Special Forces Training School (SFTS) at Bakloh, Himachal Pradesh (HP) to train the special forces and refine the Combat Freefall (CFF) skills of armed forces personnel.
- ✓ The state-of-the-art wind tunnel provides a controlled environment for military trainees. It enhances the Combat Free Fall (CFF) skills of armed forces personnel. The facility simulates real-life free-fall conditions, allowing trainees to experience various CFF scenarios.
- ✓ **Vertical Wind Tunnel (VWT):** A Vertical Wind Tunnel (VWT) is a wind tunnel that moves air up in a vertical column. These tunnels are often used for aerodynamic research and modern human flight.

Indian Army and Air Force Contingent Set Off for 'Exercise KAZIND-2023'

- ✓ In a significant development, a contingent from the Indian Army and Indian Air Force, comprising 120 personnel, embarked on a mission to Kazakhstan today. Their objective is to participate in the 7th edition of the Joint Military 'Exercise KAZIND-2023.' This collaborative endeavor will take place in Otar, Kazakhstan, spanning from 30th October to 11th November 2023.

Indian Navy Launches 25T Bollard Pull Tug 'MAHABALI' In Gujarat

- ✓ Indian Navy launched the remarkable vessel, the 25T Bollard Pull Tug named 'Mahabali,' on the 28th of October 2023 at M/s Shoft Shipyard Pvt Ltd in Bharuch, Gujarat. This launch not only represented a new addition to India's naval fleet but also a significant milestone in the 'Make in India' initiative of the Ministry of Defence.

- ✓ Mahsa Amini and the women of Iran were nominated by the European People's Party.
- ✓ The Socialists and Democrats and Renew Europe also nominated Mahsa Amini and the Woman, Life, Freedom Movement as representatives of the fight for women's rights in Iran.

About Jina Amini & The Women of Iran

- ✓ Jina Mahsa Amini, the 22-year-old Kurdish Iranian woman, was arrested for allegedly violating Iran's mandatory hijab (headscarf) law in September 2022. She died 3 days after arrest. Her death under suspicious circumstances led to the massive women led protests in Iran.
- ✓ The women are protesting under the slogan 'Woman, Life, Freedom' i.e. Iranian Women Protest Movement against the hijab law and other discriminatory laws.

About Sakharov Prize for Freedom of Thought

- ✓ It was established in 1988 by the European Parliament, honors individuals and groups defending human rights.
- ✓ The award is named after Soviet physicist and political dissident and Nobel Peace Prize laureate Andrei Sakharov

American Actor Michael Douglas to receive Satyajit Ray Lifetime Achievement Award: 54th IFFI at Goa

- ✓ American actor and producer Michael Douglas will be honoured with the Satyajit Ray Lifetime Achievement Award at the 54th International Film Festival of India (IFFI) to be held in Goa from 20th to 28th November, 2023.

- ✓ This win also marks Verstappen's 16th win out of 19 races of the 2023 season. Max Verstappen leads the F1 World Championship in 2023 with 491 points in the F1 driver standings.

- ✓ Indians who secured the top 10 positions in the Qatar Masters Open 2023 are GM Erigaisi Arjun(6th), GM Gukesh D(8th), and GM Karthikeyan Murali(10th).

- ✓ The Qatar Masters Open 2023 was held in two sections including Qatar Masters Open 2023 (main event)and Qatar Masters Open 2023 section B.
- ✓ Qatar Masters Open 2023 should be participated by players who have a FIDE rating of 2300 and above.
- ✓ Qatar Masters Open 2023 section B should be participated by players who have a FIDE rating of 2299 and Below.
- ✓ The 3rd edition of the Qatar Masters Open 2023 tournament was organised by the Qatar Chess Association.

Red Bull's Max Verstappen Wins 50th F1 in US Grand Prix 2023

- ✓ Max Verstappen, the Belgian-Dutch driver of Red Bull won the Formula 1 (F1) United States Grand Prix 2023 held at the Circuit of The Americas in Austin, Texas, The United States of America(USA) from 20- 22 October 2023.
- ✓ This marks Max Verstappen's 50th career win in the F1 and he joins Lewis Hamilton(103), Michael Schumacher(91)(Germany), Sebastian Vettel(53) (Germany) and Alain Prost (51)(France) in the 50-win club.

- ✓ McLaren Driver Lando Norris of the United Kingdom(UK) finished second place while Ferrari driver Carlos Sainz(Spain) finished third place in the podium.

141st Session of the IOC held in Mumbai; 5 Additional Sports added in 2028 Summer Olympics

- ✓ The 141st Session of the International Olympic Committee (IOC) was hosted by India from October 15-17, 2023, in Mumbai, Maharashtra. The IOC's Executive Board met during the session. The session facilitated interaction and the exchange of knowledge among diverse stakeholders in the sports arena.
 
- ✓ The 141st session of IOC was inaugurated by the Prime Minister (PM) of India Narendra Modi.
- ✓ This is the 2nd IOC Session hosted by India after 40 years. India hosted the 86th IOC session in New Delhi, Delhi in 1983.
- ✓ The 141st session of IOC approved the proposal of Los Angeles 2028 Organising Committee of Olympics and Paralympic Games for the inclusion of 5 additional sports including **Cricket (T20-Twenty20), Softball/Baseball, flag football, lacrosse (sixes) and squash.**
- ✓ IOC has suspended the Russian Olympic Committee (ROC) for violating the Olympic charter with "immediate effect and until further notice" after it incorporated sports bodies from 4 territories annexed from Ukraine (Donetsk, Kherson, Luhansk and Zaporizhzhia) as its member

India's Raunak Sadhwani Wins World Junior Rapid Chess Championship 2023 Title

- ✓ India's GrandMaster(GM) Raunak Sadhwani won the FIDE World Junior Rapid Chess Championship 2023 title in the open category. He also secured second place(Silver Medal) in the FIDE World Junior Blitz Championship 2023 in the open category.

- ✓ The inaugural edition of the Federation Internationale des Echecs/International Chess Federation (FIDE)

World Junior Under 20(U-20) Rapid & Blitz



Championships 2023 was held from 9th to 16th October 2023 in Pula(Sardinia), Italy.

- ✓ The event was hosted by the Italian Chess Federation and the total prize was Money 25,000 Euro.
- ✓ Woman Grandmaster (WGM) Govhar Beydullayeva of Azerbaijan won the FIDE World Junior Girls U20 Rapid Chess Championship 2023 title. Previously, She had won the World Junior U20 Championship title 2022 in Italy.

Jannik Sinner Wins China Open 2023 Men's Singles Title

- ✓ Jannik Sinner of Italy won the China Open 2023 men's single title against Daniil Medvedev (Russia) for the first time. It was held at the Beijing Olympic Green Tennis Center, Beijing, China from September 28 – October 04 2023.
 
- ✓ Sinner defeated World No. 2 and top seed Carlos Alcaraz (Spain) in the semi-finals. It was the 22nd edition of the China Open (1993 to 2023).
- ✓ **Women's Singles:** Iga Swiatek (Poland) won the China Open 2023 women's singles title, beating her opponent Liudmila Samsonova (Russia). With this Iga Swiatek won her fifth title of the season 2023.
- ✓ **Men's Doubles** – Ivan Dodig (Croatia) and Austin Krajicek (United States) cinched their fifth tour-level title of the season (2023) at the China Open 2023 by defeating Wesley Koolhof (Netherlands) and Neal Skupski (United Kingdom).
- ✓ **Women's Doubles:** Marie Bouzková (Czechia) and Sara Sorribes Tormo (Spain) defeated Chan Hao-ching (Taiwan) and Giuliana Olmos (Mexico) in the final.

Verstappen wins Qatar GP 2023 to win 3rd Formula1 World Championship

- ✓ Max Verstappen, the Belgian- Dutch driver of Red Bull added his name to the list of Formula One (F1) triple champions.
- ✓ Max Verstappen achieved this feat by securing 2nd place in Qatar Grand Prix 2023 sprint race, Australian driver of McLaren Oscar Piastri won the Sprint race.
- ✓ Later on, Max Verstappen won the 2023 Qatar Grand Prix main race event, followed by Australian driver of McLaren, Oscar Piastri and British driver of McLaren, Lando Norris.
- ✓ With this win Max has won the consecutive F1 World Championship in (2023, 2022 & 2021).

Ayush Shetty Wins Bronze Medal in BWF World Junior Championships 2023

- ✓ India's Ayush Shetty won the bronze medal in the Badminton World Federation (BWF) World Junior Championships 2023 held from 25th September to 8th October 2023 in Spokane, United States of America (USA).
- 
- ✓ Alwi Farhan of Indonesia won the gold medal by defeating Hu Zhe An of China (Silver) in the 23rd edition of the BWF World Junior Championships finals.
 - ✓ Ayush Shetty lost to Alwi Farhan of Indonesia. The two losers of the semifinals were given the Bronze medal, the another semifinalist Alex Lanier(France) won the Bronze medal.
 - ✓ The 18-year-old Ayush Shetty's bronze medal was India's 11th medal including 1 Gold, 4 Silver, and 6 Bronze at the junior badminton world championships since 1992.
 - ✓ Saina Nehwal won the gold medal in 2008 (India's best) and silver in 2006 while India's Sankar Muthusamy Subramanian won silver in 2022 in Spain.

India Finishes Fourth in the Hangzhou Asian Games 2022 with 107 Medals

- ✓ India finished Fourth in the medal tally of the Hangzhou Asian Games 2022 with 107 medals (28 gold, 38 silver and 41 bronze).
- ✓ The 19th edition of the Asian Games marks India's record for the highest medal tally so far, surpassing the previous record medal tally of 70 medals (16 gold, 23 silver, and 31 bronze) at the Jakarta Asian Games 2018.
- ✓ India won the highest number of medals in the Shooting event with 22 medals (7 Gold, 9 Silver, and 6 Bronze). It was followed by Athletics 29 medals (6 Gold, 14 Silver, and 9 Bronze) and Archery 9 medals (5 Gold, 2 Silver, and 2 Bronze).
- ✓ Through the Hangzhou Asian Games 2022, 74 Indian players have secured their place to participate in the Paris 2024 Olympics.
- ✓ Nagpur's (Maharashtra) **Ojas Pravin Deotale** won three gold medals in Archery including men's individual, men's compound team event along with Abhishek Verma and Prathamesh Jawkar, mixed team event along with Jyothi Surekha Vennam. He was the first Indian archer to win three gold medals in the Asian Games so far. Deotale's gold medal in the compound mixed team event along with Jyothi was India's first gold medal in the compound mixed team event so far in the Asian Games.
- ✓ **Jyothi Surekha Vennam** from Vijayawada also won three medals including gold in Women's Compound Individual, Women's Compound Archery Team along with Aditi Swami & Parneet Kaur, and Mixed team compound archery team.
- ✓ **Parul Chaudhary** won two medals including gold medal in the women's 5000m race and the silver medal in the 3000m women's steeplechase. Parul Chaudhary holds the national record for the 5000m with a time of 15:10.35.
- ✓ **Sunil Kumar** won the bronze medal in Greco-Roman(87kg division) wrestling. This was India's first medal in Greco-Roman wrestling in the Asian Games since the Guangzhou Asian Games in 2010 when Ravinder Singh and Sunil Kumar Rana won bronze medals in the same event.

- ✓ **Avinash Sable** was the first Indian to win the gold medal in the 3000m men's steeplechase event in any Asian Games.
- ✓ Indian Men's 4x400m relay team including Anas Muhammed Yahiya, Amoj Jacob, Muhammed Ajmal Variyathodi and Rajesh Ramesh won the gold medal.
- ✓ Indian women's 4x400m relay team including Vithya Ramraj, Aishwarya Mishra, Prachi and Subha Venkatesan won the silver medal.
- ✓ Indian mixed team 4x400m relay team including Vithya Ramraj, Muhammed Ajmal Variyathodi, Rajesh Ramesh and Subha Venkatesan won the silver medal.
- ✓ **Neeraj Chopra** won his second consecutive gold medal in the men's Javelin throw in the Asian games with a best throw of 88.88 metres.
- ✓ India's **Kishore Kumar** Jena won the silver medal with the best throw of 87.54 metres in the men's Javelin throw.
- ✓ India's **Annu Rani** won the gold medal in the women's Javelin throw with the best throw of 62.92m.
- ✓ This has been Annu Rani's second medal in the Asian games since she won the bronze medal in Incheon(South Korea) in 2014.
- ✓ **Hockey:** The Indian men's hockey team won the gold medal by defeating Japan in the final. This was India's fourth Asian Games gold medal including Bangkok (1966), Bangkok(1998), Incheon(2014), and Huangzhou(2022).
- ✓ With this win Indian men's hockey qualified directly to Paris Olympics 2024.
- ✓ Indian women's hockey team won the bronze medal by defeating Japan in the match for third place.
- ✓ **Badminton:**
- ✓ Indian duo **Satwiksairaj Rankireddy and Chirag Shetty** won the gold medal in the men's doubles of badminton by defeating South Korea's Choi Solgyu & Kim Wonho in the finals. This was India's maiden gold medal in badminton at the Asian Games.
- ✓ Indian men's team won the silver medal in the men's team badminton event.

India's H.S. Prannoy won the bronze medal in the badminton men's singles event.

Cricket:

- ✓ i.The Indian men's cricket team led by Ruturaj Gaikwad was awarded a gold medal after the final was called off due to rain. This was the Indian men's cricket team's maiden title in the Asian games. Afghanistan won the silver while Bangladesh bagged bronze in the men's cricket.
- ✓ **Kabaddi:**The Indian men's kabaddi team won the gold medal by defeating Iran in the finals. This was India's eighth men's kabaddi title at the Asian Games.
- ✓ The Indian women's kabaddi team also won the gold medal by defeating Chinese Taipei in the final. The Indian women's kabaddi team's medal was the 100th medal for India in Hangzhou Asian Games 2022. This was the Indian women's kabaddi team's third gold medal in the Asian games.
- ✓ Next Edition: The 20th edition of Asian Games will be held in Japan in 2027.
- ✓ **Harmanpreet Singh, Lovlina Borgohain** to be India's flag-bearers during opening ceremony.
- ✓ Renowned hockey player **P. R. Sreejesh** had the honor of being India's flag bearer during the closing ceremony, representing his country with pride on the international stage.
- ✓ **"Heart to Heart, @Future"** is the slogan for the Games. **"Tides Surging"** is the official name of the Emblem

- ✓ According to the 360 ONE Wealth Hurun India Rich List for 2023 released recently, Reliance Industries chairman Mukesh Ambani has surged ahead of Adani Group's Gautam Adani to claim the title of the richest Indian.
- ✓ Mukesh Ambani, the chairman of Reliance Industries, saw his wealth grow by a modest 2 percent, reaching a staggering Rs 8.08 lakh crore. This significant wealth increment has solidified his position as the wealthiest individual in India.
- ✓ In stark contrast to Ambani's ascent, Gautam Adani, the head of Adani Group, witnessed a significant dip in his wealth. His fortune plummeted by a whopping 57 percent to Rs 4.74 lakh crore, primarily due to a massive stock market decline in his group's firms.
- ✓ This fall was triggered by a report published in January from a US-based short seller, Hindenburg Research, which alleged accounting frauds and stock market manipulation within the Adani Group.
- ✓ Cyrus Poonawalla, the Managing Director and Chairman of Serum Institute of India (SII), retained his position as the third wealthiest individual in India. His fortune experienced an impressive 36 percent jump, reaching Rs 2.78 lakh crore.
- ✓ Shiv Nadar, the founder and chairman of HCL Technologies, maintained his position as the fourth richest Indian. His wealth increased by 23 percent to reach Rs 2.28 lakh crore



Li Keqiang, Former Chinese Premier Passed Away

- ✓ Li Keqiang, a Chinese economist and politician who served as the Premier of People's Republic of China (2013- 2023), passed away at the age of 68 in Shanghai, China.



- ✓ He was born in July 1955 in Dingyuan County in eastern China's Anhui province. Li Keqiang stepped down from his post in March 2023 and was succeeded by Li Qiang, the incumbent Premier of China
- ✓ Premier is the second-highest position in China's political system after the President.

Ex-Union Minister Babanrao Dhakne Passed Away

- ✓ Babanrao Dhakne, Former Union Minister and senior politician, passed away in Ahmednagar, Maharashtra at the age of 86. He was born on 10 November 1937 in Akola, Ahmednagar in Maharashtra. He served as the Union State Minister in the Ministry of Energy (1990 to 1991) under the premiership of Chandra Shekhar (8th Prime Minister of India – 1990 to 1991).
- ✓ Babanrao Dhakne served as the Member of Parliament(MP) as a part of the 9th Lok Sabha. He represented Beed constituency of Maharashtra as a member of Janata Dal (JD). He was the 1st person of Vanjari Community to become themember of the 9th Lok Sabha.



Legendary Indian spinner & Padma Sri Awardee Bishan Singh Bedi Passed Away

- ✓ Former Indian cricketer, legendary left-arm spinner and Padma Shri awardee, Bishan Singh Bedi, passed away at the age of 77. He was born on 25th September 1946 in Amritsar, Punjab.



About Bishan Singh Bedi

- ✓ **Career:** Bishan Bedi made his debut for India against West Indies at Eden Gardens (Kolkata, West Bengal)on December 31, 1966.
- ✓ He played 67 Tests for India between 1967 and 1979 and captained Team India for 4 years in the Test format between 1975 and 1979.

- ✓ He led Delhi to its first two Ranji Trophy titles (in 1978-79 and 1979-80). He also led Punjab to its only Ranji Trophy win (in the 1992-93).
- ✓ He played for Northamptonshire in 102 outings (1972 and 1977), and took 434 wickets, which is the most by an Indian in County cricket.
- ✓ Bedi was one of the most successful overseas players in English county cricket.
- ✓ He made his final international appearance for India against England at the Kennington Oval in 1979.
- ✓ He became the first professional head coach of India in 1990.

Record: He took 1560 wickets (more than any other Indian bowler) in 370 matches with a bowling average of 28.71.

- ✓ He has taken 266 wickets in 67 matches. With this, he made a record of being the highest wicket-taker in India.
- ✓ In June 2023, Ravindra Jadeja surpassed Bishan Singh Bedi to become India's most successful leftarm spinner in Test cricket by taking 267 wickets in 65 matches at an average of 24.25.
- ✓ **Awards:** Government of India honoured him with the Padma Shri for sports in 1970. He also received the Arjuna Award for Cricket in 1969.

Eminent Assamese Scholar & Padma Shri Awardee Birendra Nath Datta Passed Away

- ✓ Padma Shri Awardee Birendra Nath Datta, an eminent Assamese scholar, Linguist, and Singer, passed away at the age of 88 in Guwahati, Assam. He was born on March 1, 1935 in Nagaon, Assam.
- ✓ He was awarded the Padma Shri in 2009 for Literature and Education.

Padma Shri Awardee and Spiritual Leader Bangaru Adigalar Passed Away

- ✓ Padma Shri Awardee Arul Thiru Bangaru Adigalar, a Spiritual Leader and the founder of Melmaruvathur Adhiparasakthi Siddhar Peedam in Kancheepuram district (Tamil Nadu (TN)) passed away at the age of 82 in Melmaruvathur, TN. He was born on 3 March 1941 in Melmaruvathur

village. He was conferred with Padma Shri in 2019 for his spiritual services to the society.

Nobel winning American Poet Louise Glück Passed Away

- ✓ Louise Elisabeth Glück, an acclaimed Jewish-American poet & essayist and Nobel laureate (Literature 2020), passed away at the age of 80 in Cambridge, Massachusetts, the United States of America (USA). She was born on 22 April 1943 in New York, USA.

Padma Vibhushan Awardee & 11th CEC of India MS Gill Passed Away

- ✓ Padma Vibhushan Awardee and the 11th Chief Election Commissioner (CEC) of India, Dr. Manohar Singh Gill (MS Gill), passed away in New Delhi, Delhi at the age of 87. He was born on June 14, 1936, in undivided Punjab. He had a distinguished career as an Indian bureaucrat, politician, and writer.
- ✓ MS Gill was a 1958 batch of the Indian Administrative Service (IAS) officer of Punjab cadre. He has served as the CEC of India between December 1996 and June 2001. During his tenure as CEC, the Election Commission of India (ECI).
- ✓ MS Gill was awarded the Padma Vibhushan in 2000 for his exceptional and distinguished services as a civil servant.



Nari Shakti Award Winner & Kerala Adult Literacy Topper Karthyayani Amma Passed Away

- ✓ Nari Shakti Award winner Karthyayani Amma, who topped Akshara Laksham project of Kerala's adult literacy programme, passed away at the age of 101 in Alappuzha, Kerala. She was born in 1922.
- ✓ In 2019, she was also appointed as the Goodwill Ambassador of the Commonwealth of Learning for the promotion of distance education among 53 member countries. In 2020, she was awarded the Nari Shakti Puraskar, the highest civilian award for women, by the Ministry of Women and Child Development (MoWCD).

- ✓ Rajkummar Rao and ECI entered into a Memorandum of Understanding (MoU) for a period of 3 years at the event held in New Delhi, Delhi, in the presence of the Chief Election Commissioner (CEC), Rajiv Kumar, and Election Commissioners Anup Chandra Pandey and Arun Goel.



Sultan Ibrahim Sultan Iskandar, Ruler of Johor, Elected as 17th King of Malaysia

- ✓ His Royal Highness (HRH) Sultan Ibrahim ibni Almarhum Sultan Iskandar, the Ruler of the southern Malaysian state of Johor, was elected as the 17th King of Malaysia, also known as Yang diPertuan Agong (YDPA) XVII, for a term of 5 years, which will begin on 31st January 2024.



- ✓ He was elected by the Conference of Rulers during its 263rd (Special) meeting held at the National Palace (Istana Negara) in Kuala Lumpur, Malaysia.
- ✓ He will replace incumbent Sovereign Al-Sultan Abdullah ibni Sultan Ahmad Shah, Ruler of Pahang state, who has been serving as the 16th King since 2019. His tenure is set to end on 30th January 2024.
- ✓ For the first time in over 3 decades, the Ruler of Johor has been appointed as the YDPA. The last YDPA from Johar was the late former Johor Ruler, Sultan Iskandar Sultan Ismail, Father of Sultan Ibrahim. He served as YDPA of Malaysia from 1984 to 1989.

Amitava Mukherjee gets Tenure Extension as NMDC CMD

- ✓ The Ministry of Steel has extended the tenure of Amitava Mukherjee, Chairman-cum-Managing Director (CMD) of the National Mineral Development Corporation (NMDC) for a further period of 1 year with effect from 20th November 2023 up to 19th November 2024 or till the appointment of a regular incumbent or until further orders.
- ✓ He is the Director (Finance) of NMDC who has been holding additional charge as the CMD since March 2023.
- ✓ This is the 2nd extension given to Mukherjee on his additional charge. Earlier the Government extended his tenure in July 2023 till November 19, 2023.



Robert Fico formally appointed as PM of Slovakia

- ✓ On 25th October 2023, the Zuzana Čaputová, President of Slovakia, formally appointed Robert Fico as the Prime Minister (PM) of Slovakia. He will succeed Eudovít Ódor who has been serving as the Interim PM of Slovakia since 15 May 2023 after the resignation of Eduard Heger as PM.
- ✓ This is the 3rd time Robert Fico will serve as the PM of Slovakia, after having served from 2006 to 2010 and from 2012 to 2018.



- ✓ He is the head of the current ruling pro-Russian party Slovak Social Democracy (SMER-SD).

HP Appoints Former Apple Executive Ipsita Dasgupta as SVP & MD for India

- ✓ HP Inc. (known as Hewlett-Packard Company), has appointed former Apple executive Ipsita Dasgupta as senior vice president (SVP) and Managing Director (MD) of HP's India market.
- ✓ She will take over the new position with effect from 30th October 2023 succeeding Gurpreet Singh Brar, who has been serving as the Interim MD since November 2022.
- ✓ As the SVP and MD, she will be responsible for all the aspects of HP's strategy and Profit and Loss (P&L) in India, Bangladesh and Sri Lanka.
- ✓ She will be reporting to David McQuarrie, Chief Commercial Officer (CCO) of HP.

Sanjay Kumar Jain appointed as CMD of IRCTC

- ✓ Sanjay Kumar Jain has been appointed as the Chairman and Managing Director (CMD) of the Indian Railway Catering and Tourism Corporation (IRCTC). His appointment has been approved after the recommendation of Serach-Cum-Selection Committee (SCSC).
- ✓ The post was vacant since January 2021 after the retirement of Mahendra Pratap Maal. From June 2023, Seema Kumar who is the Additional Member (Tourism & Catering) is acting as CMD (Additional Charge).

Ashok Vaswani Appointed as New MD & CEO of Kotak Mahindra Bank Limited

- ✓ The Reserve Bank of India (RBI) has approved the appointment of Ashok Vaswani as the next Managing Director (MD) and Chief Executive Officer (CEO) of Kotak Mahindra Bank Limited (KMB) for a period of 3 years. The appointment is with effect from the date of taking charge, which shall not be later than January 1, 2024.
- ✓ Ashok Vaswani will replace Uday Kotak who stepped down from the post in September 2023. He

resigned 4 months ahead of the end of his current tenure, which is December 31, 2023.

- ✓ Ashok Vaswani will succeed Dipak Gupta, the Joint MD of KMB, who is serving as the interim MD & CEO of KMB until December 31, 2023.
- ✓ Ashok Vaswani is currently the president of Pagaya Technologies Ltd, the United States of America (US)- Israel Artificial intelligence (AI) fintech firm.

President Appoints Raghubar Das as Governor of Odisha & Indra Sena Reddy Nallu as Governor of Tripura

- ✓ Droupadi Murmu, President of India, has appointed former Chief Minister(CM) of Jharkhand, Raghubar Das(68 years old), as the 26th Governor of Odisha and Telangana Bharatiya Janata Party (BJP) leader Indra Sena Reddy Nallu(73) as 20th Governor of Tripura with effect from the date they assume charge.

Raghubar Das will succeed Ganeshi Lal who has been serving as the Governor of Odisha since 2018.

- ✓ Indra Sena Reddy Nallu will succeed Satyadeo Narain Arya who has been serving as the Governor of Tripura since 2021.
- ✓ Article 153 of the Constitution of India mandates the presence of a Governor in each state.
- ✓ Under article 155 of the Constitution, the President of India appoints the Governor on the advice of the Central Government, which is headed by the Prime Minister.
- ✓ The Governor is appointed for a term of five years.
- ✓ To be eligible for appointment as Governor, a person must be an Indian citizen and have completed the age of 35 years(Article 157).

Arindam Bagchi Appointed Permanent Representative of India to UN in Geneva

- ✓ Arindam Bagchi, the spokesperson for India's Ministry of External Affairs, has been appointed as India's permanent representative to the United Nations and other international organizations in Geneva. Bagchi, a 1995-batch Indian Foreign Service official, has been praised for his handling of



critical issues, including the Ladakh border dispute and India's response to COVID-19. He will succeed Indra Mani Pandey in the role. Bagchi has previously served as ambassador to Croatia, deputy high commissioner to Sri Lanka, and director in the Prime Minister's Office.

Christopher Luxon Elected as the 42nd PM of New Zealand

- ✓ Christopher Luxon has been elected as the 42nd Prime Minister(PM) of New Zealand. He belongs to (and the leader of) central-right National Party of New Zealand. He will succeed Labour Party's Chris Hipkins who was appointed the 41st PM of New Zealand in January 2023. New Zealanders went to the polls on October 14, 2023, to elect the 54th Parliament.



Daniel Noboa Becomes Youngest President Elect of Ecuador

- ✓ Daniel Noboa, a 35-year-old businessman and a member of National Democratic Action, won the 2023 General Election of Ecuador defeating Luisa González of the Citizen Revolution Movement.
- ✓ With this victory, Daniel Noboa becomes the Youngest ever President elect of Ecuador .
- ✓ Daniel Noboa is scheduled to be sworn in on 25 November 2023 succeeding the outgoing President Guillermo Lasso. He will serve out the term of Guillermo Lasso, which will end in May 2025



Kumar Sangakkara Appointed as New Chair of MCC's World Cricket Committee

- ✓ The Marylebone Cricket Club (MCC) has appointed former Sri Lankan Cricket Captain Kumar Chokshanada Sangakkara as the new Chair of MCC's World Cricket Committee(WCC). He will succeed former England captain Mike Gatting, who has held the post since 2017.



REPORTS, INDICES AND RANKING

IEA's World Energy Outlook 2023: Major Energy Changes by 2030

- ✓ The International Energy Agency (IEA) has released a report, World Energy Outlook 2023, which presents a vision of substantial changes in global energy system by 2030. The report highlights India's growing electricity demand, with annual growth of around 5%, making it third-largest electricity consumer globally by 2050, after China and the United States. China is the largest electricity consumer in the world.
 - ✓ The WEO-2023 presents three scenarios for the future of global energy:
 - ✓ **Stated Policies Scenario (STEPS):** This scenario assumes that governments implement the energy policies that have already been announced.
 - ✓ **Accelerated Policy Scenario (APS):** This scenario assumes that governments implement more ambitious energy policies in order to achieve climate and other goals.
 - ✓ **Net Zero Emissions by 2050 (NZE):** This scenario assumes that global energy-related CO₂ emissions reach net zero by 2050, in line with the Paris Agreement.
- Key points**
- ✓ Global use of fossil fuels is expected to peak by 2025, 2 years earlier than previously anticipated. Fossil Fuels such as Coal, oil, natural gas and bioenergy are each projected to peak before 2030,
 - ✓ IEA has predicted that 18% of the electricity generated in India will be from solar sources by 2030, which set to be 6% increase in 2023.
 - ✓ IEA Forecasts India's CO₂ Emission Drop by 2050, Expects AC Electricity Demand to Outpace Africa.
 - ✓ Based on current policy settings, Electric cars is expected to increase globally by almost 10 times by 2030.
 - ✓ IEA predicts that India's capacity may exceed 70 gigawatts (GW) annually by 2027. India is committed to expanding its production capacity to meet domestic energy needs and potentially export solar modules.

OECD's International Migration Outlook 2023: India Remains Top Country of Origin for New Migrants to OECD Nations in 2021

- ✓ According to the "International Migration Outlook: 2023" published by the Organisation for Economic Cooperation and Development (OECD), for the 2nd consecutive year, India has retained its position as the top country of origin for new migrants to the member countries of OECD in 2021.
- ✓ More than 407,000 people (excluding students) have migrated from India to OECD countries in 2021.
- ✓ This accounts to around 7.5% of the total migration flow. This was 86% higher than 220,000 Indians in 2020.
- ✓ China is ranked 2nd with 227,000 new migrants followed by Romania (215,000); Ukraine (189,000); and Germany(119,000).
- ✓ OECD is a group of 38 countries, most of which are high-income and ranked very high on the Human Development Index (HDI).

FAO's 1st Global Estimation of Impact of Disasters on Agriculture: USD 3.8 Trillion worth Crops & Livestock Lost over 30 years

- ✓ The United Nations Food and Agriculture Organization (FAO) released a report titled 'The Impact of Disasters on Agriculture and Food Security 2023-Avoiding and reducing losses through investment in resilience' which is the first-ever global estimation of the impact of disasters on agricultural production focused on crops and livestock.
- ✓ As per the report, the Global aggregated losses for the past 30 years (1991-2021) due to disasters events amounts to USD 3.8 trillion, corresponding to about USD 123 billion per year.
- ✓ This value is equivalent to 5% of global agricultural Gross Domestic Product (GDP), and nearly 300 million tonnes of accumulated losses per year, or the real GDP of Brazil in year 2022.

- ✓ The disaster events include floods, droughts, insect infestations, storms, disease and war.
- ✓ The report has been prepared and jointly produced by the Statistics Division (ESS) and the Office of Emergencies and Resilience (OER) of FAO.

India's Natural Gas Demand to rise 4% in 2023: IEA Report

- ✓ The International Energy Agency (IEA) released its 'Gas 2023 Medium-Term Market Report'. As per it, India's natural gas demand is expected to rise by 4% in 2023 calendar year and will continue to increase at an average annual rate of about 8% till 2026. This growth will be driven by power, petrochemical and fertiliser sectors.

Mercer CFA Institute Global Pension Index 2023: India ranked 45th out of 47; Netherland tops

- ✓ According to the 15th annual Mercer CFA Institute Global Pension Index (MCGPI 2023), India is ranked 45th out of 47 countries. The overall index value of India increased from 44.5 in 2022 to 45.9 in 2023. India was ranked 41st out of 44 in 2022.
- ✓ The 2023 Index is topped by the Netherlands with overall index value of 85.0, followed by Iceland (83.5) and Denmark (81.3).
- ✓ With the lowest index value of 42.3, Argentina is ranked 47th in MCGPI 2023.
- ✓ Singapore is ranked 7th out of 47 in the MCGPI 2023 and retained its top spot among asian countries. Hong Kong SAR (21st) and Japan (30th) have secured the 2nd and 3rd spot in Asia.
- ✓ India's sub-indices values were adequacy (41.9), sustainability (43.0), and integrity (56.5).

Ookla's Speedtest Global Index: India is ranked 47th; UAE tops

- ✓ According to Ookla's Speedtest Global Index (August 2023 edition) India is ranked 47th among 145 countries with median download speed of 50.21 Mbps (Megabits per second). India has moved up 72 places, from 119th place in 2022 to the 47th position in 2023.
- ✓ The list is topped by United Arab Emirates (UAE) with the median download speeds of 210.89 Mbps. Qatar and Kuwait stands at second and third rank

with the download speed of 192.71Mbps and 153.86Mbps respectively.

Global Hunger Index 2023: India slips four places, Ranked 111 out of 125 countries

- ✓ India ranks 111th out of the 125 countries with a score of 28.7 in Global Hunger Index (GHI) 2023. India slipped 4 positions as compared to previous GHI ranking. In 2022, India ranked 107 out of 121 countries. In 2021, it was placed at 101 out of 116 countries. The ranks of India's neighbouring countries are Pakistan (102th), Bangladesh (81st), Nepal (69th), and Sri Lanka (60th).
- ✓ Afghanistan (114), Haiti (115) and 12 sub-Saharan countries perform worse than India on the GHI 2023.
- ✓ In GHI 2023, 20 countries with 2023 GHI scores of less than 5 are not assigned individual ranks, They are collectively ranked 1–20. These 20 countries are:
- ✓ Belarus, Bosnia & Herzegovina, Chile, China, Croatia, Estonia, Georgia, Hungary, Kuwait, Latvia, Lithuania, Moldova, Montenegro, North Macedonia, Romania, Serbia, Slovakia, Türkiye, United Arab Emirates (UAE), and Uruguay.
- ✓ Global Hunger Index is jointly published by the international humanitarian organisation Concern Worldwide and Germany-based Wel thungerhilfe with the aim to trigger action to reduce hunger around the world. It was first published in 2006.
- ✓ GHI is a peer-reviewed annual report, designed to comprehensively measure and track hunger at the global, regional, and country levels.
- ✓ As per the GHI Severity of Hunger Scale, the country's score in the range of 20.0–34.9 indicates that has a serious level of hunger. So with a score of 28.7, India has a level of hunger that is serious.
- ✓ The GHI 2023 shows that 9 countries are in the 'alarming' category, 34 countries are in the 'serious' category, 37 countries are in the 'moderate' category and 50 countries in the 'low' category.
- ✓ The global score of GHI 2023 is 18.3 which is 0.8 less compared to 19.1 in 2015 and the global hunger level is considered as 'moderate'

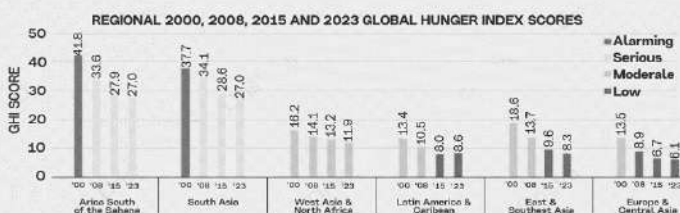
