India tops list of doping offenders in 2022: WADA anti-doping report

- India has emerged as the country with the highest percentage of doping offenders, according to the 2022 testing figures released by the World Anti-Doping Agency (WADA).
- The report revealed that out of 4,064 samples collected from Indian athletes (including urine, blood, and athlete biological passports), 127 individuals tested positive for banned substances, constituting 3.26 per cent of the sample size.
- WADA report also found a 6.4 per cent increase in the total number of samples analysed and reported in its Anti-Doping Administration and Management System (ADAMS) in 2022, compared to the previous year.
- The percentage of Adverse Analytical Finding (AAF) also increased to 0.77 per cent in 2022, from 0.65 per cent in 2021.

- The analysis was based on failed drug tests among nations, with more than 2000 samples being tested by their respective testing laboratories.
- Following India, South Africa ranked second with 80 doping failures (2.04 per cent from 4,169 samples tested), followed by Bangkok's testing laboratory in third place, reporting 1.93 per cent of its testing pool (3,402 samples), returning 65 cases of AAFs.
- > The **United States** and **Qatar** secured the fourth and fifth positions, respectively.
- India's doping violations outnumber those of major sporting nations such as Russia (85), the United States (84), Italy (73), and France (72). China conducted the highest number of samples testing 17,357 during the counting period with an adverse findings percentage of 0.25 per cent.
- India also topped the list for the highest percentage of failed EPO-Receptor Agonists (ERA) tests conducted per laboratory (blood), with 11 cases or 1.8 per cent of adverse analytical findings (AAFs).

Repo rate kept unchanged at 6.5% for seventh consecutive time

- The Reserve Bank of India's Monetary Policy Committee (RBI MPC) has decided to keep the report rate unchanged at 6.5 per cent for the seventh consecutive time.
- The RBI MPC has also decided to keep its stance of "withdrawal of accommodation" unchanged with a majority of 5-1.
- > To ensure that inflation aligned with the **four** per cent target while aligning with growth.
- The repo rate was last changed in February 2023, when it was hiked from 6.25 per cent to 6.5 per cent. between May 2022 and February 2023, the repo rate was raised by 250 basis points (bps).
- Additionally, the Standing Deposit Facility (SDF) will remain at 6.25 per cent. The marginal standing facility (MSF) and bank rate will also remain at 6.75 per cent.

- Shaktikanta Das kept the retail inflation forecast for 2024-25 (FY25) unchanged but tweaked the quarterwise figures.
- In Q1, the retail inflation is now likely to be 4.9 per cent as compared to 5 per cent earlier. In Q2, the inflation is likely to be 3.8 per cent as compared to 4 per cent earlier.
- For Q3FY25, the inflation forecast has been kept unchanged at 4.6 per cent. But for Q4FY25, the inflation forecast has been lowered to 4.5 per cent as compared to 4.7 per cent earlier.
- While inflation is moving closer to targets, the uncertainties in food prices continue to pose challenges, as well as tight global labour markets.
- ▶ For FY25, the Gross Domestic Product (GDP) growth prediction has been kept unchanged at 7 per cent.
- ▶ In Q1FY25 GDP growth target has been set at 7.1 per cent as compared to 7.2 per cent earlier.
- ▶ For Q2FY25, GDP growth target has been fixed at 6.9 per cent from 6.8 per cent earlier.
- For Q3 and Q4, the GDP growth has been predicted at 7 per cent each. For Q4FY25, the GDP growth target was 6.9 per cent earlier.

NMDC clocks record 45MT iron ore output in FY24

- India's largest iron ore miner, the state-run National Mineral Development Corporation (NMDC) has become the first mining company in the country to cross a production of 45 million tonnes (MT) in a fiscal year.
- The Hyderabad-based Navratna achieved this feat in financial year 2023-24 (FY24) with a production of 45.1 MT and sales of 44.8 MT iron ore in FY24 that drew to a close, a 10% growth in production and 16% jump in sales as compared to FY23.
- NMDC in Hyderabad achieved a record-breaking 45MT production in FY24, marking a significant milestone towards its goal of 100MTPA.
- Major contributions came from Chhattisgarh and Karnataka mines, with a notable increase in pellet production and capex expenditure.

- These awards demonstrate SJVN's commitment to driving positive change through innovative and concrete CSR initiatives.



Zimbabwe declares El Nino Drought as a National Disaster

- Zimbabwe declared drought a national disaster, with President Emmerson Mnangagwa saying the country needs \$2 billion in aid to help millions of people who are going hungry.
- > A severe dry spell induced by the El Nino weather pattern is wreaking havoc across southern Africa.
- ➤ The naturally occurring El Nino climate pattern, which emerged in mid-2023, usually increases global temperatures for one year afterwards. It is currently fuelling fires and record heat across the world.
- In southern Africa, Zimbabwe is the third country to declare drought a national disaster after Malawi and Zambia.






- According to the World Meteorological Organization (WMO), the latest El Nino is one of the five strongest ever recorded and its impact will continue by fuelling heat trapped in the atmosphere by greenhouse gases.
- El Nino reached a peak in December but should still result in above-normal temperatures until May over almost all land areas.

Romania developed the world's most powerful laser 'ELI-NP'

- In the control room of a research centre in Romania, part of the European Union's Infrastructure ELI project, engineer Antonia Toma activates the world's most powerful laser "Extreme Light Infrastructure-Nuclear Physics (ELI-NP)", which promises revolutionary advances in everything from the health sector to space.
- The laser at the center, near the Romanian capital Bucharest, is operated by French company Thales, using Nobel prize-winning inventions.
- France's Gerard Mourou and Donna Strickland of Canada won the 2018 Nobel Physics Prize for harnessing the power of lasers for advanced precision instruments in corrective eye surgery and in industry.

- "The sharp beams of laser light have given us new opportunities for deepening our knowledge about the world and shaping it,"
- The system is capable of reaching a peak of 10 petawatts (10 to the power of 15 watts) for an ultra-short time, in the order of a femtosecond (one millionth of a billionth of a second).

- Singapore, Denmark and U.S. are the best places in the world to conduct business, according to the Economist Intelligence Unit business environment ranking.
- EIU's ranking is measured based off indicators such as inflation, cost of living, economic growth, and fiscal policies.
- Some notable "big improvers" that scored well in the index were countries like Greece, Qatar and India.
- "Singapore will remain the best geography in the world to do business, as it has for the past 16 years," EIU's Country Forecast Manager and Europe analyst.

- Factors driving the Southeast Asian nation's place as a premier business destination is its political stability and the government's focus on helping domestic private-sector companies upgrade technologically.
- ➤ The EIU's ranking assesses the attractiveness of doing business across 82 countries and territories, and is measured based on indicators such as inflation, cost of living, economic growth, and fiscal policies.
- ➢ Germny and Switzerland secured fourth and fifth places respectively.

Indian Chess player Arjun Erigaisi got 9th position in FIDE ranking for the first time

- Arjun Erigaisi was the top-ranked Indian in the latest FIDE rankings released by the world governing body of chess.
- With a standard rating of 2756, Erigaisi is ranked ninth in the world. Following him is five-time world champion Viswanathan Anand, who is the second ranked in India and 11th spot in the wirld with a rating of 2751.
- The 21-year-old Erigaisi collected eight points in the 5th Shengzhen Chess Masters and Bundesliga and mounted to the ninth position on the list. This is his debut in the top 10 in the Open standard list.

- Anand is followed by the Candidates troika of 18-year-old Praggnanandhaa R, 17-year-old Gukesh D and Vidit Santosh Gujrathi, who will all be in action at the prestigious Candidates tournament later this week.
- While Praggnanandhaa is 14th in FIDE charts with a rating of 2747. Gukesh is 16th with 2743. The 29-yearold Vidit is 25th with 2727 points.
- Former world champion Magnus Carlsen still tops the charts with a rating of 2830. Following him are two Americans: Fabiano Caruana (rating of 2803) and Hikaru Nakamura (rating of 2789). Both Caruana and Nakamura are the favourites to win the Candidates, which will earn them the right to take on world champion Ding Liren.
- Meanwhile, in the women's ratings, Koneru Humpy ranked fifth with a rating of 2546 while Harika Dronavalli is 11th with 2503 points. The other Indian to compete at the women's Candidates tournament, R Vaishali, is 15th with 2475 points.
